SENATOR WATSON:

Amendment No. 4 - this is the Southwestern Illinois Development Authority legislation that was introduced and we've discussed several times on the Floor - Amendment No. 4 was the provision for Will and Kankakee Regional Development Authority. And from what I understand, that language may end up in House Bill 3153. anyway, that is taken out. Also, Senate Amendment No. 5, which was the -- was one which created the Tri-County River Valley Development Authority. I understand that has passed now, and -and is on its way to the Governor, or will be shortly. So that -amendment is out. And then Amendment No. 6 was some clean-up language on Amendment No. 4. So that naturally comes out. So I would appreciate the support of the -- of the Body on House Bill 3136, which deals with the Southwestern Illinois Development Authority. PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Is there discussion? This will be final action. Senator Watson has moved -- the question is, shall the Senate recede from the adoption of Senate Amendments 4, 5 and 6 to House Bill 3136. Those in favor will vote Aye. Those opposed, Nay. The voting is open. Have all voted who wish? Take the record. On that question, the Ayes are 50, the Nays are none, none voting Present. SENATOR RAICA:

Thank you, Mr. President. Can I ask the sponsor a question, please?

Indicates she will yield. Senator Raica.

SENATOR RAICA:

Senator Donahue, it was my understanding that the reason that the fingerprinting was put on there was because it wasn't clear whether we can do a background check on individuals just going by name, so the idea of having the fingerprints on there was a way to do a comprehensive background check. If that's the case, why would we be taking that amendment off this? And actually I don't know if it would have any validity then, because we would not have a good way to do background checks without the fingerprinting.

I -- the question seems to be in regard to who pays for the background check, and that is the hangup in the House at this -- at -- at -- why they refuse to accept this Senate Amendment. PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? Senator Welch.

SENATOR WELCH:

I had a question of the sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Sponsor indicates she will yield. Senator Welch.

SENATOR WELCH:

Senator Donahue, if we -- you want to recede from this amendment. If we recede, will there be any fingerprinting at all under this bill?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Donahue.

SENATOR DONAHUE:

No.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Further discussion? If not, Senator Donahue may -- you may close.

SENATOR DONAHUE:

I would just ask for a favorable roll call.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Donahue has -- the question is, shall the Senate recede from the adoption of Senate Amendment No. 2 to House Bill 3494. Those in favor will vote Aye. Those opposed, Nay. The voting is open. Have all voted who wish? Have all voted who

wish? Have all voted who wish? Take the record. On that question, the Ayes are 36, the Nays are 16, none voting Present. The Senate recedes from Senate Amendment No. 2 to House Bill 3494, and the bill, having received the required constitutional majority, is declared passed. 3585. Senator Rea. House Bill, Madam Secretary, please.

SECRETARY HAWKER:

Senate Amendment No. 1 to House Bill 3585.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rea.

SENATOR REA:

Thank you, Mr. President. I would move to recede from Amendment No. 1 of House Bill 3585.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Is there discussion? Senator Hawkinson.

SENATOR HAWKINSON:

Thank you, Mr. President. Senator, would you please tell us what Amendment No. 1 did?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Rea.

SENATOR REA:

Actually, Amendment 1 would make a -- would make available allowable tax credit entitled for donations to the Illinois Center for Research on Sulfur in Coal, and for equipment purchased for the purpose of utilizing Illinois coal. And it would increase that from twenty to thirty percent. And also establishes a five-percent tax credit on amounts expended for installation of such equipment.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Is there further discussion? Senator Rea, you wish to recede from the amendment - is that correct? Senator Rea.

SENATOR REA:

So as a result, why this -- it -- it returns the bill then to allow the -- the bonding for coal research and development as originally was submitted.

PRESIDING OFFICER: (SENATOR DEMUZIO)

You're moving ro recede? All right. The question is, shall the Senate recede from Senate Amendment No. 1 to House Bill 3585. Those in favor will vote Aye. Those opposed, Nay. The voting is open. This is final action. Have all voted who wish? Take the record. On that question, the Ayes are 57, the Nays are none, none voting Present. The Senate recedes from Senate Amendment No. 1 to House Bill 3585, and the bill, having received the required constitutional majority, is declared passed. Chicago Magazine has sought leave to shoot some photographs. Is leave granted? Leave is granted. 3590. Senator Watson. Madam Secretary, House Bill 3-5-9-0.

SECRETARY HAWKER:

Senate Amendments 2 and 4 to House Bill 3590.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Watson.

SENATOR WATSON:

Thank you, Mr. President. I will recede from Senate Amendments No. 2 and 4 to House Bill 3590. This leaves original language of the legislation, which is now in Senate Amendment No. 1, which did delete everything, but is language that will allow the -- pharmaceutical companies, manufacturers and the wholesalers to comply with DASA's requirement on filing certain controlled substance reports to the Department of Alcohol Substance Abuse. Amendment No. 3 was one in which -- was worked out between the professional -- private professional practice -practice individuals, such as physicians, psychiatrists and others who are licensed by the Department of Professional Regulation. There's a duplication of licensing, so the -- the effort here is

to -- to allow for one -- one license. That's Senate Amendment No. 4. Now, the two amendments that we recede from is Senate Amendment No. 2, which was a provision that was in regard to the criminal identification and investigation of individuals and stiffening the penalties and concerns that we had for those arrested from cannabis use. And that was the controversial part of the bill. The House did not concur. So instead of sending this to conference, why, the attitude is to just send this on to the Governor with the original language in the bill. I ask for your support.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Is there discussion? Senator Welch.

SENATOR WELCH:

Well, I had a question of the sponsor.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Indicates he will yield. Senator Welch.

SENATOR WELCH:

Amendment No. 2, Senator Watson, would - according to my analysis - repeal first-offender provisions of the Cannabis Control and Controlled Substances Act, disallowing an order of supervision for any offense of the Cannabis Control or Controlled Substances Act; sets a minimum fine of a thousand dollars or a hundred hours of community service. Isn't that tougher than the existing law that we have now?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Watson.

SENATOR WATSON:

Yes, it is. Yes, sir.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Welch.

SENATOR WELCH:

Well, Senator Watson, you're usually a Member who likes to

stand up for toughening criminal laws. Why are you taking that off?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Watson.

SENATOR WATSON:

We fought the good fight here on the Senate Floor. The amendment prevailed. It went over to the House. The sponsor there did not concur with our action. It takes two Chambers to pass legislation. And as a result, the other amendments on the bill are important enough to me that I think it ought to go on to the Governor, and -- and we'll fight the -- the good fight again another day.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Welch.

SENATOR WELCH:

Senator Watson, it's only the 27th of June. You're raising the white flag. I think that we should fight for the amendment if it's a good one. It seems to me that there's plenty of time left. I know that you're very persuasive. I'm sure that you could convince the House if we do send this to a conference committee, so I'd ask you to change your mind.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Watson.

SENATOR WATSON:

You could certainly vote No, Senator. That's your prerogative.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Further discussion? Senator Watson moves that the Senate recede from Senate Amendments 2 and 4 to House Bill 3590. Those in favor will vote Aye. Those opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, the Ayes

Senator Geo-Karis.

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, much as I hate to, I have to recede from Senate Amendment No. 1.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator Geo-Karis has moved to recede. Is there discussion? Senator Welch.

SENATOR WELCH:

Mr. -- Mr. President, is seems to me that what we're doing

In fact, I would expect her to lead the charge in favor of this amendment. And I think that we shouldn't recede.

SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate -PRESIDING OFFICER: (SENATOR DEMUZIO)

SENATOR GEO-KARIS:

I certainly didn't want to recede, but, unfortunately, I can't get it through otherwise. And you don't have to impinge on my integrity about the military, because I have served. So I'm just telling you that I can't get it through. And I don't want the bill to fail. And I'll be happy to sponsor it or help it in another bill.

Further discussion? Senator Ralph Dunn.

SENATOR R. DUNN:

Thank you, Mr. President, Members of the Senate. I agree with Senator Welch - which is rarely. But I think, too, Geo, you ought to try this another round. As Senator Welch said a while ago to Senator -- that it's still the 27th, and we might have another chance at it. One of the reasons that I stand in support of it is, a year from now, December the 7th, 1991, will be the fiftieth anniversary of Pearl Harbor, and I have an interest in the bill. And so I -- I would consider -- hope you reconsider, and let's try it one more time. Thank you.

SENATOR TOPINKA:

Mr. President and Ladies and Gentlemen of the Senate, I think as we look to this we should know that Senator Jeremiah Joyce had a bill which would indeed consider some of the provisions that had come out of the Senate Transportation Committee on limiting the number of special license plates. I think we're at like a hundred and seventy-six and counting. And our law enforcement officials the State have dutifully noted that they cannot keep track of all the various codes, colors, symbols, and everything else that have put on cars. And if we do start, you know, determining specific battles in any particular war, I -- I would question and I understand Pearl Harbor is a very important event - but so were many of the other events in World War II, the Korean War, Vietnam, and we're going to - once you start this - have to -- I mean, what's wrong with the Tet Offensive, too. I mean, I'd like to call that into question. So I -- maybe this may be the appropriate time that Senator Geo-Karis be allowed to go on course.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Channel 7 has requested permission to videotape.
