I rise in opposition to Conference Committee Report No. 1. know -- you may notice that there were no Republican signatures on the back of it. Not because of what it does contain, but because of what was taken out of it. As Senator Daley did mention, the report recedes from Amendment No. 2, which simply provided that election jurisdictions must accept absentee applications provided by the State Board of Elections. Now this amendment has now passed the Body three times - the Senate three times this year - and each time without a single negative vote. Yet the -- the Body on the other side -- the House majority refuses to discuss the obvious wishes of the Senate, and in their arrogance, they just simply drafted a report containing only the language that Mr. LaPaille, the Chairman of the Democratic Party, wants and needs, and excludes anything that came out of this Body. We talk a lot about opening up the Democratic process and making it easier for people to vote. I do just -- I would just ask that, at least on this side, everybody vote either a red or Present.

Further discussion? Senator Demuzio.

### SENATOR DEMUZIO:

Thank -- thank you, Mr. President and Ladies and Gentleman of the Senate. Over the course of the period of time that I have served here, some sixteen years, we have always afforded each other - each political party - the opportunity to decide for ourselves, with respect to our rules on how our party works and

There is no one of us who was elected to public office, particularly the General Assembly, who enjoys saying "No" to any legitimate, justifiable request. problem with the Appropriations Committee, and service thereon, is that all the requests frankly can be justified. are most -- for the most part commendable. And the fact is we had make some very difficult choices. Now I will say to some of you who are still a little skeptical that we are quite serious about trying to finish our business tomorrow. And the passage of these bills, because they are major appropriations, will go a long way toward reaffirming our resolve. One, that the Senate of Illinois is prepared to cut spending when there is no other alternative. Even as unpopular as it may be, we will cut spending. And two, we will say to the House, "It's over, Fellows and Ladies. We are serious about concluding our business in a reasonable fashion, sending to the Governor a balanced budget, and going home." And I will say thirdly to those of you who have some very serious concerns, that the Governor and I and Senator Philip and

the Leaders from the House met at great lengths today. And I aware, for instance, of the problem in public health - for the cocaine babies and the money they need. I am aware of the concern about day-care facilities. I am aware that there are a number other individual instances where perhaps we have to make some adjustments, and I will say to you, as I have said to you in years past, I am making every attempt, as is the Governor and Senator Philip, to accommodate those requests. We have made a very difficult political decision. We have said, as Senator Philip and I are -- don't like to do, to our Members, "Nope, no Member requests. No pork, because we're going to send a balanced budget as, responsibly, we ought to send a balanced budget. And we cutting spending as, responsibly, we have to cut spending." I will say to you that our concern about those human service aspects - day care, heating, that the one -- the Low Income Assistance Plan, cocaine babies - I -- I hate to say, "Trust me," but there will be a trailer bill. We're not leaving here until those things are addressed. But I think it's important -unemployment insurance is another one, that was just settled. So we will appropriate for that, you can be sure. I'm not leaving here without that appropriation. And all I am saying is once we pass these major appropriation bills, we have literally come closer to closure -- we have narrowed the playing field. And I think it's important for the people of Illinois to understand that the Senate set the tone of this Session and has recognized that we have to cut spending, and at the same time meet the needs of those who are truly in need. I promise you I will do that.

### SENATOR NETSCH:

Thank you, Mr. President. My concern is not with the content of the bill. And I would certainly join in congratulating the

They're going to be asked to have a Road Program of which they have made the commitment - even though we have taken thirty-six million dollars out of the -- of the Fund for State Police - they have made a commitment to continue to fund the Road -- Road Program as we passed, and as it was intended. We are going to pay back that thirty-six million three-year period, and dollars ìn а the Department of Transportation Secretary Lane has made the commitment that they can proceed with the -- the Road Program as we -- as we passed it. problem will be there's a fifteen million dollars operations. They're running a Fiscal Year '90, eight hundred and forty million dollar Road Program with personnel currently have. We are going to ask them now to run a 1.3 billion dollar Road Program in Fiscal Year '91 with a similar personnel.
