It also establishes a State Emergency Response Committee within ESDA, and authorizes ESDA to promulgate rules regarding communications during a disaster. House Amendment No. 1 removes the exemption for local emergency planning committee members from civil liability for death of any person and damage to any property, while acting in the line of duty. And I would move to concur with House Amendment No. 1 to Senate Bill 1017.
