#### SENATOR DEMUZIO:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. Senate Bill 647, when it was before us, said that the interest that was earned on investments - the funds that were held by the Illinois Agriculture Loan Guarantee Fund and the Illinois Farmer

and Agri-business Loan Guarantee Fund, would remain in the fund, instead of the money going to General Revenue. It is estimated that it would divert about 1.8 millions dollars from the Funds to General Revenue. We'd like to leave it in. The Governor said he'd like to have it go into General Revenue. I think that it's much better that we leave it in the Ag — the Loan Guarantee Fund and the Ag-Business Loan Guarantee Fund for further investment. And I would ask for the support of the — of the Senate to override the Governor's veto.

#### PRESIDENT ROCK:

Any discussion? Is there any discussion? If not, the question is, shall Senate Bill 647 pass, the veto of the Governor to the contrary notwithstanding. Those in favor will vote Aye. # SENATOR SEVERNS:

Thank you, Mr. President and Members of the Senate. Senate Bill 1093 provides the funding for the Illinois Small Business Innovation Research Phase Two Assistance Program. This was a bill that passed out of the Senate without opposition. It passed out of

the House without opposition. In this bill we have identified the funding source. It would be appropriated from the Technology Innovation and Commercialization Fund, which was appropriated one million dollars in the last two year's, but only used ten percent of that fund. I believe that many of you have received letters from those industries that have participated in SBIR. In short, it gives small business an opportunity to compete, and tap those federal dollars that are available. This bill does that. I -- I would urge -- the approval of this bill.

#### PRESIDENT ROCK:

All right. Senator Severns has moved the passage of Senate Bill 1093, the veto of the Governor to the contrary notwithstanding. Discussion? Senator DeAngelis.

#### SENATOR DeANGELIS:

Thank you, Mr. President. A question of the sponsor, please.

PRESIDENT ROCK:

Sponsor indicates she will yield. Senator DeAngelis.

# SENATOR DeANGELIS:

Senator Severns, are there any other bills that have been signed by the Governor, that are similar to this?

# PRESIDENT ROCK:

Senator Severns.

# SENATOR SEVERNS:

Thank you, Senator DeAngelis. They -- he has asigned two bills that he says do this. But, in fact, and I can quote, the language that it does is it assists small business who has seek to -- apply for the Federal Phase One Small -- Small Business Innovation Research Grant. That doesn't effect the area between after the businesses receive that phase one funding, and when they're attempting to fill that gap to get on to the larger funds by phase two. And there's no funding identified. The -- the second bill, House Bill 2656, says that DCCA can make loans or grants to

businesses that have received Federal Phase One Small Business Innovative <sic> Research Grants as a bridge. Again, it identifies no funding source. What our bill does is give the specific charts to DCCA to meet this need in Illinois where we have ranged fifteen out of twenty states -- low. And it provides the exact funding source.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DEANGELIS:

Well, first Senator Severns, I think the authorization does exist to fund the bills that the Governor signed through the -- House Bill 2656. But I also have another question.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Senator DeAngelis wishes to ask another question. We're all waiting. Senator DeAngelis.

SENATOR DEANGELIS:

Where would your funding come from?

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator Severns.

SENATOR SEVERNS:

Thank you. The funding source that we identified is within the Commercialization and Technology Fund, that we appropriated one million dollars. In the last two years only ten percent of those dollars have been used. What I'm suggesting -- and what we discussed in committee, is that four hundred thousand dollars be tapped from that left over amount, that has been rolled over two years in a row.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Senator DeAngelis.

SENATOR DeANGELIS:

Well, just a -- a comment. I rise in opposition to this veto.

This bill would, in fact, drain that Fund, which was designed for

other sources. And we already have legislation that's been signed that permits this, and we do have, in fact, authority to fund this under existing legislation.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? If not, Senator Severns may close.

SENATOR SEVERNS:

Thank you, Mr. President, Members of the Senate. The Chicago Association of Commerce and Industry supported this bill during the spring Session. It did pass unanimously. They felt it was a good bill then and believe that it's a good bill now. To especially help those small businesses who are attempting to identify sources in the research area and - it's a good bill. Our record in Illinois is unacceptable. I would urge your favorable consideration of this override.

PRESIDING OFFICER: (SENATOR DEMUZIO)

SENATOR SEVERNS:

Thank you, Mr. President and Members of the Senate. This bill, as you recall, is the bill that many of our economic development foundation directors, across this State, have written us on. It is, in short, language that was lifted...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Pardon me, Senator Severns. Could we have some order, please. Senator Severns.

#### SENATOR SEVERNS:

It is, in short, language that we lifted from the State of Missouri where that same law has worked very well. In fact, in the State of Missouri, this language has permitted the total rennovation -- or -- what is commonly referred to as the Laclede's Landing area, Union Station and elsewhere. It is a bill that does not cost the State of Illinois a single dime, but instead, provides our city councils, and our local governments, and our economic development foundations the additional tools they need to go in and attract, and keep business. I -- I was surprised by the veto, and would urge adoption of this bill.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Discussion? Senator Rigney.

#### SENATOR RIGNEY:

Well, our staff has pointed out to us, over here, Mr. President, that there're probably several problems with this piece of legislation. They list them as follows: it is rather vaguely draft, particularly in the Section of the bill that deals with giving corporations the power of eminent domain - not sure what's going on here. Furthermore, they point out that there, apparently, are no limitations on the amount of property that can be included in a metropolitan re-development area; nor are there specified caps of any kind. Furthermore, I -- apparently local governments, under this provision, can freeze tax bases for all units of local government without their approval. And I understand that there

was no discussion of this particular item at the time that it was pending here, before us.

PRESIDING OFFICER: (SENATOR DEMUZIO)

All right. Further discussion? Can we have some order, please? Senator Schaffer, can we have some order, please? Senator Geo-Karis.

#### SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate. I, reluctantly rise, to oppose this bill of my good friend, the sponsoring Senator. However, this bill gives corporations the power of eminent domain. Since when are we going to give insurance companies the power of eminent domain? I think it's bad. It doesn't contain any review or hearing -- public hearing processes, and I think we've going too far afield. And therefore, I ask for a No vote.

PRESIDING OFFICER: (SENATOR DEMUZIO)

Further discussion? If not, Senator Severns may close.

# SENATOR SEVERNS:

Thank you, Mr. President, Members of the Senate. I regret that — that the analysis on the other side is, apparently, incorrect. First of all, economic development foundations that have been formed by cities such as Decatur, for example, — and it was the director of the Economic Development Foundation there, who brought this idea to me — works along with their Chambers of Commerces and their foundations, in almost all economic development efforts. Unlike some ideas...

PRESIDING OFFICER: (SENATOR DEMUZIO)

Pardon me. Ladies and Gentlemen, the Chair cannot hear the speaker. Senator Severns.

# SENATOR SEVERNS:

Maybe the bill would have a better chance, Mr. President, if the speaker wasn't heard. The -- this legislation, or proposed

legislation, -- proposed legislation - hands the city councils the ability to provide their local tools to attract business and industry - to keep business and industry. Unlike some of the opinions that have been expressed on the Floor today, I have full confidence in the city councils to use their good judgement, in making those economic development decisions. In fact, I think it would be a mistake if the State of Illinois decides that everything the local communities do, toward increasing their economic development efforts, that we should provide another mandate from the State level. I say, let's return local control for these economic development efforts, and override the Governor's veto.

PRESIDENT ROCK:

Senator Maitland.

#### SENATOR MAITLAND:

Thank you very much, Mr. President and Members of the Senate. This is an issue that's been around here for a couple of years. And it involves the purchase of Normal Community High School by the State, which will increase the size of the campus at Illinois State University. The Governor had agreed with us that this was a proper action two years ago, in that it was eighteen acres of land and a rather substantially large building that would provide additional classrooms for Illinois State. The one thing that had to happen, of course, is that the school district had to vote in the affirmative on a referendum to build the new high school. They have, to this point, not done that, but it's still very much on the agenda. And it is my desire -- and I believe I communicated very -- very poorly with the staff as they analyzed this bill. They simply thought since the -- the referendum failed, that it ought to drop, and -- and I would conclude that not the proper action. We prefer to have this here, so that when the high school is authorized for sale, the State can enter into this agreement. I would appreciate very much your affirmative vote on this motion.

Discussion? Any discussion? If not, the question is, shall

#### SENATOR DEMUZIO:

Yes. Thank you, Mr. President and Ladies and Gentlemen of the Senate. This is a restoration of two hundred fifty thousand dollars to -- from the Ag Premium Fund to the Orr Research Center over in western Illinois. There was some confusion during the last Session, where it was placed in two different appropriation bills -- from different -- GRF or -- or from Ag Premium. This happens to be the one, two hundred and fifty thousand out of Ag Premium, and I would solicit your support.

Thank you very much, Mr. President, Members of the Senate.

Senator, I -- I support the -- the notion, but as a matter of

Senator, that -- that's your understanding. I don't have that understanding over here, at least. To me it's two hundred and fifty thousand dollars for the Orr Ag Research Center and I would ask for your support.

#### SENATOR MAITLAND:

It comes out of GRF, two hundred and fifty thousand in the DCCA bill. This is Ag Premium money, two hundred and fifty thousand for the Orr Ag Research Center and knowing you, Senator Maitland, I know you want to do everything you possibly can to promote Ag Research in Illinois. And now that I've straightened you out, and I've helped you out on that last one just a few minutes ago, I appreciate your help. Thank you.

PRESIDENT ROCK:

Senator Maitland.

SENATOR MAITLAND:

Final point, we're going to spend two hundred and fifty thousand dollars, it's real in the GRF in the DCCA budget. If we use Ag Premium, it is ultimately going to come from GRF, and that is spent, that is five hundred thousand dollars. Two hundred and fifty thousand dollars of what we want, that's what we've all agreed to, therefore, this motion should be defeated.

PRESIDENT ROCK:
