So needless to say, that cuts the amount of time down considerably. But it's something we have done in the past and something we will continue to do, to accommodate that event. So my suggestion is that we will work today until about one o'clock. And what I'd like to do is go through bills on 2nd Reading, those that are of no -- virtually no controversy and those that do not have amendments - either -- either committee or Floor amendments - so that we can hopefully get those in the mix, because Senator Philip and I have discussed the probability - as a matter of fact, the certainty - that there will be an Agreed Bill List, which will be presented on the Calendar next Wednesday, which is the 15th, to be voted on on the 16th, prior to leaving town for the event. So we're going to aim at attempting to accommodate the Membership by proposing an Agreed Bill List on Wednesday, the 15th, to be voted on the 16th, with the full expectation that the week of the 20th will be a pretty heavy duty week.
