We are attempting to accommodate the members of the Executive Committee, who will indeed make a special trip on a special day to Springfield, the day before the Regular Session starts. All right. Bottom of page 25, on the Order of Motions in Writing to Override Total Vetoes. Senator Jones. All right. Top of page 26. Top of page 26. There's a Motion in Writing to Accept the Specific Recommendations for Change with respect, Madam Secretary, to Senate Bill 1769. Read the motion, please.

SECRETARY HAWKER:

I move to accept the specific recommendations of the Governor as to Senate Bill 1769, in manner and form as follows:

Amendment to Senate Bill 1769

in Acceptance of Governor's Recommendations.
