SENATOR RAICA:

Thank you, Madam President. On a point of personal privilege, I would like to move that we suspend the rules for immediate consideration of Senate Resolution 314. It is a death resolution, and we are asking IDOT, in this resolution, to rename 171 - which is Archer Road in my district in the Village of Summit - Ronald J. Bragassi Memorial Drive, in honor of Mayor Ronald Bragassi, who passed away the day before yesterday, who was a very dear friend of mine. And I just ask to suspend the rules at this time.

SENATOR HALL:

PRESIDING OFFICER: (SENATOR DONAHUE)

State your point, please.

SENATOR HALL:

We're being honored today by a group that's right here on this side. They're constituents visiting the Capitol today, and they're from East St. Louis and students from the Clarence Junior High. They're here today because they are the top Junior Achievement students in their class. They're escorted by their teachers and a group of State Farm employees from the Metro East who also are my constituents. Would you please rise so that you could be greeted by the Senate.

PRESIDING OFFICER: (SENATOR DONAHUE)

Welcome. Please rise and be greeted by the Senators. Senator Hasara, for what purpose do you arise?

SENATOR HASARA:

On a point of personal privilege, Madam Chairman.

PRESIDING OFFICER: (SENATOR DONAHUE)

State -- state your point.

SENATOR HASARA:

Madam Chairman, it certainly is my pleasure today - especially with you in the Chair, Senator Donahue - to introduce members of

student advisory committees. That's Senator Donahue, who has students from eleven counties in her district. I have students from three counties in my district, and some of them are They're here in Representative Tenhouse's students also. Springfield spending the day with us, learning about State Government, and I think it's particularly appropriate that can't -- probably can't see you, Senator, but we're very proud of Senator Donahue in the Chair. And we would like for them to stand and be welcomed by the Members of the Senate, and congratulations all of you who have been chosen to represent your schools on our advisory committees. Thank you.

Will you stand and be recognized by the Senate? They're here in the President's Gallery. If I could have your attention, we're going to go to the Order of Senate Resolutions, and on page 17 of your Calendar, starting with Senator Raica, on Senate Resolution No. 27. Do you wish to have that called, Senator? Senator Raica. Read the -- read the resolution, Mr. Secretary.

SECRETARY HARRY:

Senate Resolution 27, offered by Senators Raica-Topinka.

PRESIDING OFFICER: (SENATOR DONAHUE)

Senator Raica.

SENATOR RAICA:

Thank you, Madam President, Ladies and Gentlemen of the Senate. Senator Topinka and I introduced this legislation -- or this resolution because of the fact that the Metropolitan Water Reclamation District of Greater Chicago was planning an expansion of a stormwater and sanitary -- sewer reservoir in and about the Village of McCook, which is part of Senator Topinka's district and part of mine. The original 1986 proposal contained no provisions for the closure or the abandonment of the highway. Lo and behold, Senator Topinka and I learned of the closure of 55th Street, which

would physically really damage our district, not only to the businesses, but to the residents which live in this community. And what this resolution does is it urges the Metropolitan Water Reclamation District of Greater Chicago to reconsider its plan to re-close -- or to close 55th Street. It urges the U.S. Army Corps of Engineers and the Illinois Department of Transportation not to approve a plan which will result in the abandonment of 55th Street, should the Reclamation District pursue the abandonment. And I would thank Madam President for calling this Senate Resolution, and just ask for its adoption.

PRESIDING OFFICER: (SENATOR DONAHUE)

Thank you, Senator Raica. Is there any discussion? Any discussion? Seeing none, all those in favor, say Aye. Opposed, Nay. The Ayes have it. Senate -- Senate Resolution No. 27 is adopted.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Topinka, are you ready for Senate Resolution 78? Will you proceed, Senator Topinka. Mr. Secretary -- Madam Secretary, will you please read the resolution?

ACTING SECRETARY HAWKER:

Senate Resolution 78, offered by Senator Topinka.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Topinka.

SENATOR TOPINKA:

Madam President and Ladies and Gentlemen of the Senate, this urges the Emergency Management Agency to convene an Emergency Management Advisory Committee in order to study the Emergency Operations Plan and any changes which should be undertaken to facilitate additional coordination between the Emergency Management Agency and local governments and other entities and any groups that would be involved in handling emergencies, disasters and things of that nature in the State of Illinois. This has been

worked out with the Emergency Management Services. It's their language. They have contributed. They endorse it, and to my knowledge, no one has a problem with it.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Any discussion on this resolution? Any discussion on this resolution? Hearing none, there will be a roll call on this resolution. All those who are in favor of this resolution will vote Aye. All those who are against it will vote No. The voting is now open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record, please. On that question, there are 56 Yeas, no Noes, none Present. And the resolution, having received the required number of votes, is hereby declared passed — and adopted. Madam Secretary, will you please read Senate Resolution — 80. 80.

ACTING SECRETARY HAWKER:

Senate Resolution 80.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Topinka, are you ready with Senate Resolution 80? SENATOR TOPINKA:

Yes. Madam President, Ladies and Gentlemen of the Senate, what this does is clarifies the legislative intent in — to how it includes all agencies, departments, boards and commissions of — of State Government which publish annual reports under the State Printing Contracts Act's jurisdictions. What occurred was, was last year we put through a bill that said there would have to be a disclaimer on the annual reports of the various agencies of the State of Illinois. There was some question on whether or not the boards of — the Board of Regents and the Board of Governors and the University of Illinois would fall under this Act. And it is the desire of this resolution to show that that is indeed the intent, and that they do indeed fall under the Act. They are all aware of this, and no one has a problem with it.

Madam Secretary, are there any Floor amendments approved for consideration? Madam Secretary, are there any Floor amendments approved for consideration?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Topinka, will you proceed.

SENATOR TOPINKA:

Well, if you're seeking a roll call, I'd seek a favorable one.

If you seek an Aye vote, I'd seek a favorable one of those, too.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

All right. We're ready to vote on this resolution. And those who wish to vote for this resolution will vote Aye. Those who wish to vote against it will vote Nay. And the voting is now open. Take the roll, please. On that question, there are 57 Ayes, no Noes, and 1 Present. And the resolution, having received the required number of votes, is hereby adopted. Senate Resolution 93. Senator Watson. Madam Secretary, will you please read the resolution.

ACTING SECRETARY HAWKER:

Senate Resolution 93.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

Yes. Thank you, Madam President...

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Could we have a little order? Could I please have a little order?

SENATOR WATSON:

Thank you, Madam President...

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Go right ahead, Senator Watson.

SENATOR WATSON:

Thank you, Madam President. This resolution creates the Chicago School Turnaround Commission, to help those reform groups and others assist in -- in the actual reform that's going on. we all recognize that reform is an important part of -- certainly of the Chicago public schools, and reform is working. And this Commission is the one in -- which hopefully will help assist reform groups and others to accomplish the reform desired. would consist of eighteen Members: nine appointed by President of the Senate, and nine appointed by the Minority Leader of the Senate; three public members with significant experience in corporate management; three public members with significant experience in education; three public members with significant experience in community involvement. Each -- Minority Leader and the President would have the opportunity to appoint nine Members. This was amended, and the reporting deadline was changed from sixty days from the adoption of the resolution to January So that's the -- that's when we would ask for their reporting to the General Assembly -- to the Senate. And also, Senator Shaw had an amendment which we adopted that said that the Commission appointments shall reflect the racial, ethnic and gender composition of the population of the City of Chicago, based on the 1990 Census data. This was -- a similar resolution was adopted, although we did change some of the language this past Session. And Senator Rock, who's very interested in resolution and certainly supports our efforts here, had appointed Members of the Commission, but because of the fact that we ended Session, that resolution just died, as a result, and nothing really was accomplished. We're trying to resurrect that now with this resolution.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Any discussion? Senator Palmer.

SENATOR PALMER:

Thank you, Madam President and Members of the Senate. I ask for a No vote on this resolution. As Senator Watson pointed out, school reform is underway. This very Body gave it its life. This Turnaround Commission is unnecessary, and it flies in the face of an already organized group, the Citywide Coalition on School Reform, which already has members from business, from civic organization, local school councils, and the entire reform community. There is — if you are looking at the same thing that I'm looking at, no school reform group has asked for this, and those of you who have been around for the last three or four years know that it is a vocal community that has brought to this Body numerous bills. We have some this last time. This is not necessary, and I ask that you not put another burden on the Chicago school reform community.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Further discussion? Senator Jones.

SENATOR JONES:

Yeah. Thank you, Madam President. Would the sponsor yield?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

She -- he indicates that he'll yield.

SENATOR JONES:

Senator Watson, could you explain to me that Section of the bill <sic> that deals with the appointment made, pursuant to Senate Resolution 1144, the Eighty-seventh General Assembly, shall remain in effect unless replacement appointments are made? Could you explain that? Because -- I recall Senator Rock made those appointments. So, explain that particular Section of the bill <sic>.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

We're going to have to have a little more order so that the Senator's question could be addressed. And, Senator Watson, did you hear the question addressed to you by Senator Jones?

SENATOR WATSON:

Yes. As you know -- as you know, Senator Jones, there was a lot of confusion over this particular issue. The intent here is to allow you to make those appointments. You, as Minority Leader, now will make those nine appointments.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Can you hear him, Senator Jones? Senator Jones. Senator Jones?

SENATOR JONES:

Yeah. Thank you, Madam President. Now, in committee when this resolution was up, the President of the Senate then was Philip Rock. Now the President is Pate Philip. Now, those appointments that are currently there, are those appointments — those appointments become the appointments of the President, which is Philip right now. Am I correct?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

No, you're not.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Jones.

SENATOR JONES:

Well, this is not what was discussed in committee. This is not what the chairman of the committee - Exec Committee - so stated. This is not what you said in committee. When this resolution was up, the Minority Leader did not make any appointments. I am now the Minority Leader. So, therefore -- the Minority Leader last Session did not make any appointments. Since that Minority Leader did not make any appointments, all the vacant

appointments belong to the Minority Leader. I am now the Minority Leader. The appointments that are currently there would be the appointments of the President. So you cannot have it both ways. And — and this was the agreement and the understanding that we reached in the Executive Committee. So the current appointments there are the President's appointments. Now, the President, if he so desires, can keep those appointments or replace them. As the Minority Leader — as the Minority Leader — it's up to me to make the Minority Leader's appointments. Let's get this matter cleared up in its entirety right now, Senator Watson.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

Well, Senator Jones, I think if you read the resolution, or this -- this particular paragraph, and read it carefully, you would concur. Now, let me just read it. "RESOLVED, That any appointments made pursuant to Senate Resolution 1144 of the 87th General Assembly are valid and shall remain in effect unless a replacement appointment is made by the respective appointing authority..." You, being an appointing authority as the Minority Leader, can make that -- can make those appointments, just as Senator Philip can.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Jones.

SENATOR JONES:

Well, what I'm -- the point I'm trying to clear up now is that in the role last Session, Pate Philip was the Minority Leader. He did not make any appointments; therefore, that falls to this side of the aisle, as the Minority Leader, to make those appointments. So the appointments that are currently there falls to the President. So therefore, those persons that are currently appointed are the President's appointments. And if he wanted to

keep or replace those, he can so desire. Right?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

That is correct.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Jones.

SENATOR JONES:

So, therefore, if -- if this resolution passes, those current Members sitting there, if -- if the -- they are the President's appointments, not the Minority Leader's appointments. Right?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

Yes. That's correct.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Jones.

SENATOR JONES:

And all the -- all the vacant appointments that have not been made are to be made by... Very good. Thank you.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Okay. Any further discussion? Senator Collins? Senator Collins.

SENATOR COLLINS:

Senator -- question of the sponsor.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

He says he'll yield for questions, Ma'am. Senator Collins.

SENATOR COLLINS:

Senator, it is my understanding that your purpose for this resolution is to provide assistance to the Chicago LSCs - local councils - and to the School -- Board to ensure the implementation of the Chicago school reform, which was basically creating the new

local school councils, giving them local control. Did the local school councils request this kind of assistance, and did they have a specific reason as to what necessitated this need for the creation of this Commission?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

No, I'm not -- I don't believe that the local school councils, as such, came -- came to me and asked for this -- this resolution at all. I know that there are some members of those local councils who support this concept and support the effort of the Commission, or at least the -- the recommendations of the Commission.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Collins.

SENATOR COLLINS:

I'm sorry, but I can't -- I don't know whether your mike was on or what, but I can't hear him because...

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Could we have some order in the Senate? It's very difficult for the sponsor of the resolution and those who are -- wish to make -- inquiries to be heard. We'd appreciate it if you would tone it down.

SENATOR COLLINS:

Yes. Senator -- Senator, when -- when -- when the Legislature created the Oversight Authority in Chicago, it was for a specific purpose, because the Chicago school system, at that time, was on the brink of bankruptcy. And so they -- they created this financial Authority. There was a purpose there, although I disagree with the Authority, but at least there was a purpose. So what I'm trying to find out here -- we created the local school councils for the purpose of local control - the whole reform

legislation. Now you're back saying that we need to create another committee somehow that supersedes that committee in some respect, that will help them or tell them how to implement the reform that we passed. And I wanted to know who asked for it, and to -- what specifically will they do? How -- will they be responding to what specific problems or what areas of reform -- of the reform that they need to implement? Otherwise, all we're Senators, is creating another layer of people that's getting in the way of the implementation of Chicago school reform what we all said was necessary in order to bring about some financial stability and to improve the -- the educational productivity of that system. And we have also been fighting here to eliminate and to reduce the -- the size of the administration and all of these other layers of people, but at the same time, we're here before this Body, creating another layer. That is somehow a contradiction, and it -- and it poses serious problem, when we don't even really know what is the real purpose for this -- for this Commission.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator...

SENATOR COLLINS:

I think we should vote to kill this thing right now, once and for all.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Then I don't suppose you wanted a response from Senator $\mbox{Watson.}$

SENATOR WATSON:

Did she ask a question? There was a...

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

There was a question asked there, somewhere in all that?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

I believe it was a rather long one, but perhaps you can desiccate <sic> it.

SENATOR WATSON:

Well -- what this committee and Commission is attempting to do is help facilitate the reform movement that's going on. Those people that involved in the reform movement, and those reformists that live in the City of Chicago and want to see a better quality of education for their young people, when they talk to me about this Commission and this committee, their attitude is, this will help facilitate; this will speed up the reform that's already in progress. And I think that this is something that needs to be done. It's nothing punitive here. Why not get more people involved? I -- I say the more people we get involved in the problems of the -- of Chicago public schools, and the more recommendations and the more ideas and the better quality of people we can bring together, the better off this whole process will be.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator del Valle.

SENATOR dEL VALLE:

Thank you, Madam Chair. I also rise in strong opposition to this resolution. I have been waiting for some time now to hear from a school reform group that is in favor of this resolution, and I've yet to hear from anyone in favor. I agree with the previous speakers that what we're doing is adding another layer of bureaucracy here. We're adding another layer of individuals who are going to concern themselves with governance issues. We're going to create confusion. We're going to send mixed messages, and that, I remind you, at a time when you have the School Finance Authority and the Board of Education and local school councils coming together in agreement around a key issue - probably the

most important issue now facing not only the Chicago public schools, but every single public school district in the Illinois, and that is the issue of finances. This Commission is not going to address that issue; I doubt very much that it will. But more importantly, it's a Commission that is going to be injected into a system that right now is trying to move towards consensus, is trying to move towards sending one message to this Body, and that message is that until we deal with the key issue of finances, we are not really going to see school reform in Chicago anywhere else in this State. So let's put this resolution to rest. Let's not get in the way of the progress that is being made, and let's act responsibly. I might add, in closing, that I'm also very surprised - and I would question why - this resolution is only being dealt with by the Senate. If it's such a great resolution, why wasn't it a joint resolution, so that we could have the other Chamber debate it as we are debating it here?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson. Senator Shaw.

SENATOR SHAW:

Thank you, Madam President. Will the sponsor yield?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

He indicates that he will.

SENATOR SHAW:

Senator Watson, is -- is this resolution -- is there any mandates in this resolution?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

Well, just that the -- the Commission would meet, of course, and discuss the issues, and then report back to us by January 1st of 1994.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

SENATOR SHAW:

I don't know -- I don't know whether you answered the question. Is there a mandate, or mandates, in this resolution?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator -- Senator Watson, please.

SENATOR WATSON:

There's no mandate at all upon the Chicago Public School District. There's no mandate upon any unit of local government. We're just asking this Commission to meet, get together, discuss some ideas of ways in which to facilitate the reform movement of Chicago public schools, and report back to us January 1st, 1994.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Shaw.

SENATOR SHAW:

Will this Commission be empowered to recommend -- additional finances for Chicago schools?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

Yes, they could. That's what their mission is, is to help us come up with some ideas, whether it's financial or whether it's just policy, or whatever it might be. Yes, sir. That's exactly what we want to do.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Shaw.

SENATOR SHAW:

Couldn't -- couldn't we do the same thing with the -- with the oversight committee? They are in the day-to-day -- they take care of the -- well, they know about the day-to-day operations and -- and what the -- details, in terms of finance, that affect Chicago schools, because they have to approve it. Wouldn't they be in a

better position to know that?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

Well, possibly, in regard to the finances and the financial problems of the Chicago public schools. Certainly that oversight board probably would have a better handle. I would imagine that this committee, or Commission, would ask for some input from that body, but I think that there's -- there's more far-reaching issues, besides financial, that this -- this Commission should be involved in, not necessarily just with the -- the public school oversight committee.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator -- Senator Shaw.

SENATOR SHAW:

You have done -- you have done an awful lot of work up there in Chicago on the -- on the Chicago school system in the last four or five months. Do you agree that there is money needed in the Chicago school system?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

Well, that's not necessarily for me to say, but that -- that's what we're asking this Commission to look at. Certainly I can see some needs for additional finances in some areas, but that's another issue, Senator, and that's something that will be certainly debated at a later date.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Shaw.

SENATOR SHAW:

To the -- to the resolution: It -- it seems to me that the School Finance Authority is in the best position to make a report

back to this Body. We have the -- we set some reform into place a few years ago, and we have not given those reforms a chance to -to work, and it's my understanding in many school districts throughout Chicago that the reform is working. The problem that we're having in Chicago - same as elsewhere in Illinois, every school district in this State - the State has not responsibility in terms of funding. We could pass this resolution and go back to our community and tell people in our community we have done great things to take care of the problems of Chicago. is a political issue. That's all it is. It's designed to get votes. But what the children of this State need is some money to be educated. And I would ask the Senator if he would withdraw this resolution, because he, as well as I do, know that money is the answer to many of the problems that -- not only Chicago, affecting all school -- school districts in this State. And without those of us who serve in this Body biting the bullet sure that our children are educated -- not rhetoric give rhetoric and pass fancy and beautiful we can come and go back to our respective communities and talk resolutions and about what we have done to reform Chicago, and to -- and to -spending too much money. So is every other school Chicago is district in this State with a low taxing body. But that is not the answer. What you're doing is criminal to the children who are trying to get an education in this State, because you're jawboning issue as it have been jawboned over the last ten or fifteen years. But the youngsters who are coming out of school not being educated in my district and your district. And I don't know what the -- all of the answers is, but I know that the cost doing business in educating our children keep going up because our demands are greater: new equipment coming into the schools. you don't -- you don't want to deal with that. You want to deal with some paper down here and some press releases.

not the -- that's not the answer. We should deal with the substantive matter and put some money in the budget, not only for Chicago schools, but every school district in this State. And I urge a No vote on the resolution.

Senator Hendon. Our last speaker, Senator Hendon.

SENATOR HENDON:

Thank you, Madam President. Will the sponsor yield for a question?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

He indicates that he will, Senator Hendon. Senator Watson. SENATOR HENDON:

Senator Watson, is there a possibility that none of these people will come from the City of Chicago? Possibility.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

...(microphone cutoff)...actual residents of the City? I guess that's -- could very well be a possibility. I know that the -- the members that I've recommended - that I've recommended our Leader to appoint - are residents of the City of Chicago, active in the -- the reform movement, have asked to be considered for this appointment, and would do a great job. And they're, really, philosophically, probably not in line with a lot of my thinking, philosophically. Probably more in line with your thinking. But I feel that those people who are in those -- in the trenches - and that's who these people are: They're principals from Chicago public schools; they're people that are involved in the reform movement - they have -- have the best input. They know the problems, know the concerns, and that's what we're trying to do here.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Could we have a little order. Senator Hendon.

SENATOR HENDON:

Okay. To -- to just bring your answer down and narrow-cast your answer a little bit, the answer to the question is yes - that there is a possibility that if President Philip and Minority Leader Jones appoint everybody to this Commission from the suburbs -- that is a possibility. It can happen. There is nothing in here that says, for instance, fourteen members must come from the City of Chicago. Is that correct?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

Well, I -- I guess you're -- you're correct, Senator, but I think you'd be woefully ill-responsible <sic> in your duties if you didn't make sure that your Leader appointed those people from the City of Chicago who would have the greatest impact. Certainly there may be people that live outside the City who have equal concerns and would like to be a part of helping solve a problem. What's wrong with that?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Hendon.

SENATOR HENDON:

Well, the -- the problem with it is that this is the Chicago public schools that this supposedly is going to try to turn around. Let me ask you another question, Senator. Is -- is there a possibility that people will be appointed to this Commission who are in favor of the voucher system, which we believe might destroy the public schools? Or is there a "You can't be in favor of the vouchers and sit on this Commission" provision?

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

Well, I would imagine that there's a possibility that someone could be appointed. There's no restrictions in that regard. It doesn't prohibit it, so I guess that there could be.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Hendon.

SENATOR HENDON:

Well, with those two answers -- and I want everybody to hear this, if you could get the attention, because I -- I don't like talking too loud when I don't have to.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Hendon, I'm trying.

SENATOR HENDON:

But if I have to, I will, Walter. So, we want to avoid that. PRESIDING OFFICER: (SENATOR GEO-KARIS)

Could we give Senator Hendon our undivided attention? Thank you.

SENATOR HENDON:

I mean, this is a very important piece of legislation here, and if we're just going to talk over it, then no one will get the significance of it. We had two key answers here, and I want everybody to hear this. One answer was that all of these members, half these members, a third of these members, or possibly all of members, could come from the suburbs, or come from downstate, or come from East St. Louis, or any other part of Illinois. There is nothing in here, on this so-called Commission, that'll make sure that at least the membership is from -- people from the City of Chicago. That was the first answer, and he said there is a possibility. The other question I asked was: Can this Commission be made up of people who are in support of the voucher system, and the answer was, yes, they -- it can. Now, why does that have significance? The reason it has significance is because if this Commission comes out with a report that says the Chicago

public schools should be shut down, or the Chicago public schools should be revamped, or the Chicago public schools should simply go to a voucher system, then those people who want to destroy the Chicago public schools, who want to have a voucher system, will be armed with a report from a Commission, and they will be able to hide behind that Commission's report. And they will able to say, "Well, we're doing this because this Commission says that we need to do this." We do not need another layer of bureaucracy to try to solve the problems of the Chicago public schools. You have the local school councils; you have the Finance Authority; you have the Board of Education. You have a lot of people in the reform movement already trying to solve this problem. Why come up with another layer of bureaucracy? And obviously, since they're not going to be compensated, people are going to want to serve on this Commission, because they have to run around; they have to spend money; there is a cost involved, and it says here that they will not be reimbursed. So are you going to encourage some poor person who has children in the Chicago public schools, like I do, to sit Commission? I say it is wrong. It's a bureaucracy. It's like a Trojan horse. They're going to roll this Trojan horse up to the and God knows what's in this Trojan horse. Vouchers could be in this Trojan horse. People who want to destroy schools could be in this Trojan horse. We should vote this bill <sic> down, and I urge a serious, resounding No vote.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson, to close.

SENATOR WATSON:

I was kind of hoping somebody else would speak before I had... Well, for all the reasons that many people have spoke, I'm not sure why there's such opposition to this, or such concern. You know, a lot of -- a lot of us on this Floor like to wear the badge

of reform, but when it comes to really doing something about being a reformist, and putting our vote where it counts, we kind of wither away. I've seen that happen on this Floor on many occasions during this Session: those who want to call themselves reformists and tie themselves to the reform groups of the City of when it comes to doing something about it, Chicago, but unfortunately, they go south on us. And those of us from outside the City who -- I'm amazed somebody over there didn't mention: Why is a downstater coming to the City and trying to implement a program by which we're trying to help the Chicago public schools? Why should a downstater be doing that? Well, I've been And you mentioned it, and you're right. And I share your problems and your concerns for the young people of City. And we ought to be doing something about it. This is not criminal, what we're doing here. All we're trying to do is establish a Commission by which we're putting some expertise at the table to make some recommendations by which we can make change and help facilitate - facilitate - the reform that's going on in the City. And you're right; it is working. The school councils are working. Absolutely. But a lot more needs to be done. And what is wrong with asking a group of people some expertise, who could come to this General Assembly and make that recommendation that further change needs to be made? We're so scared of some kind of input What's wrong with that? from people on the outside. What matters if they live in the City of Chicago? Sure, there's -- there's people in my area that have equal concern for your kids at Marshall High School, as because what's best for your kids in the City are going to be best for my people too, because I want them to be productive members of ... (microphone cutoff)... Yes vote.

Senator Watson moves the adoption of Resolution 93. Those in

Senator Garcia. Madam Secretary, will you read the resolution.

Senate Resolution 111.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Garcia.

SENATOR GARCIA:

Thank you, Madam President. My microphone is moving around on me. Senate Resolution 111 is a resolution that tries to ensure that senior citizens that are on Medicare and Medicaid are -receive information through the media of the Department of Public that they can participate in a program known as the Qualified Medicare Beneficiary Program - better known as Medicare Buy-in Program. The Buy-in Program was expanded by the Federal Government to cover beneficiaries with incomes of ten percent over the federal poverty line as of January of this year - January 1st. There are approximately one hundred and twenty-one thousand individuals in the State of Illinois who are not institutionalized seniors who don't receive these buy-in An estimated two out of five low-income elderly benefits. households spend more than twenty percent of their income on health care. This resolution seeks to urge the Illinois Department of Public Aid to improve services to seniors by doing more effective outreach, by having more public announcements - broadcasts informing seniors that they are eligible - by training caseworkers regarding eligibility on the

Buy-in Program, by providing flyers and by working with local Social Security officers to refer seniors to Public Aid offices. What this means, colleagues of the Senate, is that senior citizens may be entitled up to thirty-six dollars and sixty cents a month, and they also would become entitled to payments of premiums, co-payments and deductibles if they are eligible. It addresses the needs of low-income senior citizens. This is a good resolution, and I ask for an Aye vote.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Any discussion? Hearing none, all those in favor of this resolution, signify by saying Aye. All opposed. Hearing none, the resolution is carried and adopted. Senator Dudycz, on Senate Resolution 138? Senator Dudycz, on Senate Resolution 143? Madam Secretary, will you read the resolution.

ACTING SECRETARY HAWKER:

Senate Resolution 143.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator -- Senator Dudycz.

SENATOR DUDYCZ:

Thank you, Madam President. Senate Resolution 143 urges the Local Governmental Law Enforcement...Law...

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Would the -- just a minute. Just a minute, Senator. Could we have your undivided attention, so you -- we all know what we're voting on? Senator Dudycz, proceed, please.

SENATOR DUDYCZ:

Thank you, Madam President. Senate Resolution 143 urges the Local Governmental Law -- Law Officers Training Board to convene a committee to study and evaluate all available police pursuit procedures for the purpose of presenting to the Board a recommendation for a standardized model for police pursuit procedures for use in training of all law enforcement and

correctional officers in the State of Illinois. The Illinois Governmental Law -- Enforcement Training Board is responsible for certifying the police training academies throughout the State. And currently there are six different police academies and each one is using different police pursuit Illinois, procedures in the instruction of their recruits. This resolution states that the Illinois Local Governmental Law -- Officers Training Board shall convene a committee within one month of adoption, and they would be evaluating all available police procedures in -- regarding pursuit. The committee shall to the Board a recommendation for a standardized model for police pursuit in the use of training of all police and correctional The committee will be composed of eleven members. The officers. chairman shall be a member of the Governmental Law Enforcement Training Board, one each of the six police officer training academies, one designee from the Illinois Sheriffs' Association, one designee from the Illinois Fraternal Order of Police, one from the Illinois Police Benevolent and Protective Association, and one designee from the Illinois Chiefs of Police Association. members of this board shall serve without any compensation, after consideration of the committee report, the board shall to the General Assembly its recommendation submit standardized model of police pursuit by September 1 of this year. And I ask for your affirmative support.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Any further discussion? Any further discussion? Hearing none, Senator Dudycz, to close. Senator Dudycz moves the adoption of Senate Resolution 143. All those in favor will vote by voting Aye. And those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record, Madam Secretary. On that question, there are 57 Ayes, no Nays, no Present. And this resolution is hereby

SENATOR LAUZEN:

Thank you, Madam President. Senate Resolution 145 requests the Governor to proclaim the week of October 3rd through October 10th, 1993 as Respect Life Week in Illinois. This resolution, nearly identical form, has been adopted every year since 1973. states that the Respect for Life Program originated as a national week of prayer and study, focusing on the sanctity of all human life and recognizing that each human being, after being called into existence, has a right to life, liberty and the pursuit of It has been a long-standing policy of the State, before the U.S. Supreme Court -- decision of January 22nd. to protect the life of the unborn. It is desired that the week of October 3rd through 10th, 1993, be designated as Respect Life Week the purpose of assuring a collective appreciation and mobilization of the efforts of social forces to support human life and dignity. I'd appreciate a positive vote, and I'd be happy to answer any questions.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Any further discussion? Any further discussion? Hearing none, those in favor of this resolution will say Aye. All opposed, say Nay. The Ayes have it. Therefore, the resolution's adopted. Senate Resolution 156. Senator Topinka. Senator Topinka. Senator Topinka. Senator the resolution.

ACTING SECRETARY HAWKER:

Senate Resolution 156.

Senator Topinka.

SENATOR TOPINKA:

Yes. Madam President and Ladies and Gentlemen of the Senate, Senate Resolution 156 creates a Day Care and Life Safety Standards Task Force to study the regulation and standardization of life safety standards in home day care, in order to allow home day care to expand and flourish while maintaining high levels of safety. This is something we've not been able to achieve up to this point, and hopefully, if we bring people together who are involved in this business industry, we can come up with some kind of a documented solution.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Any discussion? Any discussion? Senator Cullerton? SENATOR CULLERTON:

Yes. I have an inquiry, Madam President. The previous Senate Resolution - 145 - that was adopted on a voice vote. I had my light on. I wanted to ask a question of Senator Lauzen, and... PRESIDING OFFICER: (SENATOR GEO-KARIS)

Your light was not -- I'm sorry. Your light was not on.

SENATOR CULLERTON:

Okay. So now that it wasn't -- let's pretend like it wasn't on. Now the question is, how can -- how would you suggest that -- since I apparently have voted on the prevailing side, since it passed with a voice vote, I would like to have that reconsidered so that we can re-debate the issue.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Are you moving to reconsider the vote by which this passed? This was passed by oral vote, and believe me, Senator, your light was not on when -- when it was closed. But anyway, you wish to reconsider? Senator -- Senator Cullerton, having voted on the prevailing side of Senate Resolution 145, now moves to reconsider

Senator Madigan.

SENATOR MADIGAN:

House Joint Resolution 1 creates a Task Force on Geographic Information Management Technology, and that task force is made up of members appointed by the Leaders of the General Assembly. The purpose of the resolution and the purpose of this task force would be to coordinate the State agencies that are all, in one degree or another, involved in this technology. In addition to those members, there would be individuals or the directors of the various departments that would be interested in this task force appointed to the committee. The voting is now open. Have all voted who wished? Have all voted who wished? Have all voted who wish? Madam Secretary, take the roll. There are now 57 Yeas, no Nays, no Present. And this resolution is hereby adopted. Senate Joint Resolution 3. Senator Watson. Madam Secretary, will you read the resolution.

ACTING SECRETARY HAWKER:

Senate Joint Resolution No. 3.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Senator Watson.

SENATOR WATSON:

Yes. Thank you, Madam Chairman. Senate Joint Resolution 3 does exactly what the Calendar suggests. It urges our Illinois Congressional Delegation to vote to support the small-issue industrial development bond program. This is the -- comes to us by way of the Illinois Finance Development Authority, Ron Bean's group, and they're interested in establishing economic development in the rural -- well, for that matter, all over the State of Illinois. And this -- the revenue bond process gives small communities that opportunity. I know of no opposition, and certainly appreciate a favorable vote.

PRESIDING OFFICER: (SENATOR GEO-KARIS)

Any further discussion? Any further discussion? Hearing none, Senator Watson moves the favorable passage of Senate -- Joint Resolution 3. All those in favor, say Aye. All those against, say Nay. The Ayes -- in the opinion of the Chair, the

SENATOR SIEBEN:

Senate Joint Resolution 13 deals with the issue of ethanol, and it encourages the United States Department of Energy, Agriculture and Environmental Protection to cooperate to fund research that will increase the production and utilization of ethanol through the development and use of more efficient

I think our concern is today, with the change of administration in Washington, that we want to see that this support continues for ethanol. And I move for the adoption of this resolution.

Senator Demuzio, on a point of order. State your point of order, sir.

SENATOR DEMUZIO:

Well, Senator DeAngelis apparently wasn't listening when the Gentleman made his motion. He didn't say he was replacing anybody; he just said he wanted to be sponsor of House Bill 1515. So I'm just wanting to know what the -- what the process is. Has it changed?
