SENATOR R. DUNN:

I'd like for the Senate to recognize a group of young people who are over on the Democrat side in the back, from Carbondale. SENATOR WATSON:

Yes. Thank you, Mr. President. Just a point of personal privilege.

PRESIDING OFFICER: (SENATOR MAITLAND)

State your point.

SENATOR WATSON:

I was in my office this morning and had the House speaker on, and listening to the House debate, which I find entertaining, especially when Representative Black's up. But it's ludicrous - it's ludicrous, Mr. President - that we are here today to act and do our business of the people of Illinois and we established a Calendar in agreement with the Speaker of the House - the President of the Senate, in good faith; Speaker of the House, in good faith - established a Calendar by which we will operate this Session, this particular calendar year. They're still over there in the House doing House Bills 2nd Reading, which were dead on arrival two and a half weeks ago in this Body. This is ludicrous, what's going on over there. And the Speaker of the House should be ashamed to lead such a Body through such travesty. Thank you.

PRESIDING OFFICER: (SENATOR MAITLAND)

Your point is well-taken, Senator Watson. Senator LaPaille, for what purpose do you rise, sir?

SENATOR LaPAILLE:

On a point of personal privilege.

PRESIDING OFFICER: (SENATOR MAITLAND)

State your point, sir.

SENATOR LaPAILLE:

In a counter to Senator Watson, who's very concerned about the Illinois House of Representatives, and as one that has been in that process for quite a while - in the legislative process - I can assure you, Senator Watson, that at least the Illinois House is debating amendments on the Floor; they're debating amendments

They -- they truly have a democracy in the Illinois House, unlike the Illinois Senate -- unlike -- unlike the Illinois Senate, where we can't even offer an amendment on the Senate Floor. We have to go to Rules Committee, and all these loops and -- and jumps, et cetera. So at least they are debating amendments. Their Members can offer amendments on the Floor, debate them. The Minority has filed hundreds of amendments. They're being heard. That's why it's taking so long in the Illinois House, is because they have a democracy, unlike here.

PRESIDING OFFICER: (SENATOR MAITLAND)

Senator Jones, for what purpose do you rise, sir?

SENATOR JONES:

Thank you, Mr. President. Point of personal privilege.

PRESIDING OFFICER: (SENATOR MAITLAND)

State your point.

SENATOR JONES:

Yes. In response to the esteemed colleague, Senator Watson, whom we sat several hours today on the Executive Committee, and evidently he must be blind as to what is really happening in his own Chamber. During my tenure in this Body, a Member who comes to a committee who has a bill and sits there for hours to have that bill called -- never once have I seen it happen as it happened today, to have Members sit there and have the committee adjourn and not have the opportunity to have a roll call on their idea or their proposition or that bill. It is a disgrace to this Body. And you sat there, Senator, and you kept your mouth shut, but you're going to talk about what you don't see over in the other Chamber. I wish you had spoken up for your esteemed colleagues who sat there in that Executive Committee - Senator Carroll, Senator Margaret Smith - not even given an opportunity to have a -- Senator Grace Mary Stern, the number one Democratic Senator in the State of Illinois, and you wouldn't even permit her ideas to

be heard. If you had spoken up in committee, maybe I would have taken in consideration some of the things you said about the other great Chamber. But when you refuse -- when you refuse to have a Member's voice heard in committee, that's a disgrace. You have a great chairman, Doris Karpel, I know she -- has to follow orders and so forth and things of that nature, but never have I witnessed Members sitting in their committee, elected to this Body, and have them sit there and have the chairman gavel the -- the committee to a close and leave us sitting Senators sitting out there in the audience. That's a disgrace. I want you to speak to that first, before you begin to attack the great Chamber on the other side of the aisle, who protects the rights of people throughout the State of Illinois.

PRESIDING OFFICER: (SENATOR MAITLAND)

Senator -- Senator Dudycz, for what purpose do you rise, sir?

SENATOR DUDYCZ:

A point of personal privilege, Mr. President.

PRESIDING OFFICER: (SENATOR MAITLAND)

State your point.

SENATOR DUDYCZ:

I'd just like to remind the illustrious Minority Leader of -- of the wonderful Illinois Senate that the speech he just gave, or the remarks that he made, are very similar to the remarks that I used to give back in 1985, '86, '87, '88, '89, '90 and the first half of 1992.

PRESIDING OFFICER: (SENATOR MAITLAND)

Senator Hendon, what purpose do you rise, sir?

SENATOR HENDON:

Point of personal privilege, Mr. Chairman.

State your point.

First of all, I want to say that I'm glad that Senator Watson said what he said, because I thought we were dead in this Chamber. We haven't -- nothing has moved around here in so long, I thought this was the morgue or something. So I'm glad that at least you've breathed a breath of fresh air in this Chamber and we can get to debate something. And I do want to remind my distinguished friends and colleagues on the other side of the aisle that even those of us who weren't here when, according to you, Phil Rock punished you so bad and didn't let any of your bills out or anything, I was not here. I was not a party to the act, yet I can't even get a single bill out of Rules to even get it to a committee to debate it, and that's just as wrong as what you say Mike Madigan is doing on the other side. I'm just shocked that us Democrats are not using the House more to punish you for what you're doing to us here.

PRESIDING OFFICER: (SENATOR MAITLAND)

Senator Demuzio, for what purpose do you rise, sir?

SENATOR DEMUZIO:

Well, on a point of personal privilege, Mr. President.

PRESIDING OFFICER: (SENATOR MAITLAND)

State your point.

SENATOR DEMUZIO:

Let me -- let me just say that I -- I have been here for twenty -- almost twenty years, and I don't remember any of the leaders that we had that were in the majority at that time that would be of the nature of the description that Senator Dudycz just made. As a matter of fact, Senator Rock put out more of your bills, Senator, than he put out of our bills, and the record will so reflect that. We have done that. In the last -- last Session, forty percent of the bills that were put out of the Rules Committee were Republican bills. Now, I don't know what that compares to this time, but I can assure you that it's

Unfortunately, we have been attempting to get Joint Rules with the House for the entire period of time that I have been here, and we never have. Now they have every right to pass whatever bills that they -- they want to send over here. We don't have any joint rules that were passed by legislative action, both in the House and the Senate. And if they want to stay here through June and extend their deadlines, they -- they have every right to do that. They are responding to their constituents and the needs of the people of Illinois. That has not been happening here.

Senator Garcia, for what purpose do you rise, sir?

SENATOR GARCIA:

Thank you, Mr. President. For a point of personal privilege.

I'm kind of excited here, Mr. President. Mr. President, I'd like to take the opportunity to recognize an outstanding youth -- group of students from the Davis School in Chicago, to be recognized. Would you please rise, in the gallery?

Will our guests in the gallery please rise? Welcome to Springfield. All right. PRESIDING OFFICER: (SENATOR MAITLAND)

Senator Woodyard.

SENATOR WOODYARD:

Thank you, Mr. President, Members of the Senate. If you'll recall, last Friday, this Body, at the last piece of business that was transacted or dealt with was Senate Bill 1083. That was the bill that would allow emergency repairs to the Danville Sewerage Treatment Plant to -- to proceed. Now, I apologize to each and every Member of this Body, because I missed it. When that bill came over from the -- from the House on Concurrence, it did not contain an effective date, and although the contracts were ready to be signed Saturday or Sunday, the attorneys for the district felt that we should readdress this. The Governor acted very speedily in amendatorily vetoing to put the new effective date in -- or put the immediate effective date in, and that's what this motion does, to accept the Governor's recommendation for change.

PRESIDING OFFICER: (SENATOR MAITLAND)

Senator Woodyard has moved to accept the specific recommendations of the Governor as to Senate Bill 1083. Is there any discussion? Any discussion? The question is, shall the Senate accept the specific recommendations of the Governor as to Senate Bill 1083, in the manner and form just stated by Senator Woodyard. Those in favor will vote Aye. Those opposed, vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record, Mr. Secretary. On that question, there are 57 Ayes, no Nays, no Members voting Present. Senate Bill 1083 -- the specific recommendations of the Governor as to House Bill -- as to Senate Bill 1083, having received the required constitutional majority vote of the Senators elected, are declared accepted. My question for Senator Woodyard was not to the bill, but as I understand it, Senator Woodyard, we were -- your motion is a motion to accept a specific recommendation for a change as a result of an amendatory veto by the Governor, something that we normally handle in a Fall Session. And here we are -- in the Senate we're dealing with amendatory vetoes and accepting those recommendations for change, and as Senator Watson pointed out, the House is still working on House Bills 2nd Reading. Is that correct, Senator Woodyard?

Yes.

Well, we thought maybe this year we'd like to identify a particular charity here in Sangamon County, in the Springfield area, that the Senate could identify and the money that we've raised could be -- could go towards that charity. And so we've done that. We raised six hundred dollars. As I say, each Member helped contribute to that effort, and Karen Hasara -- we asked her to identify that particular charity, and she is here now to introduce a few folks and make some comments about our efforts here in the Senate.
