House Bill 1612 adds language which permits a divorce court to enter a Qualified Illinois Domestic Relations Order in situations where a divorcing spouse is a member of a public pension system. The Order directs the pension system to automatically cut two checks. This bill affects only those persons who become members of public pension systems after the bill's effective date. It passed the Pension Laws Commission 13 to 1 to 1.

Thank you, Mr. President. House Bill 3180 creates the Illinois Electronic Commerce Security Act. It is designed to move Illinois document laws into the 21st century and -- and to encourage the use of electronic commerce. The bill has three basic features. First, it removes the existing legal barriers to the use of electronic communication in both the private and public sectors. It creates the legal concept of electronic records and signatures and provides that they are to be given the same legal and commercial effect as manually created and signed documents for signature, evidentiary and recordkeeping purposes. Second, House Bill 3180 deters fraud by encouraging the use of appropriate security procedures and by creating a class of computer crimes. It creates a subset of electronic records and signatures, known as secure electronic records and secure electronic signatures, which are afforded high evidentiary reliability and validity. Third, it allows, but does not require, State and local government agencies to use electronic methods of receiving and storing information. House Bill 3180 creates a legal framework for businesses, consumers, and governments to use electronic commerce as a reliable and inexpensive way to conduct business. It does not require anyone to use electronic commerce and allows flexibility and innovation within the legal framework. to answer any questions and would just ask for a favorable roll

It adds a seventh exclusion for transactions which are exempt from the three-day right to cancel: contracts between consumers and licensed mortgage brokers when the transaction involves obtaining a real estate mortgage and the first contact respecting the transaction is initiated by the consumer or by someone at the consumer's request. It is the legislative intent of the amendment to require that the initial contact with respect to obtaining a mortgage come from the consumer and not -- not a result from the consumer being solicited -- and not result from the consumer being solicited by a third party. The amendment intends no change in the three-day right to cancel where a third party has made the initial contact with the consumer. Be happy to answer any questions.

I would strongly urge the -- the sponsor to take the bill out of the record and extend the deadline - sure the Senate President would be willing to consider that - maybe have some hearings on this issue over the summer and come back in the fall. It's a very controversial, very emotional issue for a lot of people, and I'm just fearful that if we get to a conference committee report, the opponents to this legislation won't really get a fair opportunity. It's a complicated, complex, emotional issue that takes some time. So I rise in opposition. I urge my
