As required by Section 2-3.25g of the School Code, the following report provides summaries of requests for waivers of School Code mandates and appeals of State Board action to the Illinois General Assembly for its consideration.

Message from the President, dated June 16th, 2000.

Dear Mr. Secretary - Pursuant to Senate Rule 3-3(d), I hereby establish, to be effective immediately, a special temporary committee to be known as the Senate Committee on Toll Highway Financial Restructuring. Further in accordance with Senate Rule 3-1, the committee shall be composed of eight Members: five, one of whom shall serve as Chairperson, to be appointed by the President of the Senate; and three, one of whom -- shall serve as Minority Spokesperson, to be appointed by the Minority Leader of the Senate. This special committee shall conduct hearings for the purpose of reviewing and seeking testimony with regard to the status of the Illinois State Toll Highway Authority and, in particular, with regard to a document dated March 2000 and entitled "Alternatives for Restructuring the Tollway System: A Report to the Governor." The testimony shall explore the current bond covenants and the State's fiscal liability if the existing bonds were to be defeased. Furthermore, the committee shall review the financial condition of the Authority, including revenues and expenditures. The committee may explore alternatives to the current toll collection method focusing on experimental traffic congestion relief options.
