SENATOR DEMUZIO:

Well, I -- in your dictatorship, could you at least ring the bell and let us know that we're coming back into Session, or give us maybe three to five minutes notice? Is that appropriate? Is that an appropriate request?

PRESIDING OFFICER: (SENATOR WATSON)
