The resolution is adopted. Senator Syverson, for what purpose do you seek recognition? SENATOR SYVERSON:

Thank you. For the four Members that are on the Floor in this Special Session, we're going to announce it now. We'll also announce it at the 4 o'clock, but Senator Burzynski is celebrating a birthday today and he doesn't get the chance to have too many birthdays here in Springfield, since we're in the middle of July, and -- and he is one year short of the half century mark today. So, happy forty-ninth. There is a cake here for all four of you to divide up and -- and take, and if there's any leftovers, we'll have it in the -- at the 4 o'clock Session. Thank you.
