This is why checks and balanced among the three branches of power in our government were secured in the United States Constitution to protect us from arrogance and power. The Illinois Racing Board allocates valuable racing dates worth millions of dollars to race track owners. The Chairman of the Racing Board has substantial financial authority and responsibility. However, that power is constrained by statutory criteria for track owners to qualify and to be eligible to be awarded these dates. When these criteria are not met, dates worth millions should not be awarded. Governor is asking us to reconfirm Lorna Propes as Chairman of the Illinois Racing Board. Miss Propes was first appointed by George Ryan to the post several years ago. I have no personal lack of respect or affection for this appointee. However, when any Member of the General Assembly asks to speak at a public hearing conducted by an Executive Branch agency we should be allowed to speak. In my work on the Senate Appropriations Committee and years on the Audit Commission, I discovered that there were many questions about whether the National Jockey Club met the criteria to be awarded racing dates. Clean, financial statements were not available. The Chicago Tribune reported on -- on October 9th of 2003, that quote, A federal Grand Jury in Chicago is conducting a criminal investigation into a seven hundred and fifty thousand State grant to the owners of shuttered Sportsman's Park in Cicero, close quotes. were substantial questions of pay to play political contributions reported in Crain's Chicago Business newspaper. When I wrote a letter to Lorna Propes detailing these concerns I received a reply that contained the following. Quote, In short, your statement is simplistic, superficial and essentially meaningless, If it weren't talking -- if we weren't Ouch! close quotes. talking about possible -- possible corruption and millions of taxpayer dollars this would almost be funny. When I traveled to Chicago to testify at a public hearing on racing dates, I was prohibited from speaking. None of us require others to agree with us, but we do insist upon and the Constitution guarantees our right to speak freely in America. And if those of us in the Senate who have been entrusted with the voice of two hundred and

twelve thousand constituents back home are not allowed to speak before the Executive Branch, then no one is free and tyranny is only a few steps away from our door. An agency director should not hide behind the flimsy excuse that, quote, We've never done it that -- that way before, close quotes. Therefore, I ask you to exercise your constitutional authority to check and balance Executive Branch power within this Executive Appointment -- confirmation process and to vote No on this individual and send a clear message to this or any Governor that we still matter in the Senate and we insist on our right of free speech. Thank you very much.

(Secretary reads title of bill)

SENATOR HARMON:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. And thank you, President Jones, for asking me to present this bill on your behalf. Senate Bill 14 is an effort to encourage venture capital investment in Illinois. capital investment in our State is a good thing. It promotes small businesses. It creates jobs, the kind of good jobs we'd like to see here in Illinois. Jobs with growth companies in emerging markets and in new technologies. It sends a positive message to the capital markets and it generates tax revenue for What we would do -- do to encourage this sort of our State. investment here in Illinois through Senate Bill 14 is to create the Illinois Opportunity Fund to encourage venture capital in -in Illinois, in particular, in the urban and rural areas of the State that are traditionally underserved by the capital markets. This would be an effort to pool private money and invest it in venture capital funds that invest in Illinois. The mechanics are The Department of Commerce and Economic fairly simple. Opportunity will create the Illinois Capital Investment Corp., a private not-for-profit entity governed by a seven-member board of directors appointed by the Governor, but approved by the Senate. And those appointments must reflect the diversity of the State. The board will set policy -- investment policy and criteria and competitively select fund managers. The goal is to raise two hundred million over five years. The investors in the Illinois Opportunity Fund would receive a conservative rate of return and that investment will be secured by a contingent tax credit if, and only if, the Illinois Opportunity Fund cannot repay principal and interest. It is modeled after a program in Oklahoma, which also use contingent tax credits. Since 1993, no tax credits have been redeemed. I'd be happy to answer any questions.

PRESIDING OFFICER: (SENATOR VIVERITO)

Is there any discussion? Senator Rauschenberger. SENATOR RAUSCHENBERGER:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. A couple of questions to the -- the -- the presenter for the sponsor.

PRESIDING OFFICER: (SENATOR VIVERITO)

The Senator will yield.

SENATOR RAUSCHENBERGER:

In this particular case isn't it rather unusual not -- for us not only to guarantee the investors the protection of their principal, but by the construction of this as I understand it, we're also guaranteeing a modest rate of return to the investors. Is that correct, Senator?

PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Harmon.

SENATOR HARMON:

Thank you, Mr. President. Yes, Senator. It's much more like in the nature of a bond than it is in the nature of a stock investment. The -- the principal is secured by the contingent tax credit so that the investor has -- has no real downside. At the same time the -- the -- the return on the investment is limited to a conservative rate of return. So the upside is limited as well.

PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Rauschenberger.

SENATOR RAUSCHENBERGER:

So, in -- in essence, by the use of a contingent tax credit we're doing, in effect, a obligation of the State, because if either the fund or the -- the return does not meet the requirements they will be able to exercise tax credits taking away future tax revenue to make up their shortfall. Is that correct?

PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Harmon.

SENATOR HARMON:

There -- it is clearly secured by a contingent tax credit, but let me be clear, it is in the nature of a bond instrument. It is not a bond and is not, in my view, debt.

PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Rauschenberger, for the third time.

SENATOR RAUSCHENBERGER:

I -- I -- I'm not trying to confuse anybody about whether we're doing a bond, or whether we need thirty-six votes, but I did -- do want the Members to recognize that we are inserting on the State tax revenues to stimulate private investment guaranteeing people who participate in this, not only their

principal, but their principal plus a rate of return at a time when we face extraordinary budgetary challenges over the next few years and at a time when we are agonizing over the Governor's proposal to reduce funding to our pension, our major long-term obligation. I -- I just would caution people. I -- I respect the sponsor. I respect the -- the presenter for the sponsor. It's exciting to say let's go get 'em and get the venture capital industry going in the -- the State of Illinois, but using essentially State tax resources in the future to guarantee not just their principal, but their principal plus a rate of return, I -- I just think it -- this is a wrong time for a good -- this good idea.

PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Harmon.

SENATOR HARMON:

Thank you, Mr. President. In brief response, again, this is not a bond instrument. It is not State debt and modeling it after the Oklahoma program where in twelve years no tax credit has ever been exercised I do -- I believe it is an important mechanism, but practice in other states suggest it will not be utilized.

PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Brady.

SENATOR BRADY:

Thank you, Mr. President. Will the sponsor yield?

PRESIDING OFFICER: (SENATOR VIVERITO)

Sponsor will yield.

SENATOR BRADY:

Senator, who is going to get these tax credits?

PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Harmon.

SENATOR HARMON:

Investors who invest in the Illinois Opportunity Fund will receive a contingent tax credit as a part of their investment -- it's exercisable only if the fund cannot repay principal and interest as scheduled.

PRESIDING OFFICER: (SENATOR VIVERITO)

Turn your light on. Senator Brady.

SENATOR BRADY:

Thank you, Mr. President. I guess that the -- the question I have, is there any safeguards here to protect Illinois citizens against these tax credits going to campaign contributors of the Governor? You know, we've read a lot in the papers lately about pay to play. Have you put any safeguards in here so that we aren't just giving these as political paybacks?

PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Harmon.

SENATOR HARMON:

Thank you, Mr. President. Senator Brady, I think you may misunderstand the mechanics. The investor puts money into the Illinois Opportunity Fund and then is repaid from the proceeds of the investments. So the investor puts money in, say ten thousand dollars or a hundred thousand dollars. That investor is repaid from the -- the proceeds and profits of the fund. The contingent tax credit is exercisable only if down the road there's no repayment. And the -- the -- there's no -- there's no benefit to the investor over and above what the investor has put in plus the conservative rate of return promised. So, there's really no -- there -- there -- there's no benefit here. There's -- the -- the -- the scenario you've painted just doesn't make much sense.

PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Brady.

SENATOR BRADY:

Senator, I -- there is a benefit or you wouldn't be doing If you weren't trying to encourage wealthy people to invest into these funds, you wouldn't need this benefit. So the truth of the matter is, this gives them a fallback position. They may hope to seek huge returns of their initial investment or a return on their initial investment with a guarantee that if they don't get a return on their initial investment they're going to fall back and -- and benefit from tax credits the way you explained it. Or, if I don't understand it -- I mean, I'm all for making and encouraging people to invest. My point is, is anything to safeguard against heavy campaign contributors receiving these benefits. How are we going to protect, so that Illinois citizens know that their tax credits are being used judiciously and not just to pay back the Governor's contributors?

PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Harmon.

SENATOR HARMON:

Thank you, Mr. President. The -- the notion of payback just doesn't make sense here, Senator. And -- and I apologize if we're talking around each other. If you were to invest ten thousand dollars and the -- the rate of return promised you was four percent, again, we are talking about modest expectations here. The investors do not share in the upside potential of the venture capital investments downstream. They are limited to the fixed rate of return in the initial investment. So, the most that they could get would be their money, plus their four percent. They could easily make an alternative investment in a more lucrative vehicle. The reason we are using the tax credit is to encourage them to put their money into a fund that will not pay the sorts of dividends they might get elsewhere, but would have a compelling public policy benefit to the State of Illinois. PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Brady.

SENATOR BRADY:

Senator, I -- I understand and we could debate whether four percent was a good return, bad return. That's not the issue. The issue is, how do we know who's going to receive the benefit of this fallback tax credit and what are we doing to safeguard them -- the public against them just going to campaign contributors?

PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Harmon.

SENATOR HARMON:

The -- the investments are going to be managed by -- or -- or, received by a private not-for-profit corporation managed by a board that we in the Senate approve. There's no direct tie to the Governor's -- and, again, I just -- I think -- your underlying premise still doesn't make sense. There -- the benefit that you are suggesting, we are distributing, is not really that kind of a benefit.

PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Brady, we'd appreciate it if you could wrap up, because we have two more speakers.

SENATOR BRADY:

I'll close. I'll close. I -- Senator, I understand what you're saying, but I just -- we -- we happen to live in a State that is written up about every day as pay as you -- pay to play. And it just seems to me that there's a limited amount of these funds that are going to be guaranteed by tax credits. I just want -- and I -- I'm going to support your legislation as we move it to the House, but I -- I hope you'll work on it over there so that we can help remove the scrutiny of -- of Illinois. We're nationally known as the pay-to-play State. And we -- there's only going to be a limited amount. We ought to make sure that this board is -- is bipartisan, is judicious in its allocation of these limited funds so that everyone benefits fairly and we're not just paying back campaign contributions.

PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Sandoval.

SENATOR SANDOVAL:

Thank you, Mr. President, Members of the Chamber. I stand in support of Senate Bill 14. This is a good bill. This bill passed unanimously out of the Committee on Commerce and Economic Full bipartisan support. Development. It's a good bill sponsored by President Jones and Senator Harmon, as well as, myself and a number of Members of this Chamber. Just wanted to -- remind everyone that Illinois ranks eighteenth among states based on -- venture capital as a percentage of the total State gross product. And Illinois also ranks thirteenth in number of jobs supported by venture capital backed by companies. to keep Illinois strong and sound. We need to keep jobs. need to trigger the economy, create jobs both for southern Illinois, central Illinois and in Cook County. I'm -- stand in support of this bill and I ask Members on both sides of the aisle to -- to vote green.

PRESIDING OFFICER: (SENATOR VIVERITO)

Senator Jacobs.

SENATOR JACOBS:

Madam Secretary, Ladies and Gentlemen of the Senate, I also rise in strong support of this bill. You know, I live on the Iowa border and Iowa has a Value Fund that is created by venture capitals. And I have to tell you that I'm -- somewhat

embarrassed that my friends in Iowa have beat us to the punch. And irregardless of who get these funds they're very important, because if we don't create jobs in this State we won't be able to do the things that we need to do. Thank you, Senator. Senator Lauzen.

SENATOR LAUZEN:

Thank you, Mr. President. I -- I rise in opposition to this bill. Lord knows that we are ranked forty-ninth out of fifty states as far as new job creation in Illinois. But by trying to pump up a balloon when there's already a hole in it as far as regulation, tax and fee rates is going in the opposite direction. I would just ask you to consider what's in the actual bill language where what you would approve if you vote Yes on this under Section 25, part A, it says that you're authorizing award of an aggregate of two hundred million dollars of contingent tax credits and those tax credits are redeemed in any year that the Illinois Opportunity Fund is unable to return to its investors the amount initially invested plus a rate of return. So, this is a giveaway of two hundred million dollars. Of course, people are going to invest and when they lose their money, or if they lose their money, the taxpayers are going to be left with this bag. I'm -- I'm sorry, I appreciate the intention, but this is a wrong way of going about it. Good intent. Bad approach.

Senator Harmon, to close.

SENATOR HARMON:

It's time for Illinois to move to the next step, and I ask for your Aye votes.

Anything he could do for me to help advise me. When you -- when you come here you really don't know a whole lot about what's going on and you do need a lot of advice and I appreciate that. So, I think an excellent legislator, a true citizen legislator. I appreciate you honoring him this -- this day. Thank you.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Geo-Karis.

SENATOR GEO-KARIS:

Madam President and Ladies and Gentlemen of the Senate, Ralph and I went into the Illinois House at the same time. Ralph was all that Senator Luechtefeld said. And he was not afraid of women. And, as a matter of fact, he espoused the equal rights amendment. He was for it. He was for the minorities. He was very fair and -- and gentle, like you said, but he's also strong. Ralph was a real fine gentleman, who believed in the equal rights amendment, as I said, and supported it. And he was fair to the women and the minorities constantly. And all that Senator Luechtefeld said are true things, and I'm sorry he's gone, but I can honestly tell you he left his mark. An indelible mark of being a true gentleman, believed in all peoples.

Thank you, Senator Geo-Karis. Senator Clayborne. SENATOR CLAYBORNE:

Thank you, Madam President. As -- as Dave said, he told part of the story. I -- I was -- ten years ago this past Monday was my ten -- tenth -- ten-year anniversary for being in the Senate. But I think it was actually the end of April, beginning of May when -- when I met Ralph Dunn. And Ralph did have this bill. Ralph had this bill to abolish the East St. Louis Board of Election. And truly, as Senator Luechtefeld said, Ralph was a gentleman about it. He said, "You know, Senator, I could really care less, but this woman by the name of Sharon Mehrtens asked me to carry this bill" And Sharon was a Republican Party Chair in St. Clair County. He said, "You know, if it goes up I'm okay with it. If it dies, I'm okay with it." But throughout the whole process it was a challenge for me, because I had just

arrived, but Ralph was truly a -- a gentleman about it. He was very accommodating. He always informed me of what was going to happen and -- and I appreciated that. But I couldn't get him to change his mind. Even after Ralph left I saw Ralph at different events. Always such a gracious man. Was always happy to see you. He -- he always smiled. But I remember one thing that Ralph taught me and -- and -- that I learned is that even when we're at opposite ends of a piece of legislation, that you can always do it gracefully and that you can always make sure that respect is -- is -- is one that is given, as well as, received and, I, too, was honored by the fact that I had an opportunity to serve in this Body with Ralph Dunn.

Senator Jones.

SENATOR E. JONES:

Yeah. Thank you, Madam President. When I first came to the legislature back in 1973, along with Adeline Geo-Karis and Ralph was part of that infamous class of '73 in the Illinois House. And coming from Chicago, I was told if you really wanted to learn this process and have an impact on it, get to know the downstate legislators. And Ralph Dunn was one of the persons whom I got to know when I served in the Illinois House. And as it has been mentioned, he was always a gentleman. You -- you could never really get angry with him. He had a good sense of humor, but he served his community quite, quite well. And being part of our family and having passed on it's a loss -- it's a loss for all of us, because I know he was truly committed to deal with the issues of his district and the people of the State of Illinois. And as Geo-Karis pointed out, which shocked Republican colleagues, certain critical issues that were up he -but -- Dunn was on the right side of those issues. was on the right side of the issues, which sometimes his Republican colleagues did not understand. I understood. always -- he was -- he was a great friend. And I knew when he retired he was such an institution in that district that I said, well, now that he's -- he's gone maybe we can -- he retired, maybe we can changes things down there. But he passed it on to Senator Luechtefeld. And -- who's also become an icon in his district. But Ralph was an example of a person coming to this --

this Body and representing his constituency even though at times we'd disagree, I had the utmost respect for him and I appreciate what he taught me about southern Illinois. Taught me about SIU university. And I recall back in those days, it was those downstate legislators, every year Ralph was part of that group - Democrats and Republicans alike - they would always come in with a big huge project for SIU university and they wouldn't get that. But they got something and made that university what it is today. So, it's a great loss from -- from a dear old friend. And so I - I had to say those things, because he taught me quite a few things about the coal in southern Illinois.

Senator Watson, to close.

SENATOR WATSON:

Thank you very much, Madam President. Gentleman's been said. That's the first thing I, wrote down when, you know, you decide what you want to say, you're thinking what -- the first thing I wrote down was gentleman. And everybody's mentioned that. He's a -- truly was a gentleman and respect -you mentioned -- Senator Jones mentioned respect. He had respect of everybody on both sides of the aisle, because of the way he handled himself. Even in his district, the same way. He -- he was very well liked by -- by people of both parties and those of us in southern Illinois the -- you know, we take our politics pretty serious down there and -- and for someone to get the support that he did from -- from the Democrat side said volumes about -- about the respect that people had for him. And -- and in the resolution I think Scott mentioned - our friend, and that's kind of the way he was and is still today. people in his district and in his -- his region, because of the many things that he did for people. He -- he would -- he'd answer the phone many times when you called down there. He was very active in his office. He took his constituent work very serious and -- and he did an awful lot for the people of his region, and there'll be many that will remember and indebted to him for -- for a long period of time. I also wrote down that he was a quiet leader. He wasn't somebody that -- that got up and -- and did some of the things that are done on this Floor. He handled himself in a manner that was very professional, but --

and he -- but he was very effective in -- in what he did. He -he is -- has been said here, he -- he had some pretty controversial legislation over the years that he was in the Senate and in the House and -- and he was a very effective in what he did, because of the manner in which he approached this process. He -- he worked tirelessly for the University as been mentioned, Southern Illinois University. And Dave talked about the coal board and -- and the resurgence we hope will continue in the coal industry. But he's been a -- big part of that, because of what his belief was that some day the coal industry will come back and as was mentioned he established the coal board in the institute at Southern Illinois University, who is -- John Mead is still the Executive Director of that and has -- was there when Ralph -- when -- when it was first established and he does a good job -- great job for us. So, Ralph was -- will long be remembered. You know, we -- unfortunately he didn't -- time passes so fast here. It's incredible when you think about how he's only been gone ten years, I guess James mentioned, and -and half of us have turned over in that period of time and you don't even know the gentleman. But, he will be long remembered in -- in our part of the State. Thank you.
