Thank you, Madam President, Members of the Senate. I -- you know, I -- I know that the sponsor is really sincere about this, wants to do good things. I guess I just would -- I -- I taught

school for a long, long time. History. And I guess I just would ask the Members of the Senate on both sides of the aisle, are we really sure we want to do this? You know, what -- what you're asking is certainly not bad and -- and -- and anyone who might it might be accused of not aqainst caring, understanding, all of that sort of stuff. But I -- I guess I say, where do you stop? What next? Or do we find next year we have another bill like this? You know, I guess I would let it to the -- to the discretion of the teachers. Hopefully they will do a good job and do a lot of this on their own. Where -- where do we stop this sort of thing - the mandates that we require? You know, I found it very difficult to get the -- to get the history -- history gets bigger every year. And I found it extremely difficult to -- to get through the book that you had and then have a lot of other mandates to do. You know, I -- again, I -- I know that likely this may pass, because people are going to say, you know, they -- the people who vote against it don't care, but I -- I just think this is a bad road to go down. We're already trying -- we're trying to teach more than we can possibly teach And, again, on both sides of the aisle, I -- I would already. give this some thought, really, before I'd vote for it. you.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Haine.

SENATOR HAINE:

Madam President, Ladies and Gentlemen of the Senate, I rise in strong support of this bill. I heard recently on a St. Louis radio station a quiz given young adults - those attending the later years of high school, early years of college. These young adults could not determine accurately who Adolph Hitler was or Now, something is amiss when we produce students Joseph Stalin. who do not understand these momentous events, especially events which are filled with terror sponsored by government. lose something as a society if our people remain ignorant of what terrible evils have been perpetrated on mankind as a result of government terror, primarily government terror. And this bill would say to the teachers, without any lack of respect, people of Illinois consider it important to have an educated citizenry and we do not wish to repeat history because we know

what evils have been done in the past. So this is a good bill. This is a balanced bill. These are not topics which are trivial and they're -- they come right up to recent times. I would like the students to know of these great crimes and the misguided leadership of otherwise civilized nations that brought this to occur. Thank you, Madam President.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Ronen.

SENATOR RONEN:

Thank you, Madam President. I rise in strong support of Senator Collins' bill and I want to commend her for bringing this forward. And I want to associate myself with all of the remarks of Senator Haine. He's exactly right. If history becomes too much for us to teach, there's something wrong - something terribly wrong, not only with our schooling system, but with our Now, somebody once said the only thing necessary for evil to triumph is for good men to do nothing. We need to recognize and understand and make sure our children understand what is happening around the world. That's the only way, the only way we can make sure that history does not repeat itself. So, would urge all my colleagues to vote for this very reasonable bill that sets forth what our beliefs are and our policy and says very clearly that we stand firm against these atrocities that happen around the world and we need to make sure that children everywhere are taught about them and understand them. That's the only hope we have to make sure they don't happen again.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Silverstein.

SENATOR SILVERSTEIN:

Thank you, Madam President. I stand in strong support of this bill. You know, it's kind of apropos we do this today, 'cause at 11 o'clock we have the Holocaust memorial service today. And anytime you go to a Holocaust memorial service, the words are "never again" repeated - "never again". And the reason we say that is in order to have it "never again" is we have to educate, whether it be in the schools or anywhere else, and to educate children about other events that have happened, as Senator Haine pointed out, by the government is extremely essential. So, I -- and I understand there are concerns on the

other side of the aisle, but "never again" means educating our children and -- and I hope that we get a lot of greens -- lights on the board. Thank you.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Hunter.

SENATOR HUNTER:

Thank you, Madam President and Ladies and Gentlemen of the Senate. I, too, stand in -- in strong support of -- of this bill and I also would like to commend my colleague, Senator Collins, for -- for being honest enough to bring this bill to the Floor. You know, as events occur -- this is -- this is what current events that -- that we're taught in school is all about. You're supposed to keep abreast of what's going on in the world, and if we do not do that, then shame on us for not doing so. So I urge all of my colleagues to support this bill. Thank you.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Sandoval.

SENATOR SANDOVAL:

Thank you, Madam President, Members of the Senate. Who can -- who can not be in support of a bill as presented this morning by Senator Collins, but I echo the sentiments of my colleagues, Senator -- Cronin and Senator Luechtefeld. Where do we draw the Where do we draw the line in the classrooms of the children in the State of Illinois? I want to refer to the remarks made by the gentleman from Alton, Illinois, Senator Haine, talking about the rein of terror by many governments. Well, we don't need to go very far to -- to learn about the reign of terror of governments, 'cause we'd experience it right in our own country. We -- it right in my own backyard in Little Village and Cicero with the deportation of American citizens whose parents are undocumented immigrants from Mexico. When we see that our -- when we see the social injustice reign on by the American government on the undocumented children in not providing health care to young children in Little Village. You know, where do we draw the line? Where do we draw the line? And there are enough atrocities that occur in this country, social injustices, discrimination. Where do we draw the line? Let's look -- let's be a little more reflective of what happens in our own backyard, in southern Illinois, in Beardstown, in Alton, in Elgin, in

Waukegan, in La Villita, in Cicero, and let's talk about real -let's -- let's educate our children about real American values
like family, God, belief in the American way of life. So, I
stand in support of Senator Collins' bill, but I also want to say
that, you know, I think we need to get back to the basics in the
classrooms and spend the amount of time, the little amount of
time that our children have in the classroom, learning about math
and science and technology.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Shadid.

SENATOR SHADID:

Thank you, Madam President. With all due respect to the last speaker, I'm supporting this bill, but I don't think it has anything to do with documented immigrants, undocumented or whatever. I think it has to do with atrocities. That's the way I understand. Now, if it doesn't, I wish the sponsor would tell me what it means. This bill, I think, is talking about the Holocaust and anyone else that was involved, stuff like that not immigrants who are legal or illegal. So, I just want to make sure my vote is correct. Would you explain that? Does this have anything to do with the undocumented immigrants?

PRESIDING OFFICER: (SENATOR HALVORSON)

Sponsor indicates she'll yield. Senator Collins.

SENATOR COLLINS:

Thank you. This bill specifically deals with human atrocities, but we're trying to set a climate where kids or children in -- are educated to the capacity for people to develop a insensitivity that leads to discrimination that might also be reflected in how we treat our neighbor or the immigrants. But basically, this specific legislation deals with human atrocities and genocide.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Shadid.

SENATOR SHADID:

Thank you very much. In other words, atrocities like what was happening in Iraq. Those were atrocities. Thank you very much.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Emil Jones.

SENATOR E. JONES:

Thank you, Madam President. I rise in strong support of this legislation and I -- I have the utmost respect for those who are in the classrooms throughout the State of Illinois and their teaching, but sometimes, you've heard the saying that it takes a village to raise a child. Well, we are all teachers equally as well, and usually a teacher will convey to the students her experiences of what they think is best, and I was the sponsor of the bill that included the Holocaust being taught in the school system throughout the State of Illinois. And I know from attending school how limited the teachers are as relate to history, because when I went to school I was programmed. I did not know all the great contributions folks made of color to this society - the inventions and the things that they did. I didn't know about the kings and -- and queens of Africa. I didn't know about all that, 'cause it was not taught and it was taught by teachers, as far as history. So we are part of that village. Children should be educated, not programmed. So we must educate them on what's going on in the world and we are part of the village that -- that's -- that's here to help educate children. It's not that we -- we leave it all to the educators, but we are part of that team. So I cannot see why one would stand in opposition to this bill, because I've heard the same words spoken on legislation when we talked about divesting funds in South Africa and the same funds as relate to divestment of funds in -in -- in -- in -- in the Sudan. Children need to know. They should be educated and not programmed. That's why this legislation is important, because we are part of that institution and it should receive unanimous support.

PRESIDING OFFICER: (SENATOR HALVORSON)

Senator Collins, to close.

SENATOR COLLINS:

In my closing, I would like to address some of the concerns raised before I make my closing remarks. These -- the -- each school board has the capacity to determine the minimum instructional time needed to satisfy the requirement. And if you do any basic Internet search, you'll find a wealth of knowledge already developed - developed resources, including lesson plans and supporting materials for education. So, it could -- it could

even be just as limited as one hour where you can require the students to look at a -- a film, like the Hotel Rwanda. not that expansive, because the school board still has the discretion to determine how much time they want to -- to direct to the instruction. And let me just say that, as a Democrat living in a democracy, we take our values for granted sometimes and democratic institutions and values are not automatically sustained, but need to be appreciated, nurtured and protected. That silence and indifference that comes when we see suffering of others is an infringement on civil rights and human rights in our society. Many people, when they look back at the Holocaust and other genocides, they say, "Well, I would not have been involved in such human degradation or atrocities", but we find that people can be complicit in their silence and not understanding the damage that comes from -- when a government engages in legal discrimination, which allows prejudice and hatred and slaughter. As a -- a -- a descendant of slaves in America, I think that it is very important for us to be inclusive in our history, and so sometimes that -- that requires us to go back and insert what might have been left out of the history books, because history is usually written by those in power. -- but we are all a part of this nation and we should all be recognized for the contributions and we should be proud to stand on creating the character in our students that can export the -the principles that make us strong as a nation. inclusive society. We respect others, and we want to recognize that we have the capacity to do evil and let's make our children not victims of repeating history. For those who do not know history are doomed to repeat it. So I just ask for a favorable vote. Thank you.

PRESIDING OFFICER: (SENATOR HALVORSON)

The question is, shall House Bill 312 pass. Those in favor, vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 47 Yeas, 5 voting Nay, 5 voting Present. And House Bill 312, having received the required constitutional majority, is declared passed. Senator Haine, on House Bill 324. Mr. Secretary, read the bill.

Senator Haine.

SENATOR HAINE:

Thank you, Madam President. This bill is a -- a bill which would allow local government employees and private sector full-time employees who work for companies with over fifty-one - fifty or more employees to have an hour off to donate blood. It is with the permission of the employer and it's only consistent with the Department of Public Health's guidelines. And it just -- it's consistent with the Organ Donor Leave Act, which has been applicable to State employees, and it has increased the donation of blood, because it brings it to the attention of employee and employer. So I would ask for -- your support on this bill. It's -- we need more blood.

PRESIDING OFFICER: (SENATOR HALVORSON)

Is there any discussion? Senator Pankau.

SENATOR PANKAU:

Yes. Thank you, Madam President. This bill came through the Labor Committee. It was a unanimous Aye vote out of the committee. However, for those who are sensitive to the accumulation of bills that we have had this Session about leave, this is a voluntary thing; however, some of the business industry are telling us to be very careful of the number of bills that we are passing dealing with leave. So this is -- if this is a sensitivity to you, please be aware that this is in this bill. Thank you.

PRESIDING OFFICER: (SENATOR HALVORSON)

Is there any further discussion? Seeing none, the question is, shall House Bill 324 pass. Those in favor, vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 56 Yeas, none voting Nay, 1 voting Present. And House Bill 324, having received the required constitutional majority, is declared passed. Senator Burzynski, for what purpose do you rise?

SENATOR BURZYNSKI:

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senate will come to order. Will all Members within the sound of my voice please come to the Senate Chamber? We will be going to 3rd Reading. Members, please come to the Senate Chambers. Madam Secretary, Resolutions.

SECRETARY HAWKER:

Senate Resolution 188, offered by Senator Maloney.

Senate Resolution 189, offered by Senator Sandoval.

And Senate Resolution 190, offered by Senator Winkel.

They're all substantive.

PRESIDING OFFICER: (SENATOR DEL VALLE)

We are prepared to go to the Order of 3rd Reading, final passage. We ask Members to please come to the Floor. Senator Wilhelmi, for what purpose do you rise?

SENATOR WILHELMI:

Point of personal privilege, Mr. President.

PRESIDING OFFICER: (SENATOR DEL VALLE)

State your point.

SENATOR WILHELMI:

Thank you, Mr. President. Ladies and Gentlemen of the Senate, it is my honor to introduce to you one of the principals from my district who happens to be in the gallery - in the President's Gallery. His name is Brad Buzenski. He's also with

SENATOR BURZYNSKI:

The Senator just introduced a gentleman in the -- in the Gallery. How was that named pronounced again?

Senator Wilhelmi.

SENATOR WILHELMI:

Thank you, Mr. President. And yes, Senator, I found it to be very remarkable the similarity, but I want to assure you, it's not Burzynski. It's Buzenski. So there is a difference and I'll show you the card to prove it, too, sir.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Burzynski.

SENATOR BURZYNSKI:

Welcome, to my friend.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Collins, for what purpose do you rise?

SENATOR COLLINS:

Thank you, Mr. President. To Members -- for a point of announcement.

PRESIDING OFFICER: (SENATOR DEL VALLE)

State your point.

SENATOR COLLINS:

I would like for the Members of the Chamber to welcome a group from my district in -- in the State of Illinois: Muneer Aliuddin, from the Council of -- Islamic Organizations of Greater Chicago; and Hana Algarin and -- with a group of AP U.S. History students from Bridgeview, Illinois, and from the Aqsa School. They're seated here to my left. So, please give them a warm welcome.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Thank you. Seated in the balcony is a wonderful group from throughout the State who have been in existence for seventy-one years. They are the Illinois Council of Area Projects that are in the business of providing services to juvenile delinquency prevention and youth and community services. Will you-all please stand and give my group a -- a round welcome of applause? PRESIDING OFFICER: (SENATOR DEL VALLE)

Will our guests in the gallery please rise? Welcome. Senator Wendell Jones, for what purpose do you rise? SENATOR W. JONES:

Point of personal privilege, Mr. President.

PRESIDING OFFICER: (SENATOR DEL VALLE)

State your point.

SENATOR W. JONES:

Ladies and Gentlemen of the Senate, while we're in a little bit of a lull here, I have some people from my district I'd like to introduce: Mayor -- former Mayor of Rolling Meadows, Tom Menzel; Linda Ballantine, from the Chamber of Commerce in Rolling Meadows; and the Assessor of Wheeling Township, Dolores Stephan. SENATOR GEO-KARIS:

Well, thank you, Mr. President and Ladies and Gentlemen of the Senate. Senator Hendon, you do me proud and I am looking forward to you today to catch the balls you dropped the last time. And...

PRESIDING OFFICER: (SENATOR DEL VALLE)

On page 7 of the Calendar is the Order of Senate Bills 3rd Reading. This is final action. We will be calling those Senate Bills with Floor amendments that have been adopted or are ready to be adopted. On the Order of Senate Bills 3rd Reading is Senate Bill 1548. Senator Trotter. Senator Trotter seeks leave of the Body to return Senate Bill 1548 to the Order of 2nd Reading. Is leave granted? On the Order of 2nd Reading is Senate Bill 1548. Madam Secretary, are there any Floor amendments approved for consideration?

SECRETARY HAWKER:

Yes. Floor Amendment No. 2, offered by Senator Trotter. PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Trotter.

SENATOR TROTTER:

Thank you very much, Mr. President, Members of the Senate. Floor Amendment No. 2 deletes the language from Amendment No. 1, which was the supplemental bill. Specifically, there is one change and that change proposed will delete the transfer from the circuit breaker of 5.7 million dollars and only provides a straight appropriation of twenty million dollars to the homemaker Community Care Program. I'll further explain the bill when it's back on 3rd.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Is there any discussion? All those in favor will say Aye. Opposed, Nay. The Ayes have it, and the amendment is adopted. Are there any further Floor amendments approved for consideration?

SECRETARY HAWKER:

No further amendments reported, Mr. President.

3rd Reading. Now on the Order of 3rd Reading is Senate Bill 1548. Madam Secretary, read the bill.

SECRETARY HAWKER:

Senate Bill 1548.

(Secretary reads title of bill)

3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Trotter.

SENATOR TROTTER:

Thank you very much, Mr. President, again, and Members of the Senate. Senate Amendment No. 2 to 1548 provides a onehundred-and-sixty-seven-million-dollar all fund supplemental appropriations to finish out FY 2005. The GRF portion of the supplemental amounts to approximately seventy-eight Included in this supplemental is eighteen million dollars. dollars from General Revenue funds to Department of Corrections to cover a shortfall in personnel services throughout the agency to prevent furlough days and cuts in staffing. Also within DOC is a transfer of 4.9 million dollars to lessen the impact to GRF. Additionally, ten million dollars of other State's funds to DCFS to fund a shortfall in the institution of group home care prevention line as a result of higher than anticipated caseload. stated earlier, twenty million dollars will go to the Department of Aging from GRF to fund their anticipated utilization and caseload issues. 22.5 million dollars to DHS to cover a shortfall in cash -- in the cash assistance program, including TANF, and eighteen million dollars to DHS to maintain operations of the State's MHDD facilities.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Is there any discussion? Senator Syverson. SENATOR SYVERSON:

Thank you, Mr. President. A question for the sponsor.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Sponsor indicates he will yield.

SENATOR SYVERSON:

Senator, is this the -- the second supplemental that we have done this year, and if so, what's the total of both of those supplementals?

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Trotter.

SENATOR TROTTER:

This is the second and I will get that number for you.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Syverson.

SENATOR SYVERSON:

My concern is that last year, for those of us who were here and spent all the -- the time in overtime Session working to try to craft a budget that was reasonable, we worked to come up with an agreement that we were going to cut the budget by a certain dollar amount. My concern is that it didn't happen, that we made the cuts, but the spending continued. And with this supplemental, we have restored now over eighty percent of all the agreed cuts that we had last year and I'm not sure if we have even the resources even to pay these. In the discussions with this additional supplemental, were there discussions from the Second Floor as to why they felt they got themselves into this kind of financial trouble? Or were there discussions about the fact that they weren't living up to the commitments that they had made last year?

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Trotter.

SENATOR TROTTER:

Sir, you're -- absolutely correct. We did make a concerted effort to have our balanced budget and to live within our means this year, but as in every year, and again, having a supplemental is not unusual, because unusual circumstances do come up. In this case, we have increased caseloads with DHF and along with TANF. Because of the Department of the State Police increased their fingerprint checks for local governments, this increased our -- the cost of doing business with those agencies and, of course, we have in -- in Corrections, as a -- a consequence of

their union contracts, we do see now that we are going to be short at least one paycheck to those DOC workers. This will alleviate us having to furlough anyone under those circumstances. PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Syverson.

SENATOR SYVERSON:

And, Senator Trotter, I appreciate the work that you have done. I think you've been a very sincere negotiator in trying to work on this. But we know that you listed some of those things that were clearly things that we have done in the past with supplemental budgets. But a large portion of this is things that they knew they were underestimating - for example, not putting any pay raises into their last year's budget, knowing full well that they had authorized pay raises to take place before the budget was even -- even passed. So I guess -- let me ask this question: How much of that is due to contractual obligations that were made in the budget before we passed it last year?

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Trotter.

SENATOR TROTTER:

The coveted shortfall that increases net point 4. -- I'm sorry. There -- sir, to answer your question, and we are making a guesstimate here based on the -- the short time to look at the -- the exact question that you presented us, is about fifty million dollars.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Syverson.

SENATOR SYVERSON:

Thank you. So most of this supplemental, or a large portion of it, is due to salary commitments that were -- that were made, that we've had a year to make adjustments in, that weren't made. And I guess my -- frustration is that these were all things that were known at the time agreements were made last year and yet we moved forward with this -- with this massive amount of spending and now you're stuck and we're stuck having to backfill commitments that were made last year. So, I guess my concern is that people back home agreed that we stayed down here all that time last year to come up with a budget that was going to be a -- a budget that was lean, a budget that was what we had promised

the taxpayers it would be - balanced, and now that commitment wasn't kept and the spending continued and now we're back having to bail out that with money that we don't have. So, appreciate the work that you've done and it's unfortunate that we're back here with this kind of a supplemental.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Watson.

SENATOR WATSON:

Thank you very much, Mr. President. difference of -- of a lot of you here on the Floor and -- and myself and President Jones is, we were in the room. You know, we were there; budget was discussed, all the memorandums of understanding, some fifty some memorandums of understanding, in which we had to have signatures of the Governor, the Leaders, others that had interests, simply because of the matter that we just didn't truly believe that maybe there wouldn't be a followthrough with some of the agreements. So we have to sign all these memorandums of understanding. You participated in that. We participated in that. Both -- both Chambers and the House participated in that. But one that we didn't participate in, unfortunately, was a budget agreement. We sat around the table and I can remember, I said specifically, "Now, what does this Are you going to be able to operate within the budget deal that has been dealt with - the hand that we've been dealt with today? Are you going to be able to live within this? Will there be a supplemental?" No -- and the answer was, "There will not be a need for the -- any supplementals. We will be able to operate within the manner in which we've agreed." administration talking. This is the administration telling us, There won't be a problem, Senator. There won't be a We'll be able to fulfill the obligations of this budget." And we have four hundred million dollars that we cut, because we didn't have the revenue in this State. We didn't have the ability to pay for a lot of the programs that many wanted to have, but we cut four hundred million dollars out of this budget last year, out of the Governor's proposed budget - by four hundred million dollars. Two hundred and fifty million of that was Medicaid. A hundred and fifty million of it was what we would consider to be General Revenue. Right now, after last

January, after today, we are now going to be restoring a hundred and twenty million of the hundred and fifty we cut. Is that a Is that an agreement? But the Governor said, "No problem." "No problem." And then, as Senator Syverson just mentions, to go out in the Department of Aging and negotiate a contract after we've given 'em the money they know the why -- which -- the parameters in which you have to live - negotiate a contract that blows it apart. We know what we have to We know what's available and that's what we spend live with. not with this administration, not whatsoever. How many of you've been contacted by people who have the underground storage tank issue? They've -- they've removed the tanks and there's no money in the EPA to pay for it - no money in the LUST Fund to pay for the people who've removed the tanks and their subcontractors. I'm sure many of you right now are negotiating, talking to EPA, talking to the Comptroller's Office. Why isn't there any money available to pay these people their due? They've -- they've done the service. Why not -- isn't -- why isn't that money available - for over thirty-five million dollars? Thirty-five million dollars has been taken out of the -- the LUST Fund, Underground Leaking -- LUST -- the Underground Leaking Storage Tank Fund to fulfill obligations outside of the requirements in the dedicated fund that's there, and that's the General Revenue Fund - once again, mismanagement. It's all about mismanagement. They can't operate within the parameters that they're given. They ignore the legislative process. Senator Emil Jones.

SENATOR E. JONES:

Thank you, Mr. President. I believe this is the first time in the history of the General Assembly that we've had a supplemental. And all the years I've been here practically every year you sit down, you negotiate a budget and then later on you got -- you come back with a supplemental. As relate to TANF, sometimes the projections are off. Due to the economy more, the caseload goes up. You need more revenue. Sure, I sat in those meetings, and we sat down there, and I believe the budget director and the Governor, to their best estimate, recognized that we may not need a supplemental. But like all previous Governors, you cannot tell me one time that they said we had a balanced budget and come back during mid-Session saying, "We need these additional dollars." It's happened every doggoned year. You listen to the proponents on the other side, they were acting as though it never happened. The other Governors, Ryan, Edgar, Thompson, they all did the same identical thing. trying to manage a budget, you got employees. They're doing their work - correctional officers. You want to lay 'em off? The Minority Leader said lay off the correctional officers. They are working and they deserve to get paid - be it mental health, be it developmental disabilities - to be able to deliver the service for those people. It's unconscionable for us to sit here and talk about what took place in the room. Senator, is this the last supplemental we're going to see from this Governor this year?

Because in recent weeks we've heard the Comptroller speak to the fact that he's got seven hundred and fifty million dollars in bills he can't pay, he's got a seven-hundred-and-fifty-milliondollar loan he can't repay, and he believes the Governor's hoarding medical bills that he doesn't even know about. Can you respond to that, Senator?

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Trotter.

SENATOR TROTTER:

I couldn't tell you what the conversation was between the Comptroller and the Governor's Office; however, I've heard those numbers as well. I think our fiscal year doesn't legally end until the -- the first of July.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Brady.

SENATOR BRADY:

Senator, do we have any increased revenues to pay these bills with?

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Trotter.

SENATOR TROTTER:

We are accomplishing this one with transfers from within the Department's federal funds and through other State funds. So, they are -- the dollars are there. Yes.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Brady.

SENATOR BRADY:

So, Senator, you're suggesting that this won't add to the Governor's hole this year? Speaker Madigan said a billion and a half. The Comptroller seems to think is 3.5 billion dollars. You don't think this will add a hundred and forty or eighty million dollars to the Governor's budget hole?

PRESIDING OFFICER: (SENATOR DEL VALLE)

SENATOR TROTTER:

As you just pointed out, Senator, those numbers are floating. So, we don't know what the -- actual number is. It could even be less.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Brady, last question.

SENATOR BRADY:

Thank you, Mr. President. Just to clarify, Senator. What -- what you have said is that you don't know if the money's there. The Constitution requires a balanced budget. The Governor's coming back to us. He spent more money than we have. Senator Watson's right. You know, when is he going to wake up and live within our means? I mean, he can't keep ignoring the Constitution of the State of Illinois. He can't keep spending money we don't have just because he thinks it pays to mismanage CMS, to see campaign contributors get money. You need to join us and send a message to this Governor. Don't tell us you save money at CMS when you blew it. Don't tell us you lived within a budget when you blew it. You need to help us send a message to this Governor that the taxpayers of Illinois deserve fiscal responsibility. Vote No.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Hendon.

SENATOR HENDON:

Well, thank you, Mr. President. I rise in strong support of Senator Trotter's bill. Clearly, he is not the Governor. But let me say this. I rise in strong support of our Governor. I think Governor Blagojevich has done a great job in -- tough times. He believes in America. He believes that Illinois will bounce back from 9/11. Clearly, we still haven't bounced back from 9/11. I can't help, when I listen to these speeches, I just wonder would you be making these same speeches if you were in the Congress and it was President Bush who was saying we needed additional monies for this and additional monies to fight the war in Iraq and additional money for homeland security and so on and so forth. All around the country state governments have not bounced back from what was put on us by the terrorists who -- who put an economic, not just a physical attack on America, but an

economic attack on this country. Governor Blagojevich is doing the best he can under these circumstances. Well, I thought this Governor was all about doing business not as usual, and that's not, obviously, the case. I don't think any of us expected it to be this bad when he talked about not doing business as usual. And to even suggest -- and -- and if, in fact, the Governor and the administration would have addressed this issue, the budget issue, back when we brought it to their attention last January, there wouldn't be the need for all of this clamor now. could have addressed it at that point in time and they could have managed the budget in a manner in which we wouldn't see these draconian -- potential draconian cuts and we wouldn't be laying off the men and women who work for this State, especially in the Department of Corrections, who put their lives on the line every day for us and -- and -- and sacrifice a great deal to work for this State. We wouldn't be asking them to do this. Henry Bayer, the -- the -- the President of AFSCME union, came to us last summer when this was being negotiated and he said, "Senator, this isn't going to work. This Governor is not going to be able to live up to the commitment he has made to live within the means." Because with -- even within the Department of Corrections, and he was talking about human services, all the other State employees of which AFSCME represents, they can't do So, at least last summer -- at least the AFSCME union was saying a message, giving -- sending us a message that this isn't doable, but unfortunately, we live with a handshake. with an agreement and that's the way we do business here in this -- this process, but unfortunately, I guess, maybe that's not the

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Rauschenberger.

SENATOR RAUSCHENBERGER:

Thank you, Mr. President, Ladies and Gentlemen of the I want to also compliment the sponsor. I know it's not fun to carry supplementals. My recollection is, I think I carried five before the General Assembly. So, when Senator Jones says there have been previous supplementals, he's absolutely right. But there are some differences in this supplemental that I'd just point out to the Membership for your consideration that are fundamentally different than supplementals we've had in the In the past, whether it was Jim Edgar, whether it was George Ryan introducing a budget, when they were contemplating a contract with unionized employees, they allowed in their budget for an amount to -- to pay for the increases they expected to negotiate with their collective bargaining employees and with their merit comp employees. In this case, the Governor presented a budget and said he could live within it and said don't worry about the collective bargaining agreements. Well, suspiciously the amount of increase in the Correctional budget is pretty close to what it costs to -- to do a -- a pay increase across the correctional facility, but only for the collective bargaining employees. There's nothing in here for the merit comp employees. So this is -- and then take a look at the Department of Aging appropriation for twenty-million-dollar increase in the -- the community -- the homemaker services line. That's suspiciously the amount of money that it cost since the Governor permitted the collective bargaining of homemakers and for SEIU to organize them. SEIU which interestingly enough was one of the largest contributor -- contributors to the Governor's campaign and been one of his most generous contributors since. Thank you very much. Senator Syverson, the answer to your question of the two supplementals was a total of 372.5 million Of that, 122.5 million dollars was out of General dollars. This bill specifically asks for eighty-eight Revenue funds. million dollars -- excuse me, 83.6 million dollars out of General Revenue Fund, but the total is 122.5. Just to address a couple of the other issues about -- and I don't want to get into apples and oranges when we talk about contracts and we're talking about actual services that are being delivered to the constituents of This supplemental represents those the State of Illinois. services to be rendered to our citizens, to our constituents. This is not about contracts for anyone's friends or whatever else we've been reading in the paper. This is a -- a supplemental that is needed at this time. There have been thoughts of -questions came up about being layoffs. Well, layoffs, it's too late to achieve those eighteen million dollars through layoffs, but the employees still can be furloughed. We feel if people are going to work, they need to get paid. This supplemental allows those individuals to work, and especially in our Department of Corrections that we fought so hard for last year to keep open, now to get a paycheck while they're working there. Senate Bill 572, as amended, would allow local units of government, county, municipalities to -- to set up a intermodal facility development authority -- authority. They would -- it has powers to issue revenue bonds. It will have -- it will establish a TIF district. Seventy percent of all rails in the country flow through the State of Illinois and -- and the County of Cook. We established a intermodal zone in Joliet a couple -- about three years ago and what it does is put us in competition with the State of Indiana as relate to establishing these zones. It would create great job opportunities for those individuals dealing with transportation and the rail industry. It -- it is a bill that it will -- will deal with the situation in the southern suburbs as relate to a lot of the obsolete rails. If you have a intermodal situation -a zone established there, they'd be able to pool all resources together, all the rails will work together and -- for transportation, as well as delivery of products, throughout the State of Illinois. It will have a master developer to handle the entire project. It is something that is needed. piece of legislation. I ask for a favorable vote.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Is there any discussion? Senator Roskam. SENATOR ROSKAM:

Thank you, Mr. President. I rise in support of this bill. President Jones presented it in Executive Committee and -- and we're wholeheartedly supportive, at least those on the committee. I -- I just want to know what -- I think, Senator Jones, there may be a couple of -- I think there might be a couple of drafting errors that the staff has brought to the attention and I -- it's

SENATOR E. JONES:

Not to my knowledge. Not the ones that's already in existence. But I know there have been others who have -- we worked on the one for Joliet, for example. But I don't know if it could be incorporated into this district due to the -- this is between the facilities.

Senator Wilhelmi.

SENATOR WILHELMI:

Thank you, Mr. President. As Mr. President has said, there is an intermodal facility in Joliet. It has been an incredible project. It, at one point in time, was the largest earthmoving private project in the country and I can speak on behalf of that project and hopefully we'll be able to develop more with this bill. I rise in support of the legislation.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Winkel.

SENATOR WINKEL:

Thank you, Mr. President. What this legislation, House Bill 373, does is it, until January 1, 2006, allows current participants in a downstate police pension fund to transfer nonvested prior work service credit from IMRF to their downstate police pension fund. Also, it allows current -- participants in IMRF to transfer non-vested prior credits in downstate police fund to IMRF prior to January 1, 2006. Currently, there is -- in current law, there's very limited transferability or reciprocity between IMRF and downstate police pension funds. This would create a window of reciprocity for downstate police and county deputies. Be glad to answer any questions.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Is there any discussion? Senator Martinez.

SENATOR MARTINEZ:

Members of the Committee, this passed the Pensions Committee unanimously and I ask and urge for from our side of the aisle.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Burzynski.

SENATOR BURZYNSKI:

Thank you, Mr. President. Will the sponsor yield for a question?

PRESIDING OFFICER: (SENATOR DEL VALLE)

Sponsor will yield.

SENATOR BURZYNSKI:

Thank you. Senator, is there a cost associated with this bill?

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Winkel.

SENATOR WINKEL:

The transfer of credits should cover the cost of the benefits. So, this should have no fiscal impact.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Burzynski.

SENATOR BURZYNSKI:

Just, if you would, repeat that again so I make sure I hear it right. Because of the transfer of credits from the other pension fund, there should be no fiscal impact.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Winkel.

SENATOR WINKEL:

Transfer of credits should be sufficient to cover the cost and so it should have no fiscal impact on our budget.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Lauzen.

SENATOR LAUZEN:

Thank you, Mr. President. Just a question for the sponsor.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Sponsor will yield.

SENATOR LAUZEN:

What level of funding are each of these pensions enjoying right now? The downstate police, at what percent are they funded? And then also the -- the IMRF.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Winkel.

SENATOR WINKEL:

Told -- I'm told by staff that IMRF is ninety-five percent. It's difficult to answer the rest of your question since these are independent funds. So, I really can't address -- I don't even have an average figure.

PRESIDING OFFICER: (SENATOR DEL VALLE)

Senator Lauzen.

SENATOR LAUZEN:

The question that I would ask then is, generally are they

Currently it requires the Department of Natural Resources to adopt rules of operation of ATV and off -- off-road motorcycles. We are currently not in compliance and need this change. The change simply moves from "shall" to "may". I ask for your favorable consideration.
