SENATOR CRONIN:

I would -- I'm most delighted to introduce a wonderful family that's joined me here today and joined all of us here in the State Senate. The Duncan family: Cheryl Duncan, Stephanie Martinez, Natalie Duncan, Joseph Duncan and -- Nathanial Duncan. A wonderful group, a wonderful family from Wheaton, Illinois. The mighty City of Wheaton, the county seat in DuPage, the nerve network of the nation, tree city USA, I think about four or five times. It's a wonderful place, a wonderful community and I'm proud to introduce my friends, the Duncan family who are down here. Let's give the Duncan family a warm Senate welcome.

PRESIDING OFFICER: (SENATOR DeLEO)

Would our guests in -- are they in gallery? Please rise -please rise, be recognized. Welcome to Springfield. Senator Cronin, you missed your class photo earlier. You missed your class photo earlier. Senator Roskam stood in for you, sir. We -- going to start, as we mentioned, on House Bills 3rd Reading. Page 78 of the Calendar. Before we do that, I'd like just to make an announcement to let the Body know what the intentions are for today and next week. We're going to do some 3rd Readings. Today will be final passage. We will hope to move some of these bills today. It is getting very close to -- to the end of deadline. I'd like to -- remind all Members that Floor amendments should be filed by the close of business day tomorrow. All Floor amendments be filed by the close of business day tomorrow, so they can get to Rules Committee and to appropriate committees early next week. We will be returning on Monday. Monday afternoon at the hour of 3 p.m. We will be doing final passage, 3rd Readings Monday evening and all day Tuesday. We have quite a lot of 3rd Readings on the Calendar. House Bill 1370.

(Secretary reads title of bill)

3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Forby.

SENATOR FORBY:

Thank you, Mr. President. House Bill 1340 {sic} (1370) comes from Attorney General's Office. This bill amends the Prevailing Wage Act regarding violations by allowing higher penalties and -- on the second violation. This bill will increase penalties violation on the Act from a Class B to a Class A misdemeanor. This bill also increases a longer period of violation from a two years to four years in a five-year period. What this bill does, actually is, the people that tries not to pay prevailing wages -- putting everybody on a same playing field. This bill is not to go after somebody that made a twenty-dollar mistake or something like that. This bill is for somebody that's doing this on purpose that's not on the same playing field. So, I'll try to ask {sic} any questions.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you. Is there any discussion? Is there any discussion? Senator Righter, for what purpose do you rise, sir? SENATOR RIGHTER:

Will the sponsor yield, please, Mr. President?
PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates he'll yield for a question, sir. SENATOR RIGHTER:

Thank you. Senator Forby, this bill had a lengthy discussion in the -- in the Senate Labor Committee, which you Chair. And there were some serious questions raised by the business community about the -- the need for these changes. One of those areas - I just want to talk about one of 'em here - is with regards to the amount of time by which -- the expansion of the amount of time in which the Department of Labor can find that there are two quote, unquote violations. It's being expanded from two years to five years. I mean that is a pretty serious

expansion. And I know that you have a lot of employers, particularly small employers, in your district, Senator Forby, as I do in mine. What -- what do we say to these smaller businesses who - it's been my experience - have plenty of prevailing wage investigations launched against them that -- that why is this necessary to so dramatically expand the amount of time with when -- within which they can be found to have a second violation and be subject to much more severe penalties?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Forby.

SENATOR FORBY:

Well, as you know, before I came to the legislature I was a small contactor. And what I want to do as a small contractor, if I had to pay prevailing wages, I expect everybody else to. All this does is try and put everybody on the same playing fields and this is not to go after people. This is to stop the people that's coming in down the road. They see this penalty, they're gonna think twice before they're not paying prevailing wages.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Righter.

SENATOR RIGHTER:

Senator, let's go back to the point I raised in my question. The -- the need to expand, more than double the amount of time within which -- an employer can be found in violation twice and be subject to such severe penalties. I mean, what you're talking about, Senator Forby, you know, the offenders who -- are the repeat offenders. What I'm talking about is, how many other groups, employers are you going to find to fall within this two-violation category by expanding it from two years to five years? I mean, I -- I get the impression you're talking about the chronic violators that you want to go after. What I'm suggesting to you is the breadth of that expansion that's going to catch a lot more people than that.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Forby. Is that a question or is that a statement, sir? Senator Forby, to answer the gentleman's question. SENATOR FORBY:

Not every violation out here today is -- will be on that one or two year -- one or two term things. But, you know, anybody

can appeal a violation if they want to. So, what this is all about is, like I said before, it's going after the people that is -- intend to do a violation. So, these people that see that goes from two to four years different, they're going to think twice before they try to do this - violations.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Righter.

SENATOR RIGHTER:

Thank you, Mr. President. To the bill.

PRESIDING OFFICER: (SENATOR DeLEO)

To the bill, sir.

SENATOR RIGHTER:

Ladies and Gentlemen, I hope that everyone in Thank you. here who has employers in their district who may be subject to the prevailing wage requirement, will take a very close look at this legislation. This is a very aggressive increase. Not just as -- on the issue that I talked about with Senator Forby on the length of time within which you can be found to have a second violation and be subject to much more severe penalties, but other issues as well. I don't think this bill is aimed at the chronic repeat violators who violate on every project. That's what we should be concerned about. The people who are out to -intentionally violate the law, not the employers who make a mistake on the records. And I don't think anyone in here represents an employer who wouldn't over five years make a mistake on their records. And this is going to subject them to much higher, much more severe penalties. I don't think in a State where we are already lagging far behind our neighboring states in job creation that this is another thing that we want to toss on those employers and say, here we want you to deal with this as well. I would urge a No vote.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Forby, to close, sir.

SENATOR FORBY:

This -- I agree what you saying, Mr. Righter, but this bill is not to go after people that made a twenty-dollar mistakes. This bill is not to go after somebody that didn't do something on purpose. This bill is to go after people that's done intentionally, on purpose. I am going to do this. I'm going to

beat the people out of it. With this, adding a term to it longer, it's going to make the people think twice. I think this
is a good bill. I was a contractor for thirty years and when I
had to pay prevailing wages, I expect everybody else to have to.
So this puts everything on the same playing field so everybody's
equal. I'd ask for an Aye vote.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you. The question is, shall House Bill 1370 pass. All those in favor, vote Aye. All those opposed will vote Nay. The voting is open. Have all voted who wish? Madam Secretary, please take the record. On that question, there are 32 Ayes, 24 Nays, 0 voting Present. House Bill 1370, having received the required constitutional majority, is declared passed. Senator -- Senator Righter, for what purpose do you rise, sir?

I would request a verification of that roll, please. PRESIDING OFFICER: (SENATOR DeLEO)

Gentleman requests a verification. Will all Members please be in their seats. The request is certainly in order. Madam Secretary, would you please read those people voting in the affirmative.
