Elwood portion of that arsenal has been developed by CenterPoint and it's created one of the most successful intermodal facilities -- intermodal facilities in the country, certainly in Illinois. This will allow for a big developer, ProLogis, to come in, develop the southern end of the arsenal in Wilmington and create an additional one hundred and seventy-five thousand dollars in the first year of the abatement, only for the school district. And then by year ten of the -- the abatement - it's a ten-year that would result in one million three hundred thousand going to Wilmington School District, which is very, very -- a poor school district. The Department states that failure to resolve that conflict would jeopardize federal grants.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Hendon, for what purpose do you seek recognition? SENATOR HENDON:

Thank you, Mr. President. I rise in strong support of this legislation. We have to remember that the people who are in this predicament -- we drafted the legislation in the first place, so we have a responsibility to -- to them on this license. It's still the same one, so I'd urge an Aye vote.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Lauzen, for what purposes you rise, sir? SENATOR LAUZEN:

A question for the sponsor.

PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates he'll yield for a question, sir.

SENATOR LAUZEN:

Senator, is there any precedent in Illinois law where we go in and write in a law that protects an investment for a group of

people? I mean, by law in the State of Illinois. I've never heard of anything like this. But maybe there's a precedent that I'm just not aware of.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

SENATOR CLAYBORNE:

Not particularly, Senator, but all we're asking is that that applicant be considered. This is one of the factors. It's not exclusive, as we try to address this previously, where we -- in - in the same law, where the Board may give favorable consideration to economically depressed areas of the State. We - we just added that to try to balance this off to allow those minority investors to -- for that applicant to be considered since they did lose money.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator -- Senator Lauzen.

SENATOR LAUZEN:

Thank you very much, Mr. President. How were these favored investors selected in the first place and what is the basis for the preference in the future? How were they selected initially and what is the basis that we protect anybody's investment in Illinois?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

SENATOR CLAYBORNE:

As I understand it, the licensee afforded ownership opportunities to these particular investors.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Lauzen.

SENATOR LAUZEN:

I'm -- I'm sorry, Senator, I'm not clear on that answer. How were these specific investors given this right to invest, initially? And now upon what basis are they given preference in the future? What was the basis?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

SENATOR CLAYBORNE:

Well, I -- I actually wasn't there, Senator Lauzen. My understanding is that, obviously, this licensee probably sought,

because of the law, probably sought out individuals who had an interest and who had the financial wherewithal to -- to be able to buy interest in -- in that particular license and to that particular applicant. In terms of a preference, Senator Lauzen, this -- this country is based upon preferences. You know, throughout the entire history of this country, there's been a preference given. So, we're -- we're -- we're really just trying to bring equity into a process by which some people lost money.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Lauzen.

SENATOR LAUZEN:

I -- I just think that this is the -- this may be the most amazing thing I've seen in -- in fourteen years of serving in the Senate and especially the statement that this country is based on preference. To say that this country, founded on the principal of all men and women are created equal, that there would be a preference and that this country is formed on preference. I just think it's terrible. I urge a No vote.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Burzynski.

SENATOR BURZYNSKI:

Thank you, Mr. President. Will the sponsor yield for some questions?

PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates he'll yield for a question, sir.

SENATOR BURZYNSKI:

Thank you. Senator, it's my understanding that there currently is a lawsuit relative to these individuals getting their funds back from the original investment group. Is that correct?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

SENATOR CLAYBORNE:

I assume that that's -- that's the case. I don't -- I don't know that, Senator.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Burzynski.

SENATOR BURZYNSKI:

Thank you. That was made pretty evident in committee today

and -- that that is the case. That being said, if these individuals get their funds back from the -- original investment group, will they still be under what you call "favorable consideration" then for the boat -- for the -- for the next license, as well?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

SENATOR CLAYBORNE:

These -- these provisions would still stand.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Burzynski.

SENATOR BURZYNSKI:

Thank you. So then they get two bites at the apple? Okay. I'll -- I'll say this to you. Can you define what "favorable consideration" means?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

SENATOR CLAYBORNE:

Just something they would -- that the Board would consider, that's all.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Burzynski.

SENATOR BURZYNSKI:

Thank you. I don't understand what that means, though. "Favorable consideration" - and does it mean that the Board, and I -- my reading of the bill says that the Board "shall" give favorable consideration, not "may" give favorable consideration. And "favorable consideration" to me means that if I have two people coming to me and I'm supposed to give one favorable consideration and not the other, then I'm supposed to choose the one that says "favorable consideration". So, it's a foregone conclusion that they would be part of any license that might be awarded. Is that fair to say or am I missing something? PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

SENATOR CLAYBORNE:

I really didn't understand your question, but let me -- let me say this. That the Board will consider many factors in determining whether an -- a license will be granted to a

Senator Burzynski.

SENATOR BURZYNSKI:

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

SENATOR CLAYBORNE:

I can't. No. No.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Burzynski.

SENATOR BURZYNSKI:

Thank you. Well, there -- there's a list of -- of those. It's in any court case, but you don't have that with you relative to who the people are?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

SENATOR CLAYBORNE:

No, I don't.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Burzynski. You want to share that list with us? SENATOR BURZYNSKI:

I -- I've got the list right here, Senator, if you'd like to see it. It includes several individuals, a couple that we know quite well, or at least we know the names of, and some others that aren't quite so famous, if you will. But to the bill: First of all, I think there's some real concerns. We don't know what "favorable consideration" means. There is no definition. I've got my assumption what that means, but we know what Secondly, I guess what this points out is that assumptions do. to invest in that license whenever it available, the first thing I need to do is I need to go to the individuals that are in this lawsuit, the individuals, minorities that were a part of the original cast of characters, so to speak, and get them in my group to go purchase this license because that not only gives me a heads up or gives me a leg up, what it basically does is assures that I'm going to get that

vote, unless there's any wrongdoing involved. Because in the bill it says "the Board must give favorable consideration". And when we don't know what that is, I'm going to have to assume that means those individuals are going to be a part of that license. I would urge a No vote. Thank you.

Senator Righter.

SENATOR RIGHTER:

Thank you, Mr. President. Will the sponsor yield, please?
PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicate he'll yield for a question.

SENATOR RIGHTER:

Thank you, Mr. President. Senator, I want to make sure that I'm clear in the way I'm reading the language that you've got in your bill. It's not -- we're not -- we're not identifying people based on their minority status or gender, we're identifying specific individuals, is that right?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

SENATOR CLAYBORNE:

That's correct.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Righter.

SENATOR RIGHTER:

Who are those individuals, Senator?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

SENATOR CLAYBORNE:

The -- the question's been asked and answered. But, Senator Burzynski has the list. I don't have it.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Righter.

SENATOR RIGHTER:

Did -- you've already read a list of all the names for -- on the Floor here in the record?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Clayborne.

SENATOR CLAYBORNE:

No, I said Senator Burzynski has the list. I don't -- I

don't have the list.

Senator Righter.

SENATOR RIGHTER:

With all due respect, Senator, I think it's appropriate because what we're doing here is we're saying that if you've got these certain individuals, these specific people as investors, you're going to get a discount. That's what you're saying. I think it's fair that we put on the record the name of the individuals -- the names of the individuals that we're helping out. Would you do that, please?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator James Clayborne.

SENATOR CLAYBORNE:

Since Senator Burzynski has the list, he can pass it to you and you can read it and I'll accept what you -- what you read -- what you've read.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Righter.

SENATOR RIGHTER:

...bill. To the bill.

PRESIDING OFFICER: (SENATOR DeLEO)

To the bill, sir.

SENATOR RIGHTER:

Mr. President, thank you. I think the fact that the sponsor doesn't want to read the list of names ought to be instructive to everybody in this Chamber, because now we're not granting a preference based on ethnicity or race or gender, we are now providing a specific discount for certain individuals whose names are not going to now go into the record in the debate. And so if you vote for this, you're voting to give that discount to specific individuals and you don't know who they are. And if you're comfortable with that, and you're talking about millions of dollars, if you're comfortable with that, you should vote for that. If you're not comfortable with that, please vote No.

PRESIDING OFFICER: (SENATOR DeLEO)

President Jones, for what purpose do you rise, sir? President Jones.

SENATOR E. JONES:

Thank you, Mr. President. I rise in support of this bill. And it's very interesting sitting here listening to the debate on this issue. In the nineties when the Leader on your side of the aisle, Pate Philip, pushed through this legislation, that included that twenty-percent provision for minorities and women. He even twisted arms on that side of the aisle to make sure they had enough votes to vote for that. In doing so, that was favorable consideration given to those individuals who qualified. The directions given to the Gaming Board. All those persons who participated did nothing wrong. They followed the law that we passed, and most of you on that side of the aisle who voted for All we're saying now is that since they've done nothing wrong, and since the Attorney General and -- and the Gaming Board did not look at that fact, they should have protected those individuals who came with clean hands in response to the law that we passed and say, hey, you've done nothing wrong. But they were silent on this issue. For those of you who followed your former leader and voted for that, it is your duty to protect them. don't know who all those individuals are. All this bill does is say, since you've done nothing wrong, you will be given favorable consideration. And they should be given favorable And if they're giving directions to the Gaming consideration. Board, you damn right they need directions. And it is our duty, it is our obligation to do that. I urge an Aye vote.

PRESIDING OFFICER: (SENATOR DeLEO)

Is there any further discussion? Any -- Leader Watson, for what purpose are you seeking recognition, sir? SENATOR WATSON:

Yes. Thank you very much. It's not our obligation at all. People take a risk every day. We have some pharmacists up here in the gallery. They have their reception tonight, by the way. I hope you all will go over there to see them at the Illinois Pharmacy Association's -- building from 5 to 7. But anyway, they take a risk. They take a risk every day. They invest in their business, and do you think the State of Illinois has been good to Illinois pharmacists? Do you think they've been good to 'em?

Absolutely not, but they take a risk. Nowhere did we, Senator Jones, nowhere did we do this under -- under Pate Philip's leadership did it -- was it dictated as to who's going to be -- who's going to benefit. I mean, this is ludicrous. I mean, this is something that -- and it's unfortunate that nobody from the media here is paying any attention. And, Senator Clayborne, I'm really surprised and I don't think this is you. I don't think this is you at all. But this is -- this is an area that we should not go. This is a direction -- this General Assembly should not go down this path, not at all. So, I urge a No vote and a strong No vote. This is crazy.

It -- everyone in the -- in this Body, in Chamber, knew that Rosemont was going to get a license. They were chosen under my good friend, Pate Philip, it -- it -- he -- it -- it was clear -- they -- they ended up, Senator, I -- Senator, Senator...

PRESIDING OFFICER: (SENATOR DeLEO)

Please -- please give the speaker your attention, please. SENATOR HENDON:

You are -- you are -- you are Minority Leader. I expect better conduct from you being Minority Leader in the House of Lords. This is the Upper Chamber. I have been taught to and -- and when I first got here I might have been a little rowdy like that, but I have learned that this is the House of Lords, the Senate, and -- and I'd appreciate if you'll let me finish. We were all here when Rosemont was ordained, chosen, selected. Everyone knew where it was going, so it is -- it is wrong to say that this has not been done before, that no one has -- has -- has been selected or chosen and -- and -- and remember, we are -- we legislated minority participation because sometimes - guess what?

- if we don't legislate minority participation, then -- then there will be no minority participation. We are one State. We should all work together. I appreciate an Aye vote.

Thank -- thank you. To address -- some of the concerns. Senator Lauzen, I, too, am proud of this country. people who've served this country. But, Senator Lauzen, when -when the founders said everybody was created equal, everybody In fact, they said that an Africanwasn't treated equal. American was three-fifths of a man in this country. And as a result, a lot of people in this country have been denied access to property, to the ability to -- to vote, whether it was minority or women. What has happened is, as Senator Hendon said, sometimes, well not sometimes, there are times that you must correct the wrong by trying to make people inclusive. All we're saying in this process is that they will be considered. For whatever reason, you all have taken it that they've gotten a license already, but it's just a factor in consideration. these people -- maybe these individuals may make a decision they don't want to participate. Maybe they've been soured on the process. There's not a given that they will get this license. There's not a given. We have not specifically made that determination. All we've said is that they should be considered. You know, and -- and I guess it goes to the issue of how we look at things, how we view things, but when you've been constantly denied some rights, sometimes you want a little inclusion, my You know, I can only think of what happened -what's happening in D.C. with a guy by the name -- name of Jack Abrahoff {sic} (Abramoff), where, I guess, you assume there's a pay-to-play because what has happened, and I believe most of 'em, or of your party that have participated in this process. maybe that's why you have a jaundice feeling about that. But all this is, is just a consideration. It's not a guarantee. I would ask for your favorable vote.

SENATOR CULLERTON:

Thank you, Mr. President, Members of the Senate. The Illinois law has for a long time provided that a railroad operating in Illinois maintain a police force and have police powers conferred on it. There was a recent Illinois Appellate Court ruling that kind of questioned that statutory authority. So, this bill was initiated to correct that, and at the same time, there was some issues raised by the United Transportation Union. So, it does three things. It -- it does make clear that railroad police officers are subject to the same training requirements as all other police officers and restrict the authority to employ railroad police officers to rail carriers that are -- that are registered with the Illinois Commerce Commission. So, it has to be a registered -- with the Commerce

Commission in order to have a police force. It would allow for railroads to adopt rules and policies defining the role of the railroad police officers in non-criminal employee investigations. And it says that they can exercise their power on their employer's property statewide. And, as I said, it's an agreement between the Railroad Association and United Transportation Union. It's a good bill. I'd be happy to answer any questions and ask for an Aye vote.

Senator -- Senator Crotty, on the bill.

SENATOR CROTTY:

Thank you very much. Senate Bill 2257 is a bill that has been passed out of this Body last Session. It amends the Children and Disabilities Article of the School Code regarding reimbursement for special education classes for children from orphanages, foster family homes, children's homes or State housing units. It requires that if a child who is eligible to receive services is adopted and that child continues to receive support services from the Department of Children and Family Services, then that child shall continue to be eligible to receive the services. What it basically does, is for many of the school districts that have children that are foster children and when those children are adopted, it would allow our school districts to be -- still remain whole and those children would not be dropped off of the hundred-percent reimbursement that those schools are getting from those children who are needing Many of these children have some severe services. disabilities and so for -- for us it's a happy time for kids to be adopted, but for our school districts, they still have to provide the same services to that child when -- as he was when he So, this is just to make sure that our was a foster child. school districts are also helped.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you. Is there any discussion? Senator Cronin, for what purpose you rise?

SENATOR CRONIN:

Yes. Thank you, Mr. President. I rise in reluctant opposition and -- and here's why. Senator Crotty, my friend, my colleague, who's got the best of intentions here, pointed out

that this cost three million dollars last year, and that's true. FY'07 costs fourteen million; FY'08, thirty million; FY'09, forty-six million; FY2010, up to sixty-one million; and so on and Let me make sure you understand what you're doing It sounds good, but after you've let the dust settle and, you know, you read the fine print, you're going to hear about this from your school boards. This is a zero sum game that we're There's a finite number of dollars for education. obligate the State to -- for a hundred-percent reimbursement of this group - and the policy has been that once a foster child moves to an adoptive home, it -- they're -- the adoptive parents have a responsibility - the money to pay for this program is going to come out of another categorical program. It's going to come out of another pot. So, a vote in favor of these adoptive kids - and we all want to support adoption, and do support adoption - the kids that are going to suffer may be the The kids that may suffer are going to be another foster kids. special ed community. So make no mistake about it, when you feel good about voting Yes for this bill, you're Yes vote is going to harm another group of people. And so I -- I -- with reluctance, I vote No. The responsible thing to do would be to fund both of the programs to fund special ed as we should, but we know that's not going to happen, so by voting Yes, you're helping one but you're going to be hurting another. So, I reluctantly ask for a No vote.

SENATOR CROTTY:

Thank you. I would like to respond to some of the things that my -- my colleague has mentioned. You're right. You will hear from your school board members, especially those members who are serving in school districts that will not receive reimbursement for providing the very same services to that same child only because now that child has been adopted. It will not take anything away from the foster kids that are -- already in the system because they are being -- reimbursed right now at a hundred percent. So, I would ask that all of you who voted for this before, vote for it again, because in the long run when the children are adopted and those school districts - all of our

school districts - are still serving those kids that have some profound needs, that -- that district should not be penalized because of those children being adopted. So, I just ask that we still keep up the -- the funding on those children that were wards of our State. Thank you.
