Judee Ross was killed after being struck by a car. She was taking some pictures and her family watched as a car - a drunken driver - actually hit her and killed her. She was a seventh-grade teacher. Everyone knows how hard she worked, and what happened is, he ended up going to jail, but only serving three years. We needed to clarify reckless driving or -- or aggravated homicide. What this does exactly is provide that a DUI that causes the death of a person properly be classified as homicide while driving under the influence of alcohol, other drug or drugs, intoxicating compound or compounds. So that if you -- you kill somebody, that it is considered homicide.

## PRESIDENT JONES:

Is there any discussion? Any discussion? Seeing none, the question is, shall Senate Bill 1143 pass. All those in favor will signify by voting Aye. Opposed, Nay. The voting is open. I also want to say thank you to House Member and -- Representative Brandon Phelps, who carried this bill admirably in the House, and now I am very proud to be able to carry this bill in the Senate. person commits the offense of a disorderly conduct at a funeral or memorial service when he or she does one of three things: number one, creates noise, singing, playing of music, or any other audible disruption within a two-hundred-foot zone of a cemetery entrance or any funeral site thirty minutes before and thirty minutes after that funeral; second, this person creates disorderly conduct when he or she with knowledge, again within the same parameters - two hundred feet and a half hour before and after - with any visual images or signs that contain threats,

either veiled or actual, which we call "fighting words", - that's the second way a person engages in disorderly conduct; and third, if he or she blocks the entrance of a cemetery or a funeral, that also is the offense of disorderly conduct. The first offense is a misdemeanor, Mr. President, and the second offense would be a And just to -- to give everyone in this Chamber an felony. understanding, the reason why Lieutenant Governor Quinn, why Representative Phelps and why I have worked very hard on this bill is because there are some, unfortunately, in this State that would come into our State and would disrupt a military funeral of veterans who have served honorably with courage and distinction in World War II and Vietnam and Korea. We have some Members here in this Chamber, like Senator Viverito and Senator Haine, who risked everything for our freedom and for our democracy. some would like to come to the burial grounds and the cemeteries and the funerals and spew venom because of their disagreement with certain policies in this country. Well, Mr. President, they can speak out -- they can speak out at town hall. They can speak out two hundred and one feet from the cemetery entrance. can speak out anywhere in a public place, but we feel that the zone of privacy for the families of men and women who are currently serving in Iraq and Afghanistan, who lose their lives fighting for freedom and fighting for our democracy and our country, those families and our loved ones who perish overseas fighting for America deserve privacy and they deserve the ability to bury their loved ones in peace. This is the Let Them Rest in Peace Act and it's called that because these men and women deserve the right to be laid to rest with honor in a peaceful, calm atmosphere so that their families can say goodbye and so that we all in Illinois can pay respect and tribute and keep others away from those funerals and those burial grounds, pay respect and tribute to our American heroes, men and women that were born and raised right here in Illinois, that have with courage gone overseas to fight for our country. constitutional. It is not content-based. It is a reasonable time, place and manner regulation of speech, and we believe, I believe, strongly that any court in America will uphold this law. I -- I've in the past, you may recall, we -- I objected to the violent video game bill, stating that it was unconstitutional, which has proven to be true, and as well as the denial of the -- the COLA for the judges, and this one I am very concerned about and there's no question that it will challenged in court, but I really believe that the sponsor, Senator Wilhelmi, has done a -- a very good job in trying to answer the issues concerning the constitutionality, such that I learned since the committee that the ACLU is neutral on the bill, so obviously they've come a -- a long way. The other benefit to passing this bill is that there's a particular individual who has this desire to -- to demonstrate at these funerals that's the cause of this legislation. And in the states that have banned or ban attempted to this practice, whether constitutional or not, he has gone to another state. So, it's actually worked for the purposes for which it was -- it was There is a problem. If -- if it's challenged and we lose, we have to pay the legal fees, not only for ourselves, the State in defending the bill, but also the -- the winning side, if you will, and that did happen in Kansas, but that bill was drafted in a more reckless way than this one, and so hopefully this will be upheld and the offensive behavior, while at the same time protecting people's right to -- to -- to speak in this country will be -- the offensive behavior will be ended and the right to -- to speech will be upheld. So, I compliment the sponsor and ask for an Aye vote.

Any further discussion? Senator Geo-Karis. SENATOR GEO-KARIS:

Mr. President and Ladies and Gentlemen of the Senate, I think this is probably a -- a bill that will stand constitutional action. It's -- it's only -- only fair for heaven sakes when

Thank you very much, Mr. President and Members of the Ironically, one week ago while this bill was being debated in the Judiciary Committee, I was attending a military funeral, that being of my oldest brother who served in the Second World War, fought at Omaha Beach in Normandy on -- June the 6th, I find it hard to imagine that any person could have such a twisted, warped view of so-called -- their view of the socalled Christian religion that they claim to espouse, that they would seek to interfere with what Senator Haine most beautifully described as a sacred ritual. I know it was extremely hard on members of -- of my -- my brother's family when we laid him to rest and to have individuals show up to disrupt this most sacred ritual, seems to me highly appropriate that this is the type of activity that if we ever criminalize anything, that this ought to be criminalized. And so, Senator Wilhelmi, I again -- I join others in commending you for bringing forward this legislation. This is no longer in my eyes something that's theoretical. would have hated to have walked through a -- a -- and be picketed by a group of vermin that would show up in attempt to -- to take away vestiges of nobility that should surround such a sacred ceremony. SENATOR JACOBS:

Senator, I also want to thank you for taking the lead on this issue and how you spoke so eloquently. You did a very good job and I think this passes constitutional muster, also. But my question does go to preserving the First Amendment. How do we make sure that the people that have the right to speak, have the right to speak? I mean, what -- what is it exactly about your bill that makes it constitutional?

Senator Jacobs, the highest court in the land has determined that speech can be regulated, but there are certain parameters that must be met for it to pass constitutional scrutiny. And those tests include whether the regulation includes and contains reasonable time, place manner restrictions. And what this bill does is it has a twohundred-foot buffer. It's a half hour before and then through and a half hour after the funeral service and those in my mind are reasonable time, place and manner restrictions. In addition to that, there's a court case Burson versus Freeman - this is a United States Supreme Court case - that allowed that same kind of a buffer - it was a hundred feet in that case - and we all know that in our -- around our polling places, we're regulated on where we can go and what we can say a hundred feet from the polling places. Similar to this bill, you're limited to what you can do and say in a two-hundred-foot zone from the gate or entrance of a cemetery or funeral. And that's why, Senator Jacobs, I believe that this bill is constitutional. It applies to all funerals. I believe that the courts will uphold this law, and -- and they should.

Thank you, Senator. So I understand, so if I'm two hundred feet away, I can protest all I want to protest, but if I'm closer than two hundred feet, I can't protest?

Thank you, Mr. President. That is correct. If you're two hundred and one feet away from the -- the door of the church or the gate of the cemetery, you can say whatever is within the law and -- and this -- this -- this speech, and this conduct and these signs, you can bring those out two hundred and one feet away. Obviously, the intent of this legislation is to keep the group from Kansas far away from Illinois, but if they so choose to come to Illinois, they are not allowed within that two-hundred-foot buffer zone, and I believe it's constitutional, Senator.

### SENATOR FORBY:

Thank you, Mr. President. To the bill: I want to thank the speaker for this bill. I've been at a funeral. I've seen what happens in my district. It is disgusting. If we have -- if this goes to court, and we have a judge for this, he needs to be at one of them funerals first to see it firsthanded. This is pathetic. This bill will be good. Two hundred feet is not far enough away, but it's something to work with, but this is something to work with and I'm glad the sponsor is running this bill. But I hope everybody keeps their eyes open 'cause our veterans -- if it wasn't for them, we wouldn't be here today. PRESIDENT JONES:

### SENATOR CLAYBORNE:

Lightford. Out of the record. Wait a minute. House Bill 4339. Mr. Secretary, read the bill. Senator Lightford. Lightford seeks leave of the Body to return House Bill 4339 to the Order of 2nd Reading for the purpose of an amendment. Seeing no objection, so ordered. On the Order of 2nd Reading is House Bill 4339. Mr. Secretary, read the bill. Mr. Secretary, have any amendments been approved for consideration?

### SENATOR LIGHTFORD:

Thank you, Mr. President. Ladies and Gentlemen of the Senate, this bill addresses inner-city student transfer assistance. There are twenty-eight community colleges that currently participate in the Minority Student Transfer Centers. The original funding amount some years ago was two million dollars. That amount has been eroded drastically down to nine hundred and sixty-six thousand three hundred dollars. That was only appropriated for this area. What myself and Representative Collins would like to do is establish a three-year pilot program to include all of the City Colleges in Chicago and a number of the community colleges listed so that we can continue to advance our students from two-year community colleges to four-year universities. I'd be happy to answer questions.

#### PRESIDENT JONES:

Is there any discussion? Any discussion? Senator Luechtefeld.

### SENATOR LUECHTEFELD:

Thank you, Mr. President, Members of the Senate. You know, first of all, a question, Senator. What did -- and you may have said this, but I didn't hear it. What will this cost us approximately?

### PRESIDENT JONES:

Senator Lightford.

# SENATOR LIGHTFORD:

Two million four hundred.

## PRESIDENT JONES:

Senator Luechtefeld.

## SENATOR LUECHTEFELD:

I -- I guess, you know, the idea of -- of making that transition between the community college and four-year schools is great. You know, we -- we need to try to continue to do that, but I -- I think that's what colleges should be all about. I can't imagine that we want to start and add some more money to try to tell colleges and help colleges do what they - community colleges - what they are already supposed to do. You know, all of them have counselors. All of them attempt to do this. This basically gives some colleges, I think maybe -- I really don't know, many of them are the City Colleges. I think there's one

maybe in Champaign that is going to get money to do this. I guess I -- I'm saying this is not a bad idea, but I just think it's the wrong way to go about it and -- and I -- I know that this is probably going to fly out of here, but at least I would like a -- a number of Senators to give this some thought. Is this really what we want to do? We're going to give community colleges some extra money to see to it that they -- students make the transition between community colleges and four-year schools. Isn't that what they're all about already? Why would we want to do -- there are so many other problems we have that are much, much bigger than this. Let them put their resources there, the money that they already have. If they think it's so important, then they need to do it and they are already doing that. So, again, it won't change maybe a lot of votes, but I just think this is really an unnecessary bill. Thank you.

#### PRESIDENT JONES:

Senator Link in the Chair.

PRESIDING OFFICER: (SENATOR LINK)

Senator Burzynski.

### SENATOR BURZYNSKI:

Thank you, Mr. President. Will the sponsor yield for a question?

PRESIDING OFFICER: (SENATOR LINK)

Indicates she will.

### SENATOR BURZYNSKI:

Thank you. Senator, I'm looking at the synopsis of the bill and I -- I remember this from committee obviously and we were talking about this, but just a couple of questions. Is the intent to help students who are, say, sophomores at a community college transfer or -- or to help assist them in knowing the ropes and -- and everything it takes to get into a -- a university? Is that the intent?

PRESIDING OFFICER: (SENATOR LINK)

Senator Lightford.

### SENATOR LIGHTFORD:

Yes, and in fact, what it would do is provide two counselors -- well actually, one coordinator and one recruiter at eleven or twelve institutions. And there's a list of responsibilities and duties that each individual would hold. The coordinator would be

responsible for working with the district's academic advisement staff to develop a program plan that will transition students to universities. They would interface with university admissions department to assist students during the transition. assist students with course selections, majors, housing, child care and financial aid. They would track student progress and the effectiveness of campus activities. They would implement a transition strategy and work with students on that strategy. They would interface with the president, the deans, the academic advisors, faculty, staff and program directors. oversee the activities of the recruiter. They would assist students in filling out applications and finding a university match. They would establish financial aid initiatives and assist students in finding and applying for funding sources and they would also coordinate housing arrangements, and that's the coordinator's duty. Then we also would like to have a recruiter involved and the recruiter would identify transfer candidates by working with deans and faculty. They would develop and recruit strategies, include a proactive campus recruiting strategy that will attract dedicated students. They would design, implement and execute on-campus recruiting activities, including campus fairs, information sessions, workshops and seminars. They would create on-campus marketing and communicating strategies awareness and to educate students the increase opportunities that exist with universities. They would develop and maintain a partnership with the deans, program directors, professors and academic advisors. Establish partnerships with university, as well as other institutions of higher ed and trade and they will report program effectiveness to coordinator. So, what's actually happening, Senator, is that right now we have twenty-eight community colleges that sharing nine hundred and sixty-six thousand dollars and my example would be, you have Rock Valley College only receiving eighteen thousand one hundred and twenty-two dollars a year. There is no way that they can hire a coordinator and a recruiter and they only have eighteen thousand dollars for the entire You also have Kankakee Community College who only received twenty thousand nine hundred and ten thousand and then you have Lincoln Land Community College right here in Springfield

who only received twenty-one thousand, and so that's why it's important that we increase this program back to the original funding of two million dollars so that these colleges have a fair chance. They -- they don't have the ability to hire the coordinators or the recruiters to actually do an effective job.

PRESIDING OFFICER: (SENATOR LINK)

Senator Burzynski.

#### SENATOR BURZYNSKI:

Thank you. For a moment I thought you were filibustering, but reading that long list. Senator, it -- it seems to me like what you're trying to get at is -- is increasing funding to community colleges so they can reach out to these students and help them matriculate into a four-year university. Most four-year universities do have recruiters that work very closely with the community colleges. So I think that takes care of part of the aspect that you're talking about. But is it -- are -- are you saying that -- that there's an original program out there that used to be around two million dollars and it's been cut and what you're trying to do is restore that?

PRESIDING OFFICER: (SENATOR LINK)

Senator Lightford.

### SENATOR LIGHTFORD:

Yes. Actually, there's a program of funds that was received through HECA and it was the Minority Student Transfer Centers, and those are the ones that's being reduced drastically. And I only expressed all that information to you just in case it was not shown on your prompter so that you can understand the relationship and what the schools are not receiving. So the Illinois Community College Board has a difficult time on implementing a program with very little funding and hiring two individuals. They only want a coordinator and a recruiter, and there's no way anyone will work for a shared amount of eighteen thousand dollars.

PRESIDING OFFICER: (SENATOR LINK)

Senator Burzynski.

### SENATOR BURZYNSKI:

Thank you, and I'll be quick now, Mr. President. I understand that. I guess I have one question. It seems to me -- or a couple of comments. First of all, it seems to me, it'd be

better to put the money into the existing program, rather than to establish a brand new program. You've already got the people there. You've already got everything set up, number one. Number two, Senator, just a -- a follow-up question: Is this subject to appropriation?

No.

PRESIDING OFFICER: (SENATOR LINK)

Senator Burzynski.

#### SENATOR BURZYNSKI:

Well, to the bill then: It -- it just seemed -- and to the -- to this concept, it seems to me that in a time when our community colleges, all of them throughout the State, need additional assistance, when our public universities need additional assistance, that we really don't need to be establishing a new program. This is really the thing that community colleges are supposed to be doing. This is their mission, is to prepare students already to get into that four-year university, to know how to articulate their coursework and everything else. It seems to me there's some redundancy. I would urge a No vote. Thank you.

PRESIDING OFFICER: (SENATOR LINK)

Senator del Valle.

# SENATOR DEL VALLE:

Thank you, Mr. President. Just in responding to that very last comment by Senator Burzynski, first: This isn't redundant. As a matter of fact, what this effort represents is an attempt here to strengthen current efforts. There is a history here. The minority student transfer programs were established many years ago, but the fact of the matter is that they have been very weak efforts, in part because we haven't funded them at the -- at the level that they need to be funded and also because of the failure of IBHE and ICCB to provide proper oversight, to evaluate programs, to establish performance standards and to ensure that these programs are meeting the -- the original intent of -- of the Minority Student Transfer Centers, which is to take minority students who are nontraditional students who are lacking

information on higher education opportunities, who information on financial aid opportunities and providing the kind of academic counseling, intensive counseling, that's needed in order to ensure that they can transition successfully from a twoyear college to a four-year college. We know what the statistics are. The number of African-Americans and Latinos, in particular, going on to four-year colleges is extremely, extremely low and, in -- in some cases, declining and so this effort and this program is an attempt to strengthen existing efforts. Now, it's important that IBHE and ICCB come together and look at what we need to do to make better use of the nine hundred and sixty-six thousand dollars which represent a significant reduction over the original amount and make better use of those dollars to hold these programs accountable at these community colleges. And so, this bill does something - and this is a key point - that was not in the original effort and that is that it clearly defines the function and the purpose of these transfer centers and how they're going to use staff to provide the kinds of services that are going to ensure successful transition for these students. I thank Senator Lightford for moving this forward, because it's going to force - this bill is going to force ICCB and IBHE to make better use of the dollars that are currently available, as well as supplement those existing dollars, so that we could do the job that needs to be done with our minority students throughout the State.

PRESIDING OFFICER: (SENATOR LINK)

Senator Harmon.

## SENATOR HARMON:

Thank you, Mr. President. I rise in support of Senator Lightford's bill. This will be of great service to community college students I represent in both the city and -- and suburban portions of my district. I applaud the Senator for advancing it and I urge you all to vote Aye.

### SENATOR DAHL:

Thank you, Mr. President. To the bill: You know, just a few minutes ago, we had a -- a bill that passed here, Senate Bill 1144, that Mr. Wilhelmi so elegantly proposed with regards to the

veterans, which I totally agree with, and we're also -- as we're all aware, right now in our community colleges, we're not funding our veterans. We're -- we're taking money away from them and it -- it's not being spent for what it's supposed to be spent for and now we're going to take another two million dollars on -- and spend it for another program when we're not funding what we're already obligated to fund. I think it's time that we became physically responsible, do what we're supposed to do. Before we start voting for new programs and new expansions, let's take care of the people we're supposed to be taking care of and -- and put this money back into the veterans where it's supposed to be at the community college. I urge a No vote.

### SENATOR HENDON:

Thank you, Mr. President. I just want to remind the Body that minorities are veterans, too. Minorities serve this country just like anyone else. This is a program already established. Senator Lightford is just trying to make sure that the community colleges have the help that they need to help these young people and race should not enter -- be left out of this as if it's a non-factor. We understand that minority students have a tougher time at it, but minorities serve this country just like everyone else. The two bills are not related, whatsoever. We voted for Wilhelmi's bill, and I urge a vote for Senator Lightford's bill. PRESIDING OFFICER: (SENATOR LINK)

Senator Hunter.

## SENATOR HUNTER:

Thank you, Mr. President. I rise in support of this bill and I also would like to commend this -- the -- the sponsor for sponsoring this bill. As we all know, community colleges bridges the gap between high school and a four-year university. Many of our children simply cannot survive in a four-year institution -- educational institution. So therefore you have the community college system there to assist the kids and they get more support there. And this is a wonderful, wonderful bill and I urge everyone on the Floor to support this bill. Thank you.

It's expanded to cover a situation where the child's parent is deceased or has been missing for at least three months, the parent incompetent, or the parent has been incarcerated. It provides that an adoption shall terminate the visitation rights of a However, if the adoption is within the family, a relative. relative may petition the court for visitation rights, but the relative must follow the same procedure that they -- that a

person does when they seek visitation rights. It requires the court to consider caregiver status when determining whether to grant visitation to a relative. And the bill clarifies that a child's parent can always petition to modify a visitation order. Well, Senator Dillard, one thing that we want to make sure is that the -- the results of the bill are -- is effective for all the people of the State of Illinois. We want to make sure that if we give a tax credit to anyone - and this is a -- sort of like a Republican idea turned Democrat - if we give a tax credit to anyone, we want to make sure that it works and that it's working for the people of the State of Illinois. That's why - if we look at it, it was one year - I was able to talk some of the powers to be into making it two years because of the series that are planning to come here right now. And we'll look at it. If it works, then we'll look at it later making it gradually four years or more. I do understand where you're coming from, but we want to be able to look at it as often as possible.

PRESIDING OFFICER: (SENATOR LINK)

Senator Hendon, to close.

### SENATOR HENDON:

That's a wrap.
