It's a little bit confusing when you look at the title of the bill, but I do think everybody on the Republican side in committee supported it. I think it is a good program that's set up. There's plenty of safety measures for young people who are fifteen/sixteen year old -- years old. And it seems like, really, the clear intent was to protect from human blood and potential of contamination there, which obviously wouldn't be a concern in a -- a veterinarian's office. So, we did support it, but wanted just to kind of highlight so Members of our side of the aisle understood this a little bit more.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you. Thank you very much. Senator Frerichs, to close, sir.

SENATOR FRERICHS:

I have nothing more to say. Thank you very much, Mr. President.

PRESIDING OFFICER: (SENATOR DeLEO)

Seeing no further discussion, Ladies and Gentlemen, the question is, shall House Bill 3165 pass. All those in favor will

Continuing on House Bills 3rd Reading, on the bottom of page 44 of your Calendar is Senate Bill -- House Bill 3382. Senator Wilhelmi, do you wish to proceed, sir? He indicates he wishes to proceed. Madam Secretary, read the bill.

SECRETARY SHIPLEY:

House Bill 3382.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Wilhelmi, to the bill, sir.

SENATOR WILHELMI:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. House Bill 3382 provides that a defendant who has previously been required to register under either the Sex Offender Registration Act or under the Child Murderer and Violent Offender Against Youth Registration Act, who thereafter becomes required to register under either of the Acts, shall be required to register for the remainder of his or her natural life. There are two separate statutes. If you are an offender of one, you have to -- the way it is now, you have to be an offender on that same statute a second time before you're required to register for life. Under this bill, either -- either charge would make you register for life a second time. I'd be happy to answer any

Thank you. Is there any discussion? Is there any discussion? Seeing no discussion, Ladies and Gentlemen, the question is, shall House Bill 3382 pass. All those in favor, vote Aye. All those opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Madam Secretary, take the record. On that question, there are 55 Ayes, 0 voting Nay, 0 voting Present. House Bill 3382, having received the required constitutional majority, is declared passed. House Bill 3393. Senator Raoul, do you wish to proceed, sir? He indicates he wishes to proceed. Madam Secretary, please read the bill.

SECRETARY SHIPLEY:

House Bill 3393.

(Secretary reads title of bill)

Senator Raoul, to the bill, sir.

SENATOR RAOUL:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. House Bill 3393 amends the State Finance Act to create the Married Families Domestic Violence Fund as a special fund in the State treasury. Subject to appropriation and approval by the Attorney General, the monies in the fund must be used as grants to public or private non-profit agencies solely for the purposes of facilitating or providing free domestic -- violence legal advocacy, assistance, or services to married or formerly married victims of domestic violence. I urge your support and I'll yield

to any questions.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you. Is there any discussion? Is there any discussion? Senator Lauzen, for what purpose you seek recognition?

SENATOR LAUZEN:

Thank you, Mr. President. A question for the sponsor.

PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates he'll yield for a question, sir. Senator Lauzen.

SENATOR LAUZEN:

Do I understand the -- this legislation correctly, that there's going to be a fee put onto -- like the -- the process of getting a marriage license and being able to move forward on a -- on a marriage, that a fee is going to be placed on that in order to -- on all marriages in order to help fund where there's violence in some marriages?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Raoul.

SENATOR RAOUL:

Yes, the -- the fee would be on marriage licenses, which would apply to all marriages, for a domestic violence legal advocacy fund.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Lauzen.

SENATOR LAUZEN:

Then let me ask you the question, and I -- I'd ask you to -- to respond to this, that I've been asked about this bill. A person asked me - who I respect - asked me why would or should

good marriages have to pay for potentially violent ones? PRESIDING OFFICER: (SENATOR DeLEO)

Senator Raoul.

SENATOR RAOUL:

You know, we -- we fund all sorts of different programs with -- with all taxes that we pay. And that we fund our criminal justice system with the funds paid by each taxpayer, doesn't mean that each taxpayer has committed some criminal act. So under that same philosophy, what we're trying to do is help victims of domestic violence, which I hope that every Member in this Chamber would want to do that, notwithstanding the fact that the Members of this Chamber might not engage in domestic violence or might not be victims of domestic violence. And so it would be that philosophy that would support charging these fees on -- on marriages.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you. Further discussion? Senator Righter, for what purpose you seek recognition?

SENATOR RIGHTER:

Will the sponsor yield, please?

PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates he'll yield for a question, sir.

SENATOR RIGHTER:

Thank you.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Righter.

SENATOR RIGHTER:

Senator Raoul, it's -- I -- and I was obviously not in committee when this was presented. It's my understanding,

however, that previously, either as a part of the bill or in an amendment that was going to be put on the bill, there was language that would have provided for protection against sweeps for this fund. So I guess a two-part question: One, is there language as the bill is being presented now that protects from fund sweeps? Second, if there is not, why not?

Senator Raoul.

SENATOR RAOUL:

No, there's no such language, but we feel pretty confident that the -- the -- that the fund would be left alone.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Righter.

SENATOR RIGHTER:

Well, I appreciate that, Senator Raoul, and I think all of us have had an abundance of confidence that certain things wouldn't be swept - newborn screening fees and other issues like that - and they wound up being swept. So, I guess, why isn't there language on there explicitly to protect that, Senator Raoul? I mean, if you're going to go the step of telling couples who are going to get married that they're going to pay more, is it that much farther to go to say, "and we're going to put a little insurance in here to make sure that it's not taken for other purposes"?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Raoul.

SENATOR RAOUL:

You know, in each bill, there -- there -- there can always be language slapped onto it to protect against our fears, but,

you know, I -- I try to keep the -- the bills that I introduce limited in the -- in the language. Our Codes are so -- are -- are -- are so expansive already that, you know, I have confidence that the -- the fund will not be touched.

SENATOR RIGHTER:

To the bill, sir.

Thank you. I appreciate, first, Senator Raoul's concern for the fact that the Illinois Compiled Statute volumes are getting too thick, and that's why he decided we shouldn't have language in there protecting this important fund from being swept. Having said that, I think this fund clearly should have that language in there. We've all seen instances where have there been -- there have been sweeps in funds in the State treasury, where we all rolled our eyes or shook our heads and said, "Wow, why would we allow for that?" And I think if this doesn't have that kind of language, we are walking exactly down that road with this -- with this particular fund. And so for those Members who are considering voting for this and you're concerned about where the money is going to go, I would urge caution. Thank you, Mr. President.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Senator. Further discussion? Senator Dillard. SENATOR DILLARD:

Thank you, Mr. President. I very reluctantly rise in

opposition to this bill. I voted for it in committee primarily as a favor to the sponsor - whom I consider a good friend and somebody that I very much respect - to help him get it out. But upon further reflection, Senator Carl Hawkinson, who represented his area of western Illinois for years and used to be the Chairman of the Judiciary Committee, always, always had problems with a tax on marriage. And this is a tax on marriage, and Senator Hawkinson harped, for those of us who are on that committee, for years that taxes on marriage are a bad thing. And I understand Senator Raoul's nexus here, and I'm somewhat sympathetic. But without the sweeping or anti-sweeping of fund provision in here, I just don't think it's worth taking the risk. You know, the back of my money may say "In God We Trust", but in Rod I do not trust. And until we get some type of assurance that a tax on marriage will not be swept for some other purpose I might not agree with - and I certainly think combating domestic violence is a very worthy cause - I'm not willing to make this commitment and I'm going to change my vote from a Yes in committee to a No here on the Floor. Thank you.

PRESIDING OFFICER: (SENATOR DeLEO)

Further discussion? Further discussion? Senator Murphy. SENATOR MURPHY:

Thank you, Mr. President. To the bill. I applaud...
PRESIDING OFFICER: (SENATOR DeLEO)

...bill, sir.

SENATOR MURPHY:

I applaud the sponsor for his attempt at funding this very worthy cause. I -- I applaud the groups -- behind it for their creativity in trying to get themselves the funds they need to

fight this scourge. But I think it's -- I -- I think it's rather shameful that, frankly, we have pushed these groups into this level of creativity to get the funds they need to stop domestic violence. This is estimated to raise about nine hundred thousand dollars. This ought to be a line item in the Attorney General's budget in this year's budget so that they can fund this program properly without a tax on marriage. What you're hearing from this side of the aisle and, frankly, I think from many on the other side of the aisle, is we support the program, we support the level of funding, we're opposed to a marriage tax as a means to do it. It's reprehensible that they need to go to these -- these Legislative gymnastics to actually get this money. So I, unfortunately, am now also in a position to urge a No vote.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Senator. Further discussion? Senator Carol Ronen. Good afternoon, Senator. How are you?

SENATOR RONEN:

Good afternoon, Mr. President. I'm very well. Thank you. It's good to see you.

PRESIDING OFFICER: (SENATOR DeLEO)

...purpose do you rise, ma'am? SENATOR RONEN:

I -- I -- I rise in support of this piece of legislation and I want to thank Senator Raoul for putting this forward. And I just want to say to the -- people, you can't have it both ways here. You can't say you support the services that this small fee increase will provide and then not vote for this bill. You can't say you support the groups who have come up with this plan, not who were forced into this plan, but have come together to say

this is a commonsense way to raise revenue for a very, very needed service. And we're not talking about a big tax increase. Let's be clear here. We're talking about a five-dollar increase on a marriage license; a fee that hasn't been raised in a long time. So if you're against domestic violence, if you think it's wrong, if you support the women's organizations and the domestic violence shelter and the antiviolence groups that have been working so hard on this bill with Senator Raoul, then the only way you can vote is to vote Aye. So I would ask all my colleagues to join Senator Raoul in this very important bill. PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Senator. Further discussion? Senator John Cullerton.

SENATOR CULLERTON:

Yes, thank you, Mr. President, Members of the Senate. Obviously, I'm -- I'm supportive of the bill, but the -- the comments about the tax on marriage reminded me of -- of something that -- there was a bill that I sponsored a few years ago that passed with forty-one votes here, which was an unusual coalition of divorce lawyers and Christian right-type organizations, that actually imposed a thirty-day waiting period before you got married to discourage people from getting married who had not really thought through the -- their decision, and actually, kind of - you could avoid the thirty-day waiting period if -- if you had had some kind of training with a minister, like the Pre-Cana that the Catholic Church offers - under the recognition that some marriages should not be entered into. And the actual divorce rate would be lower if we didn't have some of those marriages. So I -- I would just say that if there's a fifteen-dollar fee

that's added to a marriage certificate and that's a reason why you wouldn't get married, because now it's going to cost fifteen dollars more, maybe that's a marriage that you shouldn't be entered into in the first place. The other thing was that at the committee, someone testified that marriages now are really expensive. They cost like ten thousand dollars, okay, for a marriage. When -- when Senator DeLeo's daughter gets married, the cake is going to cost ten thousand dollars. So I don't think that it's really a tax on a marriage. Come on, it's not a tax on a marriage. The -- the fact is that the bill as originally drafted was probably unconstitutional. I'm very cognizant of Hawkinson's views that we should not unconstitutional fees. This one is so directly related to the benefit that it is constitutional and we ought to vote for it.

Thank you. And -- and -- and I appreciate the sentiments of -- of all who has spoken to this bill. And what -- what I think I've heard consistently from both those who say that they're now opposing the bill, while they voted for it in committee, and those who spoke on -- on my side of the aisle, is that -- that this is a worthy cause. And five dollars - five dollars - on a -- on a - five dollars - on a marriage license fee is what we're talking about here. Five dollars. And if -- if these domestic violence legal advocates, who do good work, very good work, are not worth the five dollars, you explain it to your voters. I urge a Aye -- Aye vote.

House Bill 3394, having received the required constitutional majority, is declared passed. House Bill 3412. Senator Wilhelmi. Do you wish to proceed, sir? He indicates he wishes to proceed. Mr. Secretary, please read the bill.

ACTING SECRETARY KAISER:

House Bill 3412.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Wilhelmi, to the bill, sir.

SENATOR WILHELMI:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. House Bill 3412 creates the Taxi Safety Act of 2007.

Under this legislation, a couple things must take place in our taxicabs in the State of Illinois. First, there -- if there is a collision with a pedestrian that results in bodily injury, the responding law enforcement officers must test the taxi driver for drug and alcohol use. Second, inside the taxicab, there must be certain information posted about the taxi driver and the cab, including a photograph, the driver's license number, as well as the medallion number on the outside. That way, if you're in a taxi and the driver is driving -- recklessly or dangerously, you can call the police, you can call 9-1-1, and you can report the number of the taxi, the driver's license number of the -- of the driver. And the -- the police officer will then help you, get you out of that vehicle so that no damage occurs. Unfortunately, this results from a death of a resident in my district - a young lady, who was on her way to dental school to follow in her father's footsteps. She was killed by a taxi driver as a pedestrian in Chicago - a terrible, tragic accident. This will make us all safer when we're driving in taxicabs in the City of Chicago. We've revised it so that the City is neutral. into consideration some of their concerns and I would be happy to answer any questions. I ask for an Aye vote.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you. Is there any discussion? Is there any discussion? Senator Cronin, for what purpose do you rise, sir? SENATOR CRONIN:

I'm just wondering, Senator -- for a question. What if you can't pronounce the name of the -- I mean, I -- I don't mean that in a disparaging way. But do you know what that symbol is that - in the consonants? It looks like the symbol for boron. Do you

know what that letter is?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Wilhelmi.

SENATOR WILHELMI:

I'm sorry, Senator, I do not. But the good news is there's a number in the cab and the number will identify that vehicle. Because, of course, if you call the police and said, "I'm in a yellow taxicab in the City of Chicago" - one of a thousand or so. So there is a number and it's called a medallion number.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Senator. Further discussion? Senator Watson.

SENATOR WATSON:

Yes, thank you. Question of the sponsor.

PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates he'll yield for a question, sir. Senator Watson.

SENATOR WATSON:

Does this impact Chicago only?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Wilhelmi.

SENATOR WILHELMI:

Want to make sure I understood the question. Did you say does it impact Chicago often? Oh! Only. No, no it does not. This is a statewide program.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Watson.

SENATOR WATSON:

Well, I guess my question would be then, what is the definition of a taxi?

Senator Wilhelmi.

SENATOR WILHELMI:

A -- a taxicab -- thank you, Mr. President. A taxicab would be a vehicle used to transport people to and from their places of destination. And I believe that it would be for hire and it would be pretty obvious because most of these vehicles have the word "taxi" on them.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Watson.

SENATOR WATSON:

Well, we -- we have senior vans, senior citizen vans. We have people who drive schools' fifteen-passenger vans. We have a -- a multitude of transportation available that aren't necessarily what I would consider to be a taxicab. Are they impacted?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Wilhelmi.

SENATOR WILHELMI:

Thank you, Mr. President. I don't believe they are, Leader Watson. I believe that this, again, is for vehicles for hire that are traditional taxicabs and this does not extend to the examples that you've given here this afternoon.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Watson, for further discussion.

SENATOR WATSON:

Yes, thank you. Would you please point that out in the bill, Senator?

PRESIDING OFFICER: (SENATOR DeLEO)

SENATOR WILHELMI:

Senator Watson, that is not in the bill. Again, I believe that the -- the word "taxicab" is defined in the Vehicle Code and I -- I believe that it would be, as I said before, a vehicle for hire as we know traditionally a taxicab to be.

PRESIDING OFFICER: (SENATOR DeLEO)

Further discussion, Senator Watson.

SENATOR WATSON:

Well, I understand this is a new Act. It does not identify or address the Vehicle Code. So, therefore, I would assume taxi would be considered a very arbitrary term.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Wilhelmi.

SENATOR WILHELMI:

Senator Watson, I appreciate this line of questioning because I want to make it clear on the record and for legislative intent purposes. I want to make it clear that the vehicles that we are contemplating in this legislation are limited to a taxicab as a vehicle for hire that reflects the word "taxi" on it, does not extend to the -- the -- the small or larger vans that are used to transport elderly folks or people with disabilities. And I appreciate the question.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Watson.

SENATOR WATSON:

Would also that include a little thing on the top of -- of the vehicle that says "for hire" or "not for hire"? I'm just kidding. I'm just kidding.

She indicates she wishes to proceed. Mr. Secretary, please read the bill.

House Bill 3425.

(Secretary reads title of bill)

Senator Garrett, to the bill, ma'am.

SENATOR GARRETT:

Yes, thank you very much, Mr. President. House Bill 3425 allows local municipalities to study, for four years, alternative ways in which to control the deer populations within their own municipalities. This bill would sunset on January 1, 2014. I'd be happy to answer any questions.

...you. Is there any discussion? Senator Sieben, for what purpose you seek recognition, sir?

SENATOR SIEBEN:

Question for the sponsor.

Senator Garrett.

SENATOR GARRETT:

Yes, thank you. Currently, right now, one community that I represent, Highland Park, is working with the University of Wisconsin in coming up with a program of spaying deer or taking - making sure that without culling the deer that they have some sort of control over -- over -- over the deer population. So, really what this is, is allowing communities to work with authorities to make sure that they do this under guidance.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Sieben.

SENATOR SIEBEN:

Thank you. Can you explain also what the involvement and what role that the Department of Natural Resources would play and how would the Department of Natural Resources be involved in these studies and these control methods?

Senator Garrett.

SENATOR GARRETT:

Yes, thank you. The municipality would be reporting back to the Department of Natural Resources. So, Department would have

Now, to the bill: I rise in strong opposition to this legislation because part of the language would require that the DNR must - that the DNR must - permit the local government to implement these alternative methods. DNR is strongly opposed to this bill because the authority to regulate wildlife in this State has always been granted to the State and not to unit of local government. So the effect of this bill is to signal a shift in that authority. I think that's a dangerous precedent to start. Also, the Department of Natural Resources tells me that they're opposed to the legislation from a biological stand -- standpoint, because they do not believe this method of -- of deer control will work or is cost-effective. So I would suggest a No or Present vote.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Senator. Further discussion? Senator John Sullivan, for what purpose you seek recognition, sir? SENATOR SULLIVAN:

Yes, thank you. A question of the sponsor.

PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates she'll yield for a question, sir. SENATOR SULLIVAN:

Yeah. Senator, I understand that -- that there was a study done, I believe, in Highland Park - Is that correct? - that was done to try to address the overpopulation of deer. Is that correct?

Senator Garrett.

SENATOR GARRETT:

Yes.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Sullivan.

SENATOR SULLIVAN:

And -- and was this done with -- in -- in the coordination with the Department of Natural Resources?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Garrett.

SENATOR GARRETT:

It was done in conjunction with the Department of Natural Resources and the University of Wisconsin.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator John Sullivan.

SENATOR SULLIVAN:

So what was the -- the Department of -- the results of the study, did the Department of Natural Resources agree with those findings?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Garrett.

SENATOR GARRETT:

The Department of Natural Resources - which in -- in all fairness does not support anything other than hunting when it comes to the culling of deer - I thought was pretty neutral on it. They -- they purported that the findings didn't show any real significant change either way.

PRESIDING OFFICER: (SENATOR DeLEO)

SENATOR SULLIVAN:

Yes, the Department is -- is not neutral on it. They're very much opposed and were not in agreement with the -- the findings of the study. In -- in fact, I just want the Members to know that they -- during that study, they sterilized -- they sterilized deer. And to do that - you can imagine - you have to capture the deer; you have to actually make a surgical incision. And over half of the deer that were sterilized ended up dying. They were -- they died from the procedure. Then they -- they did -- they had a controlled area and a treatment area, and they actually looked at to see if there was a -- a reduction in the deer population in the controlled area versus the treatment area. And indeed there was absolutely no difference, because deer -migrate, they move around, they -- they -- they aren't confined to a -- to a -- a certain area. This, as Senator Sieben mentioned, takes the control away from the Department of Natural My last -- I guess I'll make it as a statement Resources. instead of a question is that this bill went before the Local Government Committee. If you look at the bill, it amends the Wildlife Code. This should have been in the Conservation and Aq Committee. I ask for a No vote.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you. Further discussion? Senator Mike Jacobs, for what purpose you seek recognition?

SENATOR JACOBS:

Question of the sponsor, Mr. President.

PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates she'll yield for a question, sir.

SENATOR JACOBS:

Senator, are -- are there -- are there currently laws in Illinois that keeps a city from studying this -- this issue?

Senator Garrett.

SENATOR GARRETT:

Well, of course any municipality can take on whatever issue they want to study. There's no law against that.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Jacobs.

SENATOR JACOBS:

In the affirmative then, why do we need the law? If they have the right to already study this, why do they need the State nanny to say you can do it?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Garrett.

SENATOR GARRETT:

You know, it's a good question and I think this bill points out the diversity of this State. In heavily populated areas where we see the deer population growing dramatically, there are many communities that really can't hunt the deer down. We don't do that. It just isn't allowed and we don't have a hunting season. So, hunting, you can say, is a -- is a good method for culling deer. Our -- our roads are overrun by deer, our yards are overrun by deer, so this particular community worked with University of Wisconsin to come up with a remedy without shooting deer. And, you know, I'm not here to say it's a perfect plan, but what I am here to say is that we ought to be able to not just -- we ought to be able to look outside the box and -- and -- it's

not a one-size-fits-all approach when it comes to culling the deer. So what this bill does is give communities an opportunity to work with the -- to work with DNR and come up with something that -- that is acceptable. Unfortunately, DNR only wants to see deer controlled by hunting, and it just doesn't work in northern Illinois.

Further discussion? Senator Jacobs.

SENATOR JACOBS:

As a resident of northern Illinois, I would point out to you that currently it does work. We allow bowhunters to go into the parks. And I'd point out that the deer were here first. And why -- why are you pushing out the deer? Yesterday this Body was saving horses and now you're going to -- now you're going to euthanize these deer? I mean, how exactly, other than snaring a deer, shooting a deer with a tranquilizer, or shooting a deer with a gun or bow -- are you going to catch it with a net? What -- what -- now -- give me some help here.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Garrett.

SENATOR GARRETT:

Senator Jacobs, we're not euthanizing deer. When you shoot a deer, you're killing a deer. I think the whole point here is that if we don't protect the deer in some way from proliferating, we are going to have more dead deer who are being hit by cars, or -- or deers hitting drivers. I mean, it's -- it's -- it's -- it's a dangerous situation. We don't want to be working against DNR. We've tried very hard to be collaborative with them in this effort. So, again, it's a geographic issue. We're -- we're

trying to do the best we can to solve the problem.

Further discussion? Senator Burzynski, for what purpose you rise, sir?

SENATOR BURZYNSKI:

Thank you, Mr. President. To the bill.

To the bill, sir.

SENATOR BURZYNSKI:

You know, I understand that this is a geographic issue, but I think that -- you know, I rise in -- in strong -- excuse me, strong opposition to the bill. I think there are better ways to handle this. And a lot of times you all say, "Well, you oppose everything; you never present an alternative." Well, I guess the alternative is I have a slaughter facility now in DeKalb, that we'd be more than happy to slaughter those deer for you. So maybe we just need to put some -- sort of tranquillizer in them, we're going to move 'em out to DeKalb, we'll slaughter 'em, get -- make sure they get to where people can actually utilize them for the purpose that's been intended - you know, for good food. Thank you.

PRESIDING OFFICER: (SENATOR DeLEO)

...you, Senator. Further discussion? Senator John Jones.

SENATOR J. JONES:

Thank you, Mr. President. I'll be brief. Just to the bill: You -- you know, as Senator Sullivan said, the -- the first thing that upsets me is, when I look at something like this that -- that actually the Department of Natural Resources is dealing with this, why in the world we -- we direct these bills to a certain

committee where they'll get out. You know, this should have been debated in the Ag and Conservation Committee. That's very disturbing to me. Department of Natural Resources is opposed to the bill. You know, Senator Burzynski just mentioned the -- the horse slaughtering plant and, quite frankly, you know, we might be able to -- to tranquilize those deer that's -- that's overpopulated in your area and maybe even shoot some 'em with the bows, and then we'll take 'em over to the slaughtering plant and we'll process 'em, and -- and we'll take 'em to the needy that -that need food. But there is better ways to do it than -- than the direction you're going, Senator. And -- and I would just urge a strong No on this. Because not only are we talking about deer today, but tomorrow it'll be something else. Just like yesterday was horses; today it's deer. Is it going to be fox, raccoons? What's it going to be next? So I would encourage you to vote No.

PRESIDING OFFICER: (SENATOR DeLEO)

The last person seeking recognition on this issue, Senator Crotty. Then Senator Garrett to close. Senator Crotty, for what purpose you rise?

SENATOR CROTTY:

To the bill.

PRESIDING OFFICER: (SENATOR DeLEO)

...bill, ma'am.

SENATOR CROTTY:

I'm Chairman of Local Government and it happened to come through our committee, but I think the reason being is it was a municipal situation with municipalities. And the Illinois Municipal League along with the Northwest Municipal Conference

are two of the proponents of the bill. I can tell you, I live in Oak Forest and that's exactly what we -- most of my community is, is forest preserve. And we've had a lot of problems with the population of the deer. It's not uncommon to pick up one of our local newspapers -- and we've already had deer come into a culde-sac, a court, where kids were playing in front of their own home and a deer had attacked a child. We've had a school bus hit a deer. We've had many, many car accidents where deers -- the deer were running across 163rd Street. So, I rise in support of this bill. And all this is doing is allowing the municipalities to work with DNR on the population of the deer, especially in many of our residential areas. So I encourage a Yes vote.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you. Senator Garrett, to close, ma'am. SENATOR GARRETT:

Yeah. I want to thank everybody for their comments. I -- I didn't realize that there was really going to be this much discussion. But I don't -- first of all, what happened with the horse slaughtering bill, I hope doesn't reflect any -- doesn't reflect poorly on this bill. They're very different ideas and it -- just because, you know, that bill didn't go successfully for some in the Chamber doesn't mean that you should vote against this bill. Again, this is not -- the Northwest Municipal Conference, the Illinois Municipal League are very supportive of this. They understand that in the northern part of the State, where the population is much more dense than in the southern part of the State, we don't have the tools and -- to deal with the dramatic increase in the deer population. So we've worked with the Department of Natural Resources and -- and we want to be

partners with them. And, quite frankly, they -- they haven't been able to come up with alternatives to what we've approached them with. And we are working with the University of Wisconsin. I mean, how credible can that be? It's a program that's been in place for many, many years and they are also working with other states. So this isn't just an independent idea by one particular suburb. This is an idea that is basically being looked at from a national basis. So please take that into consideration. We do understand the Department is against it, but we also are trying very hard to work with them. Again, it's for a different type of population than southern Illinois. And I really would appreciate an Aye vote.

PRESIDING OFFICER: (SENATOR HENDON)

Is there any discussion? Senator Risinger.

SENATOR RISINGER:

Yeah. To the bill: I just want to remind the Members on this side of the aisle, there is a mandate in this bill. There's a possibility that it could raise energy rates. But it did pass through Energy and Environment Committee with one negative vote. PRESIDING OFFICER: (SENATOR HENDON)

Further discussion? Seeing none, the question is, shall Senate Bill 877 pass. All those in favor will vote Aye. Opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 53 voting Aye, 1 voting Nay, none voting Present. Senate Bill 877, having received the required constitutional majority, is declared passed. ...Body, we're going -- with leave of the Body, we're going to proceed to page 18. Page 18 in your Calendar. Senate Bill 940. Senator Kotowski. Madam Secretary, Senator Kotowski seeks leave of the Body to return Senate Bill 940 to the Order of 2nd Reading for the purpose of amendment. Senator Kotowski.

SENATOR KOTOWSKI:

Thank you, Mr. President, and thank you, Ladies and Gentlemen of the Senate. Senate Bill 940 is an excellent bill. It's good commonsense legislation and it's received support from both sides of the aisle. It amends the Firearm Owners Identification Card Act to require the State Police and the Department of Human Services to enter into an agreement with the FBI to implement the National Instant Criminal Background Check System in Illinois. Floor Amendment No. 1 also amends the Mental Health and Development {sic} (Developmental) Disabilities

Confidential {sic} (Confidentiality) Act to expand the requirement that the Department of Human Services report to the State Police persons receiving mental health care, irrespective of the manner provided, to include persons whose mental condition is of such a nature that it poses a clear and present danger to that person, any other person or persons or the community, evidenced by violent, suicidal, threatening or assaultive behavior. This bill came about through the strong leadership of Attorney General Lisa Madigan. I'd be more than happy to answer any questions.

PRESIDING OFFICER: (SENATOR HENDON)

Is there any discussion? Senator Pankau.

SENATOR PANKAU:

Thank you, Mr. President. Will the sponsor yield for a question?

PRESIDING OFFICER: (SENATOR HENDON)

He indicates he will. Senator Pankau.

SENATOR PANKAU:

Senator, yesterday in -- in committee when this was brought forward - and it did pass out of committee unanimously - you had the Chief of Staff from the Attorney General's Office there and she was basically explaining the process by which they currently give information to the -- to the State Police, as well as the new method of doing it. And for everybody in the -- in the room - because -- because of Virginia Tech, this is a hot issue right now - could you please explain what is presently done with those who have mental illness and what the new procedure would be? PRESIDING OFFICER: (SENATOR HENDON)

Senator Kotowski.

SENATOR KOTOWSKI:

Sure, absolutely. The -- the -- the new procedure will involve those -- not just those who have been put in a medical facility, but those who are -- gone through outpatient who are deemed to be at risk to themselves or to someone else. And the process involved in it is to make sure that the person who would be providing the care would share that information to the Department of Human Services who would then share it with the Illinois State Police. And might add, there's an additional provision to the bill, which I highlighted it, which makes sure that the Illinois State Police shares this information about people who are potentially at risk with the National Instant Check System. Currently, the State of Illinois does not do that and this bill addresses that.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Pankau.

SENATOR PANKAU:

I think it was also brought out in testimony that as of January 1st now, when this bill takes effect, that single -- sole practitioners, psychologists, psychiatrists, whatever, will now be required to provide information, where they have not been in the past. And I believe she went into some ways in which they will now be notified, other than all of us telling them that the bill is now going to happen. How will this happen so they know that they have to provide this information?

PRESIDING OFFICER: (SENATOR HENDON)

Senator Kotowski.

SENATOR KOTOWSKI:

The Attorney General's Office acknowledged that they will

commit their resources to making sure that all providers throughout the State get the information they need in order to have -- be as informed as possible about the stipulations connected to the bill.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Kotowski.

SENATOR KOTOWSKI:

No, they did not.

Senator Pankau.

SENATOR PANKAU:

Did anyone sign in as neutral on this bill?

PRESIDING OFFICER: (SENATOR HENDON)

Senator Kotowski.

SENATOR KOTOWSKI:

Yes, they did. The Department of Human Services signed in as neutral.

PRESIDING OFFICER: (SENATOR HENDON)

ABC Channel 20 seeks leave to -- video. Leave granted? Leave is granted. Senator Righter.

SENATOR RIGHTER:

Thank you, Mr. President. Will the sponsor yield, please?
PRESIDING OFFICER: (SENATOR HENDON)

He indicates he will yield. Senator Righter.

SENATOR RIGHTER:

Thank you. Senator Kotowski, and I -- and I apologize, I want to walk through this a little bit. The bill applies to hospitals and what other entities insofar as who is under the requirements of this Act?

SENATOR KOTOWSKI:

Thank you for your question. Yes, it would.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Righter.

SENATOR RIGHTER:

Okay. Then help me, Senator Kotowski, with the sole practitioner who is a psychologist or psychiatrist who is seeing someone once every two weeks or so, the individual has periodic bouts of depression. At what point is the practitioner supposed to know that they have to report this person to the State Police? PRESIDING OFFICER: (SENATOR HENDON)

PRESIDING OFFICER: (SENATOR HENDON)

Senator Righter.

SENATOR RIGHTER:

Thank you, Mr. President. Senator Kotowski, the individual in my example and the person -- the patient he is seeing, the doctor decides that he does not fit that description. Okay. He does not report that patient to the State Police. That individual either gets or retains his or her FOID Card and then commits an act of violence with it. What are the repercussions for the individual practitioner? Is he subject to a lawsuit? Is there any immunity provisions in here for making a judgment call? PRESIDING OFFICER: (SENATOR HENDON)

Senator Kotowski.

SENATOR KOTOWSKI:

Thank you for your question. It's an excellent question. There are no penalties to the practitioner.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Righter, to the bill, sir.

SENATOR RIGHTER:

No -- well, with all due respect, Mr. President, and I

Take your time, Senator Righter. Senator Righter.

SENATOR RIGHTER:

Thank you very much, Mr. President. Senator Kotowski, are there any provisions in here that would provide for absolute or even qualified immunity for a psychologist or psychiatrist who makes a good-faith judgment that the person's name should not be reported to the State Police? Is there anything in there like that?

PRESIDING OFFICER: (SENATOR HENDON)

Senator Kotowski.

SENATOR KOTOWSKI:

No, there are not, but nor are there any provisions that would allow them to be punished according to this bill.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Righter.

SENATOR RIGHTER:

Right, Senator Kotowski, and I appreciate that, but I'm sure, as you would recognize, that doesn't protect them from civil lawsuits from the family of someone who may have been injured. The second area I want to question on is with regards to -- there's a -- there's language in the bill that requires the State Police and the Department of Human Services to enter into some kind of an agreement with the FBI related to the federal database. Can you explain further that provision and what hopes you have that the federal government will help the State administer this new system or deal with this new system?

PRESIDING OFFICER: (SENATOR HENDON)

Yes, sir, I will. Just for point of clarification - I think it's important information for the entire Chamber to know: As of April 30th, 2007, the National Instant Check System Index contained four million, four hundred five, six hundred and fifty records. That's four million records from twenty-two states in the nation that participate. But the National Instant Check System contains no record from Illinois. No -- no records from Illinois. It's incumbent upon us to provide data to the NIC System regarding persons who are prohibited gun purchasers under federal/State law. So essentially what this would require, a memorandum of understanding with the Illinois State Police and the FBI to make sure that this information that we have in the State of Illinois regarding prohibited gun purchases would be shared.

PRESIDING OFFICER: (SENATOR HENDON)

Senator...

SENATOR KOTOWSKI:

...would be shared with the National Instant Check System.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Righter.

SENATOR RIGHTER:

Thank you, Mr. President, for your indulgence. Senator Kotowski, let's talk about the flip side of the coin here, and that's where an individual's name is transmitted to the State Police in error or falsely. Are there any remedies for that individual? Any specific procedures for that individual to be able to get off whatever list -- list the State Police will put

'em on, saying they can't have a FOID Card because of a mental illness?

PRESIDING OFFICER: (SENATOR HENDON)

Senator Kotowski.

SENATOR KOTOWSKI:

Senator, thank you for your question. It was my understanding that was going to be part of rulemaking through JCAR, in which we were going to work to address that.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Righter.

SENATOR RIGHTER:

To the bill please, Mr. President. Thank you. Ladies and Gentlemen of the Chamber, this is a very difficult topic and we are addressing it in a very, very brief amount of time. And as much faith as I have in the Senator and his staff, this is something that will not be played out here in the end on the Senate Floor, but in the rulemaking process. And I hope, I sincerely hope that the sponsor and the people who are working with him will follow diligently the bill, not just to see if it gets signed into law, but the rulemaking process that takes place afterwards. Because that's where we're going to find out how practitioners and individual gun owners are going to be impacted by this. Thank you, Mr. President.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Jacobs.

SENATOR JACOBS:

Couple questions of the sponsor, please.

PRESIDING OFFICER: (SENATOR HENDON)

He indicates he will yield. Senator Jacobs.

Would you support a "one gun bill a month" law?

SENATOR KOTOWSKI:

I have a tremendous amount of respect for you, Senator. You're tall, you're handsome, you have a lot of hair. The question at the current moment is irrelevant. I would like to speak to the bill.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Jacobs, to the bill.

SENATOR JACOBS:

Senator, on my computer here, the -- the most common methods of suicide are as follows: Bleeding is number one, people cutting their carotid artery; number two is burning; number three is drowning; number four is drug overdose; number five is electrocution; number six is hanging; number seven is jumping; and guns -- shooting don't come until eleven. So, shouldn't we really be banning ropes? Shouldn't we be banning matches? Maybe

toasters? I mean, when -- when is enough going to be enough, Senator?

SENATOR SCHOENBERG:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. To the bill: I rise in strong support of Senate Bill 940. The Attorney General and her staff have methodically reviewed the existing law to identify areas where we could hold health care institutions and providers, not just public -- private institutions, but public institutions as well, to be more accountable and more responsive in the hope of averting greater tragedy. This is a commonsense law and I urge you to vote for it.

SENATOR HAINE:

But I just want to ask you about a -- a small section of it that has to do with insurance assistance. Now, the insurance assistance, as I understand in the bill, does not reference insurance for individuals. It's about insurance for contractors. Without the humor, Mr. President. Senator Ronen, are there any income thresholds or gross receipts thresholds at all for the contractor? I mean, can the contractor be a multi-billion-dollar corporation who would be the last entity in the world who would ever need a taxpayer subsidy in order to do this work? Would they qualify for this?

PRESIDING OFFICER: (SENATOR HENDON)

Senator Ronen.

SENATOR RONEN:

Well, the best way I could -- I could seriously answer this is that all of this work will be done in conjunction with the lead task force advisory group, working with the Department of Public Health. The idea here is that there will be small companies who will have a capacity to do this and -- in towns throughout Illinois, not only Chicago - problem is significant in Peoria, East St. Louis. So that they would be working with these small companies and select them. And I trust in this advisory committee that -- that we're not going to be spending whatever resources are identified unwisely.

Now -- now all of them work in cooperation with and under the direction of the Public Health Director.

SENATOR RIGHTER:

...bill, please, Mr. President. Thank you, Senator Ronen, for -- for your responses. Ladies and Gentlemen of the Senate - and I think that we're seeing part of the problem with the one-hour

posting notice, particularly with regards to lengthy amendments - I -- I think this is a fine idea. I think it is a terrible idea for the taxpayers to pay for liability insurance for a contractor, regardless of how wealthy or how big they may be, in order to do this work. If a contractor installs windows, particularly in an area that is depressed and needs it, and does it negligently, then they're the ones who should pay for that, not my constituents and yours. I do not believe that this bill is drafted carefully enough. I appreciate very much the sponsor's intentions, but at this time and place we do not need to be helping these entities with taxpayer dollars in providing these subsidies. Thank you, Mr. President.

And if there's any damage, they're getting together to see what the damage will be due. I have no opposition on this. Like I said, everybody's for this bill. And I ask for an Aye vote.

I understand that we're still going to have continued discussions in the House, 'cause I'm not sure that we've quite cooked this soup to the extent that it should be correctly served. Senate Bill 831.

Senator Crotty.

SENATOR CROTTY:

Thank you very much. Senate Bill 831 gives the counties of Will, Kendall, Boone, Lake, DeKalb and Grundy the ability to impose a tax on the sale of motor fuel for consumption by motor vehicle or watercraft in half-percent increments, at a rate not to exceed four cents per gallon. The tax is subject to a public referendum. Any of these six counties may opt out of imposing the tax on the sale of diesel fuel. The proceeds from this motor fuel tax law are to be used solely for the purpose of operating, constructing, and improving public highways and waterways, and acquiring real property and rights-of-way for public highways and

waterways within the county imposing the tax. We already have three counties that do this, but under just a -- a resolution or an ordinance by the board. This particular one allows those six, but only under a public referendum.

PRESIDING OFFICER: (SENATOR HENDON)

Any discussion? Senator Dahl.

SENATOR DAHL:

Thank you, Mr. President. To the bill: I have parts of several counties that are involved in this bill, but I feel that this is just another attempt to raise some money that we shouldn't have to raise had the fuel tax money been left where it should have been in the first place over the last few years and used for the proper purposes. And this four-cent-a-gallon increase in fuel tax, even if it is done with a referendum, is going to hurt the very people that we're trying to help. Most people, if -- if they're passing through or -- or moving out of the -- the county area, will be able to buy their fuel other places, where the elderly, single mothers, people that can't get out of the counties are not going to be able to do that. I -- I think this is a bad -- is a bad bill and -- and we're -- we're -- we're going to be putting it on people that can't afford it again.

PRESIDING OFFICER: (SENATOR HENDON)

Further discussion? Senator John Jones.

SENATOR J. JONES:

Thank you, Mr. President. To the bull -- to the bill: The -- well, there's a lot of bull here too, but... Even -- even the President up there's agreeing with that one. But I -- I -- I tell you what, you -- you better take a close look at this --

this bill here right now, folks, because, quite frankly, it is a -- it is a referendum for -- for a tax increase on motor fuel. But you better -- you better, before you make this vote, you better pick up the phone, call back to your district office real quick, because your phone is ringing off the wall. What we need to be doing is taking the sales tax off of gasoline, not putting more on it to the -- to the constituents back home. And that's what we ought to be doing. And I would encourage a No vote on this bill.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Burzynski.

SENATOR BURZYNSKI:

Thank you, Mr. President. Will the sponsor yield for a couple of questions?

PRESIDING OFFICER: (SENATOR HENDON)

She indicates she will. Senator Burzynski.

SENATOR BURZYNSKI:

Thank you. Senator, just a couple of things. I think in your opening remarks you made comments that this is a front-door referendum, is it not? It has to go to the voters first.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Crotty.

SENATOR CROTTY:

That is correct.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Burzynski.

SENATOR BURZYNSKI:

Thank you. And in addition to that, you talked about what the purposes or what the funds could be utilized for. I think

After -- after going to committee, I had checked on this and when we talk about waterways, we talk about the bridges and the right-of-ways in order to get over those waterways.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Burzynski.

SENATOR BURZYNSKI:

Thank you. Is there any cap on how much money can be generated by the tax?

PRESIDING OFFICER: (SENATOR HENDON)

Senator Crotty.

SENATOR CROTTY:

It can't go over four cents a -- a gallon.

PRESIDING OFFICER: (SENATOR HENDON)

Senator Burzynski.

SENATOR BURZYNSKI:

Thank you. But there's no cumulative amount that they can collect in one particular year or for any type of project?

PRESIDING OFFICER: (SENATOR HENDON)

Senator Crotty.

SENATOR CROTTY:

I would imagine that it would be just, you know, on the amount of the gallons of gas that would be sold in those

Senator Burzynski.

SENATOR BURZYNSKI:

Thank you. To the bill: You know, I -- I come with mixed emotions on this particular bill, because it does or could potentially lead towards a tax increase in motor fuels. However, I believe that any county that at this point would put this type of issue on the ballot, that the vote would be overwhelmingly No. But having said that, I don't think that it really is that detrimental to at least give counties -- these counties the opportunity to place that vote. So thank you, Mr. President.

PRESIDING OFFICER: (SENATOR HENDON)

Further discussion? Senator Wilhelmi.

SENATOR WILHELMI:

Thank you, Mr. President. To the bill: I want to rise today in strong support of this. I want to thank the Senate sponsor. These are tough issues. There's no question about it. And when you look back at what this bill really does, it really is about local control. It allows six counties to be able to put this on a ballot to let the voters decide whether they want a tax increase on their -- on their motor fuel tax. The maximum is four cents a gallon, but all of us here in this Chamber, I think, believe in the principle of local control. That's what this bill does. We understand that right now gas prices are high and, of course, now that we're going into the summer season, they're going to remain high. But we also understand that in some of our communities, the infrastructure needs are also high. In Will County, we have 1.5 billion dollars' worth of road projects that

need to get funded, and if the voters believe that this is the way to go to fund those road projects, then let it be that way, and let the voters decide. This is about letting each and every one of our constituents in these six counties - Ladies and Gentlemen, it's only six counties that this bill allows for a front-door referendum - let them decide. If we vote No and -- and this bill fails, they'll never have the chance. So I want to encourage you to think through this. This is about local control. It's about finding a solution for infrastructure needs in six counties. It's a sensible approach and I'd ask you to vote Yes.

PRESIDING OFFICER: (SENATOR HENDON)

Further discussion? Senator Dillard.

SENATOR DILLARD:

Thank you, Mr. President. Just like I did a couple of days ago, I rise to echo what Senator Wilhelmi said. I certainly am - in support of local control. And especially when it comes to infrastructure referendums, the local people ought to decide. But I want to give you all a political tip, if we're going to ask our residents to raise gas taxes locally. Yesterday a number of us filed an amendment to a bill of Senator Althoff's to eliminate the sales tax, the State sales tax on gasoline. As gas prices press about four dollars a gallon, it would save Illinois consumers fifteen to sixteen cents per gallon. So, if you're worried about any criticism at all on this bill, if you're one of the sponsors or proponents of it, go -- come on over here, I'll give you the amendment number, and you ought to sign up as a cosponsor, eliminate the State sales tax on gas. It's fifteento sixteen-cents-per-gallon savings. There are studies that show

most of that money, which goes to the State's general fund, would get made up by people coming over our borders from the other states who avoid - especially truckers - filling up in Illinois. And that it's basically a revenue-neutral proposal, but a way to mitigate this. And if you're a proponent, to help you pass these gas tax -- local gas taxes, let's get rid of the State sales tax on gas, fifteen to sixteen cents a gallon at four bucks a gallon, and it'll just help make your local referendum hopefully successful if it helps grow jobs in your counties. Thank you.

Senator Crotty, to close.

SENATOR CROTTY:

Thank you very much. I appreciate the discussion on -- on this -- on this bill and I, too, had some reservations, but I think when I actually saw that it was through a referendum that this can be done on those six communities, and I also realized that we have DuPage, Kane and McHenry that can impose that tax on the sale of motor fuel just through an ordinance or a resolution by their county board, I think this allows the voters to make that choice. I ask for a Yes vote.
