#### SENATOR DAHL:

Thank you, Madam President. Julianna Gehant was from Mendota, Illinois, which is in the 38 District. Julianna was thirty-two years old. She's from Mendota. She graduated from Mendota High School. After high school, she enlisted in the U.S. Army and served our country for twelve years in the Army Corps of Engineers. She was stationed around the world, from Korea to Bosnia and other international hot points. She rose to the level of Staff Sergeant. And more recently, Julianna attended Northern Illinois University as an elementary education major. She could presume -- pursue her lifetime dream of becoming a second-grade schoolteacher. When you look at everything Julianna did accomplish in life and where she wanted to go, one thing stands out: Her life was of service - service to her family, service to her community, and service to her country. What happened at NIU on February 14th didn't just rob Julianna's family and -- friends of a wonderful part of their lives, it also robbed all of us of the tremendous good work and dedicated service she has given back to our country and our communities. As lawmakers, there are some things we have to do we don't like to do, but there's nothing worse than what we're doing today. When an event like the tragedy at NIU happens and

innocent people are impacted - and not just innocent people - good people, decent people who have devoted their lives to serving others, whether it's the victims of this shooting or our fallen heroes from other wars, law enforcement members, firefighters who die in the line of duty, it kind of chokes you up. The world is truly a better place because of the work Julianna did, and our world will not be the same without her. We cannot erase the tragedy of February 14th, but we can remember the victims and honor them. This Senate resolution is a good start. Again, Julianna's friends and family, your loss is our loss. Hopefully this resolution can be one small way this Body can express not just our sympathy for your loss, but our thanks for her life. Thank you.

### SENATOR DILLARD:

Thank you, Madam President and Members. Daniel Parmenter and his family attended my church, Christ Church of Oak Brook. And, in fact, that's where his funeral service was held. And his father was a member of our men's weekly breakfast group. Dan Parmenter was a big kid, really big tall guy, about six foot five. In fact, in one of the obituaries, somebody referred to him as a young man the size of a refrigerator. You may remember that some headlines, including one in the <a href="Chicago Tribune">Chicago Tribune</a>, said that Danny died protecting and sheltering his girlfriend, which he did. Dan was a typical sports guy. He was a football player at York High School in Senator Cronin's district, proud member of the York Dukes. He was a rugby player. The business adviser to the Northern Star newspaper said that, quote, "Dan was our

gentle giant", end quote. He worked at the campus student newspaper as an advertising representative. He was a finance major from Westchester, Illinois. And he was a proud member of Pi Kappa Alpha, also -- or better known as the Pikes. But Dan's family and friends, if you look at what they said about him, are going to remember his -- his, not only his size, but his intelligence, his honesty, his common sense, and incredible strong work ethic, as people who knew him at Northern Illinois and his football coach from high school would say. And he had a tremendous curiosity about learning. In fact, he sat in the front row of that class with his girlfriend, and people who knew him and at his funeral said it was very typical for Dan to sit in the front row because he wanted to soak up the knowledge that was there. He was somebody who was an honor student and clearly wanted to learn. So, please remember his family and his friends and the Northern community in your prayers. Do not forget his girlfriend, Lauren Debrauwere, who was seriously injured. still has more surgery to go. But Dan Parmenter -- and I read a great column by Mark Brown, the good and great Sun-Times --Chicago Sun-Times columnist, who's an adviser to the Northern Star newspaper. And I think Mr. Brown summarized it so well that this is the kind of young man that you want to be in the State of Illinois, to grow up, to have a family, to live here. And to have him taken at such an early stage of his life is -is just a terrible, terrible tragedy. So please -- Senator Burzynski and others from the Northern Illinois community, my heart goes out to all of you and their families. And Dan Parmenter will be sorely, sorely missed. Thank you.

She was involved in the school's choir, the drama programs, and her peers described her as popular and high-spirited. She was on the path to success. She demonstrated it with her talent and drive and the endeavors she undertook at NIU, and during her time at Glenbard North High School as well. Gayle's memory will be carried on by her family and loved ones. Her hidden energy and drive for things she found exciting will never be forgotten. Let us all pray for them to have the strength to go through these heartbreaking times. And remember, always remember the legacy of Gayle Dubowski.

### SENATOR SANDOVAL:

You know, it was ten years to the day almost that I was sitting at my desk at the Environmental Protection Agency when I received the phone call from another family member that my sister had been killed in a tragic car accident - a teacher, a young lady who had lived in our neighborhood for -- born in our neighborhood and walked the streets of our neighborhood and stayed around to teach the children of our neighborhood, a Latina. Ten years to the day I received a call from the family

of Catalina Garcia, another young Latina who was studying to be a teacher, lived just a few blocks away from my district office, had decided not to be a statistic, had decided to do something with her life, to take advantage of an education, of immigrant parents who had just arrived here from Mexico not too many years ago, and to someday come back and teach the children at Morton East High School, where she had graduated from just a couple years ago. She was a -- a twenty-year-old sophomore from Cicero, majoring in elementary education. One of her teachers said she was a star among stars. Her brother said she was their princess. After receiving that call, I called my good friend, Larry Dominick, the President of the Town of Cicero, and we went and walked over from my office to visit the family. It was a -it was a tough moment. You could only imagine 'cause many of you have lived those tragic moments, 'cause some of us have lived through that. And I wish it on nobody and I wish it on no one's family. Catalina Garcia - just yesterday - 's life will be forever embedded in a classroom at the new community center of the Town of Cicero, just across the street from my office. In the new community center, there will be a learning center, and we dedicated last night a learning center -- a classroom, where children from our community will learn about computers, about the Internet, they will learn to read, they will learn about math, and they'll learn what it needs to get ahead in life, and they will learn not to be a statistic. They would learn to live and dream about the American dream. tragedy, but it's also a time to celebrate, in our community, someone who had made it out of poverty, someone who had -- was not going to be a statistic, someone who was going to do

something with her life. And we, in my community, have a high dropout rate, sixty-five percent dropout rate from high school. She was not. She had succeeded. So it is with much sorrow that I stand here with all of you celebrating the life of one of my constituents, Catalina Garcia, whose memory will live on forever in the Town of Cicero.

#### SENATOR NOLAND:

Madam Chair. Thank you, Ryanne Mace was Carpentersville, Illinois, which is in my -- my district. was a sophomore and a psychology major at NIU. She had the unique ability to help and comfort people with her words and her actions, so I'm told by her family. In high school, some of her friends were kind of the fringe kids, her father tells us. were the kind of kids who were maybe picked on by others and who were sometimes disenfranchised. She was a level-headed kid and smart, and as a result, people would come to her for advice. At some point in her life, she decided that she wanted to help others in the field of psychology. At NIU she majored, as I say, in psychology. She was -- she was nineteen years old. She was an honors student and she had the intention of attaining a doctorate-level degree and working in the field of counseling. She'd already served an internship in high school at a counseling center. And so I stopped to think, what good could we do here on behalf of her. And I want to take the opportunity here to thank my colleagues from both Chambers for politicizing this event with all the things that we might. I think there is some information that she would want me to pass

on to you and hope that we might act on. It's important for us to note that mental health disorders here in the United States cost us over three hundred billion dollars. And seventy-five percent of those disorders are successfully treated. eight percent of insurance companies impose oftentimes arbitrary restrictions on access to mental health treatment by way of higher copays, limited outpatient treatment and lower caps on lifetime benefits. And I think that the family would want us and the families of all of these individuals - while recognizing that there's only so much that we can do to prevent instances like this, to do everything that we possibly can to help prevent these instances in the future. And on behalf of Ryanne, who's a psychology major, I think that she would want us to devote what resources or application of the law that we possibly can to come to bear on instances and prevent instances like this. wrong that we suffer these disparities in the application of our health care resources. And so I say this, that we should mourn not the dead, but those who move ahead now with blithe indifference, those who see the world's great wrong and the -the great wrong that might have prevented this instance and dare not act.

Seeing no further discussion, Senator Burzynski, to close. SENATOR BURZYNSKI:

Thank you, Madam President. Gayle Dubowski. Catalina Garcia. Julianna Gehant. Ryanne Mace. Daniel Parmenter. I've heard those names many, many times over the last three weeks and they're names that we really shouldn't forget. Three weeks ago today, a terrible tragedy occurred on the campus of Northern

Illinois University. And while I personally did not know any of those that were -- lost their lives or that were injured prior to that time, I now have had the opportunity to meet many of them and witness their resolve in both their physical and emotional recovery. And it is truly a remarkable spirit that indwells within all of us that helps us to move forward after these types of terrible tragedies. During the past three weeks, I've been on the campus several times. First, the day after the tragedy, hearing firsthand of the actions and activities that had gone on with all of the first providers, first response people, the University faculty, the University Senate, administration, all of the police agencies that were on campus. And I can tell you that all of these had in the uppermost of their mind that they were there to serve the community, that they were there to serve Northern Illinois and its students. I also had the opportunity to be on campus several other times at memorial services, where the lives of all of these individuals were celebrated, as well as mourned. And today, we gather here to mourn for the lost lives and those who were injured. Many have been very closely touched by this event, and surely all of us and all of our lives have been forever changed, because who of us here would expect that our students would not be safe on one of our university campuses. I can tell you that the response of the University, the surrounding communities, the State of Illinois and the federal government has been nothing less than superb, as everyone has worked together, again, to meet the needs of the community, the University, but again, most importantly, the needs of the students and their families. As we continue to mourn, it is also now time for us to heal and

move forward. And as we continue to pray for and to offer our expressions of sorrow and grief for the victims and their families, may our prayers be that those families and the entire NIU community seek peace and strength in the great comforter, the God of mercy, the God of strength and the God of all comfort. As Northern Illinois University President John Peters has so appropriately said, it's time to move forward, together forward. We should never forget this terrible tragedy, but we almost -- we also must continue working together for a brighter and better tomorrow. My heartfelt condolences and sympathies go out to those families who lost loved ones and who were victims of this tragedy. Forward, together forward. Thank you.
