And this Act will ensure that families needing long-term care for their loved ones have access to critical information by requiring the facility to fill out a Consumer Choice Information Report annually. Now -- currently there is nowhere you can go for this information. This information report covers over one -- one hundred factual items, including questions covering areas such as medical care, treatment, and services; the staffing; the facility statistics; ownership and administration; and safety and security, among many other items. The consumers can access this information through the Department on -- of Aging website. I'd be happy to answer any questions.

PRESIDING OFFICER: (SENATOR CLAYBORNE)

Is there any discussion? Seeing none, Senator Maloney, to close.

SENATOR MALONEY:

Thank you, Mr. President. I think Illinois is going to be

SENATOR GARRETT:

Since she's new to the process, I think we better not indulge her so easily and -- and read our analysis.

SENATOR HAINE:

What that very simply means, if you're going to put a bridge in and you're going to collect tolls, it must be compatible with I-PASS. We just worked out agreements with Indiana and some other states. We want to have one transponder that works on all of them. So if you're going to put in a toll bridge, make sure it's compatible with the system that we have in place for the entire State of Illinois. I ask for a favorable roll call, Mr. President.

And you may recall that in January, the new driver's -- GDL laws prohibited drivers under the age of eighteen to be on the road after eleven o'clock on Fridays and Saturdays unless they were participating in a school-sponsored or work-related activity. This essentially precluded a very successful national program known as Safe Rides from providing alternative transportation home for young people who themselves in need of a ride after curfew on weekend nights. Safe Rides is a peer-operated program that dispatches volunteers under adult supervision and it provides alternative transportation home for teenagers who may find themselves in circumstances such as being impaired or having -- being on a date that has gone bad. It's worth noting that while area schools and law enforcement officials have long been supportive of this program, which is under the sponsorship of Boy Scouts of America, because of the new GDL laws, unfortunately this highly successful program was -- forced to suspend. This would enable that program to be reinstated. And I'd be happy to answer any questions you might have.

PRESIDING OFFICER: (SENATOR CLAYBORNE)

Is there any discussion? Senator Bomke, for what -- what purpose do you seek recognition?

SENATOR BOMKE:

Just for clarification, based on what you provided us, it is not primary coverage the Boy Scouts of America are providing, but excess coverage.

It also clarifies that for violations involving cell phones, the employee would have to have the intent to provide the phone to an inmate or to use it for an inmate's benefit to be criminally prosecuted. The bill also provides that for -- for violations involving legally owned items, employees may store them in a locked vehicle in institution's parking lot without fear of prosecution so long, of course, as those items are not illegal. Is there any discussion? Seeing no -- sorry about that. Senator Rutherford, for what purpose do you seek recognition? SENATOR RUTHERFORD:

Sponsor indicates he will yield.

SENATOR RUTHERFORD:

Senator Wilhelmi, what was the genesis of this?

Senator Wilhelmi.

SENATOR WILHELMI:

Thank you, Mr. President. The genesis of this came from a

Senator Trotter, please explain the bill. SENATOR TROTTER:

Thank you very much, Mr. President, Members of the Senate. This bill amends the Public Utilities Act to permit the Public Utility Fund to carry a balance of fifty percent of the previous year's appropriation level. Funds in excess of that level are to be funded to the utilities that paid the taxes. It also amends the Illinois Vehicle Code to allow the Transportation Regulatory Fund to carry a balance of fifty percent of the previous year's appropriation. This, in essence, allows them to have six months' worth of operating expenses versus the two months which was passed last time, in 1984.

PRESIDING OFFICER: (SENATOR CLAYBORNE)

Is there any discussion? Senator Watson, for what purpose do you seek recognition?

SENATOR WATSON:

Yes. Thank you, Mr. President. Just a question of the sponsor.

PRESIDING OFFICER: (SENATOR CLAYBORNE)

The sponsor indicates he will yield, Senator Watson.

SENATOR WATSON:

Would this be considered a dedicated fund and could these funds be swept by the Governor?

PRESIDING OFFICER: (SENATOR CLAYBORNE)

Senator Trotter.

SENATOR TROTTER:

No, they are dedicated in the sense as has been the -- the language that's always been in the bill, that if there's any excess dollars, they automatically will be sent back to the

Senator Watson.

SENATOR WATSON:

And that's what this does?

PRESIDING OFFICER: (SENATOR CLAYBORNE)

SENATOR TROTTER:

That's in keeping with the language that has always been there. That language has not been changed by this bill. This just allows them to keep fifty percent dollars more. Previously, this had enough resources and revenues for two months of operational dollars. This allows them to have at least up to six months of operational dollars in the budget. And, again, any excess over that will go back to the utilities that paid the fund. So, as the language reads, we have -- not changing anything that would -- would allow these funds to be swept.

PRESIDING OFFICER: (SENATOR CLAYBORNE)

Senator Watson.

SENATOR WATSON:

Well, I guess, who asked for this and what's the intent? I -- I -- I just don't understand what the intent is here. And -- but who asked for this? Who wants this?

PRESIDING OFFICER: (SENATOR CLAYBORNE)

Senator Trotter.

SENATOR TROTTER:

The ICC. So, the Illinois Commerce Commission would like to see this done, 'cause it gives them more flexibility to run

Senator Harmon, please explain Senate Bill 1989.

SENATOR HARMON:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. In 2005, on the eve of Thanksgiving, there was a horrible train crash in the Village of Elmwood Park in my district between an express Metra train and seventeen

automobiles. In response to that crash, we, in the last General Assembly, expanded a DuPage County pilot program for camera enforcement at railroad grade crossings. In the implementation of that new law in the Village of Elmwood Park, they have encountered certain procedural difficulties and -- and practical concerns. Senate Bill 1989 addresses those concerns. It conforms the railroad grade crossing law to the -- the intersection camera enforcement. I'm not aware of -- of any organized opposition to this and I'd ask for your Aye votes.

Is there any discussion? Seeing none, Senator Harmon, to close.

SENATOR HARMON:

I'd ask for your Aye votes.

PRESIDING OFFICER: (SENATOR CLAYBORNE)

PRESIDING OFFICER: (SENATOR CLAYBORNE)

Senator Bomke, for what purpose do you seek recognition? SENATOR BOMKE:

I'm -- I'm sorry, I didn't get my button on quick enough. Questions to the sponsor.

PRESIDING OFFICER: (SENATOR CLAYBORNE)

The sponsor indicates he'll yield, Senator Bomke.

SENATOR BOMKE:

Thank you, Mr. President. Again, I apologize. I -- I have some concerns, Senator Harmon, regarding this legislation. I -- I mentioned my concerns in committee regarding the use of cameras. Under current law, these offenses were subject to administrative adjudication and was handled by the courts. Now it would appear that this would be treated not unlike a parking ticket, with a two-hundred-and-fifty-dollar fine. Is that

Senator Harmon.

SENATOR HARMON:

That is correct. It would be administratively adjudicated much the same as a parking ticket.

Senator Bomke.

SENATOR BOMKE:

Also, under current law, you have -- the ticket must be given to the -- the defendant within thirty days. This now extends it to ninety days. And I indicated my concern because of the price tag on the ticket or the hefty fine, anyone who -- who gets a ticket -- yet -- I mean, if you're like me, I have it difficult knowing what I did yesterday. Thirty days seems almost excessive to get a ticket, but ninety days it seems to me that it would make it difficult to defend. I mean, could it be that it's not constitutional?

PRESIDING OFFICER: (SENATOR CLAYBORNE)

Senator Harmon.

SENATOR HARMON:

Thank you, Mr. President. I -- I don't believe that there's a constitutional issue. Again, this conforms to the red light camera crossing rules. It's also based on a photograph of your automobile in the course of the violation. So, there's not much to remember.

PRESIDING OFFICER: (SENATOR CLAYBORNE)

Senator Bomke.

SENATOR BOMKE:

Under current law, a person must be notified that if they were not the operator of the vehicle at the time of the alleged offense, the person could notify the police in writing and -- of the name and address of the person who was operating the vehicle. Why has this been removed?

SENATOR HARMON:

Thank you, Mr. President. That's one of the consequences of -- of another change, which is the elimination of a requirement that we provide a photograph of the driver -- of the operator. That's for a technical reason. As I understand it from the professionals in the field, with the anti-glare or anti-reflective windshields on cars today, you can't capture an image of the -- of the -- or, the operator of the vehicle, as we had hoped when we passed this originally. Again, this is reflective of the -- the rules for red light cameras. We're adopting the same standard.

PRESIDING OFFICER: (SENATOR CLAYBORNE)

Senator Bomke.

SENATOR BOMKE:

Lastly, under current law, it was a violation of two-hundred-and-fifty-dollar fine. It also allowed a judge to impose a twenty-four-hour community service in place of the fine. It would appear that that provision has also been removed from the bill, which could be to the detriment of the less fortunate or the poor.

PRESIDING OFFICER: (SENATOR CLAYBORNE)

Senator Harmon.

Again, I'd say this was a consequence of having adopted a pilot program at the same time we were adopting similar, but not identical, provisions for red light cameras. We're trying to establish the same standard. As I understand it, this is the same as the red light cameras.

Senator Bomke.

SENATOR BOMKE:

Couldn't community service still remain an option?

PRESIDING OFFICER: (SENATOR CLAYBORNE)

SENATOR HARMON:

It could and I'd be happy to entertain an amendment in the trailer bill.

PRESIDING OFFICER: (SENATOR CLAYBORNE)

Senator -- Senator Bomke.

SENATOR BOMKE:

Thank you, Mr. President. Senator Harmon, I have a great deal of respect for you. I do have a difficult time with cameras. Think it's unconstitutional. I think it's -- it -- it -- as I've mentioned before, it's difficult to know what you did yesterday, let alone thirty days later or ninety days later. I think the fact that you want to add the community service is certainly a good idea. I would hope that you would do that in a trailer bill. I probably will be voting No on this bill. But I think it does affect the less fortunate, those that are poor, not the ability to work it off through community service. I think it's a wonderful idea if you would propose that in a

Also, the lemon law is really a consumer protection bill -type of bill and this is a protection of -- of public property.

Isn't this a little different than the -- than the standard

lemon law type of protection?

PRESIDING OFFICER: (SENATOR MARTINEZ)

Senator Silverstein.

SENATOR SILVERSTEIN:

I don't think so. I mean, a vehicle is a vehicle, whether it's used for consumer or nonconsumer use. But I can see your distinction. But I -- I -- personally, I don't think that's -- that's -- that's valuable.

Senator Risinger.

SENATOR RISINGER:

To -- to the bill: I -- I'm going to vote for this bill. I think we ought to have that type of protection, but I also

SENATOR WILHELMI:

Thank you, Madam President, Ladies and Gentlemen of the Senate. Senate Bill 2674 amends the Park Commissioners Land Sale Act regarding the sale of golf course land. The measure

would allow a park district with a golf course in a non-home rule county with a population greater than five hundred thousand but less than a million to sell up to eight acres of land should that land no longer be needed or deemed necessary or useful for golf course purposes. The particular situation we have at the Joliet Park District is a parcel along Route 59 in Caton Farm Road in Joliet, extremely valuable land. two hundred acres at Wedgewood Golf Course. They want to sell up to eight acres to a developer, take the sale proceeds, reinvest it in the property to build a -- a beautiful golf clubhouse and banquet facility. Right now, they are not able to have banquets with their golf outings or banquets for the community, and it's a shame because revenues are going outside of the district as opposed to back to the district. So this is a very creative way to make sure they can build such a facility and not ask the taxpayer to come forward with more money through a referendum. SENATOR ALTHOFF:

I understand that, Senator, but there is a provision that they can go to referendum and request that the voters approve becoming home rule. Is there a reason that these communities elected not to follow that path?

Not any reason that I'm aware of.

Just in conclusion, typically this is an unusual precedent to set, to allow two communities to come to the General Assembly and request this provision to be able to initiate a tax increase. I would just look at the Body again as a whole and have you really consider whether or not you want to vote Yes on something that's unusual. Thank you.

SENATOR RUTHERFORD:

Senator Koehler, these two communities that are not home rule, did they not pass an ordinance or resolution within their city councils to embrace and support this action?

Yes, thank you, Senator. Yes, both communities did pass such a resolution supporting this.

Thank you, Madam President. I think the point is -- and -- and couple of these communities are in my home district. I'm going to be supporting the -- the legislation. When I spoke to the communities about this, I had the same question that was perhaps expressed by some of my colleagues just a few moments ago. But in order to respond to it, the mayor and the city councils did debate this in full public disclosure, they did have open meetings, they did have opportunity to have it brought to the forefront, so the public was quite aware of it, and then they passed resolutions in support of this piece of legislation. So, Senator Koehler, thank you very much for sponsoring the bill.

Senate Bill 2682 deletes the -- well, underlying bill and authorizes school boards to award a diploma to an honorably discharged veteran who left high school before graduating to serve in the United States armed forces during the Vietnam Conflict provided the veteran resided in an area within the district and has not received a high school diploma. Currently, school boards have the authority to issue high school diplomas to World War II and Korean Conflict veterans who left high school to serve in the armed forces. I would ask a -- a favorable vote.

Senate Bill 2690 came out of a situation in my district in which a community college passed a referendum, and when they began construction of many of the buildings that the referendum allowed them to build, there was a great deal of frustration in the sense that many local businesses could not get any of the -- the work because of the -- the bidding process. What this -- what this bill will do is it will allow local businesses if they were within five percent of the lowest bid, with a two-thirds vote of the community college board, that local business can secure the work. I'd be happy to answer any questions.
