Mr. Secretary, please read the motion.

I move to concur with the House in the adoption of their Amendments 1, 2 and 3 to Senate Bill 2016.

### PRESIDENT CULLERTON:

### SENATOR RAOUL:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. Senate Bill 2016, as amended by House Amendments 1, 2 and 3, would create the 2016 Olympic and Paralympic Games Act. It's enabling legislation to support the City of Chicago's bid to host the 2016 Olympics. Several weeks ago, we had discussion as we passed the -- the shell bill out to the House about some of the components in this. And I -- and we pretty accurately predicted what the language was going -- that was going to be in the bill. But I'd like to go over some of that. The probably most important provision in the bill is one that provides for a State financial guarantee as is required by the -- guarantee is required by the International Olympic Committee for any bid city competing for the Olympics. The State would provide, in our case, a two-hundred-and-fifty-million-dollar guarantee. I'd like to note that that two hundred and fifty million dollars

would only be tapped after first going through any surpluses from the organizing committee. And it's projected that - a conservative estimate - that there would be at least four hundred and fifty million dollars in surplus. Secondly, there's a -- there's five-hundred-million-dollar guarantee that's always -- already been approved by the City of Chicago. The first two hundred and fifty million dollars of that guarantee would be tapped before going to the State's guarantee. Additionally in the language of this bill is that if, for some reason, we would go to the State's guarantee, there would be a dollar-for-dollar match expenditure on downstate roads for having to tap into that quarantee. The bill also contains language providing for targets for minority contracting in connection to the games twenty-five percent for MBEs and five percent for WBEs - and -and creates a oversight board to -- to monitor the level to which these goals are being met. It creates a -- unified public safety command to coordinate law enforcement agencies for security and public safety, which would be a board that would be chaired by the Chicago Superintendant or mayoral designee. Language protecting the Olympic trademark to prevent any unauthorized use of the Olympic trademark. Professional licensure exemptions for physicians and physical therapists and nurses and trainers who would be traveling with their respective countries. And FOID and Criminal Code exemptions for the firearms that will be used in competition. I urge your support on this bill. This is a bill that will be beneficial to the entire State of Illinois. We foresee that facilities throughout the State would be used for -- for the 2016 Olympic Games if Chicago were to win the bid. Thank you, Mr. President.

The bill clarifies that although an employee may not be required to work overtime at the request of a director, or his or her designee, employees may still voluntarily accept overtime. The refusal of any employee to such overtime work shall not be grounds for discrimination, dismissal, discharge, or any other penalty or employment decision adverse to the employee. The bill also outlines posting, investigation and enforcement provisions of the Act.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Senator. Is there any discussion? Is there any -- Senator Pankau, for what purpose do you rise, ma'am? SENATOR PANKAU:

Thank you, Mr. President. This bill addresses the longtime practice of the previous administration of requiring - mandating - overtime with virtually no notice ahead of time that it was going to be required. They just come to you that day and say you're working overtime. And if you refused, there were some administrative punishments that they put on your record. I urge a strong Aye vote for this. Hopefully this will send the message that it's much better to ask than to be required. Thank you.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Senator. Is there further discussion? Further discussion? Senator Cronin, how are you this afternoon, sir? SENATOR CRONIN:

How was your dinner last night?

SENATOR CRONIN:

I -- I feel satiated and healthy today.

PRESIDING OFFICER: (SENATOR DeLEO)

Good. You look good, sir.

SENATOR CRONIN:

Got a good night's sleep and ready to debate an issue.

PRESIDING OFFICER: (SENATOR DeLEO)

For what purpose do you rise, sir?

SENATOR CRONIN:

To the bill, if I may please.

PRESIDING OFFICER: (SENATOR DeLEO)

To the bill, sir.

### SENATOR CRONIN:

With all due respect to my colleague from this side of the aisle, I rise in opposition to this bill. A lot of us here talk about the -- the sanctity of and the virtue of the collective bargaining process. And, you know, whether it cuts one way or the other, I think if you want to be consistent about it, you'd have to stand up and oppose this bill today. And I'll tell you why. You know, I sat there and listened to the testimony. Catherine Shannon, the Director of the Department of Labor, was very persuasive. She obviously has pretty, you know, solid credentials in the area of advocacy for labor. And she sat down and she said, look, you know, when we sit down and negotiate the contract, those who are at the table for these workers choose not to make this an issue. They put other issues in front of

it. And so, to go around the process and to say that, you know, we're going mandate this by State law -- and I certainly understand, Senator Frerichs, you know, you've got some people in your area and they're coming to you and you're advocating. I understand that. But the right thing to do here for the process, to -- to -- to -- to give the -- the proper amount of respect to collective bargaining, to respect the views of people like the Director of the Department of Labor, the right thing to do here is to vote No. So I urge you to sort of overlook this -- this sort of drama about they're making them work overtime and earn time and a half and all that kind of thing, and, you know, this -- the sky is falling and safety and all these other concerns, which I think are all red herrings. This is about collective bargaining and going around the process. And for those of you who respect that process, you should vote No.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you. Further discussion? Further discussion? Senator Jacobs, are you seeking recognition on this matter, sir? SENATOR JACOBS:

Thank you, Mr. President. I rise in strong support of the Senator's bill. I don't view this so much as a -- a worker's right as I do a single-parent right. There's a lot of single parents that work for the State of Illinois. They have children. They're required to work mandatory overtime. What are they supposed to do? We have a forty-hour workweek in Illinois. We ought to stick with that. If government needs more employees, we should hire more employees.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Senator Jacobs. Further discussion? Further

discussion? Senator Murphy, are you seeking recognition on this bill, sir?

### SENATOR MURPHY:

I am, Mr. President. A question of the sponsor.

PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates he'll yield for a question, sir.

#### SENATOR MURPHY:

Will this bill, if it passes, require the State to hire more employees so that we cannot mandate overtime?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Frerichs.

#### SENATOR FRERICHS:

I believe there will be a requirement for new employees. This General Assembly has passed money for positions that have not been funded. I think that there are significant savings. It's true, we pay time and a half to these people who are doing over -- overtime. If we just hire new people, we could have savings in the amount the State spends in overtime.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Murphy.

### SENATOR MURPHY:

In the Deficit Reduction Committee, I had asked AFSCME if they felt like hiring new employees would actually reduce the cost on overtime. They didn't have any concrete numbers on that. Do you have any such numbers to -- to -- to support the claim that this would actually reduce spending?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Frerichs.

### SENATOR FRERICHS:

I'm not -- I'm not claiming it'll reduce spending, but if you're paying time and a half and you figure a benefit package might be somewhere under half of their salary, I figure it'd probably be at least a wash. And for people who have -- have children at home, they're single parents or they're dual-income families - in a lot of these towns, they have dual -- both working for the State - when both parents are forced to do overtime or single parents forced to do overtime, they're unable to get their kids. And they don't -- and it's uncertain. They don't have access to daycare for a -- for a sixteen-hour shift. And so, even if it's just a wash and doesn't save money, I think this is a bill worth supporting.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Murphy.

#### SENATOR MURPHY:

...you -- thank you, Mr. President. If it's a wash, why won't the departments just hire more people on their own so they don't have to have the fight with labor about the mandatory overtime?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Frerichs.

### SENATOR FRERICHS:

That is a very good question. I don't think we've gotten a very good answer from at least the past administration. And that's why I'm pushing for this bill.

PRESIDING OFFICER: (SENATOR DeLEO)

Okay, Ladies and Gentlemen, further discussion? Senator Bomke.

### SENATOR BOMKE:

Thank -- thank you, Mr. President. To Senator Murphy's question: I'm told that the overtime cost was about sixty million dollars last year. With that sixty million, I believe, an additional eight hundred employees could be hired. To your question as to why the administration hasn't hired additional people: I think we just went through six years of a Governor bragging about how he reduced employment, so he would have rather expended more money to prove that he could reduce people at no cost savings. So the actual cost I believe, Senator Frerichs, is around sixty million dollars and with that we could hire about eight hundred additional employees.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Senator. Further discussion? Senator Koehler. SENATOR KOEHLER:

Yes. Thank you, Mr. President. To the bill.

PRESIDING OFFICER: (SENATOR DeLEO)

To the bill, sir.

### SENATOR KOEHLER:

This is an important bill. And I think that we have to understand that just by requiring -- by forcing somebody to work overtime does not give you a quality, you know, amount of time from a worker. The biggest stressor in -- in work places are forced overtime where somebody has got issues at home or is feeling burnt out. In a -- in a conducive work environment, where you have positive labor-management relations, you have no problem in getting people to volunteer for overtime. I've seen that. I've -- I've spent the last twenty-one years of my life as the Director of the Labor Management Council in Peoria. I know this. So, along with this, I think this is an important

step, because this should not be bargained. You can bargain other things, but you shouldn't effectively force somebody into a burn-out situation. I urge an Aye -- a strong Aye vote on this.

PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Senator. Further discussion? Senator Millner, are you seeking recognition on this bill, sir?

SENATOR MILLNER:

Thank you, Mr. President. A question for the sponsor of the bill, if I may.

PRESIDING OFFICER: (SENATOR DeLEO)

Sponsor indicates he'll yield for a question, sir.

SENATOR MILLNER:

Does it include public safety?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Frerichs.

#### SENATOR FRERICHS:

It covers Department of Human Services, Veterans' Affairs, Department of Corrections, and Department of Juvenile Justice.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Millner.

### SENATOR MILLNER:

Thank you, Mr. Chairman {sic}. My only concern on that issue would be if it's Department of Corrections - and I ask the sponsor - what would happen if you're in a situation where people get sick, you have to guard the prisoners, and you order somebody you have to stay here to watch the prisoners and they say, "no", and they leave? I mean, do the prisoners then watch themselves? Or -- I mean, I -- I -- what would we do in a case

like that?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Frerichs.

#### SENATOR FRERICHS:

You still have voluntary overtime. But I was going to point out that there are exemptions and this Act shall not apply in the event of any declared national or State emergency or disaster or other catastrophic event that substantially affects or increases the need for State services. For many years in the past, our administrators, our Governor's Office, our directors have been able to manage around these issues without having such a high degree of forced overtime.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Millner.

#### SENATOR MILLNER:

Thank you, Mr. Chairman {sic}. And -- and -- and that's a concern. So they could, in theory, order somebody back. It's not a natural disaster, but if there were nobody to watch the prisoners, this bill would allow them to do that, correct?

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Frerichs.

#### SENATOR FRERICHS:

My belief that in -- in time of emergency, there are exemptions.

PRESIDING OFFICER: (SENATOR DeLEO)

Senator Millner. Senator Millner, in a -- in a committee, it's the Chairman of the Committee, and in the Chamber, it's the President. Further discussion? Senator John Sullivan.

### SENATOR SULLIVAN:

#### SENATOR SULLIVAN:

I rise in strong support of Senator Frerichs' bill. I -- I represent the Quincy Veterans Home and I know firsthand the impact of overtime on -- on many of the nursing staff over there. A previous speaker -- I certainly disagree with a previous speaker who said this is all about collective bargaining. In my opinion, this bill is about a quality of life. It's allowing moms and dads and certainly single parents to spend time with their families. And -- and I've seen the impact of -- of -- and -- and, actually, the turnover in employees because it's had such a devastating impact on the -- on the quality of home life. I just want to thank Senator Frerichs for introducing the bill and I certainly urge a strong Yes vote.

### PRESIDING OFFICER: (SENATOR DeLEO)

Thank you, Senator. Further discussion? Last person seeking recognition before we close, Senator Forby. Senator Forby, for what purpose do you rise, sir?

#### SENATOR FORBY:

Thank you, Mr. President. To the bill: I think this is a great bill. You know, the last six or seven years, all we could hear in this State was head count. Head count is a major issue problem in this State. And I think you're going to see that this new Governor that we got now is not going to say head count. You know, there's money out there to pay for this. I've checked on IDNR. I've checked on IDOT. I checked on several

other entities in this place. There's federal money out there that we could be hiring people and doing stuff. But, the big deal, we did not want no head count. The head count is wrong. We need to hire people and take care of our State. This is a fantastic bill.

Thank you. Thank you, Senator Forby. Okay, Ladies and Gentlemen, Senator Frerichs, to close, sir.

#### SENATOR FRERICHS:

Thank you very much, Mr. President. I think there's been a lot of good discussion on this bill. This is a bill about quality of life for employees. It's also about quality of life for the people we treat. That's why the Veterans of Foreign Wars is a proponent of this bill, because they see what happens when people are forced to work sixteen hours of shifts, how the quality of care decreases. And so I think this is good for all the people of the State of Illinois. And request an Aye vote.

### PRESIDING OFFICER: (SENATOR DeLEO)

On Senate Bill 1370, when federal law first required states to allow residents to register to vote at driver's license facilities, Illinois law was changed to require Secretary of State employees to serve as deputy registrars in the facilities. However, this approach was not successful and an individual can only be a deputy registrar for the county in which he or she resides and can only register voters for that county. Because the Secretary of State facilities have employees from numerous counties and are frequented by residents of numerous counties, it simply is not practical to have all the necessary deputy registrars on duty at all times. Therefore, in accordance with the current requirements of the Illinois

Election Code, Secretary of State employees now accept voter registration applications and forward those applications to the appropriate local election authority. Senate Bill 1370 eliminates the deputy registrar requirements and codifies the current practice.

But then the federal Drug Enforcement Agency had difficulties with the language in the Controlled Substances Act regarding that prescribing authority. They do not have any member of their police department - they're all part-time

I would ask for an Aye vote.

PRESIDING OFFICER: (SENATOR HENDON)

## SENATOR HARMON:

Thank you, Mr. President. I rise in reluctant opposition to my friend Senator Sullivan's bill. I was looking at some of the debate from the past iterations of this bill and I -- I noted that President Cullerton had -- had spoken against this bill in the past and had made some very salient points. And I just wanted to call the attention of the Body to some of these. The physical impact of a truck hitting another vehicle is forty percent greater when it's traveling at sixty-five miles per hour than at fifty-five miles per hour. Senator Sullivan mentioned that our neighbors in Missouri did this very same thing. In the year after they increased the speed limit in 1995, Missouri saw a steep rise in fatalities involving large trucks. In Missouri, they went from ninety-seven fatalities to a hundred and sixtyseven in one year - a seventy-two-percent increase. Illinois, that would translate to an increase of approximately a hundred and fifteen fatalities. So I rise, again, opposition. And I urge caution for those of us -- I appreciate that it does not affect Chicago, but it is a safety issue. And I wanted to call the attention to the Body to those statistics. Thank you, Mr. President.

Thank you, Mr. President. To the bill: You know, we've -we've discussed this over the years. And having -- having a little bit of knowledge about the trucking industry, there -there are -- you know, many -- many more things involved here than -- than just the speed limit. And each -- each and every one of us already knows that the speed limit out there on the highway in the State of Illinois at the present time is for everybody sixty {sic} miles an hour. And as Senator Sullivan said, this does not affect Chicago. When you get north of Joliet on 55 where it goes to three lanes and it becomes like the speedway at Indianapolis when the green flag is dropped and everybody is running eighty miles an hour, that -- that will change. I -- I fully support a sixty-five-mile-an-hour speed limit for trucks. This is an economical thing - economics for the -- for the industry, as well as safety. We're all safer if everybody is moving at the same speed. And this -- this would be an enforcement issue. I would highly support a sixty-fivemile-an-hour speed limit for cars and trucks and a total, absolute enforcement by the State police, county police, local police, any police for all of us, for all of us at a sixty-fivemile-an-hour speed limit. I don't see any difference in the safety issue that we're talking about here with any of us going back to our districts on our cell phones in the left lane on the interstate driving eighty miles an hour and think that it's good policy. That's just plain wrong. This is a common-sense bill. We're all safer with everybody moving at the same speed.

And I -- and I've experienced myself, running down the road, it's a lot better when everybody's running the same speed. So, you know, we're getting -- you know, this -- this is not Chicago, so -- it don't go into Chicago. It's mostly on the interstates. So this is a good bill. We need to pass this bill. And we need to make everybody safer. And this will make the people safer on the highway. Thank you.

## SENATOR SULLIVAN:

Thank you, Mr. President. I appreciate the comments of all of my colleagues on both sides of this issue. I -- I'm very familiar -- I would like to say, with regard to Senator Harmon's comments about Missouri, I'm -- I'm very familiar with Missouri. My district, of course, borders Missouri. And I've spent a lot of time over there in my previous occupation. And Missouri also has -- allows trucks to go sixty miles per hour - all vehicles, for that matter - on all roads, not just interstate highways. And so, when you start to compare -- I don't think we're -- in my opinion, that we're comparing to apples to apples when we

compare Missouri to Illinois, because this bill is specifically on open, rural interstates, where, you know, it's not in congested areas. It's in four-lane -- on four-lane highways, not two-lane highways. And I certainly urge a strong Aye vote.
