It was a piece of legislation that was on the agreed bill list in the Education Committee and provided for, in certain emergency circumstances, a school district could go forward with emergency repairs under twenty-five thousand without the State Superintendent's okay. I -- as soon as I realized my error, Mr. President, I filed a motion to reconsider, hopefully to keep the bill in the Chamber, so I'd give the Members a chance to revisit the vote. The bill had already left the Chamber, is in the House of Representatives now on the certification process. So, I wanted to let the Membership know. I apologize for doing that. We -- we've -- we originally put police officers and -- and people -- and teachers, people who we would expect would have an added protection, and we're expanding this enhancement of assault and battery on the basis of employment to just about everybody. Pretty soon, if you commit an assault or a battery on just about anybody who works anywhere, it's going to be automatically aggravated. And I -- I urge a No vote on this bill.

Thank you. And I appreciate the comments from both my colleagues here.
