It also creates the health care provider deferred compensation plan. Health care providers who participate in the Children's Health Insurance Program, ALL KIDS Health Insurance or Public Aid may opt to participate in the State's Deferred Compensation Plan instead of receiving money for services under this program. The State Board of Investment will develop and establish the program, while the Department of Central Management Services will administer the program. CMS has agreed to be a neutral party to this bill following amendment. We -- and I'll be happy to answer any questions.

## PRESIDING OFFICER: (SENATOR CLAYBORNE)

Is there any discussion? Seeing none, the question is, shall House Bill 489 pass. All those in favor, vote Aye. Opposed will vote Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Madam Secretary, take the record. There are 58 voting Yea, none voting Nay, none voting Present. House Bill 489, having

### SENATOR HARMON:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. House Bill 519 amends the Pension Code regarding the transfer of credits among systems for investigators. In the last General Assembly, we opened the window for transfer of service credits among funds through January 1st of 2008, but several other positions were not specifically authorized to make the transfer. This corrects that technicality and reopens the window for investigators both at the Department of Revenue and at the Office of the Attorney General to transfer their service credits by paying the employee contributions, including the --the employer normal cost plus interest at the actuarially assumed rate. I'm not aware of any opposition and I ask for your Aye votes.

### PRESIDING OFFICER: (SENATOR SCHOENBERG)

Is there any discussion? Any discussion? The question is, shall House Bill 519 pass. All those in favor will vote Aye.

## SENATOR RADOGNO:

Thank you, Mr. President and Members of the Chamber. House Bill 547 creates the Identity Protection Act. This is a result of a June 2006 task -- Social Security task force that made recommendations to protect the public from identity theft. There have been a number of changes made to the bill over the last few years, so there is now no opposition and it is ready to be put into effect. So I would ask for your Aye vote.

### SENATOR CRONIN:

If I may, I'd like to draw your attention to the gentleman seated on my left here on the Senate Floor. I wanted to just offer a sort of commendation to Dean Clark who has served as a very valuable member of the Illinois State Board of Education. And I know it's a labor of love for those that serve on the State Board of Education. And I know that Dean Clark has really thrown his whole life into the mission of education. He's very active locally. He's a businessman. He's very active with the school community. But he really has -- he's a great example of citizenship, who's really devoted a considerable amount of himself to this cause. I asked Dean, I said, "Dean, how long have you been on the State Board exactly?" And he said, "Six years, four months, twelve days". So, it's been a very trying experience. He's done a marvelous job. He's a great citizen. He's a great advocate for kids and schools and schoolchildren. And I just wanted to invite all of the State Senators to give

Thank you, sir, for your service, Dean. And will you please rise? With leave of the Body, we will return to House Bills 3rd Reading, House Bill 436. Senator Lightford. The lady wishes to proceed. Madam Secretary, please read the bill.

Senator Lightford.

### SENATOR LIGHTFORD:

Thank you, Mr. President, Ladies and Gentlemen of the Senate. House Bill 436, as amended, affects the Code of Illinois and the State Finance Act regarding ex-offender loans. This is a bill that I'd first taken to the Commerce Committee. They shared some concerns. I drafted an amendment to try to make the -- the program much stronger and I believe we've done that. The bill would allow DCEO to establish an ex-offender business ownership grant and loan program. It awards grants to organizations that work with ex-offenders so they can provide low-interest loans to them that would not exceed five thousand dollars in an effort to mentor them to start and operate positive businesses with their re-entry into society. It also awards grants to organizations to be used solely for the purpose of an ex-offender acquiring a business plan that's developed in assistance by a creditable source. And in order to receive a

grant, the qualified ex-offender must apply and then provide fifty percent - they have to invest half - of the cost to develop the business plan. It is permissive for the Department of Commerce and Economic Opportunity so that it would alleviate any possible audit concerns. And it came over as a result to the Second Chance Act of 2007 that Congressman Davis passed in Congress and former President Bush signed on -- in April of 2008. And so it would establish this Ex-Offender Fund. No moneys from the State of Illinois - all federal dollars. And our agencies were there to assist me making this bill stronger. I'll be happy to answer questions.

PRESIDING OFFICER: (SENATOR SCHOENBERG)

Is there any discussion? Senator McCarter.

SENATOR McCARTER:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR SCHOENBERG)

Lady indicates that she'll yield.

## SENATOR McCARTER:

Senator Lightford, I -- I recognize your -- your good intentions on this -- on this bill. I -- I also know that it is difficult for ex-offenders to acquire loans to start new businesses. In fact, on every SBA loan application, there's a specific question that says, "Have you ever been arrested?" So, there's a concern in issuing any kind of a loan to a exoffender. Why? Because they're not really sure they're going to get the money back. So, for that reason, I have -- that's one of the reasons I have a concern. But one of the things that we talked about to make this successful was the need of a mentoring program. And -- and, actually, when we -- when we

first heard this, that was the result of that first hearing, is that there would be a mentoring program required for this. But as of such, I haven't seen it. It's -- have we included that mentoring program and is it specifically stated that is required in this?

PRESIDING OFFICER: (SENATOR SCHOENBERG)

Senator Lightford.

### SENATOR LIGHTFORD:

Senator McCartney {sic}, you asked a couple questions and one was who was going to -- you were concerned that the exoffender would not pay the loan back and that's the reason why I down with the Department of Commerce and Opportunity, the Department of Corrections, the State Treasurer, the House sponsor, the House staff, the Senate staff and myself. We all sat down to craft a program that we thought would be more than what the House sponsor sent over, in lieu of some of the concerns that you had. Now I have in front of me a copy of a not-for-profit organization that assist ex-offenders and they have the mentoringship opportunity there. They have vocational training, transportation, recovery home, continuing care, recovering coaching, spiritual support, drug-free transitional housing. We all know that many ex-offenders, in order for us to reintegrate them into society, they need some type of assistance. And so we have these not-for-profit organizations, like the Safer Foundation, for example, the IOTA Incorporated, who are already assisting ex-offenders. would just be another opportunity for them to provide the fivethousand-dollar loan. It's not money to just give them. It's a loan to assist them in developing their business plan and

carrying it forward. A business plan meaning ownership. It's something that I thought you'd love - business. So why would you want to stop ex-offenders from having the opportunity to establish their own business, to become reintegrated into society, to move them off of our Correction's payroll? Where now we're literally paying thirty thousand dollars or more a year to house them. Instead, why don't we let them have an opportunity to start their own business and allow them to be taxpayers and they pay back into a system that they once had taking care of them? So, through not-for-profit organizations, that's where the mentoring program comes in. So if you don't see it written clearly that it's a mentoring program, perhaps you ought to visit some of the not-for-profit organizations that assist ex-offenders or go over to the Department of Corrections and meet with a parole officer, then you will learn the exercise in how we try to support ex-offenders from recidivism. So, I think that we have a good program here. I believe that all the agencies were involved to support it. We, in fact, had that the loan would not exceed three percent. We changed that. We made the loan two percent, lowered the prime. We addressed every concern that you have.

PRESIDING OFFICER: (SENATOR SCHOENBERG)

Senator McCarter.

### SENATOR McCARTER:

Senator Lightford, I -- I guess if -- I still do have some concerns with this. I understand it appears as though we're not giving the money -- money away, but when you -- you arrange to loan someone money with very little chance of getting it back, you're in essence giving it away. Now, I -- I know -- I'm not

sure the types of businesses that were discussed in the -- in the -- in the committee - hot dog stands, barbershops and lawn care businesses - can really be started for five thousand, to include the business plan. That's another reservation I have. But I -- I -- I suppose I was looking for the language within the bill and I just didn't see it. And if -- and if you can tell me where it's at, that's -- that's fine. I -- I just like to know where it says in the bill that organizations like this -- in fact, I don't know the organizations you mentioned - but I just need to know where in the bill where it says that mentoring programs will be required, because I believe that's the only way we can success -- make sure that this is going to be a success for these people that we're trying to help.

PRESIDING OFFICER: (SENATOR SCHOENBERG)

Senator Lightford.

## SENATOR LIGHTFORD:

Senator McCartney {sic}, that's what these not-for-profit organizations like Safer are. They're mentoring organizations for men and women who have been released from incarceration. If you need it to be so elementary stated, that's what the organizations consist of. You know, it bothers me that you would want to debate a five-thousand-dollar loan that is not State money. It's federal money that is coming to the State through the Second Chance Act of 2007. And the only way we can secure that support is to establish an ex-offender fund. Now instead of the money in the original bill going directly to the person, it's going to the not-for-profit organization, who is already audited, who already help this clientele, who already provide a number of services that I've listed to you. Five

thousand dollars is enough money for an ex-offender to develop a business plan. I spoke with you about this issue. You told me that you knew people who had been released from incarceration. In fact, you stated two people. One, you said, well, he's got a job, and the other one, his parents gave him fifty thousand Now, many individuals I know released incarceration, if their parents would give 'em fifty thousand dollars, if they knew their parents, if they were in a situation where they can get fifty thousand dollars from their parents, perhaps they wouldn't have been in the situation they were in that led them to the institution in the first place. And so I'd like for Members to be open-minded to the fact that this is a loan that will be paid back to the organization, however they deem to set that up. It has nothing to do with State money. It's from the federal government. And I just don't understand the debate.

PRESIDING OFFICER: (SENATOR SCHOENBERG)

Senator McCarter.

SENATOR McCARTER:

To the bill.

PRESIDING OFFICER: (SENATOR SCHOENBERG)

To the bill.

SENATOR McCARTER:

Ladies and Gentlemen, I -- I just don't think this is a -- a good gamble to be taking when we're -- we're trying to protect the -- our taxpayers' hard-earned money, especially during the state -- the -- the financial state we're in. I don't think we should be making risky loans like this. As well, the Second Chance money is federal money, but you know what? That's my

constituents' money, too. I don't distinguish between State money and federal money. It's all my constituents' money. I'm concerned about it. Also, the Second Chance program is able to help these same organizations that we're brokering money to. We're basically -- we're going to take funds - federal funds from Second Chance and we're going to be the brokers to other organizations that help ex-offenders. Now, I -- I -- I expect that we've just got a lot of time on our hands and we don't have other serious things to do. But I -- I just don't think it's -it's right for us to be doing this. It's -- it's -- it's not a good risk and the mentoring program is not being mandated within it. And considering the -- the more important things we have to do regarding the State and our financial situation, I suggest we leave this up to the federal government Second Chance program to -- to go directly to the organizations. And it'd probably be best for us just to step out of this. I -- I encourage a No vote.

PRESIDING OFFICER: (SENATOR SCHOENBERG)

Senator Kotowski.

### SENATOR KOTOWSKI:

Thank you. Thank you, Mr. President, Ladies and Gentlemen of the Senate. I want to thank the sponsor for her great work on this bill and for commitment to -- to making changes to meet the needs of people on the committee. You know, I'm kind of mystified why there's so much opposition to this bill. I mean, the fact is, there's money out there from the federal government for this program right now to help ex-offenders. It's not like it's a fiction. It's a reality. And people can go and get funds to help support someone who's working on a business plan

and they have to provide fifty percent of the money up front fifty percent up front. So this isn't something that's based in a fiction. This is a reality. And you know what? news about this bill is it sets up a structure whereby DCEO can put safeguards in place that -- where the -- the organizations that are out there that work in mentoring, that work in exoffenders. See that's important. I worked in nonprofits for fourteen years. You could start a nonprofit for just about Sometimes the safeguards in place are important. This is one of these cases. So I applaud the sponsor. reality is, I know people are afraid of providing dollars in support for ex-offenders. I get it. I get it. But the fact remains is the dollars are out there. This is a good program. This gives people an opportunity to create jobs and make something out of their life. So I applaud the sponsor. I applaud what she's doing. I think it's silly that we're having a debate over this. And let's pass this bill.

PRESIDING OFFICER: (SENATOR SCHOENBERG)

Senator Lauzen.

### SENATOR LAUZEN:

Thank you very much, Mr. President. I -- I am -- all respect to the sponsor. I respect your work and -- lovely lady. I have to say we ought to be examining our brains to be passing something like this. I have spent my entire life since I was fifteen years old serving small business. It is one of the toughest things in the world to succeed at. Only fifteen percent of the people who start in business three years later are still in business. That means that there's an eighty-five-percent failure rate. Now, we already have in -- the -- the

people who are trying to help in this, with five thousand dollars -- and I took care of the books at one point through an organization of four hundred and fifty offices around the country - twenty-two thousand small business clients. number one reason why folks fail is undercapitalization. create the expectation and the false hope that five thousand dollars is going to allow you to be successful in business is a form of insanity. I have sat at hundreds of small business owners' kitchen tables. I have seen marriages break up over, frankly, a spouse saying to another spouse, "You're not the man I married anymore", because of the failure. The wife leaves, takes the children. The person collapses. Now is this really what we want to do. Now I know that there's an argument that says that, "Well, but this is federal money." Like it don't count. Well, I'll tell you what: If I waste money out of this pocket in my pants, the federal pocket, or this pocket of my pants, the State, we're still wasting money. So it is a form of insanity to vote Yes on this bill. It is wrong and I don't think we can look any of our constituents in the eye and say we are the guardian of your money when we say that we're going to trust. We've had credit meltdowns in all areas. This is the type of legislation that leads to bad debt and credit meltdown. Please, don't do this. Vote No.

Senator Emil Jones, III.

#### SENATOR E. JONES:

Thank you, Mr. President. I rise to move the previous question.

SENATOR RAOUL:

### SENATOR RAOUL:

I appreciate Senator Kotowski's enthusiasm on this bill. I think my -- my -- I think my emotions -- I think Senator Kotowski sucked all my energy out and -- and -- and -- and my -my enthusiasm from yesterday rubbed off on him, maybe on the softball field. But I -- I rise in strong support of this bill. You know, the -- the Second Chance Act had bipartisan support because the United States Congress - folks on both sides of the aisle - realized that we've got to do something. We've got to do something to reduce recidivism and to allow people who have paid their debt to have an opportunity to participate in our economy. I sponsored a bill earlier this Session and I worked well with Senator Righter to -- to remove some of the barriers towards obtaining licenses for ex-offenders. But many barriers still exist, barriers to employment. So if we're going cut the pathway to employment with other entities for ex-offenders, what other options do they have? Well, there's two that I see. One, is recidivism - crime. The other is to employ themselves, is -is entrepreneurship, is small business. So let's -- let's just look at this logically. We're -- we're not removing barriers enough to employment with other entities and so we leave them with two other options - crime, which impacts everybody and

impacts us economically, or let them provide for themselves through small business. And I think that this is -- this is a well-drafted bill in the spirit of the Second Chance Act. Should be supported on both sides of the aisle. I -- I -- I strongly urge a Aye vote on this.

Senator Delgado.

SENATOR DELGADO:

Thank you, Mr. President. Will the sponsor yield?

SENATOR DELGADO:

Senator Lightford, first of all, Small Business Loan Association gives small business loans to potential businesses.

Isn't that correct?

PRESIDING OFFICER: (SENATOR SCHOENBERG)

Senator Lightford.

SENATOR LIGHTFORD:

Yes, Senator.

PRESIDING OFFICER: (SENATOR SCHOENBERG)

Senator Delgado.

SENATOR DELGADO:

So we could intelligently assume that all -- not all loans then are paid -- then are paid back and -- and -- by the SBA, and some of those businesses fail, too, don't they?

PRESIDING OFFICER: (SENATOR SCHOENBERG)

Senator Lightford.

SENATOR LIGHTFORD:

Yes.

SENATOR DELGADO:

So, to the bill, Mr. -- Mr. President: The difference is...

SENATOR DELGADO:

...many times -- and I'm speaking from the perspective of a former felony parole and probation officer that I was in another state in my career. And when we talk about making a difference, maybe some of those people who are getting those loans in the Small Business Association -- the difference between them and some of these ex-offenders were they didn't get caught in any of their errors as younger people, but they, too, fail. And when I opened up my business in Miami as -- with three thousand five hundred dollars and created a Subchapter S corporation and bought access to DuPont Teflon to do high-line vehicles and aircraft and boats, that made us a pretty profit. And that small business did make it. One of the previous speakers talked about failure. But more importantly, as someone who has had parolees and probationers on a felony level, they have met their contract. They have served their dues and that contract is to be penalized. That's where the word "penitentiary" comes from penance. And they have the -- they have the right to have a second chance in America, to be able to be picked up from the bootstraps and to be able to have and move forward with their lives, because they have met their obligation to that state, county or city jail. So when we also talk about having to -- to -- to rehab and give someone a second shot at the American

dream, we have to stop getting -- get away from the keepers and the kepts. We have to get away with -- with saying that they'll never make it, because we are pretty much cutting off part of our society as never being able to be brought up again once upon It could be our children. It could be our nephews. And it could be our neighbors. So let me let you know, as a standing person who has experience on both ends, that when I took on a parolee or probationer, we know who the good ones are. Those loans will go to the right ones and they're very ambitious, because apparently they were pretty good businessmen on the street until they caught. So now let's give them an opportunity to shine one more time, because this is the way it works. Once upon a time there was a man who had -- who fell three times and he was able to stand again and dust himself off. Let's give that chance, because they did their time. signed that contract and they've repaid their costs, so they paid that penance. Let's vote Yes and let's do the right thing. And now I'm a State Senator, Mr. President. And to close, I am proud to say, knock on wood, none of my cases have come back and recidivised and that goes from the DCFS wards to the parole and probation adults that I had on the felony list. And I ask for an Aye vote.

I -- I wish to commend the sponsor. We know that she has been a strong advocate in ensuring that we're -- all the citizens of the State of Illinois, all 12.5 {sic}, have equal access to all the opportunities that it has to give. I feel compelled to speak because I'm just really shocked at some of the debate that I've heard today, especially from individuals who know -- who knows how this system works. Not surprised from those people who might -- might have just gotten here and doesn't understand that we have mechanisms in place to make sure that our taxpayer dollars are not misused. DECO {sic} (DCEO) is one of those agencies. Surprised not necessarily to not hearing from them and saying, "I don't see stuff in the bill." Well, we have JCAR, which promulgates bills for us, which is a rule committee that we have that really spells out the intent that is there. Every -- every word and every dot -- i is not dotted in every bill. But the intent is there. This intent is to allow people to have a chance, a second chance if you will. And the -- the inference that these ex-offenders are hardened crooks and will not assume any kind of responsibilities of paying back their bills, is assuming that every ex-offender is an armed robber, every ex-offender is a bank robber. That -- but we know that there are a lot of nonviolent ex-offenders out here and they need a chance to get on with their lives. We know that unemployment in the State of Illinois is higher than -- than most states. Well, one of the ways for us to get back on our feet, to make this State viable again, is to ensure that we give opportunities to people when there's a chance. thousand dollars is not a lot of money, but it's an opportunity. It's going to put Illinois back in its posture of taking care of

our own, starting with that five thousand dollars -- the things that built this State in the first place, and that is little, small mom-and-pop stores and businesses, not no conglomerate. We're not talking about opening up a new grocery store. But it can open up a little store on that block. We're not talking about a big furniture store; it might be a used furniture business. But this is a help using our federal dollars, which all states get, not just Illinois. All states get these dollars to help these individuals to get that needed opportunity and we have gone further by ensuring that DECO {sic} This is not just has them mentor with established groups. giving your friend, who's not an ex-offender, some money who's just going to pass it to you. We have groups out here with intelligent people who knows how to work with non-for-profits, knows how to work with individuals and successful businesses that -- who's going to be overseeing these dollars. It is just wrong that we here in Illinois don't recognize that. Wrong that we don't want to have individuals have another opportunity to get on our taxpayer rolls. We need those dollars. dollars will multiply. That fifteen percent that was mentioned that are successful, well, let's -- let's all pray for them and hope that that number is larger, that eighty-five percent of these individuals do not fail. There will be some failures, but if we don't give 'em a chance, it will be higher than that. The cost to our State will triple. Let's pass this bill. Let's do the right thing. Let's stop being naïve and just hateful. This is -- and judgmental. This is the right thing to do and I ask for an Aye vote.

I've not asked for an appropriation from the State of Illinois. We are going to secure federal dollars that was designed from

the federal government to assist this country in helping exoffenders. And this is a program that I believe will be very beneficial to them. I've spoken to the warden at the Stateville Prison who has a barber and teaching school there. teaching them how to become licensed barbers. They -- giving them certificates. When they get out, if they want to open a barbershop, they need help. They can't go to a bank and acquire a traditional loan because they have no credit. So here's an opportunity for them to go to a community organization that is providing services for ex-offenders already. They're doing it. As Senator Trotter indicated, they're intelligent people. know their jobs. They know how to assist in turning their lives around. This is just another tool that would help them. would help them perhaps purchase the liability insurance that they would need. This is a example of one that I already have. It would help them purchase and receive their L2R 123 letter of certification from the Illinois Department of Revenue. It would help them purchase their BCA 2.10 Articles of Incorporation. That's a hundred and fifty dollars right there. It would help them get their license so that they can be certified. It would give them all the assistance here that they need in order to pay two hundred and fifty dollars to the City of Chicago for their license. Five thousand dollars can go a long way in helping a individual say, "I want to purchase a lawnmower and some cutters and I want to go door-to-door in my community and start a lawn care service." Well, how much money do you need for that? want to open a barbershop. I just need to rent a spot. I can cut hair. I'm licensed." How much money do you need for that? "I want to wash windows. I want to go to all the storefronts in

my community and knock on their door and ask them, can I clean their windows?" How much money do they need to start a business like that? How much money do they need to get a hotdog cart and sell hotdogs and chips and pops outside of the hospitals, just in areas because their licensed to sell fruit? Have you ever stopped and purchased anything off of those carts? would it cost them to do that? Five thousand dollars would go a long way in helping this individual do what? Become a taxpayer citizen. No need of hustling and selling drugs no more, because he's making or she's making decent money to take care of their No need of robbering. No need to robbing the neighbors. They got their own income. And it baffles me, it does, that everybody don't get it. What's so difficult about the importance of reducing recidivism? What's so difficult about understanding that we want safe communities? parolee is released back into my community, I want to make sure he has an opportunity or she has an opportunity to get back on their feet so they're not hustling my child to become a gang member and sell drugs for them. Get it, people. This is not about Republican. This is not about Democrat. This is about investing in human lives. These are non-violent offenders. I made sure of that. The only opposition was the group who wanted violent offenders to be included. But guess what? I knew you quys wouldn't get that part. So I made sure it was the nonviolent offender. I also made sure that at the end of the day, nothing is quaranteed. But when you lend a hand and you give people an opportunity, you'd be surprised how you can turn their lives around and make a difference. So I just ask everyone in this Chamber to recognize that we passed a capital bill

found to be in need of diagnostic evaluation or treatment, or both, for -- for prostate and testicular cancer. This is modeled after what we did a few years ago for those who -- those females who suffer from breast cancer.

It also codifies that employees only have to sign -- not only -- it does codify that employees only have to sign one, not both. The legislation also seeks to keep any documents provided by the Illinois Public Labor Relations Board and the Educational Labor Relations Board

confidential and not to be released to employers. The legislation additionally sets a one-hundred-and-twenty-day time limit for the Board -- or the Boards to certify the employee organization after the presentation of dues cards or interest petitions to the Illinois Public Labor and Educational Labor Relations Boards. Additionally, the -- House Bill 2445 requires the Labor Relations Board to employ sixteen attorneys and six investigators and the Educational Labor Relations Board to employ eight attorneys and five investigators. And, finally, the -- much of what is in this legislation is a codification of what was in the Illinois Supreme Court in 2008 in the County of DuPage versus the Illinois Labor Relations Board. I'd be more than happy to answer any questions.

The reason we stand here now with a twelve-month extension, Mr. President, with all due

But it clarifies that offenses do not apply to picketing or other protected actions by organized labor. A recent U.S. Department of Justice study said that seventy-six percent of female homicide victims were stalked first, prior to their death. It's terrifying and it's something that we need to do all we can to protect our victims from. will broaden the definition of stalking. It amends the Criminal Code to update our stalking laws. It updates the cyberstalking So it encompasses all technologies that stalkers use to track and harass their victims. This is our opportunity to make sure that our Criminal Code follows twenty-first century technology. And it creates special considerations for stalker's bail and requires electronic monitoring of stalkers released on bail. This is an initiative of the Attorney General's Office. I'm extremely proud of this legislation, and I would ask an Aye

And because revenues are down everywhere and jobs are down everywhere, they needed to find some way to be able to support the -- the charitable trusts that they already -- that they already -- that so desperately need their help. I know that there are people who are against license plates or another additional license plate, but I would ask for a favorable vote. PRESIDING OFFICER: (SENATOR DeLEO)

Thank you. Is there any discussion? Is there any discussion? Senator Rutherford, for what purpose do you rise?

SENATOR RUTHERFORD:

To comment on the legislation, if I may, Mr. President. PRESIDING OFFICER: (SENATOR DeLEO)

To the bill, sir.

### SENATOR RUTHERFORD:

Thank you very much, Mr. President. We're creating -- if this goes into law, we're creating two more specialty license plates. Earlier today, I believe, we created, if they became law, an additional three. So we're up to five. The day before, we created one or two more. I'm going to remind you all, once again, that Secretary of State Jesse White actually had to go out and publish a specialty brochure so that law enforcement, when they sit in their vehicle, to have to pull somebody over, they can look down at least eighty different designs to

determine what kind of specialty license plate that they are questioning. I understand the underlying intent for the purpose of the funds, but there exists today on the books, since 1995, the ability for the Secretary of State to create the Universal Charitable License Plate and we have yet to promulgate the rules to do that. If we did, we would be able to do the Teamsters' needs, the UAW's needs, the "mommy loves apple pie" needs, the Boy Scouts, Girl Scouts, Kiwanis, Rotary and Lions Clubs all within a Universal Charitable Plate. So with all respect to the Senator's good intent, I am going to stand in opposition as I have for every specialty license plate now for the last decade.

#### SENATOR MURPHY:

Thank you, Mr. President. House Bill 3729 allows non-home rule cities in counties of three million or more which have an in-house convention and visitors bureau as a department of the city to use hotel tax revenue for general municipal purposes as well as promotion to tourism. Requires the city to have a separate vote and ordinance to authorize the use of the hotel tax in the annual budget to ensure that the public is aware. -- in -- in the Village of Prospect Heights, who is, I believe, the only municipality that fits this direction, we've got a situation where you've got a surplus in this specific fund and the roads in front of the hotels are pothole-ridden in the nonhome rule community. They're going to have to layoff police, they're telling me, because they don't have the municipal budget to fund them, but they're sitting on a surplus in this other area of their budget. What they're asking for, they think tourism requires a decent road in front of the -- the hotel and they think it requires a safe reputation and a strong police They're asking for a little bit of flexibility to address these concerns. They're asking for a flexibility that home rule communities already have without coming down here.

And I'd ask for an Aye vote.

PRESIDING OFFICER: (SENATOR DeLEO)

Is there any discussion? Is there any discussion? Senator Dahl, for what purpose you rise?

SENATOR DAHL:

Thank you, Mr. President. To the bill.

PRESIDING OFFICER: (SENATOR DeLEO)

To the bill, sir.

SENATOR DAHL:

This -- this bill came in front of Local Government Committee and -- and we asked for the amendment that Senator Murphy was willing to put on it. I -- I think that basically what the amendment did, it made a terrible bill a bad bill. it did make it a little bit better. The -- the issue here is that, you know, this has been tried in -- in the past. In fact, I tried it myself last year and couldn't even get it out of committee. We were attempting to use pillow tax for county and village government to -- communications and for a small amount to be used for safety to buy vehicles and cars, and -- and the reason was that Starved Rock State Park does not have rescue on their own and it's up to the counties and municipalities to -to do that. I -- I think if we're going to take this bill to the point where we're using it for one community, it should be a statewide bill where every county, every town, every community is able to use a portion of their pillow tax for -- for safety needs and not just one community. We're -- we're heading down a slippery slope here and I encourage a No vote.

I'll just get to the bill, because I think Senator Murphy answered the question for me very well. This is a dedicated

fund for tourism and it's tourism to the State of Illinois, which is used to promote tourism in our State, which is the number one attraction. When we talk about competition, we're talking about competition with other states - Indiana, -- Iowa, Wisconsin -- Missouri, every other state. We're trying to promote tourism. That's the reason this fund was put in place. If you have such a surplus that you're trying to sweep this fund, then they're not doing their job of promoting tourism in this community. When they said they have road problems and that, they should -- that means they must have a lot of tourism coming in and they should be promoting it even more. This is as -- as Senator Dahl said, we're setting a terrible precedence by doing this. This bill is setting an example that we shouldn't -- on a road that we should not be going down. I have stood here and listened, especially from the other side, about we should stop sweeping funds of dedicated funds. Well, if you truly believe this, this thing should have a lot of red lights coming up. I ask for all No votes on this.
