In 1991, he negotiated the release of foreign nationals and British and American -- more than twenty Americans from Iraq. Ladies and Gentlemen of the Chamber, it is my pleasure to introduce to you someone who's very special in my life and, in a way, is special to all of our lives and -- and touches all of our families directly or indirectly. My stepmother, Rita, is here with us, who, among her many wonderful acts on behalf of our family, is also a retired hospice nurse. SENATOR BISS:

Thank you, again, Madam President. Senate Bill 2196, as amended in the House, accomplishes three somewhat related things. The first is some corrections to a bill that we passed just this past spring, which in turn was clarifying the bill creating the Tier 2 pension system for the State University Retirement System. These are entirely technical clarifications to make the intent of that bill entirely unambiguous. The second is some changes to the return to work laws for the State University Retirement System. There's some -- some technical changes that were worked out between the employers and the Retirement System to make sure that implementation would be smooth. And there's also a -- a -- a fairly modest change to tighten, simplify, and strengthen the reform by eliminating what's known as the "eighteen paid week" condition. I do want to make special mention, 'cause I know there was some anxiety on a related topic last spring, that there's no -- no delay of the reform in this language, and I believe that

this clarification to the return to work provision is entirely uncontroversial and indeed supported by -- by all parties. Finally, there's a provision that the University of Illinois shall operate the School of Labor and Employment Relations as a district {sic} and autonomous entity within the University of Illinois for purposes of offering curricula and other educational programs. Appreciate your support and happy to take any questions.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Is there any discussion? Seeing none, the question is, shall the Senate concur in House Amendment No. 2 to Senate Bill 2196. All those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 43 voting Yea, 12 voting Nay, 0 voting Present. Having received the required constitutional majority, the Senate does concur in House Amendments {sic} No. 2 to Senate Bill 2196, and the bill is declared passed. Senator Steans, on Senate Bill 2352. Out of the record. Senator Link, on House Bill 1604. Senator Link. Ladies and Gentlemen, we're on page 5 and Secretary's Desk, Nonconcurrence. Senator Link indicates he wish to proceed. Mr. Secretary, please read the motion.

SECRETARY ANDERSON:

I move to recede from Senate Amendment 1 to House Bill 1604. Signed by Senator Link.

Senator Link.

SENATOR LINK:

Thank you, Madam President. The underlying bill of 1604 amends the Property Tax Code and would allow assessors in counties

with less than three million to declare a property that receives homestead exemption that it is not entitled to as an omitted assessment, but we -- that is the underlying bill that we passed and I would like that to be the bill.

SENATOR ALTHOFF:

A comment to the bill, please, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

To the bill, Senator.

SENATOR ALTHOFF:

Thank you very much. I'd like to thank Senator Link. This has been a work in progress for a very long time. We were working with the Realtors, not only over the Session, but over the summer. This is an excellent bill. It's supported by every single assessor, I believe, in the collar county area and I certainly, when we get to that opportunity, would urge an Aye vote.

SENATOR MUÑOZ:

Thank you, Madam President. The bill creates a tax credit to the incentive {sic} developers to develop properties -- are owned by the State and had more than a hundred employees at any time during two years preceding the bill's effective date. The credit would be equal to thirty percent of expenditures. The credit cannot exceed ten million per project. Only a total of forty million of credits can be issued. Credit can be transferred and be used against some income taxes or insurance taxes. I know of no opposition to the bill.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Is there any discussion? Senator Hastings, for what purpose do you rise?

SENATOR HASTINGS:

To the bill, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

To the bill, Senator.

SENATOR HASTINGS:

I want to say thanks to the -- to the sponsor for bringing this bill. Tinley Park Mental Health Center is one of the properties that'll be affected by this. It has a lot of issues in

terms of environmental impact when it's destroyed, rebuilt or redeveloped. This bill will help developers, incentivize them to revitalize our area. And I want to say thanks to Senator Muñoz for that.

And this bill should help spark private investment in shuttered State facilities, which will be a great boon to the affected communities. So, again, thank you, Leader Muñoz. I urge an Aye vote.

Here's my concern, and -- and hopefully you can keep me from thinking this is enough problem to say -- to vote No against this bill. But what would keep someone on the east side of town - the other side of town is this facility - from closing their facility and coming across town to take advantage of this program?

Senator Muñoz.

SENATOR MUÑOZ:

The way it's in the bill, this is not for any other company to come in unfairly or to take advantage of the opportunity. This is for — in areas that are having this problem or it's an eyesore. The State owns the facility. The State is spending money. I'll give you a simple example. In Joliet, the mayor that spoke in committee, it's 3.7 million dollars just to keep it secured for the prison in Joliet. That's an example. I don't know if that helps you any.

SENATOR McCARTER:

Not -- not really, Senator, because here's -- here's the -- here's my concern. You want to make sure that a abandoned State property, like one of our developmentally disabled institutions or prisons, doesn't cost the State more to upkeep. I understand that. You don't want it being an eyesore. I understand that. You're going to give someone an advantage, a saleable tax credit, which I think are great, to actually come in there and do something with

it. But if we're just shifting it from one side of a town to the other side of a town, we've created a -- the same problem on the -- where these people left from. Now, if you're saying if somebody comes from out-of-state or, you know, to -- to -- to locate there and invest there in the community, that makes sense to me. I'm just afraid, as much as we need the -- we need to -- the State needs to get out from under the -- the burden of these properties and to allow that to be invested in the communities, specifically my community, that we're just going to have a -- a shifting, just like we did with STAR bonds, potentially, to give people the -- the -- the motivation to relocate from one side of town to the other. Is it possible that we can come back, kind of qualify that, so that this can be a better and safer bill for those communities, including mine?

I would say what's in the bill now -- there is safeguards in it, and I'll tell you this much, Senator, if a certain municipality wants to do what this bill talks about, they're going to have to go to the local mayor. I'm sure they're going to vote on it. There's going to be -- they have their own safeguards. Each municipality's going to do it. I -- I don't think a company can just come in and say, from one side of town, and -- we're going to go in there and take control over a certain property. That's not what this bill does.

I'll look for that in the bill, but that's not the way I have it here. DCEO must approve a qualified rehabilitation plan outlining eligible expenditures for qualified structures for qualified taxpayers.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator McCarter, to the bill. To the bill, Senator McCarter. SENATOR McCARTER:

Thank you. I understand what they're approving. They're approving the actual rehabilitation cost and expenses. They're not approving whether it is going to negatively affect another part of their town. They don't have the ability to stop that. They only have the ability to approve the expenses and especially when -- and they -- then they have to get an actual audit when it gets up to a million dollars. So that's my concern about the bill. I think it's -- we're thinking in the right direction. Until you can come back and protect our communities from a -- a simple transfer from -- of one company from one side of the town to the other, I have to be in opposition to the bill. I apologize.

I move to concur with the House in the adoption of their Amendments 2, 3 and 4 to Senate Bill 1523.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

President Cullerton.

SENATOR J. CULLERTON:

Thank you, Madam President, Members of the Senate. This bill amends the Chicago Park District Pension Article. And the bill phases in an increase in employee contributions from the current nine percent to twelve percent in 2019. Employer contribution will also be increased and the supplemental employer contributions will be made in 2015, '16 and '19. The bill reduces benefits for Tier 1 members, and the retirement age for those younger than forty-five will increase from fifty to fifty-eight. The COLA for Tier 1 members will be reduced to the Tier 2 COLA, and there will be no COLAs in 2015, '17 and '19. There's also a duty disability, which will be reduced from seventy-five percent of salary down to seventy-two percent of salary. And any benefit increases that we in the General Assembly may pass in the future, we would have to identify a funding source, otherwise the benefit increase will be null and void. The bill also does lower the retirement age for Tier 2 members from sixty-seven to sixty-five for retirement and sixty-two to sixty for early retirement. is true that there are some unions that are not even representing anyone at the Park District who've indicated that they're opposed

to the bill. And I assume that that is because they're taking the position that the bill is unconstitutional. But as I've said before on a number of occasions, we here in the Senate are not the Supreme Court, and unless we pass a bill that someone can challenge, it's all -- we're never going to know. This is a bill that's very similar to the bill we passed for the Water Reclamation District, which I sponsored and which has not been challenged. If -- if these unions object to this bill, they can go to court. They can -- we know what their arguments would be. They would say that we're unilaterally increasing employment -- contribution rates without any benefit increase, and there's no consideration. All those arguments would be made. There's no funding guarantee. But let 'em make it in court. In the meantime, we should pass this bill and recognize the fact that this pension system has come together to try to improve their finances. They need our support. And for that reason, I would ask for an Aye vote.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Is there any discussion? Senator McCarter, for what purpose do you rise?

SENATOR McCARTER:

A question, please.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Sponsor indicate he'll yield. Senator McCarter.

SENATOR McCARTER:

Senator, have the -- what has the -- have -- have you been talked to by the unions in any way that they -- and have any indication from them they might file a lawsuit over this plan?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

President Cullerton.

SENATOR J. CULLERTON:

No. There's a number of unions that are affected. Some of those unions -- when I say affected, they have members in the Park District. Some of those unions have indicated they're supportive of the bill. Others are neutral and some are against. So, you know, we can't predict what -- what they want to do. As I said, the Water Reclamation District was a bill we passed. That's been on the books for, I don't know, a year and a half or so. No one's filed a lawsuit there. And that was a similar type of bill, where we increased contributions from employer/employee. And the same arguments, legal arguments, could be made, but they haven't been made yet.

Senator Muñoz, on Senate Bill 1787. Senator Muñoz, on Senate Bill 1787. He indicates he wish to proceed. Mr. Secretary, please read the motion.

SECRETARY ANDERSON:

I move to concur with the House in the adoption of their Amendments 1 and 2 to Senate Bill 1787. Signed by Senator Muñoz.

SENATOR MUÑOZ:

Amendment 1 and 2 amends the Funeral or Burial Funds Act to allow the Comptroller to refuse to issue or suspend the license of a seller of pre-need contracts under Illinois Funeral and {sic} Burial Funds Act and -- if the applicant/licensee engages in a lockout, as defined in the Employment of Strikebreakers Act, and the Comptroller has a reason to believe that the lockout is negatively affecting consumers. I -- ask for its adoption.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Is there any discussion? Senator Dillard, for what purpose do you rise?

SENATOR DILLARD:

Just -- can you come back to me, Madam President, after Senator Muñoz is finished on this bill, please?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Absolutely. Senator Righter, for what purpose do you rise? SENATOR RIGHTER:

To the bill, if I $\operatorname{\mathsf{I}}$ -- I'm sorry, to the motion, if I might, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

To the motion, Senator, please.

SENATOR RIGHTER:

Thank you, Madam President. Ladies and Gentlemen of the Senate, Senate Bill 18 -- 1787 was the subject of some discussion, some heated discussion, in the Executive Committee earlier today. What we have before us is a situation whereby the Comptroller's

Office in Illinois regulates the sale of these -- these pre-need insurance products. So if a family doesn't want to have to deal with the details of a funeral at the time when they're grieving, they can go in early and make those arrangements early and -- and a funeral home or funeral home chain has to be licensed by the Comptroller in order to sell those products. Now, the Comptroller has a legitimate role to play when it comes to consumer protection. In other words, if there is a funeral home or chain or {sic} funeral homes who are selling products and then not making good on the contract or if there's some other kind of scam going on. That's not what we have here today before us. The bill before us would allow the Comptroller to revoke the license of a funeral home or funeral home chain to sell these products if there's a labor dispute, having nothing to do with protecting the consumer. There is a labor dispute ongoing now in the northern part of the State with, I think, sixteen different funeral -- a chain that owns sixteen different funeral homes. Federal law regulates labor issues. The federal Labor Relations Act regulates labor issues in this country. It preempts State efforts to put -- give an advantage to one side or another. This General Assembly, several years ago, passed something very similar to this. It was struck down by the federal appellate court and, in fact, if you read the opinion, the federal court chastised the State government for what it said was an obvious act -- an unconstitutional Act, weighing in on behalf of one side or another. That's what you have here today. The consumer complaints, with all due respect, are from the Teamsters. That's it. This has nothing to do with the actual quality of the pre-need products that the Comptroller is supposed to license. Now, we talk about and we read about and we commiserate

with our constituents and the taxpayers about, you know what, sometimes Illinois is just a place where politics is a dirty business and things get done for the wrong reason. And we bemoan with our constituents, Democrats and Republicans do, about the fact that Illinois is a bad place to do business. And one of the reasons it's a bad place to do business is because business entities come in and they understand that they got a set of rules by which they have to abide - and in this instance, it's the federal Labor Relations Act - but then if something goes wrong, if there's a controversy, if they irritate the wrong special interest group, then, look out, the next thing you know you're going to be in Springfield trying to defend yourself because someone has decided to bring a bill to send a message or teach a lesson or something like this. This is exactly why we are the butt of so many jokes across the country about the way things are administered and the way this government operates. Right here. This is why people are disgusted with politics. This is why people don't want to get involved in our process of self-governance. It's because of issues just like this bill. This bill has nothing to do with protecting consumers. It is blatantly unconstitutional and I hope that this Chamber will reject this effort. Thank you, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Any further discussion? Senator Muñoz, to close? SENATOR MUÑOZ:

Yes. Thank you, Madam President. Ladies and Gentlemen of the Senate, this is a consumer protection concern that the Comptroller herself identified. And we're trying to get some type of resolution to protect the public's welfare. Regarding any type

The gentlemen in England now a-bed shall hold themselves accursed they were not here, and hold their manhoods cheap whiles any speaks that fought with us on -- on Crispian's Day.
