Is -- is it the Chair's ruling that that is the case regardless of what the sponsor rises and says? If the -- if the sponsor rises and asks the Presiding Officer if he would like to play a game of ticktacktoe, does that -- does that...

PRESIDING OFFICER: (SENATOR LINK)

We'll make -- we'll make it easier. Senator Jacobs, do you wish to adopt the amendment?

SENATOR JACOBS:

Yes.

PRESIDING OFFICER: (SENATOR LINK)

Thank you. Senator Jacobs seeks leave of the Body to adopt Amendment No. 2. All those -- is there any discussion? Seeing none, all those in favor, say Aye. Opposed, Nay. The Ayes have it. The amendment is adopted. Are there any further Floor amendments approved for consideration?

Thank you. I come to you on bended knee, Senator Righter, to ask for your help. We've been working on this storage bill with the Press Association, who's been opposed. We did pass the bill through committee with no opposition. I think we have the votes in the Senate to run it without the Press Association's approval. But we are trying to move the bill along to the House because there are some negotiations still going on between the Press Association and the storage unit facilities. So I'd ask for your kind consideration to move this bill to the House so we can continue to move on it.

PRESIDING OFFICER: (SENATOR LINK)

Is there any discussion? Senator Righter, for what purpose do you rise?

SENATOR RIGHTER:

Will the sponsor yield, please, Mr. President?

PRESIDING OFFICER: (SENATOR LINK)

Indicates he will.

SENATOR RIGHTER:

Senator Jacobs, when the bill -- you referenced the bill passing committee -- you referenced the bill passing committee unanimously - that was when it was a substantive bill. I mean, it actually had -- it had substantive language in it, which is considerably different than the way it looks now before the Senate. Correct?

Yes.

Senator Righter.

SENATOR RIGHTER:

I appreciate that. The -- the Presiding Officer's a little hard of hearing. I was just trying to help -- help him out, Senator Jacobs.

PRESIDING OFFICER: (SENATOR LINK)

Excuse me, Senator Righter. Can we please keep the conversations to a minimum? Senator Righter.

SENATOR RIGHTER:

Senator Jacobs, where is this bill going in terms of its substantive language than is different than what passed committee? Obviously, it's somewhere different - otherwise you wouldn't have shelled it.

SENATOR JACOBS:

What the storage facilities and the Press Association seem to be arguing about, quibbling about, is whether it should be a one-week or a two-week notice. And that seems to be the extent of what -- what they've moved on. I was simply pointing out that we -- I believe we had the votes to run the bill without the Press -- 'cause the Press Association was opposed to the bill, and we passed it out of committee unanimously. And I think we could've run the bill, but I wanted to work with the Press Association.

SENATOR RIGHTER:

Last inquiry. Senator, did you consider simply seeking to extend the deadline on the bill, keeping it here in the Senate where you and your fifty-eight colleagues can control the content of the bill, rather than sending it over to the House and letting the House write your bill for you and then sending it back over here forty-five minutes before we adjourn and an hour and a half after they've adjourned so you can either take their bill or have nothing at all? I mean, did you consider that?

Senator Jacobs.

SENATOR JACOBS:

I think that it's important to -- for us to understand that it's a two-body House -- Senate and House and we try to work together when we can. This is not a controversial issue. This is not a issue that's going to come back as something we don't recognize. This is a simple bill that is going to clear up some longstanding problems with some people feeling the Press Association gouging them and some people think that they haven't been. So we want to make sure that everybody gets their opportunity to be heard. And the bill will come back for concurrence. So you'll have full opportunity to hear the bill, and if the bill doesn't meet your specifications, you know, I would -- I would not move it - because I am listening to what you say. PRESIDING OFFICER: (SENATOR LINK)

I mean, this is a process issue here and -- and we have two options before us. And we've done this before already this -- this Session. We can either compromise, write the bill here in the Senate and then send it over to the House in the language that we want. And I have the utmost confidence that, Senator Jacobs, you would work with people on both sides of the aisle in order to get the bill appropriately positioned. Or we can send it over to the House as a blank slate and then, late in the Session, let the Speaker and his folks send it over here like a one-item menu, and you're going to eat what they want for lunch or you're going to get nothing. I don't like this Chamber -- I don't like this Chamber being put in that position, and that's why I will be voting No on the bill and would urge a No vote. Thank you.

I would just ask for your favorable consideration. We're -- Floor Amendment No. 1 {sic} is a page and a line amendment that makes the following changes: removed Section {sic} (subsection) (d-5)(2)(A-F) to follow the -- to allow the -- for the following of rulemaking process; changed the penalties portion of the bill on page 11 to be consistent with the Illinois Student Records Act - removes fines, but allows for lawsuit; added language similar to (3) in subsection (f), to allow appending education records if the information is designed to support a student {sic} (study) of students or former students to Section -- subsection. This is a bill that's a work in progress. And that's what our amendment does. We'd like to move it on 3rd, Mr. President.

PRESIDING OFFICER: (SENATOR LINK)

Is there any discussion on the amendment? Seeing none, all those in favor will say Aye. Opposed, Nay. The Ayes have it. The amendment is adopted. Are there any further Floor amendments approved for consideration?

SECRETARY ANDERSON:

No further amendments reported.

3rd Reading. Now on the Order of 3rd Reading is Senate Bill 3092. Mr. Secretary, please read the bill.

SECRETARY ANDERSON:

PRESIDING OFFICER: (SENATOR LINK)

Senator Delgado, on your bill.

SENATOR DELGADO:

Thank you, Mr. President, Members of the Senate. Senate Bill 3092 deals with student and educator data. This bill is a work in progress. The IFT, ISBE and other stakeholders in the education community are working towards an agreement in the Illinois House. We have committed to hold the bill in the House until we reach that agreement. The bill attempts to ensure parents are informed about decisions made regarding their child's personally identifiable information through increased transparency. Requires stronger and more vigorous privacy and security protections for student and educator data, and prevent vendors from using personally identifiable data in their care for commercial or marketing use. As I indicated, there's still no agreement on this issue, but we have made progress. At this time, I'm asking for a favorable vote to keep the discussion between our stakeholders moving on this important issue, as I've passed it through my Education Committee as the Chairman of Education.

PRESIDING OFFICER: (SENATOR LINK)

Is there any discussion? Senator McCarter, for what purpose do you rise?

SENATOR McCARTER:

Question of the sponsor, please.

PRESIDING OFFICER: (SENATOR LINK)

Indicates he will yield.

SENATOR McCARTER:

Senator, thank you for your work on this. And I -- and I -- and I -- what I hear you saying is you're concerned about the privacy, you're concerned about what -- what data we collect and how it's disseminated, whether it's to be sold. And -- and where so many times, at least myself and a few others, if there's a -- a bill that doesn't -- yes, I'm -- I'm -- I've lost a little weight, you're right. I couldn't grow one like yours so I had to quit. But, you know, we don't -- myself, I don't intend to vote on a -- a bill that's empty and has no language. This -- you have done this. It's not where it should be, as you've recognized. But explain to me, because this is one of my concerns, what kind of data are we collecting and how will that data be transmitted, transmitted to who and for what reason?

PRESIDING OFFICER: (SENATOR LINK)

Senator Delgado.

SENATOR DELGADO:

Yes, thank you for that question, Senator McCarter. And I do agree that voting on something empty would be not the right thing to do. However, as I chair the Education Committee, been working on this in a long-time process all Session. Senate Bill 3092 is an initiative of IFT. Public Act 96-107 established the P-20 longitudinal data system to track students through their preschool, elementary, secondary, college, and work careers to enable informed analysis of programs for policymakers, education groups, and the public. The State Board and school districts use electronic data systems - some of them are cloud-based - to store a variety of student and educator data, including a large amount of personally identifiable information. And the IFT would like to

see increased regulation regarding the storage and maintenance of this data. Because once it's in someone else's cloud, being any of the big providers, that's routinely just then sold, and how would they know they're not students or the material they were looking at was not a student paper. So that's one of the reasons why we're going down this route.

PRESIDING OFFICER: (SENATOR LINK)

Senator McCarter.

SENATOR McCARTER:

So I understand now how it's going to be collected, where it's going to be stored, but will that data be sold and used for commercial purposes in any way?

PRESIDING OFFICER: (SENATOR LINK)

Senator Delgado.

SENATOR DELGADO:

Thank you for that question, Senator McCarter. No. This is exactly why I want this bill. We don't want our data being sold to those marketers and others, and going into these young people's lives, especially if the parents may not have wanted them to do so.

PRESIDING OFFICER: (SENATOR LINK)

Senator McCarter.

SENATOR McCARTER:

Okay. So, what -- exactly what changes would you like to see take place in the House for this to be a bill that you could -- you could be happy with?

PRESIDING OFFICER: (SENATOR LINK)

Senator Delgado.

SENATOR DELGADO:

Right. I can't give you a definitive answer right here. I know that all the stakeholders, ISBE, IFT, the other stakeholders, just keeping this process moving. I will be personally and working also -- I understand I'm working -- Senator Biss, who's a member of our committee, had also made some observations, as we'll be working -- I will be working with this bill in the House too, with those sponsors, being part of that negotiation, making sure we keep a tight rein and making sure that necessary information that must be collected, especially since we know that the P-20 Council -- and actually my -- my mentor and my predecessor, the Chairman of that, Miguel del Valle, also wants to look at these things because they have a longitudinal data study going. We want to look at those things over the summer. So I'm going to shepherd this all the way through and hope, working with the Chair of the Education over there and others, we'll be able to come to something that we can all live with. So this is a protracted process, Senator McCarter, but I feel pretty confident we're doing the right thing to protect the -- the interests and privacy of our Illinois citizen students.

PRESIDING OFFICER: (SENATOR LINK)

Senator McCarter.

SENATOR McCARTER:

Thank you, Senator. I -- I appreciate all the work you're -- you're doing on this. I -- I -- I -- I -- I'm with you. I agree with you that we need to protect the data. I -- I agree that it should not be sold. I -- I have one last question and that is, will this support the Common Core curriculum?

PRESIDING OFFICER: (SENATOR LINK)

Senator Delgado.

Actually, we're -- we put 'em in components. That's a separate component. It really has nothing directly to do with that. That's separate in itself. And -- and we could have -- and that's another, if you will, twenty dollars, a different bill. And as one of my co-sponsors, who's actually -- yes. This is a bipartisan initiative. This -- being a bipartisan initiative, we are doing this to -- to make sure we carefully -- watch this as we move down the road. But it has nothing to do with Common Core. PRESIDING OFFICER: (SENATOR LINK)

I thought we were on the last question, Senator McCarter. Senator McCarter.

SENATOR McCARTER:

We -- we are. To the bill.

PRESIDING OFFICER: (SENATOR LINK)

To the bill.

SENATOR McCARTER:

And that was my plan, by the way. Thank you, Senator, for the work that you're putting into this. I think it's -- it's important that this data collected via the Common Core curriculum - I -- I think we have to admit that, that -- that there is a interface there - it's important that this not be sold. And I think you have business concerns here that would -- would really like for this to be sold. And, you know, we did not get to vote on whether we thought Common Core was the best for Illinois. We had that discussion. That's passed. Some of us -- some of us believe it should have been and maybe would not have agreed to that. Some can. But we at least need to make sure that that data is not sold. And so I do agree that that needs to be our objective.

Senator Rose, for what purpose do you rise? SENATOR ROSE:

Thank you, Mr. President. I rise in support of the bill. And if I may, to my colleague, Senator Delgado, this is -- it is a work in progress. But the bottom line is this, we do not want to be in the business, in any way, shape, form, of having a child's data inadvertently, accidently, or even intentionally, put out there. If we don't take the time now to decide how, when, why the data is being used, data is being accessed, and who, more importantly, who can access that data, and even more importantly than that, the security of the servers that are in use, this data will get out there. It's only a matter of time. How many times in the last month can you count of a high security data breach? Target. Anybody here have their credit card stolen like -- by Target, like I did in December? I'm sure, considering that forty percent of America had a Target credit card, probably forty percent of this Chamber had their Target credit card stolen. We're dealing with something even more precious than that. You're talking about a child's academic performance. Who can access that? What are they going to do with it? Where does it go? If we don't give Senator Delgado the opportunity to continue this conversation, the first time a Google Doc gets posted inadvertently on the Internet and that kid's performance is made public to the world, we have no one to blame but ourselves. All our colleague is asking for is the opportunity to continue the conversation. Maybe you know I'm very passionate about what we do in our K-12 school systems, as you all are here. We have many educators in this Chamber.

But this is a very sophisticated issue and complex that has to have the sunshine and the discussion. 'Cause when does it start? It's got started now with this. Two double -- two Chambers is to continue that -- a seamless approach. If no agreement is reached, it won't move. As you know me, I'm not trying to shove anything down anyone's throat. But complex issues are difficult in the General Assembly. We -- as we've seen too many easy lobbers going through the field. But this one here is where the -- the pedal meets the ground here, the road, so to speak. And I think, with our seniority, these are the kind of issues that a chairman and a Leader is going to have to deal with. The desire and the need, the intangible, to protect student privacy, with the fact that we are -- the whole gist of this is to protect privacy of our students in Illinois, to make sure that parents are ensured proper notification, that clouds in corporate or marketing strategies do not use their clouds to capture information. So the desire for the State of Illinois to address this issue as to the privacy -- privacy of their -- population of students, in this case our Illinois students.

PRESIDING OFFICER: (SENATOR LINK)

Senator Luechtefeld.

SENATOR LUECHTEFELD:

You know, again, I do not question your -- your desire to -to make -- make that better, I just say to you, all of those things
that you just stated of -- of the -- are -- were present -- are
present now. Nothing has changed. All of those things you've
stated were -- are -- are present here in the Senate and those
will not change. You know, the desire to protect their -- their
privacy, those sorts of things, that's here now. So we'll see

SENATOR BISS:

To the bill, Mr. President.

SENATOR BISS:

Thank you, Mr. President. I would like to thank the sponsor of this bill and the Chairman of our Education Committee for bringing forth this topic. I'm a very, very passionate believer in privacy, particularly privacy around data and doubly particularly privacy around data around minors. But I also want to thank the sponsor for his willingness to negotiate and his commitment to wait for an agreement on this matter before we eventually are prepared to enact a bill into law. And the reason for that is that the other side is also raising extraordinarily important points. These are questions about our accountability framework as a public education system. These are questions about our ability to conduct educational research that's critical for improving our schools and teaching us about best practices. And so, as this process moves forward, I'm hopeful we'll be able to reach an agreement, and I -- I really am extremely appreciative of the Chairman's commitment, as someone who feels passionately about those -- those other questions and concerns, that we're going to be working through this until all of those

The bill requires the State Board of Education to identify industries in Illinois that face workforce shortages and award grants of one thousand dollars per pupil to schools districts for each student in the district who successfully completes an industry-recognized certification program designed to -- mitigate workforce shortages. Originally, the State Board of Education was opposed to this. We have amended it to make it subject to appropriation and I believe -- unaware of any opposition.

The -- the problem with that proposal -- or that approach is, the budget's going to be passed by the end of May, and if this is going to be appropriated, we're going to need to have a number before the end of May to put it in this budget. As the sponsor of the idea, I think it would be instructive for you to shed some light on what kind of a number you think should be put in that line item in the budget that your good friend, Senator Kotowski, is going to have to put together by the end of the month. So, again, could you please give us an estimate? I mean, are we talking ten million dollars, hundred million dollars, five dollars? I mean, how many -- how much money are we talking about? PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Well, in this year's budget, the number would be closer to zero dollars. The effective date is July 2015. So we have some time here for my good friend, Senator Kotowski, and I to have some conversations ourselves, with superintendents, with school boards around the State. We don't want to rush this through, but I think if we get this through this year, we're also hoping to begin a discussion, because we've seen too many school districts that have vocational education rein them back in. And I think that's part of the reason why we have some of these workforce shortages.

I think one of the things we've got to be careful of is making promises to people out in the State of things that we're doing when, in actuality, it isn't really doing anything. I think this is a decent concept. I think starting it in July '15 makes some sense. If maybe we could put pen to paper, we could figure out a way to start it a little bit earlier. But this -- we're going to pass a bill today that doesn't take effect for like fourteen months. Why don't we just work on it next spring and actually put it in the budget? You can find out in the interim how many people have an interest in it. This has the feeling of being more of a headlinegrabbing bill than a bill that actually makes a difference in the near term. That being said, I support this priority. I think this is a very important step in the right direction as a concept. But this sure looks like -- this sure looks like more of a headline bill than something that's going to help people anytime soon.

It will urge school districts, provide financial incentive for them to motivate students in this area so we can close that skills gap that we all want to address and we hear from local businesses. I think whatever investment we do decide to put into this will be well worth it. Put the money in the front end instead of dealing with issues in the back end. So I urge support. Thank you.

Wow! This is amazing. I mean, I don't know if people in this Chamber read the newspapers or know what's going on in the State of Illinois. Here we are, the State with the worst financial mess in the United States. You're asking to make — to break your promise and make a temporary tax increase permanent. On top of that, you're proposing other tax schemes, like the millionaires tax and the progressive tax. And here we are, at the State where the people of Illinois had the least amount of faith in their legislators, and you want to pass a bill that you don't even know how much money it costs and you use the same old phrase that is so damaging to people in the State of Illinois, that so many people have been using on that side of the aisle for years now. They are making sure that you're leaving a legacy to your kids that's going
