The Senate of the 98th General Assembly is convened in its Second Special Session. Under the practice of this Body since the 88th General Assembly, the new rules adopted in the 98th General Assembly and its officers and committees are in effect for the continuous period of the 98th General Assembly, including any Special Session. There are three organizational resolutions that will be adopted today. These resolutions inform the House that the Senate is ready to conduct business, create a Senate Committee of five to wait upon the Governor, and create a Senate Committee of three to approve Journals for the Senate for all days of the Special Session.
