## PRESIDENT CULLERTON:

Ladies and Gentlemen, can I have your attention, please? I would ask the Members to please be in your seats. I ask the Members to please be in their seats. Ladies and Gentlemen, the Consul General of Israel to the Midwest is here. I'm pleased to introduce the Honorable Roey Gilad, Consul General of Israel to the Midwest. In addition, he has a Master's Degree in Middle Eastern studies from Hebrew University in Jerusalem and a Bachelor's Degree in Middle Eastern studies from Tel Aviv University. He served as a staff sergeant in the artillery forces in the Israel Defense Forces. He is an avid marathon runner. He's already participated in ten marathons, two of which were in Chicago. His best time is 3:46. My best time was 3:18. A lot of you might not have known that. So, when I learned his best time, I was nervous, but I found out he was slower than I was. addition to his mother tongue of Hebrew, he is fluent, as you will learn shortly, in English and Arabic and is knowledgeable in French. ## PRESIDING OFFICER: (SENATOR HARMON)

The Senate will come to order. On page 17 of your printed Calendar on the Order of House Bills 3rd Reading, with leave of the Body, we will turn to House Bill 318. Senator Steans, are you ready to proceed? Mr. Secretary, please read the bill.

SECRETARY ANDERSON:

House Bill 318.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR HARMON)

Senator Steans.

### SENATOR STEANS:

All right. Thank you, Mr. President, Members of the Senate. So we're doing two bills here together today, House Bill 318 and next we'll be taking up House Bill 317. They work as a package to do the fiscal year '15 budget fix. Together -- I'll give you an overview what together these -- these two bills are doing. They are addressing the 1.6-billion-dollar problem we have in the current fiscal year budget, fiscal year '15. There's four hundred and forty million dollars of cuts, which is a 2.25 percent reduction generally across the board. There is an exclusion for development disability and mental health providers. There's also

a increase of spending of about seven hundred and twenty-seven million to address core problems that we had in the budget this year. This takes care of the child care payments that we've been hearing so much about, Corrections payroll, court reporters. also provides a ninety-million-dollar lump sum to fix payroll gaps at the Governor's discretion to -- to use and a ninety-sevenmillion-dollar lump sum into the ISBE budget to plug school district problems, as they're now going to be experiencing these cuts, and that will be based on fiscal-distressed school districts. There's a net increase of spending thus of two hundred and eightysix million and we also have 1.4 million, about, in fund sweeps between these two bills, as well as twenty-seven-million increase in hospital assessment for additional revenue. The Governor is also given greater flexibility to transfer funding between lines, up to four percent from the usual two percent. I would just add that while this is not an ideal budget, I think it's really tough doing budget cuts this late in the year. We clearly had a significant budget challenge we needed to get through for this fiscal year. We knew it was an incomplete budget. This takes care of that without adding any debt and without any new tax revenues. It also allows us to now turn our focus onto the looming fiscal challenges we have for fiscal year '15. I would urge an Aye vote on this and then the next bill that we have, House Bill 317, as well. Thank you.

PRESIDING OFFICER: (SENATOR HARMON)

Thank you, Senator Steans. Is there any discussion? Senator Radogno, for what purpose do you rise?

#### SENATOR RADOGNO:

Thank you, Mr. President. To the bill.

### SENATOR RADOGNO:

First of all, I would like to thank Heather Steans for sponsoring this bill. I know this is not the ideal piece of legislation that you would like to be sponsoring, nor, for that matter, the ideal piece of legislation that we all would like to be voting on. But, as you pointed out, we have a 1.6-billiondollar problem in the short term that needs to be addressed before we even begin to look at the very significant challenges we have going forward. We will take a vote on this bill knowing full well it's going to cause some hardships, but it also does some good things in terms of preserving the child care program, avoiding some layoffs at Corrections, and other things that will allow State government to continue to function. It is a small but very significant step in moving this State forward. And while we often are quick to point the finger of blame all the way around, I think that today is a good time to give credit where credit is due, and credit goes to, certainly, Senate President Cullerton, Leader Durkin, Speaker Madigan, I've played a role in this, but significantly, credit goes to our new Governor, who came into a very partisan and rancorous situation and after many weeks of working and tearing his hair out, I'm sure, has brought together both Chambers and both parties in something I anticipate we think will pass that, again, represents a small but significant step forward and hopefully a model for all of us under the dome to look at as we go forward and, again, face the -- the very significant challenges that we have in fiscal year '16. So I, too, would urge an Aye vote on this bill. Thank you.

SENATOR KOTOWSKI:

Thank you, Mr. President. Statement of legislative intent. Some questions.

Please state your point.

### SENATOR KOTOWSKI:

Yes. A question to the sponsor: Senator, do facilities licensed as long term care for under age twenty-two by Department of Public Health and commonly referred to skilled nursing facilities for pediatrics suffer a rate cut under House Bill 318? PRESIDING OFFICER: (SENATOR HARMON)

Senator Steans.

## SENATOR STEANS:

No. Long term care facilities for the under age twenty-two are licensed under the ID/DD Community Care Act and those facilities do not have their rates cut under House Bill 318.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Kotowski.

## SENATOR KOTOWSKI:

So, Senator, the language on page 71, line 22 and 23, of House Bill 318 does not cut the rates for any facility referred to as a SNF/PEDs and licensed as a long term care facility for under age twenty-two?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Steans.

You are correct. The language you referenced does not cut rates for facilities licensed as long term care facilities for under age twenty-two, the SNF/PEDs, under the authority of the ID/DD Community Care Act.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Kotowski.

#### SENATOR KOTOWSKI:

Thank you for the clarification and to the bill. I appreciate the content of the bill. One of the things we've talked about for the last several years amongst our caucus is these special interest surplus funds that exist that we can use to address our immediate financial crisis. This bill provides about 1.4 billion of those dollars. Keep in mind, that is a -- partially a revenue solution for the challenge we have before us, which, I think, dictates in the future that we're going to have to examine and look at that possibility in the future for some other challenges that we have. But I think the fact that we're mindful of the fact that these funds, these special interest surplus funds, have been treated differently than other funds, other than are areas of the government that funded health care or human services, services to developmental disabilities, autism, mental health, that we're using these dollars to address these immediate financial needs and I appreciate the direction that the bill is taking us and I look forward to the -- seeing a bunch of green buttons. Thank you.

### PRESIDING OFFICER: (SENATOR HARMON)

Thank you, Senator. Our final Member seeking recognition is Senator Sullivan. For what purpose do you rise, Senator? SENATOR SULLIVAN:

Thank you, Mr. President. A question of the sponsor.

Sponsor indicates that she'll yield. Senator Sullivan.

SENATOR SULLIVAN:

Thank you, Mr. President. Senator Steans, this has the -- the fund sweeps language in it. Is that correct?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Steans.

SENATOR STEANS:

Correct.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Sullivan.

SENATOR SULLIVAN:

Thank -- thank you. And -- which includes the Road Fund. Is that correct? You nod - you indicate yes. I -- I just -- I rise in opposition to the legislation. I -- I just would like to make a couple of points. I appreciate the work that everybody has done on both sides of the aisle on the legislation, but this -- we're kind of in historic territory here with regard to sweeping three hundred and fifty to sixty million dollars out of the Road Fund. We've never done that. We've worked very hard, actually, with our colleagues on the other side of the aisle to stop Road Fund diversions. This more than doubles any Road Fund diversions, this sweep does. There's been some claims made over the last several days that this is surplus money that's sitting in the Road Fund. It's not surplus money. This money is allocated. It's authorized for construction projects for this upcoming construction season, as well as construction projects that have been started over the past several years and the money needs to be authorized over multiple years. So this is not surplus money. Our constituents

pay gas taxes with the assumption that this money is going to be used to repair and improve roads. This is not what this money is doing - what this action here today does. Additionally, I want everybody to know that these sweeps are not just going to affect State highway projects. Because the money goes into the Road Fund, it's driven by a formula. The money is allocated off the top for various projects. Whatever's left over is what ends up going to your municipalities, to your townships and your counties. Those moneys are going to be reduced at that level as well. For these reasons, I will be voting No.

PRESIDING OFFICER: (SENATOR HARMON)

Thank you, Senator Sullivan. We've had one additional Member seeking recognition. Senator McCann, for what purpose do you rise? SENATOR McCANN:

Thank you, Mr. President. Will the sponsor yield?

PRESIDING OFFICER: (SENATOR HARMON)

Sponsor indicates that she'll yield.

## SENATOR McCANN:

Senator, thank you for sponsoring this legislation. I want to clear up. Will there be any Road -- Road Fund projects that will be halted or stopped or prevented from starting in any way, shape or form for FY '15?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Steans.

#### SENATOR STEANS:

Thank you for the question. I had wanted to clarify after the previous Senator's remarks. A couple facts on this. I'm going to get to that question. I'm going to read a letter from Department of Transportation. First, just want to indicate, it's two hundred

and fifty million dollars that can be swept, not more than that. And they're still projecting a year-end balance at the end of fiscal year '15, the current fiscal year, of nine hundred and sixty-eight million dollars in the Road Fund. Letter from -- I'm just going to read the letter from the Illinois Department of Transportation on this subject of these -- fund sweeps in particular: Per our discussions about the proposed fund sweeps involving the Road Fund, State Construction Account Fund, and the Motor Fuel Tax Fund, the Department has prepared a revised financial model for the Multi-Year Highway Program. The results of the revised model show that, while the projected available balances in the Road and State Construction Account Funds are lower than the Department normally considers prudent, they are still positive. Even with the proposed sweeps, the Department would still be able to match all of its currently expected federal funds and deliver the fiscal year 2016 Annual Element of the Highway Program at the introduced level of 1.85 million dollars -- or -so -- excuse me, one billion eight hundred fifty million dollars. PRESIDING OFFICER: (SENATOR HARMON)

Senator McCann.

### SENATOR McCANN:

Thank you very much for clarifying that. So my -- my understanding of that letter that you just read is that while it's not a perfect scenario, there is still plenty of money to -- to -- to make all the federal match, all projects will continue. And would you say - I don't want to put words in your mouth - but would you say that in your discussions with the Governor, with Leadership that this enables us to patch the hole for FY'15 and move forward into '16 with a -- hopefully, a more robust outlook, especially

towards capital projects?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Steans.

#### SENATOR STEANS:

Yes. And what I would say is we can now actually turn our attention to the -- the next fiscal year. I think until we have done this and done a fix to fiscal year '15, we're not able to even have those conversations and start trying to address the future issues that we have.

PRESIDING OFFICER: (SENATOR HARMON)

Senator McCann.

### SENATOR McCANN:

Last question. Thank you so much. Will this also -- will - this hopefully will avert any layoffs within the Department of
Corrections, hopefully within all agencies, but would -- would you
say that this will definitely take care of our correctional
officers and avert any layoffs, especially in -- in Corrections?
PRESIDING OFFICER: (SENATOR HARMON)

Senator Steans.

### SENATOR STEANS:

Well, yes. This is increasing the allocations to take care of the Department of Corrections' issues. They're still having the 2.25 percent reduction as in -- all the agencies are. So I wouldn't want to say that there's guarantee that there's not going to be any impact, but it's the same as everybody else. This is fixing what the -- the -- the big hole that they'd had in the current fiscal year, their operational costs for the Department of Corrections.

PRESIDING OFFICER: (SENATOR HARMON)

Thank you. Yes. I do want to just note, I appreciate Leader Radogno's comments. I do think we're in a new area -- era here of shared governance. It's been very much appreciated, I know, by myself and my -- my -- my Co-Approp Chair, Senator Kotowski, of having the opportunity of really working with the Republicans on budgets. We look forward to doing that for next year as well. Urge an Aye vote. Thank you very much.

Thank you very much, Mr. President. Senate Bill 26 {sic} provides that a school district must comply with any valid local government zoning ordinance that applies where the pertinent part of the school district is located.

Is there any discussion? Any discussion? Seeing none, the question is, shall Senate Bill 36 pass. All those in favor will vote Aye. Opposed, Nay. The voting is open. Have all voted who wish? And Senate Bill 36, having received the required constitutional majority, is declared passed. ### SENATOR MARTINEZ:

Thank you, Mr. President, Members of the Senate. The Senate Bill 42 amends the Department of Professional Regulations {sic} (Regulation) Law to allow certain health care workers who have had their license revoked or denied due to past criminal convictions the ability to petition the Department of Financial and

Professional Regulation to restore or issue their license. The ability to petition the Department to restore or issue a license does not apply to anyone who has committed a sex crime or who requires registration as a sex offender as part of his or her sentence, or if an individual -- conviction is less than five years old from the date of petition. The Department may refuse to restore or issue any license which has been revoked. The Department must take into account factors such as the seriousness of the crime, prior disciplinary action by any state or federal agency, and the date of the conviction, among others when considering the restoration of a license. And I'll be happy to answer any questions.

PRESIDING OFFICER: (SENATOR HARMON)

Is there any discussion? Any discussion? Senator Righter, for what purpose do you rise?

SENATOR RIGHTER:

Will the sponsor yield, please, Mr. President?

PRESIDING OFFICER: (SENATOR HARMON)

Sponsor indicates that she will yield. Senator Righter. SENATOR RIGHTER:

Senator Martinez, I heard in your description of the bill you mention certain people with -- people with certain crimes still would not be allowed to petition. I would like you to repeat who that is and then confirm for me that someone with a conviction for any other kind of forcible felony will be allowed to do the petition.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Martinez.

SENATOR MARTINEZ:

The individuals that will never be able to petition for any -- for a restoration or any license is anybody who has committed a sex crime or who is required to register as a sex offender as part of his or her sentence, and also a -- an individual's conviction is less than five years old from the date of the petition.

### SENATOR RIGHTER:

The petitioning process that you -- I mean, this would simply allow them to petition. Can you elaborate for me just a little bit on what that involves? I mean, they file a request with the Department and what happens from there? What kind of consideration is this given?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Martinez.

### SENATOR MARTINEZ:

Let -- let me explain a little bit of why this -- this bill was brought to my attention and I want to just talk a little bit more. There are individuals that might have committed a crime maybe twenty years ago, a forcible felony. A forcible felony could be anything from throwing a snowball at a police officer or having been found with a weapon that was never used in a crime or things like that. That stays with them. So right now, we have individuals, right now, in my -- in my district, like many others that have also approached me. I had Senator Althoff, who also worked with me on this bill, on her constituent, who brought me the fact that he could not get his license renewed -- could not get his license renewed because of the fact that he had a forcible

felony that had happened twenty years ago. So when it came time for him to come and renew his -- his license, he was denied. So all we're asking in this bill is that the Department's given a little bit of flexibility to look at each case individually to make sure that nothing further than what has been committed in this bill, to make sure that it's nothing to do with a sex crime or any kind of sexual act, but more important, that he -- he or she is just looking to renew their license, because they have not had any problems again with the law.

### SENATOR RIGHTER:

What about someone who's convicted of elder abuse?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Martinez.

## SENATOR MARTINEZ:

Let me just -- let -- and, again, this will be at the discretion of the Department, but we have some of these -- some of the -- the petitions {sic} to restore, you know, their revoked license: poor {sic} (prior) disciplinary history, impact on injury, motive for the offense, the lack of -- these are -- these are the different things that the -- that the Department will look at when they're looking to see if they want to renew this person's license. So I think that anything that has to do as a health care provider where you -- I would think that if you abuse an -- an elderly person, I don't think that we will want to restore that person's license. This is just for people who had maybe prior convictions of some kind of forcible felony that wasn't violent, that wasn't sexually motivated or anything like that, that we can

actually help them restore their -- their license. PRESIDING OFFICER: (SENATOR HARMON)

Ladies and Gentlemen of the Senate, this is final action. If we could bring down the volume just a little bit, so that the speakers can hear each other. Senator Righter, another question? SENATOR RIGHTER:

Thank you, Mr. President, for your indulgence. Senator, can you walk through, again - and I'm sorry, because of the noise - the criteria? I mean, what -- what is it the people from the Department have to consider? Because while I appreciate all you're saying in this bill is that they will be allowed to petition, that nevertheless opens the door, and because you're only excluding those whose crimes are crimes of sexual violence, that means you are opening the door to a whole bunch of other people convicted of a lot of crimes, crimes that -- some of which are mandatory prison time according to our Criminal Code.

### SENATOR MARTINEZ:

Thank you. The Department must consider -- some of the following things when they are considering the potential to restore or -- or even revoke a license, which is seriousness of offense, the prior disciplinary history, impact on any injured party, vulnerability of the injured party, motive for the offense, lack of contrition for the offense, lack of cooperation with the Department, lack of prior disciplinary action, self-reporting of misconduct. Those are all things that the - and there's more here - that will be taken into consideration by the Department as they look and renew or actually continue with the -- with -- with

revolving -- I mean, actually revoking the person's license.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Righter.

#### SENATOR RIGHTER:

Thank you, Mr. President. Last area of inquiry. Senator, is there anything in this process or, if not, can you assure me that you will speak to the Department in its rulemaking on this to get into the process, an opportunity for those who may have been victimized by the crimes that the person committed to have input into this process, to be able to go to someone in the Department in some kind of hearing setting or submit a written statement saying "I don't think that this person should be allowed to have a license because of XYZ"?

PRESIDING OFFICER: (SENATOR HARMON)

Senator Martinez.

## SENATOR MARTINEZ:

I really believe that the Department is very cautious. First of all, back in 2011, when we created the law, there was a lot of things that were put into the law that practically took away their power to even do anything, but as some of these cases started to show up on the renewal of their licenses, what we've seen is that we need to give them some leeway. And I'm pretty sure that we can talk to the Department. I will talk to the Department because I think it's important that, as somebody who is trying to renew their license, as same as the individual who was hurt by an individual. I think they will take that all into account.

PRESIDING OFFICER: (SENATOR HARMON)

Senator Righter.

SENATOR RIGHTER:

To the bill, if I might, Mr. President. Thank you. Senator Martinez, I am going to support this legislation. I do have concerns, because we are now opening this process up to a -- a much larger field of individuals who have been convicted of much more serious crimes, and I'm going to rely upon you, and whoever you'd like to being into the process, to make sure that the rules that flow from this legislation have due regard and keep in mind that the first -- the first and most important defense that needs to be made is on behalf of the people who may be cared for by these individuals. And one of the things that I've discussed with the Chairman of the Criminal Justice Reform Commission is the need for looking at individualized treatment. So we often speak, as the previous speaker spoke, about the gravity of the offense instead of the risk of the particular offender, and that's what we need to start doing. And what Senator Martinez's bill allows is
