Steel and other steel manufacturers in Granite City, which was a city literally founded on the industry of steelmaking, which has supplied America with steel for all purposes. In fact, the Alton -- old Laclede Steel in Alton supplied and forged the steel which constructed the World Trade Center that was destroyed in 2001 pursuant to a murderous terrorist attack upon our people. But these steelworkers represent the heart and soul of the citizens of Illinois and we -- I'd like to take a moment to welcome them.

#### SENATOR HAINE:

Thank -- thank you, Mr. President and Ladies and Gentlemen of the Senate. To preface my remarks, I wish to...

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Haine, excuse me just one second. Ladies and Gentlemen, shh. Please let's hold the visiting down. Senator Haine, please continue.

#### SENATOR HAINE:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. To -- to preface the presentation of this with a few Since the foundation of the United States, the remarks: manufacture of steel has been an integral part of the prosperity and the strength of the United States of America. Steel was produced to build our railroads, to construct our towers, our offices, our structures. Steel was used to manufacture the implements of war to defend the United States against tyranny, particularly in World War II. In fact, Adolph Hitler, the Chancellor of Germany, once dismissed the ability of America to be an arsenal of democracy, to use FDR's words, by saying all the Americans can make is chewing gum and razor blades. Contrary to his belief, we funded not only our armies, but the armies of the Soviet Union and Great Britain, and we won that war and every war since - every war since. We've won wars with the manufacture of steel. And also, I might add, Ladies and Gentlemen of the Senate, the sons and daughters of steelworkers have been in the front lines of all the armed services in all of these wars. So this industry's

at stake. In late March of 2015, U. S. Steel temporarily closed its Granite City Works, an historic enterprise going back to 1908. They are laying off two thousand eighty employees. The primary blame here rests upon unfair trade policies which allow the Republic of China to dump steel on the world market, especially the United States, driving out our manufacturing base. resolution, Senate Resolution 2-5-4, urges the President of the United States and the United States Congress to review the national tariff policy on steel goods and take action similar to what was taken by President George W. Bush in 2002. In addition, the resolution urges the President and the Congress to consider all possible trade and economic policies to protect our industry, our steel industry, and to minimize financial distress to that There isn't anything more important, Ladies and Gentlemen of the Senate, than to make this industry once again a buttress of our economy and the foundation of our industrial strength. I ask for an Aye vote.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you, Senator Haine. Is there any discussion? Senator Manar, for what purpose do you rise?

To the resolution, Mr. President.

PRESIDING OFFICER: (SENATOR SULLIVAN)

To the resolution, Senator Manar.

#### SENATOR MANAR:

SENATOR MANAR:

Thank you. And let me first thank Senator Haine for bringing the resolution forward. I am a grandson of a steelworker from Laclede Steel in Alton, which is pretty close to Senator Haine's home. And this resolution is very simple and straightforward. It

says that we as a Body stand with this industry and we stand with those that have been affected, not just in Granite City, but elsewhere. And I just simply rise to urge an Aye vote on this important matter. Thank you.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you, Senator Manar. Is there any other discussion? Senator Oberweis, for what purpose do you rise?

SENATOR OBERWEIS:

A question of the sponsor.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Indicates he will yield for a question. Senator Oberweis.

SENATOR OBERWEIS:

Senator, do you believe in free trade?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Haine.

## SENATOR HAINE:

Senator Oberweis, I believe in free trade that's fair trade. I don't believe in the trade that we've engaged in in the last twenty years, which has hollowed out our industrial base, sent the jobs of our people over to China, Korea, and all -- Indonesia, India, around the world. Let's keep 'em here.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Ladies and Gentlemen, please. Please, Ladies and Gentlemen, please. Please, no more outbursts. Senator Oberweis.

#### SENATOR OBERWEIS:

Senator, can you explain how the trade that we have had has not been free?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Haine.

#### SENATOR HAINE:

Senator Oberweis, I am not a trained economist, but I can tell you that when I graduated from high school and worked summers at -- at the Owens-Illinois Glass Works to attend St. Louis University, I observed glass, steel, paperboard, three refineries, several small foundries, all in my hometown of -- an area of Alton, Wood River, Roxana, and Hartford. You went down to Granite City, you had American Steel, General Steel; you had A.O. Smith; you had U. S. Steel - prior to that, it was called the Granite City Steel Works. All of those jobs went overseas in an effort to compete with our well-paid workers with low-wage workers working in areas with no environmental protection. People tell me - they've been to China - you choke to death in the capital city of China. There are no environmental laws, no labor laws. To compete with that kind of a system, run by the Communist Party, as opposed to a free market system, is absolutely not fair trade, and it should be ended.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Oberweis.

### SENATOR OBERWEIS:

Senator, I have been to China a half a dozen times or more in the last few years and have been there over the last twenty-five years on numerous occasions. I understand a little bit about how their system runs. Are there failings? Absolutely. But I will tell you that, in many ways, they have a much more free economy and a much more free enterprise system than we do today in the United States. I think -- are you familiar with what is generally referred to -- or sometimes referred to as "the law of comparative advantage"? Under that idea, Senator, different companies have

different natural advantages. We may have advantages in agriculture. They may have an advantage, perhaps, in lower wages or in some other areas. They have problems. They do some things that are not right, not best for the world. I fully admit that. But to try to go back to an era of protectionism, I believe is a very serious mistake for our country. Free trade allows us to get more goods for our consumers at a lower price, while at the same time allowing our most efficient producers to produce those goods and sell them worldwide at a lower price, helping the economies of both countries.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Haine.

### SENATOR HAINE:

I could not disagree more. I could not disagree more. trade policies that have been implemented in the past thirty years have rewarded worldwide financial houses, large banks. They have not helped the working people of America. Our middle class is being hollowed out so people who own stocks in multinational corporations can make money, because they're selling cheap steel, and this is low grade steel, all around the world. The -- it's not only the United States, but it's also Europe. I -- I can cite to you -- I won't mention his name - there's a prominent lobbyist who works these halls. He told me that some of his clients who went overseas, or who buy overseas, tool and die and other implements, have found that the Chinese products are deficient. They're not as good as the United States. They found that -- the Wall Street Journal had an article a month ago saying that Chinese steel is a low grade compared to the American steel. But if you're running a bank or a stock house in Zurich or in London or in New

York City and you don't care about those issues, you just care about the bottom-line profit, you would support the hollowing out of our industries. From McKinley, President McKinley, all the way through World War II, the Korean War, all the way up to thirty years ago, we've had an industrial and a foreign trade policy that was fair. Now we've shipped all our jobs overseas. Why is it that our middle class is stagnating? Why is it? Because people can't come out and work for a union wage with benefits. Senator Oberweis, if you've been to China, I assume you've had a great time choking on the smog and the pollution in Peking and Chongging and everything else. We don't have that in Granite City. Support 2-5-4 and let's keep America strong. Let's keep America to its historic manufacturing base of steel, not only to provide good union jobs, but also to provide the strength if we face a foreign enemy like we're facing today with fanaticism emanating from the Middle East and around the world. We need steel and we need steelworkers. We need steel managers. We need to make steel in the United States and keep it here. Thank you.

## PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Oberweis. Ladies and Gentlemen, please. Senator Oberweis.

## SENATOR OBERWEIS:

Senator, you're a wonderful speaker and you've got some good talking points. The problem is, it's just not based in fact. Think about this for a moment. American businessmen are not stupid. If the steel produced in China is of poorer quality - guess what? - those who need good quality steel are going to buy American-made steel or European-made steel or wherever they're going to get the quality they need. This -- if we go back a

hundred years, more than fifty percent of Americans were employed on the farm. We have moved way beyond that. To return to fifty percent of Americans working on the farm would be a great step back in our economy. It would be a great step back in the goods that are available to our -- our consumers today. We must focus on the areas that we are leaders. And by the way, yes, I've been to Beijing. Yes, I've seen smog there. Have you been to Los Angeles? I've been to Los Angeles too and we've got similar smog problems in Los Angeles, for heaven sakes {sic}. problems. We need to fix those problems. Certainly, labor wage rates in China are a problem and need to be fixed, but when you try to stop trade and you try to hold people down in other countries, instead of allowing people in other countries to also have access to good jobs and also to grow the world economy, where we can all benefit, we don't do any good for ourselves and we don't do any good for the rest of the world. Thank you.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Further discussion? Senator Anderson, for what purpose do you rise?

SENATOR ANDERSON:

To the resolution.

PRESIDING OFFICER: (SENATOR SULLIVAN)

To the resolution, Senator Anderson.

### SENATOR ANDERSON:

Thank you, Mr. President, Members of the Senate. Senator Haine, I just want to thank you for bringing this resolution. While I am a conservative Republican and I do believe in fair trade, I also believe in the idea that American workers and American steel do create the best product. As a union member

myself, as a union fireman, there's no better firemen on the face of this planet than American firemen. There's no better steelworkers and grades of steel than American steel. And I find it frustrating for myself when I go to the store; I struggle to find things that I want that are made in America. I recently was in the market to buy a ladder, just for general housework. And I went to countless stores and could not find a ladder made in America. And by doing a little research, we find that the reason for that is because of overregulation in our own country. And I think a -- a -- a lot of these things could be taken care of if we lighten up our -- our regulatory environment. But not to get too far in the weeds, Senator Haine, I thank you for your resolution. I would also urge an Aye vote and would urge everybody here to think about when you -- when you buy a product, to buy American. Thank you.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Further discussion? Senator Forby, for what purpose do you rise?

SENATOR FORBY:

To the resolutions {sic}.

PRESIDING OFFICER: (SENATOR SULLIVAN)

To the resolution, Senator Forby.

#### SENATOR FORBY:

Senator Haine, I thank you for bringing this resolution today. And I think people who listen to this and hear what's said on this Floor is a lot the State of Illinois is standing for. You know, if you want to go overseas and some other place and pay eighty/ninety cents an hour in a sweatshop, work fifteen to twenty hours a day, that's what you're getting. Do we want to compete

with that? I think not. And that's another reason the State of Illinois does not agree with right-to-work state. Thank you.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Further discussion? Senator Link, for what purpose do you rise?

#### SENATOR LINK:

Thank you, Mr. President. First of all, I want to also thank you, Senator Haine. As a young man, I grew up in the City of North Chicago, where we had the steel mills and the smokestacks, and they're all gone now. We have a few retired steelworkers still left with us. But it was, when the town was prospering, when we had the steel mills there. But on this, I would ask for one other thing, Mr. President; I would ask for a roll call on this resolution to be proud to vote Yes. Thank you.

### SENATOR McCANN:

Thank you, Mr. President. To the resolution.

## SENATOR McCANN:

I would just like to commend the sponsor for bringing this resolution today. When I graduated high school in 1988, we were told that we were part of a new frontier, that we were -- we were going to have several jobs throughout our lives, several careers; we weren't going to be like our fathers and grandfathers and go to work in a factory or a coal mine or a steel mill and retire after twenty or thirty or forty years of hard work and have a good

pension and good benefits; that we were going to have to go out into the world and we were all going to have to be entrepreneurs and we were all going to have to compete against one another - and that's, of course, what we have done. And then came NAFTA, in which both parties conspired against the working people of this country. Both parties are guilty of NAFTA and the other regressive trade agreements that allow totalitarian nations, such as China and others, to manipulate currency, as one of the speakers spoke earlier about it making it fair, about China maybe being more fair than -- than America. I would ask that speaker, is China more fair when it manipulates world currency to allow itself a specific disadvantage? So we have to look back at where we've been to get a true sense of where we're going. And what we need to do is implement more policies that allow for good-paying jobs so that the middle class, who have evaporated over the last generation or two, can be restored. As I had a constituent say to me in Jacksonville last week, he said, "We have the rich, we have the poor, and we have the rich-poor". We need the middle class to be returned to its rightful place. The American dream that people around the world dream about or what we think about as being middle class, hardworking Americans with good-paying jobs and good benefits to raise our families. So God bless you, Senator. I look forward to supporting your resolution.

Excuse me, Mr. Secretary. Correction: Senate Resolution 436. Senator Bennett, do you wish to proceed? Mr. Secretary, please read the resolution.

Thank you, Mr. President. This is Emma. This is my daughter. She's eighteen months. My wife and I -- she was -- she's a twin and...

Senator Bennett, excuse me one minute. Ladies and Gentlemen, shh. Shh, please. Senator Bennett, please continue.

#### SENATOR BENNETT:

Thank you. Emma's a twin and was the first child -- or the

only children that we have. And I remember when we first got an ultrasound, when my wife and I were still expecting, and the doctor informed us that there was some irregularities with Emma's internal Specifically, some of the organs where -- are not, I guess, in the -- the regular spot they would be. And the doctor informed us that this is a condition called heterotaxy, that it can be serious, but that the doctor did not really know much about it. You see, it's very rare. And we found out later, it occurs in about four out of every one million children. At this point, you can see Emma is very healthy and active, and she has not required any additional surgeries. But I brought a friend, Hallie, who's standing with me. She's nine, and she has had about eleven surgeries to address some of the -- the conditions that she has, and is also very active and a very happy little girl. I'm very happy to have her here. But what we've done is, we've been part of a group, our family, to raise awareness for heterotaxy so that other families won't be told by doctors, "I don't much about it. You might have to go out and look it up on the Internet and find out more about it." That's not a good place for new parents to be, obviously. So we're just trying to raise awareness and that's what Senate Resolution 436 does. It names yesterday, actually, Heterotaxy Awareness Day. And I would just ask for your Aye vote. PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you, Senator Bennett, and your help presenting the resolution. Ladies and -- is there any discussion on the resolution? Is there any discussion?
