Now that the paperwork is official, I would like to take a moment to tell you a little bit about our newest Senator on this side, Senator Chuck Weaver, from the 37th District, who is replacing Darin LaHood, who has moved on to Congress. Chuck is a native of Peoria. He graduated from Dunlap High School, Bradley University, and DePaul Law School. He's had a number of achievements and service to the Peoria community. He -- comes to us after serving as an at-large member of the Peoria City Council. He's had national leadership experience with over thirty Kentucky Fried Chicken restaurant franchises. Also, he's been a participant

in over fifty limited liability corporations and start-up businesses. So he has a strong background there. He's also been very active in the community, including with the Boy Scouts. So Chuck has -- is married. His wife is Lauri and they have three children, and they recently joined the grandparents' club. So, welcome, Chuck. We're excited to have you.

Welcome to the Senate. President Cullerton, for what purpose do you rise?

SENATOR J. CULLERTON:

A point of personal privilege.

SENATOR J. CULLERTON:

Well, first of all, I'd like to welcome Senator Weaver. I'd like to welcome him and I -- it's the first time I've heard that you went to DePaul Law School. It's a fine law school. I'm sorry you couldn't get into Loyola, but it's still a very good school. And I'm looking forward to working with you in the Senate. We also have -- for those people who are paying attention to the average amount of time that the Senators -- the average Senator's served in the Illinois Senate, it's a little over eight years and it's been reduced by about a half a year because we have a -- a new Senator on the Democratic side as well. And this would be Senator Laura Murphy. Senator Laura Murphy is here. And I think all of us in the Senate, both the Republicans and the Democrats, would agree that Laura's going to be a big improvement over what we've been used to. And I -- I think Senator Murphy is over here with the other Senator Murphy and I think they're commiserating

Ladies and Gentlemen, if I can have your attention, please. I'm pleased to introduce the Consul General of the Philippines, Generoso Calonge. I really want you to listen to this gentleman's résumé. It's very impressive. He has served the Philippine diplomatic missions in Tel Aviv, Washington, D.C., Moscow, Abu Dhabi, Dubai, Saipan in various capacities, as well as the Department of Foreign Affairs' Office of the Undersecretary for Policy, Office of the Undersecretary for International Economic Relations, Office of the Undersecretary for Legal Affairs {sic}, Intelligence and Security Services. The Consul General was Ambassador to Israel for three years before his assignment to Chicago in the summer of 2014. He's earned his bachelor degree in economics from the University of the Philippines in Manila in 1976, completed his degree in law from the University of the Philippines, Diliman in 1985, and then moved on to finish his master's of law from Harvard Law School in 1988. Consul General Calonge has -also attended the Officer Cadet School of the Australian Army as a Military Science scholar from '78 to '79. He served as an officer in the Philippine Army for six years before joining the Foreign Service. Consul General Calonge is married to Gloria Salazar Calonge and has three children. So, Ladies and Gentlemen, let's welcome Consul General Generoso Calonge to the Illinois Senate.

Please proceed.

SENATOR MORRISON:

Thank you, Mr. President, Members of the Senate. Although we are missing two of our Senators, who have been replaced by stellar new colleagues, there is a gentleman who is not with us today from the Senate staff that I would like to make some brief remarks about. Ian Watts, from the Senate communications staff, the

Thank you, Senator. We wish him well. Congratulations. We'll now proceed to go to Supplemental Calendar No. 1. Mr. Secretary, House Bill 3rd Reading, 800. Senator Tom Cullerton. Mr. Secretary.

House Bill 800.

Thank you, Mr. President. House Bill 800 is just a trailer bill to House Bill 4025 and it clarifies the effective date of 4025.

Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 56 voting Aye, 0 voting Nay, 0 voting Present. House Bill 800, having received the

SECRETARY ANDERSON:

Senate Joint Resolution 35, offered by President Cullerton, Senators Radogno, Martinez, and Barickman.

PRESIDING OFFICER: (SENATOR MUÑOZ)

President Cullerton.

SENATOR J. CULLERTON:

Thank you, Mr. President, Members of the Senate. Senate Joint Resolution 35 would appoint Frank J. Mautino as the Auditor General for the State of Illinois for a term that would commence on January 1st. Representative Mautino has represented the 76th District since 1991, which was the same year that I came to the Senate. He, at that time, was appointed to fill the remainder of his father's term, another gentleman who I served with in the House, and he's been elected ever since from a district that is an area that I think, as one would say, a very bipartisan fashion. He's -- Senator Rezin is his Senator. And he's been a Member of the Legislative Audit Commission from 1997 to earlier this year when he stepped down. So I strongly recommend that we support him and hopefully he can have -- build the same reputation that Bill Holland has built over his service for decades. And I also would like to ask that Senator Martinez talk a little bit about the process by which the Audit Commission went through to make these recommendations. So with that, I'll be happy to answer any questions and ask for the support of Senate Joint Resolution 35. PRESIDING OFFICER: (SENATOR MUÑOZ)

Is there any discussion? Leader Radogno.

SENATOR RADOGNO:

Thank you, Mr. President. I rise to support this resolution. The Audit Commission, I want to compliment them on the process that they went through. They really did their due diligence. They eliminated candidates that did not have the appropriate qualifications and they ultimately chose to recommend Frank Mautino for the position. They deemed him to be eminently qualified and I think that this is something that we've done before by recommending a seasoned legislative professional. Our last Auditor General, Bill Holland, came out of a partisan environment but proved very quickly that he was for the taxpayers of Illinois and acted in a most impartial manner. I think those that know Frank, have served with him, recognize that he has that same potential, and I'm sure he will do a fine job. He certainly reassured us all he wants to represent the taxpayers. So I would urge your support of this resolution. And, again, thank you to the Audit Commission.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Martinez, for what purpose do you seek recognition? SENATOR MARTINEZ:

To the resolution.

PRESIDING OFFICER: (SENATOR MUÑOZ)

To the resolution, Senator.

SENATOR MARTINEZ:

Thank you very much. The -- the process was a very -- you know, it was a very long process, but at the same time, it was really -- the application {sic} were put out there, both through online, through the newspaper. We had fourteen applicants that actually applied. We came down -- Senator Barickman was the

minority on the other side who was very involved also in this process. We -- from fourteen candidates, we brought it down to seven. From seven candidates, we brought it down to four. And from the four candidates, the Audit Commission did take a vote, 11 to 1, in support of Representative Mautino. So it was a process, very open, very transparent. The -- the -- the interview process, people traveled from out of State, came in. It was an interview that was very fair, very open. Everybody asked great questions and I really believe that we had many good candidates that did apply, who went through the process of the interview, did a great job, but when it came down to the bottom of the, you know, the decision making, I think we all felt that if someone had that experience being on the Audit Commission for over twelve years as Chairman -- Co-Chairman of the -- of the Audit Commission, it was Frank Mautino. So I urge an Aye vote.

Senator Barickman, for what purpose do you seek recognition? SENATOR BARICKMAN:

To the resolution.

Resolution, Senator.

SENATOR BARICKMAN:

Thank you, Mr. President. To -- I want to expand on just a few of the comments made by my colleague, Senator Martinez, here that -- this afternoon. Thank you for those, Senator. The Commission, I've -- have been a -- it's been my pleasure to serve as a Co-Chairman of the Audit Commission now for some three years. Having served with Mr. Mautino, I can tell you that the Audit Commission today is providing all of us a tremendous service. And

I think that generally the Audit Commission does the work that it does. It's been led very well by General Bill Holland and the -the result of the work done by the Audit Commission is a better Illinois. And I -- I think many of us who are familiar with the work that has been done under the leadership of Bill Holland are grateful for his years of service to that Audit Commission, and as we embarked on choosing his successor, we spoke among ourselves many time about the need to identify someone who can bring the knowledge and the experience to continue the positive work that is being done under General Holland's leadership. The Commission went through a rigorous process of reviewing those applications, performing interviews, and ultimately with recommending Mr. Mautino as our candidate. I think the -- the result of this is that the legislative process can work. I think it was a -- it was a pleasure to work with my colleagues across the aisle and in the other Chamber on that selection process, and I, too, stand pleased to -- to support Mr. Mautino's nomination and ultimately his appointment to this office. I think Mr. Mautino brings the experience and the knowledge that is necessary to continue the good work done by General Holland. I think we'll all be well served under Mr. Mautino's leadership and guidance and look forward to supporting him here today. Good to see you in the crowd, Frank. Thank you.

Senator Rose, for what purpose do you seek recognition? SENATOR ROSE:

In the old days, people like Senator Haine would use words like honor and privilege. And he's not even here for the joke. Oh, well. But I would say, having spent ten years serving with Frankie in the House, it was my honor and my privilege to get to know you. At one time, we were on the Legislative Ethics Commission together, and you served with distinction. You were always fair. You were always honest and it was a great privilege watching you work. So I look forward to watching you work in this new role. Thank you.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Amanda Vinicky, Illinois Public Radio, requests permission to photo and video. There being no objection, leave is granted. Senator Rezin, for what purpose do you seek recognition?

SENATOR REZIN:

Yeah, first of all, I would like to commend the Commission for going through the process in a bipartisan manner. He represents the -- a little bit more difficult part of the district for me, to say the least, but, you know, on the big issues, when
