3rd Reading of the bill.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Murphy, on your first bill. Senator Murphy, on her first bill.

## SENATOR L. MURPHY:

Thank you -- ooh, there it goes. Thank you, Mr. President. Senate Bill 21 -- 2167 makes it a petty offense for a person to falsely impersonate a veteran for financial gain. So, this is a constituent-driven bill that -- someone was trying to get a discount by impersonating a veteran or any member of Reserve Forces. This would make it a petty offense consistent with current statute. It's CLEAR compliant and I urge an Aye vote. Thank you. PRESIDING OFFICER: (SENATOR MUÑOZ)

Is there any discussion on Senator Murphy's first bill? Okay, there we go. Senator Haine, for what purpose do you seek recognition?

### SENATOR HAINE:

I'm -- I'm sorry, I was tied up in a -- a conversation with another Member of the Body who had assumed another name. And I was just asking the Senator, would she yield for a question?

PRESIDING OFFICER: (SENATOR MUÑOZ)

Sponsor indicates she will yield.

## SENATOR HAINE:

Let's go through this step by step, Senator Murphy. So what is personation?

Senator Murphy.

Personation - so they're pretending to be something that they

SENATOR HAINE:

I -- no. Senator Murphy, I asked, what is personation.

SENATOR L. MURPHY:

It's probably embodying a person. Embodying a...

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Haine.

SENATOR HAINE:

And can you kind of link that up in our minds. Let's paint a picture of what false personation is.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Murphy.

SENATOR L. MURPHY:

False personation would be someone going into the 7-Eleven, saying I would like a discount for my Slurpee, when they are not a veteran and they're asking for the veteran discount. So that would be falsely impersonating a veteran or a member of the Armed Services.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Haine.

SENATOR HAINE:

Are they wearing a uniform?

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Murphy.

SENATOR L. MURPHY:

No, no uniform is involved. That's what makes it difficult for someone to identify them. But they would have to produce identification, as they're required to get discounts currently.

So, if I'm -- is there a First Amendment right to say that you're Morris Fishbein if you want to, the old head of the AMA? PRESIDING OFFICER: (SENATOR MUÑOZ)

## SENATOR L. MURPHY:

I don't know if Morris would appreciate that; however, any other veteran, if you are trying to do it for monetary gain, then it's wrong and it's illegal.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Haine.

## SENATOR HAINE:

I'm still not following you. So, if you do it -- how would
-- how would your example be monetary gain?

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Murphy.

# SENATOR L. MURPHY:

If you wanted to get that ten percent discount for the Slurpee, that would be monetary gain.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Haine.

## SENATOR HAINE:

So we're going to pass a bill that prevents people from taking advantage of saying they're a veteran to get a ten percent discount

on a Slurpee?

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Murphy.

## SENATOR L. MURPHY:

Well, certainly, a member of the Armed Services that has supported their country and -- and defended our liberties is worthy of being the only ones eligible for that discount. That's why it would be so important to pass this bill, to prevent other people from impersonating that veteran and obtaining that discount where they never earned it.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Haine.

# SENATOR HAINE:

Senator, I am not going to go home and lose sleep over the fact that somebody says they're a veteran and -- to get a Slurpee. I mean, I -- I'm just at a complete loss. What if I went into the store and I said I was a -- an officer of rank, such as a captain, such as Senator Hastings, and I'm entitled to a twenty percent discount on a Slurpee?

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Murphy.

# SENATOR HAINE:

Rather than being just an enlisted soldier.

# SENATOR L. MURPHY:

Well, although we really respect the work of the higher ranks and all of the efforts that guys like Senator Hastings did at West Point, it -- the rank is not really material here. It's anyone that has served our country, you should not be able to impersonate them for monetary gain.

## SENATOR HAINE:

Okay. Does -- doesn't it help the recruitment to have someone state that they're in the Armed Forces? Because it encourages people to see this being an attribute of virtue. In fact, the ancient Romans, the essence of virtue was to defend the State of Rome. That was the first definition of "veritas", to defend the State. So if someone comes in to get a Slurpee and they say they are a solider, they are encouraging this ethic of service in the face of danger, right? So why would we care? They're encouraging people. If they're doing a personation of a veteran, they've raised us to high esteem, even though they went to West Point.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Murphy.

SENATOR L. MURPHY:

Yes.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Haine.

# SENATOR HAINE:

Senator Murphy, congratulations. You will make a great Member of the Senate. And the next time -- I don't drink Slurpees, but I'll be happy to buy you a drink at the VFW. Thank you.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Bush, for what purpose do you seek recognition? SENATOR BUSH:

To the bill.

PRESIDING OFFICER: (SENATOR MUÑOZ)

To the bill, Senator.

Well, I -- I think we have statutes that already allow seniors to have a discount. And if you're a senior and you look old enough to be a senior, you can get the discount.

# SENATOR BUSH:

So -- so you're saying, if we look old enough to be a senior, we can abuse retailers, et cetera, by getting a discount when it's really not -- we're legally not seniors?

## SENATOR L. MURPHY:

Just you, Senator Bush.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Murphy, over here, over here. What do you have against kids?

I have nothing against -- nothing.

And -- and -- and -- and if they want to get a -- a -- a lollipop or a Twizzler or whatever it is, you know, they ought to be able to do so without paying a hundred or two hundred dollars to go out trick-or-treating. I think you should pull this out of the record.

Like a -- Slurpees in general or is it a specific Slurpee? Flavors?

Senator Murphy.

# SENATOR L. MURPHY:

It'd include all varieties of Slurpees.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Murphy -- Senator Hastings.

# SENATOR HASTINGS:

Thank you, Senator Murphy. I am in full support of this bill that you support Slurpees. And this has nothing to do with veterans, but the discount on Slurpees, I'm -- I'm a hundred percent in support of. Thank you very much.

PRESIDING OFFICER: (SENATOR MUÑOZ)

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Murphy.

# SENATOR L. MURPHY:

I would respect a petty officer and any other rank, so you would definitely be included in the discount.

PRESIDING OFFICER: (SENATOR MUÑOZ)

Senator Noland.

# SENATOR NOLAND:

You can imagine as a petty officer, a Navy petty officer, I -- and as a corpsman, you know, I feel as though we're kind of in a special class. Why is there not some sort of special in -- provision in the bill to -- an -- an increased fine for those that imitate petty officers, and not just make it a petty offense for imitating or personifying a petty officer, but make it a misdemeanor or perhaps even a felony? Why -- was there any consideration in that regard?

That the bill itself might be reworked in order to provide that special recognition. But you are willing to work on that. Is that correct? PRESIDING OFFICER: (SENATOR MUÑOZ)

would you then be willing to perhaps hold it on 2nd here until we can work this out?
