SENATOR HUTCHINSON:

Thank you, Mr. President and Members of the Senate. Today is Pay Equity Day. Today is the day, April 12th, that marks how long women must earn to earn the same amount of money that a man earned for the same job over the last year. I wanted to point out a couple of different things. One is that the overall number is seventy-nine cents to the dollar. The other thing is that, for African-American women, it's sixty-three percent, and for Latino women, it's fifty-four percent. And that means that African-American women lose more than eight hundred and seventy-seven thousand dollars over the course of a forty-year career. Latino women lose over a million dollars over the course of a forty-year career. To put this in perspective, if women earned the exact same amount as our male counterparts, we would be able to afford seven additional months of mortgage and utilities or 1.6 years more worth of food. This costs American women every year five hundred billion dollars a year - just this gap alone. So, in honor of this day, in honor of pointing out the fact that, for the same work, we ought be paid the same amount, I would like to leave the General Assembly with this one thought. That our illustrious historical figure named Fred Astaire had a partner. Her name was Ginger Rogers. She did everything he did - backwards and in heels - and didn't make nearly as much money for it.
