Senator Link, could you tell me, why are we asking for this change? I believe that we have procurement set up through the -- that dictates the process for this by -- for the Illinois Gaming

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Link.

SENATOR LINK:

Very simple, for the first twenty-some years of the gaming bill in effect, we never had procurement set up for anything and then all of a sudden, arbitrarily, the Gaming Board, in 2009, decided that they would ask for outside bidding on this company and here it is. The people that use this are the casinos and the independent video poker games and we feel it's very appropriate to have more nationally accredited people doing the testing, instead of just having one.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Rezin.

SENATOR REZIN:

...you -- thank you. But you mentioned that this was an arbitrary process. I mean, actually it was not arbitrary. There's a procurement process that is put into place specifically to allow the Gaming Board to make these decisions, based on tests, to make sure that everything that the company needs to provide has been provided, make sure and look at costs as well, security, and affects taxpayers. My question to you is, the company that went through this process that testified, however, did not receive the bid, are they the one that is actually supporting this bill? Are they the company that's actually supporting this bill?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Link.

SENATOR LINK:

One of the companies, but let me clarify something. You know,

like I said earlier, for twenty years we did not do this, then all of a sudden, arbitrarily, in 2009, they decide to go out for bids on their own. Cost the taxpayers money to go out for these bids. We have to pay for it, where all they have to do is do this nationally accredited companies that the State would not be paying for and that would be given an opportunity that's -- to use at these other facilities that the State would not be spending a penny on.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Rezin.

SENATOR REZIN:

Thank you. To the bill, please.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

...the bill.

SENATOR REZIN:

Thank you. There is a process that's set up. It's a procurement process for the Gaming Board, which is a State agency, so it's not an arbitrary process. The procurement process is done specifically to protect taxpayer from fraud and corruption. This bill is simply a bill that's supported by a company that did not receive the winning bid in a process. I ask for a No vote. Thank you.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Any discussion? Seeing no discussion, Senator Link, to close. SENATOR LINK:

Thank you, Mr. President. If we're trying to avoid corruption, then why shouldn't we use more accreditated organizations to do the testing? This does not give an advantage to one company or another. When the RFP was written originally in

2009, it basically solidified the one company that had it for those years that they would have it forever. I would much rather have more groups, more people having an opportunity, and it would not cost the taxpayers one penny. I ask for a affirmative vote.

It would add the position of administrative service officer to the list of exempt employees who are appointed by the executive director of the district with the advice and consent of the board of commissioners. I know of no opposition. Would appreciate the Chamber's support.

Mr. Secretary, are there any Floor amendments approved for consideration?

Senator Martinez.

SENATOR MARTINEZ:

Thank you, Mr. President. The amendment just takes care of a technical issue and I'll be happy to discuss it on 3rd Reading. PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Is there any discussion? All those in favor vote -- vote Yea. Opposed, Nay. The Yeas have it, and the amendment is adopted. Are there any further Floor amendments approved for consideration? ACTING SECRETARY KAISER:

No further amendments reported.

3rd Reading. On the Order of 3rd Reading is Senate Bill 2536. Senator Martinez wishes to proceed. Mr. Secretary, please read the bill.

Thank you, Mr. President, Members of the Senate. Senate bill adds a new Section to the Illinois Public Aid Code. It provides that all non-relative providers in the child care assistance program for the first time shall participate in an orientation and pre-service training within six months after they begin providing services. The training will be an annual process for providers. Relative providers in the program shall be encouraged, but not required, to attend these as well. The providers shall be paid fifteen dollars an hour for their attendance. And also it states that the State shall provide health insurance to the qualified home care providers. And I'll be happy to answer any questions.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Syverson, what purpose do you rise?

SENATOR SYVERSON:

Thank you, Mr. President. Question for the sponsor.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Sponsor said she will yield.

SENATOR SYVERSON:

Senator, we talked about this in committee earlier. I think the -- couple of the concerns, but the biggest one is, in light of where we are financially today, we're told that the cost of this is going to be thirty million dollars a year. And do you know

where in the budget that we're going to come up with that or what program we have to not fund to be able to fund this new program?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Martinez.

SENATOR MARTINEZ:

Senator, in the past, we've paid for these services. All we're -- making sure is that training is a component of it because it is federally mandated.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Syverson.

SENATOR SYVERSON:

But this is a new program. This isn't -- we haven't paid for this in the past, so this is a -- a new program, which is going to add this added money to that.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Martinez.

SENATOR MARTINEZ:

Senator, in the past, we have paid for training and we also have paid for health care. We want to make sure that that stays in the -- in the legislation and in the -- and -- and in the agency that takes care of these providers.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Syverson.

SENATOR SYVERSON:

If we've done this in the past and we're already doing it, then I'm -- I guess then I'm confused as why are we putting a new law into place. If we're already doing it and we're already paying for it, what does this bill do that's not currently in law then? PRESIDING OFFICER: (SENATOR SILVERSTEIN)

I think it's -- what my understanding is, there is -- there's a continuing negotiation going on and we want to make sure that this continues to be part of the negotiations.

SENATOR SYVERSON:

So we're saying it's -- it's part of the negotiations, but currently, we are paying for this and it's in law right now and we're expending this thirty million currently in the budget?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Martinez.

SENATOR MARTINEZ:

Not in law, but it's current practice.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Syverson.

SENATOR SYVERSON:

When you say current practice, is that -- where's the Department coming up saying this is going to be an added cost of thirty million dollars and if it's -- I guess I'm confused about why we're -- if we're saying now that it's -- that we're already doing this?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Martinez.

SENATOR MARTINEZ:

Hasn't -- it hasn't been included in this year's budget and that is what our intention is. We want to make sure that training is important and that we want to make sure that the fifteen dollars

an hour is also part of this and that's probably where you see the increase.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Syverson.

SENATOR SYVERSON:

Okay, I guess -- and again, I'll wrap it up with this, Mr. President. I guess I'm still concerned that if -- if -- if we're currently requiring this and we're already paying for this, I'm not sure why they would come back and say this is an expansion, and the fact that it's a thirty-million-dollar price tag. And even if it was something, it still comes down to, the question is, if it's not funded, where do we come up with the thirty million dollars to pay for this program? Do we have to make cuts in other areas to pay for this or does it come out of higher education or what -- where -- where are we going to come up with this thirty million dollars if it's not currently allotted for?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Martinez.

SENATOR MARTINEZ:

Thank you. Thank you, Senator Syverson. I -- I think that as we continue to negotiate this -- I know that we are working -- currently working on the budget. We want to make sure that this training is an annual training. It's an estimated number. It might be less, hopefully. But you know what? I just want to make sure that it is part of the negotiations going on right now and Human Services will make that determination as we move forward in the -- in the budget process.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Delgado, what -- purpose do you rise?

SENATOR DELGADO:

Thank you, Mr. President. I -- I rise in support of the lady's legislation. And I just want to bring to attention of the Senate, as we continue to tinker with our day cares, our health, moving and shifting people around, the beneficiary are the children, the families that have to be cared for, and to make sure that the adequate training, that the adequacy and that it's codified, that this become a negotiation as we move forward in Illinois and keep evolving the budget - what budget? - to evolve the concepts that are necessary to put 'em on the table, because right now these populations are on the menu if indeed they're having inadequate trainings and dealing with our most vulnerable, our most treasured child -- children, knowing that at fifteen dollars an hour, to -- to -- to encourage their participation. There will be online training also. There'll be those who will want to opt out because of their longevity. This is a multiverse and I think it's too much to discuss in this particular setting. That's why I commend the sponsor to be able to bring this forward and, as she's indicated, to bring it to the full table, as she is a -- one of our Majority Leaders also, to continue to push the envelope, make sure we have sunshine on this issue so that we can discuss exactly how we move the billions that are truly under this Dome, and someone is getting that money, once someone told me. And it's very clear about prioritizing, and at least put it again in place so that at the end of the day when we make these selections that we are truly doing the people's work, 'cause we don't need to walk with the great. She is definitely walking with the needy. So in this case, if we could encourage our providers, who are families out there, to get this training and to give 'em a decent

opportunity and make sure that they're covered by their health, so they can adequately give better support to the children and those that they're caring for, and I would ask for your Aye vote.

This is a very good bill. I think it just really continues to train our providers out there. They should be compensated, you know, at the fifteen dollars an hour for the training also. I really hope that it's something that we continue to work during the negotiations and I really believe that this is the right thing to do for those providers that take care of our children and our elderly. And I ask for an Aye vote.

And Senate Bill 2536, having received the required constitutional majority, hereby declared passed. Senate Bill 2537. Senator Martinez, do you wish to proceed? She wishes to proceed. Please, Mr. Secretary, read the bill.

And Senate Bill 2537, having received the required constitutional majority, hereby declared passed. Senate Bill 2563. Senator Tom Cullerton. Turning to top of page 14. Senator Sandoval, on Senate Bill 2566. Senator Sandoval, on Senate Bill 2587. Senator Hutchinson, on Senate Bill 2587. Senator Hutchinson. Senate Bill 2587. Senator Sullivan. Senate Bill 2588. Senator Muñoz. Senate Bill 2593. Senator McConnaughay. Wishes to proceed. Please -- Mr. Secretary, please read the bill.

Seeing -- any discussion? Seeing no discussion, the question is, shall Senate Bill 2593 pass. All those in favor, vote Yea. Opposed, Nay. The voting is open. Have all voted who wish? Have all voted who wish? Have all voted who wish? Take the record. On that question, there are 54 voting Aye, no voting Nay. And Senate Bill 2593, having received the required constitutional majority, hereby declared passed. With leave of the Body, we're going to go back to Senate Bill 2588. Senator Muñoz. ...to proceed. Please read the bill.

ACTING SECRETARY KAISER:

Senate Bill 2588.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Muñoz.

SENATOR MUÑOZ:

Thank you, Mr. President. 2588... Currently, the Freedom from the {sic} Drone Surveillance Act provides that law enforcement may

not use a drone to gather information unless one of the exemptions to the Freedom (from) Drone Surveillance Act applies. This adds the law enforcement agency the use of a drone for law enforcement training purposes as one of the exemptions under the Act. It also provides law enforcement agency usage of a drone for training purposes on private property requires lawful consent. let's -- law enforcement must provide advance and onsite public notice when the agency intends to use a drone for training purposes on public lands, highways, and roadways, or areas belonging to State or political subdivisions of the State. Information collected by the agency use of a drone during law enforcement may be retained by a supervisor at the agency and may be disclosed to another government agency. However, any such information must be deleted as soon as it's no longer required for training purposes, unless there's reasonable suspicion in the information that contains evidence for criminal activity or the information is relevant to an ongoing investigation or pending criminal activity.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Connelly, what purpose do you rise?

SENATOR CONNELLY:

Thank you, Mr. President. Question of the sponsor.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Sponsor said he'll yield. Senator Martinez {sic}.

SENATOR CONNELLY:

It's actually Senator Muñoz.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Muñoz.

SENATOR CONNELLY:

Senator, at committee, we had a rather spirited debate on this issue and it -- it had really to do with the fact that these drones and the -- the cameras that are embedded there, they're going to be taking pictures of private property, wouldn't you agree?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Muñoz.

SENATOR MUÑOZ:

I agree to a certain extent. If you're on a public land, and I'm sure there might be across the street that they could get --capture some images there, but before they do that, they have to, in notice, notify anyone within the area that the -- going to be taking -- training's going to be taking place before they can even start doing any of the training.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Connelly.

SENATOR CONNELLY:

Thank you, Mr. President. I -- I didn't hear the end of that, but I guess the point I was trying to make, Senator - and -- and you know how much I respect you - there seemed to be -- the biggest concern was, how does a private property owner provide consent for one of these training exercises? I mean, where in the bill does it allow for -- how does a person provide consent?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Martinez -- Senator Muñoz.

SENATOR MUÑOZ:

From what I'm reading here, it's just saying the agencies must provide advance and onsite public notice when the agency intends to use a drone for training purposes on public lands,

highways, or roadways, or areas belonging to the State or political subdivisions of the State.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Connelly.

SENATOR CONNELLY:

Just as -- as an example - and I know I brought this up in committee - suppose I own a large apartment complex, and you name the suburb of Illinois, and I'm the owner; I'm not the -- you know, I'm not a tenant. I -- but I've been told there may be criminal activity. Do I call in -- if I call in that village police department and say, "You know what? Use my facility for a training exercise." Am I the one giving consent for the drone to go over other -- what I consider other people's property or do they have to get the consent and approval of each tenant of that apartment complex?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Muñoz.

SENATOR MUÑOZ:

That, Senator -- I don't believe in the bill that an individual resident or homeowner can call the village or the municipality and request for a training purpose at their home location. This is for law enforcement to utilize their own department for training purposes. This is not used for individual -- or I -- you -- if I call them at my house and say, "I want this done." This is for training purposes, sir.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Connelly.

SENATOR CONNELLY:

Now, Senator, where - and I'm just -- I don't know the answer

to this question - where does the City of Chicago, the Chicago police, where do they train the use of drones? Or do they have a facility? 'Cause I'm -- I'm unaware of it.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator -- Muñoz.

SENATOR MUÑOZ:

I'm not aware of where the Chicago police uses any drones or where their training facilities are at. I can find that information out for you.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Connelly.

SENATOR CONNELLY:

To the bill, Mr. President.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

To the bill.

SENATOR CONNELLY:

Thank you, Mr. President, Members of the Senate, and thank you, Leader Muñoz. We had a great discussion, I thought, at committee. It's -- it's complicated, this issue. We understand that the technology, in my opinion, is moving faster than -- than we can keep up with it. I know Senator Biss and I have brought a number of privacy bills. I have grave concerns with this bill. I just think that it -- it can be used to secure images on private property without consent. I think it's a very, very slippery slope. And as much respect and admiration as I have for the -- for the sponsor of this bill, I would respectfully ask that everybody vote No.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Thank you. Senator Righter, what purpose do you rise?

Will the sponsor yield, please, Mr. President?
PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Sponsor said he'll yield. Senator Muñoz {sic}.

SENATOR RIGHTER:

Thank you. Thank you, Mr. President. Senator Muñoz, just following up a little bit on Senator Connelly's area of questioning - and we did have kind of a vibrant discussion in committee - and I think you, as well as anyone, know that, you know, in our -- in our history, there have been decades or generations where, in that time frame, in that decade or that generation, there was a certain issue that kind of permeated the public discussion, and the one that we are in now is privacy - because of the technology that exists now, not just in the hands of -- of private individuals, but certainly in the hands of the government in terms of law enforcement, is so pervasive now. One of the things we talked about in committee was the bill requires that if a drone flies over and records activity on a -- on -- over private property, it has to provide, quote, unquote, "lawful consent" to the property owner. The -- the term -- "lawful consent" is not defined in the bill. Can you help me understand what that term means?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Muñoz.

SENATOR MUÑOZ:

Based on the way I read the bill -- I mean, from what I'm told, it's the lawful consent you would have to have - which would probably be written notice. You're the attorney, Senator. You know, we understand the concerns that you and Senator Connelly had when we did have a vibrant conversation and I respect everyone's

opinion, mainly the attorneys because they know the law. But, again, with this -- what we're trying to do with this bill, Senator, is for training purposes. I know it was brought up in committee, what if someone was smoking pot in the backyard? Well, this bill is not designed to look for someone smoking pot in someone's backyard. This is for training purposes. It -- what -- it is put in the bill in the event of criminal activity. I think a simple example would be if someone was seeing someone being murdered, whether you'd shot someone several times, whether that individual was stabbed. Well, if the drone, in fact, did take that image, I would think that everybody would be happy that they turned that in to the law enforcement agency. You have the State's Attorney - all of you know, as attorneys, State's Attorney approves charges. So if there was a charge brought up on a drone while it was doing training purposes on that training day, State's Attorney -- it goes to the State's Attorney. They approve charges or not. PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Righter.

SENATOR RIGHTER:

Senator, I appreciate all that. The -- the question I have is, what is lawful consent? I mean -- and I understand a lot of what you just said, and a lot of what you said, you said in committee, but I'm asking a very simple question here and it's not about whether I'm a lawyer or whoever are lawyers. The question is, what is lawful consent? Because at some point, if this becomes law, private property is going to be surveilled by a drone, intentionally or otherwise, and someone is going to ask whether or not law enforcement had lawful consent and then they're going to look at the bill and say it's not in here. So, outline that for

me, please.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Martinez. Muñoz.

SENATOR MUÑOZ:

Yes, it would be expressed as lawful consent whether they do it verbally or written. That's the best way I can answer it, Senator.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Righter.

SENATOR RIGHTER:

Thank you, Mr. President. Is that consent required to be obtained before the flyover or can it be subsequent to the flyover? PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Muñoz.

SENATOR MUÑOZ:

Before the exercise or the training.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Righter.

SENATOR RIGHTER:

So, in your mind, it could be verbal; it could be the -- a - a police officer knocking on the door of a -- a house that borders the law enforcement training area where the drone is supposed to be flying over and saying, hey, just want to let you know we'll be flying over at... What kind of specificity needs to be given in that notice? And here's why I'm asking that, is because, as you know, in cases of search warrants, I mean, search warrants are -- are -- are written pretty particularly with regards to the premises to be searched, what specific items they would look for, if there are adjacent buildings that can be searched in

as well. So what degree of specificity does the officer who knocks on Mrs. Johnson's door and says, we're going to be doing a flyover of your house, does that officer need to give to her?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Muñoz.

SENATOR MUÑOZ:

The notification would be a written notice, whether it's a one-day, and you give them the notice whether it's a week or two notice. I don't think they're going to be going door to door because the intent of the bill is not to be on private property, Senator. It clearly states public notice {sic} - highways, roadways. You know, you brought up the scenario in committee, as well as now, about the possibility of can it happen? I'm not going to stand here and lie to you, saying it can't, but at the end of the day, we're asking for permission. We can't do it now. You know, anybody can have a drone and -- and do the recording, but if you're law enforcement, we need the permission in order for them to do the training. This is what the bill is about. This is not about trying to infringe on someone's privacy, whether Mr. and Mrs. Whatever is doing something in their backyard. This has nothing to do with that.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Righter.

SENATOR RIGHTER:

Thank you, Mr. President. So, referring back to committee, Senator Muñoz, let's talk about that -- that -- that hypothetical we talked about in committee, where the drone for training purposes is flying right over the edge or the border of the law enforcement property that it's allowed to train over, but because the cameras

have such a wide angle, you can see three, four, five city blocks into residential area, so you are viewing and recording private property -- private property that is four or five city blocks in for however long that drone flies. What if that happens? What happens then? Do we give subsequent notice? Do we go back to the homeowners later and say, oops, sorry, we were flying over your property? How is that going to be handled?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Muñoz.

SENATOR MUÑOZ:

Again, Senator, when the notice goes out -- I'll give you a simple example. You're talking about a hypothetical situation where you're talking five or six blocks out. I can see the training academy at the Chicago Police, simple example, is on Loomis Street, Loomis and Jackson. That area is where they do the training in the parking lot for pull-over stops and hypothetical situations that -- what can occur and what happens when you pull a vehicle over. Now, could it cross over onto Jackson? Yes, absolutely. But to go five or six blocks in, that is not the intent of this bill. That's a little bit too far-reaching, Senator.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Righter.

SENATOR RIGHTER:

To the bill, if I might, Mr. President.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

To the bill.

SENATOR RIGHTER:

Thank you. Ladies and Gentlemen of the Senate, I come to this Chamber having been a felony narcotics prosecutor. There are

many other people in this building who have law enforcement in their backgrounds, including the sponsor of this bill, and we should all respect that. But going back to what I said earlier, the test these days, when we are talking about new ways for government or law enforcement to do investigations or to train, is whether or not the technology they are utilizing presents a realistic invasion of privacy for people in their properties, in their homes, and this is the quintessential example of it. This is not a Republican-Democrat issue, whatsoever. The suggestion was made in committee that this bill be redrafted so as to prohibit, as a matter of law, recording property that is private. That suggestion was not taken up. I would suggest to you that that is the only way to fix this bill. I appreciate and take as sincere as anything the sponsor's words that it's not the sponsor's intention to record activity on private property, but we know it's going to happen. If anyone has looked at these cameras, you know that they cut over a very wide angle. They are going to tape homes and apartment buildings and other private property that they have not given notice to, not intentionally - not intentionally, but it's going to happen. This bill at some point has to become law - a bill like this to allow for training - but this bill is not right. It's not ready. It's too open-ended. This will result in an invasion or invasions of property -- private -- of privacy on private property and then, remember what we talked about, when the private property owner goes to the police and said, you didn't give me lawful consent, the police will be able to define what lawful consent is any way they choose. That is too open-ended. This bill is not ready to go. I urge a No vote. Thank you, Mr. President.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Thank you. Senator Raoul, what purpose do you rise?

SENATOR RAOUL:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Sponsor said he'll yield.

SENATOR RAOUL:

Senator Muñoz, I -- you know, I know that you've -- you've done a good job historically of bringing good bills with regards to law enforcement, and as I expressed in committee, I've got --I -- I share some of the reservations that we've heard from the other side of the aisle. I want to focus in on this notion that this is for training purposes and that information is supposed to be deleted as it -- at the moment that it's no longer required for training purposes, except that there's -- and unless there're -there're a couple of exclusions to that, and one is if there is reasonable suspicion that the information contains evidence of criminal activity and information is relevant to an ongoing investigation or pending criminal activity. Is there anything that narrows down whatever that criminal activity will be? Could it be a misdemeanor? Could it be -- there's a wide range of criminal offenses in our Criminal Code. It -- it occurs to me that, with this language, there could be a -- a wide breadth of argument as to we've got information that could be relevant to some criminal activity. It could be even selling loose cigarettes. Is there anything that narrows that at all in this bill?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Muñoz.

SENATOR MUÑOZ:

No, Senator. The way you have it is, is just criminal activity. Can it apply to anything? Yes. But will it apply to that? That's not the intent of the bill for them. Again, as I mentioned, for someone smoking pot or someone riding on someone's property, this has nothing to do with that.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Raoul.

SENATOR RAOUL:

And -- and -- and I -- and I wholly appreciate your intent and -- and I'm familiar with the Chicago Police Department's Training Facility and the surrounding area. Does anything in this bill limit it to police departments and municipalities the size of Chicago or does this apply to just any police department who either now or in the future obtains drones and wants to do some training, and -- and if you have any knowledge of how many law enforcement agencies may exist in the State of Illinois?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Muñoz.

SENATOR MUÑOZ:

This would apply to any law enforcement that's licensed by the State of Illinois to be a police department or sheriff's department, anyone with law enforcement, provided that they meet the standards from the State and federal.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Raoul.

SENATOR RAOUL:

Senator Muñoz, when we left committee, I had hopes that conversations were going to take place that would narrow this bill. I -- I have to say that I share the unreadiness that -- with all

due respect, I share the unreadiness that we heard from the other side of the aisle. Is there any chance that we can get an extension on this bill and try to have further conversations to narrow this down? Given that we -- I -- I haven't -- I have no idea how many police departments, law enforcement agencies, we have in -- in the State. I trust the leadership of some more than the leadership of others. But this opens the floodgates to what could be done with drones. I know the vast majority of 'em don't have drone training programs today, but when we pass law, it applies from today going forward and -- and this is dangerous. Is there any chance that we can get an extension and try to narrow this language?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Muñoz.

SENATOR MUÑOZ:

Thank you for your input, Senator, but, you know, we worked, we talked with everyone. I understand everyone's concerns, but, again, the intent of the bill is not to hurt the private citizens. In fact, this bill -- the intent of this bill - for law enforcement at a time when there's no budget for a lot of 'em. A lot of -- a lot of departments throughout the State are laying off. They can't hire people right now. The bad guys actually have better fire power and are doing way better than we are. So -- and that's only the local criminals. How about the terrorists? How do we compete with people blowing up stuff? How do you -- when we have things in the City of Chicago, things can happen. This is a serious thing. You talk about we're opening up floodgates to hurt the private citizen. This protects the average citizen.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Raoul.

To the bill.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

...bill.

SENATOR RAOUL:

You know, with -- with all due respect to my colleague and -- and -- and -- and I know what -- his intent on this and I'm --I am for training. I'm absolutely -- am for training and training is important, but this is dangerous, Ladies and Gentlemen, and I share the sentiments we heard from the other side of the aisle. This is not limited to the Chicago Police Department. This can be any police department. We've heard of, quite frankly, of abuses in other areas from other police departments that don't run as well as some larger police departments. When we talk about the notice provision, the notice, as pointed out by Senator Connelly, the notice will go -- if you have a property, it'll go to the owner of the property, but there are a lot of people within that property that -- that may have units within that property - backyards that have their privacy rights, Ladies and Gentlemen. And -- and -- and the -- the exceptions to information being deleted leave a -- a huge escape for -- for a law enforcement department to say that they're using it for training purposes, but they're actually using it inappropriately for -- investigatory purposes. I -- I -- I share the sentiments of Senator Righter that this is not right. I -- unfortunately, I -- I -- I seriously urge my colleagues to either vote Present or No on this bill, because privacy rights are at stake.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Thank you, Senator Raoul. Senator Rose, what purpose do you

SENATOR ROSE:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Sponsor said he'll yield.

SENATOR ROSE:

First of all, I find this debate uniquely fascinating because you're seeing the far left and the far right coming back around and meeting. Leader Muñoz, I -- I respect your passion for law enforcement - I'll start there - however, I'm concerned with the way this is drafted. If I'm running up -- a drone up a public street - okay? And the drone {sic} says you can't use this for anything other than reasonable suspicion and then the data has to be destroyed for crimes, but what if I trained to be a civil code enforcer and I run up the street to figure out who didn't take out a permit on their fence they built? It's not a crime. What happens to that data?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Muñoz.

SENATOR MUÑOZ:

Senator, the way the bill states, all the data is going to be erased. You know, we talked about criminal activity. What if that drone had seen some of that and got recorded? I -- I doubt -- I know for sure, why would any department want to waste their time seeing if someone didn't pull a permit poling a fence -- putting up an illegal fence or doing a garage or what have you? Right now, we don't even have enough manpower. We're backed up in every municipality throughout the State for serious offenses that occur on the streets, whether it's in Aurora, the City of Chicago.

The State Police is backed up, their crime labs - unbelievable. So I doubt it very seriously if they're going to be looking for someone that needs a permit or didn't pull a permit.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Rose.

SENATOR ROSE:

I -- actually, for that very reason, I respectfully disagree with your conclusion. Because all these municipalities are broke, they will be out looking for every dollar they can find. I mean, that's exactly what will happen. It is actually already happening. Assessors are using it to assess, oh, who added this, who added that. Let me ask you this as an aside, can I train -- could I train my model club -- my -- my model drone club, if I wanted to, to follow police officers with a drone?

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Muñoz.

SENATOR MUÑOZ:

Not under this bill, you can't. But every citizen that has a drone, I'm sure they do whatever they want with it. The drones that are going to be for -- in this bill, are going to be for training purposes.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Senator Bivins, what purpose do you rise? Sorry, I didn't see your light -- light, Senator Rose. Senator Rose, again.
SENATOR ROSE:

Thank -- thank you. I'll -- I'll -- I'll wrap here. To the -- to the bill, if I may, Mr. President. First of all, actually, there's a very interesting YouTube video where a drone actually does track a police car for about two blocks and it's fairly

amazing to watch the police officer's reaction when he finally realizes he's being followed. But, look, I understand the world we're in right now. And -- and I may correct for the record, if I can, that the existing law, irrespective of this bill, already allows drone use for terrorists and those things. I mean, that -- that's already there. There's clearly some -- going to be some interplay always between the right of a citizen to personal privacy and law enforcement, and that's going to revolve around a wonderful thing we call the Bill of Rights. Right? But what I'm concerned about this - and -- and it's -- and it's not the intent of the sponsor, or even that I could eventually get to a vote on a bill like this, 'cause, frankly, I was a prosecutor and I could get to a vote on a bill like this - but when we rush these things through and we don't walk through all the nuances, we are creating all kinds of problems at the trial court level, with admissibility of evidence, with -- well -- you know, as a young prosecutor, when you lose a case because the Legislature didn't think it through, that tends to stick with you. And all I -- all I ask as we kind of navigate this brave new world we're in, that we do it right and we think about all the possible exigencies that occur, and I just don't know at this stage we have. Because you look around -- and I appreciate your answer, Senator, about not being used for code enforcement. I read an article last week where it is being used for code enforcement, where people are already -- municipalities, assessors, whatever, without any rules in place, are already doing this anyway. So what I do believe is it's -- we've got to -- we've got to have this conversation and I do believe, just as passionately, we got to do it right. And just simply sending something through and then letting litigants after maybe someone's

been in handcuffs or -- or -- or not, it's not the best use of our time or the court's time to not walk down the path fully the first time. Thank you, Mr. President.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Being no further discussion, Senator Muñoz, to close. SENATOR MUÑOZ:

Thank you, Mr. President and Ladies and Gentlemen of the Senate. I appreciate all the discussion we had on the Senate Floor. I respect everyone's opinion. I know you guys are as passionate, as the way I am, about the bill. And as the Senator that just spoke before me, he's saying he's seen it out there, doing it in municipalities now for money. My response to that is, how is he doing it, when the bill doesn't even exist? I will be the first person to come back on the Floor if this should become law to say, hey, if there's problems out there and we're infringing on people's rights, that's not the intent of this bill. But what I will tell you about, law enforcement in the State of Illinois is trying to compete with the bad guy and trying to compete with the terrorists. And you know what? Thank God, we haven't had anything major happen here. But you know what? That's why it's called training. That's why the government does what they do with our military. That's why the police departments do what they do. You train personnel. And it's not only because of drones. Well, you know what? When we don't have the manpower, this will help in And let me give you an example of how many certain areas. proponents. You have Stephenson County Sheriff's Office, Tinley Park Police, Village of North Aurora, Mahomet Department, Iroquois County Sheriff's, Crest Hill, Shorewood Police, Oswego, Huntsville, Plainfield, Lake County Sheriff's, Criminal Justice

Do what's right and give law enforcement the tool only for training purposes - again, training purposes. Thank you and I ask for an Aye vote.

2196 is the initiative of the University of Illinois in concert with the -- with the Latino Policy Forum. The bill amends the governing Act for all nine public universities to provide legal authority for undocumented students, who meet the conditions necessary to be deemed an Illinois resident for tuition purposes, to be eligible to -- to access State-based financial aid. Financial aid includes any student aid or -- or benefit funded or administered by the State, State agencies, public institutions, or the university, such as scholarships, grants, awards, stipends, room and board, tuition waiver, or -- or other financial or inkind assistance. The bill excludes access to grants provided through the MAP grants. This is an initiative that -- all the public universities are online {sic}. All they really want is just to have the ability to decide and give aid to a student, an undocumented student. We have all the universities on board with this bill. And when you're talking about a hundred and forty-four thousand students that are at the public universities, only fifteen hundred would qualify for any type of financial aid by the institutions. Like I said, all the universities are on board with this. We have educated these young men and women from the age of primary to secondary. Now they are in college. They are, you know, pursuing professions that are going to benefit our society, our State of Illinois. And I will be happy to answer any questions. PRESIDING OFFICER: (SENATOR SILVERSTEIN)

Thank you. Can we keep the voice -- the noise down? I know we're competing with a lot outside and a lot of Members are complaining they can't hear the debate. So please give each speaker your undivided attention. Senator McCarter, what purpose do you rise?

Ladies and Gentlemen, we had this discussion in the committee. This, at a time when resources are scarce, you're going to add more people to the same potential pool of money. And it's not going to change; it's not going to add money to the pot in any way. What this is going to do is give the opportunity for someone that is undocumented or, if you consider -- to say it another way, you can say they're not a legal citizen, and you're going to give them the opportunity to take a scholarship away from someone that is legal. And so, it's up to you. At a time when the -- the resources are scarce and they're not going to grow -- I mean, in fact, even in -- in this committee, believe it or not, someone said that this will somehow be better because it'll increase the amount of money. Now how it does that, I have no idea. We know that the resources are scarce. What we're going to allocate, in money, for these students is not going to change, but you're going to add more people to it that have an opportunity. They're going take -- they're going to take that scholarship away from someone else. Those that obtain it that are undocumented, illegal citizens will take it away from someone that is legal. I urge a No vote.

SENATOR MARTINEZ:

Let me just clarify something. This is -- this allows the students to compete. We're only talking about one percent of the

overall hundred and forty-four thousand students that right now attend a four-year university. This gives the ability for the university to offer some kind of financial assistance to -- to young men and women, who are already paying in-state tuition, who are working two and three jobs to stay in school. There is a list of qualifications that they have to meet in order to even compete. When we talk about young men and women, we're talking about sometimes students that have a 4.0 average that other universities would love to have, other states would love to have. We want to be able to give the -- the control to the universities to be able to let these young men and women compete for some of these dollars that are there. It doesn't include the MAP grant. The MAP grant was taken out. This is other types of -- of scholarships that some of the universities have and we -- all we want to do is be able to give this opportunity to these students. We are not taking anything away from anyone other than adding maybe fifteen hundred students to that amount of a hundred and forty-four thousand students that already compete. So all we're asking for is to give the ability to the university to be able to have that power to decide, because right now they cannot do it based on the federal law.

A few years ago, of course, the State of Illinois adopted a policy of "60 by 25" by which our State committed to having sixty percent of our adult workforce earn a postsecondary credential by the year 2025. Those of us on the Higher Education Committee, other Members of this Chamber, have heard Jim Applegate, the Director of IBHE, and other higher education leaders make clear that we cannot attain that goal affording college access only to traditional students. We can only reach this necessary goal of sixty percent of Illinois' adult workforce having a postsecondary credential, and our State thus being robust to compete in our regional, national, international economies, by nontraditional students earning degrees after high school. Those nontraditional groups, of course, include first-generation college students, ex-offenders, lowincome students, students of color, and undocumented students. Furthermore, please note that our State has already invested its resources in these children, as they have attended our elementary schools, middle schools, junior highs, and high schools. investment obviously has proven to be prudent and effective, for these students have earned admission to our nine public universities. The money has already been spent to prepare these students for college. So this bill would give these students, who have done all that we encourage them to do - to study, to get good grades, to participate in extracurriculars, to get their college applications turned in on time - this bill would give those students the opportunity to bring our investment in them, our K through twelve investment, to degreed status - of obvious benefit to the students themselves, to their families, their communities, and our State. Ladies and Gentlemen of the Illinois Senate, I would like to make it very clear that, for children who were brought here as young children, illegally, by their parents and who have grown up here and become a part of our society, I do favor finding a path to citizenship for those children, because we don't blame kids for mistakes that parents have made or for activities that -- that parents have committed. However, as the previous speaker just said, this is a revenue-neutral bill. That means that there is a fixed amount of money that's going to be allocated. Should those funds go to legal citizens of Illinois or illegal citizens of Illinois? Until those children do have that path to citizenship, until they do become citizens, I believe it should be allocated to those here legally who are citizens. And for every thousand dollars or whatever amount it is we take away -- or for every thousand dollars we give to somebody who's here illegally, we're taking it away from somebody who is here legally. And if you're going to broaden it and say we're going to make these funds available to people here illegally in Illinois, why not make 'em available to people here legally in Indiana, or legally in Iowa, or Wisconsin, or Florida? This bill makes no sense. absolutely unfair to say we're going to take Illinois taxpayer dollars and give it -- take it away from legal Illinois citizens and give it to people here illegally. I strongly urge a No vote on this legislation.

I am both offended and -- I'm offended by that comment and it's very divisive to start indicating that this will -- this is what the intent is. We have passed legislation, as one of the original Members of the Latino Caucus who's nonaffected. But I wake up every day with affirmative action as my coat, because as a Puerto Rican born in the United States of America, if affirmative action laws weren't here for women and people of color, then will I be on that grill? Because then you wouldn't have to honor me. They wouldn't have to worry about us minorities, because I wake up with affirmative action laws that provide me these opportunities that I can go, and you have to abide by that because it is a law that makes you do that. Because if you didn't have it, oh, Lord, have mercy, what would you do to the Puerto Ricans - what you want to do already, take away our citizenship next? You blessed us in 1917 because you had a war coming and you wanted to draft our men. And my dad was one of those World War II vets - not one fingerprint, not one interview. They gave him a blessing and they took him to Bunker Hill, they took him to San Juan, they took him to war. And you all honored my dad here - thank you and I bless you for that. But you're

talking about things that are way old-school. It is both offensive and divisive to start talking about whose going to take what. When we talk about in the State of California who allows undocumented students to apply for and receive state-funded financial aid. Minnesota, students who meet the Dream Act requirements are eligible for state financial aid. In New Mexico - and that's how it's pronounced - allows state financial aid for undocumented In los Estado de Texas, all students meeting the guidelines of residency shall qualify - in Texas - qualify for state financial programs. The State of Washington allows students granted Deferred Action to child -- for Childhood Arrival status to apply for and receive State Needs {sic} (Need) Grant. So when we're here to bring Illinois together, I'm not concerned about Iowa and -- and my neighbors in Indiana, who, by the way, trash us every day, just go to any conference. We're here to bring Illinois together and divisive comments will only take us I'm moving into a Jetson system not into the backwards. Flintstones. So let's be very clear, as a non-affected U.S.-born Puerto Rican from the City of Newark, New Jersey, my community is only here by the power of affirmative action on a Commonwealth that was created - that today sits in Washington and no one wants to claim it - the oldest colony in America, in the Western Hemisphere, if not in the world. So you want to talk immigration, you want to talk international politics, well, bring your lunch. You're talking about fifteen hundred of your kids, our citizens. And as a former parole agent, I'm not concerned about them. As a former child welfare specialist, we service them. These are human rights. So let's keep our divisive politics out of this about what your policies are in the Presidential or immigration. That's

a separate conversation. Well, we have moved, and I applaud the Senator and other Senators who have moved their Acts here, to provide in-state tuition for those who need it. So let's keep things in perspective. Senator Martinez, you've done a great job on this, and I appreciate all the Senators who stood up on this. But this isn't novel, but it does expose those of you throughout these hundred and two counties that we continue to have a struggle in bringing Illinois together. And as long as we do and as long as the politics take precedence over the human rights, then this State -- well, we'll continue under a kingdom. I would ask for an Aye vote.

Senator Raoul, what purpose do you rise?

SENATOR RAOUL:

To the bill, Mr. President.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

To the bill.

SENATOR RAOUL:

As my brother just stated, this is -- the sky's not falling on this bill. I -- you know, I -- I -- from now on, I want to be known as Senator Raoul from the island once known as Santo Domingo, and -- and I'm an honorary member of the Latino Caucus right now. But with all seriousness, you know, there is a value, that's been recognized by the courses, a value in higher education, of diversity. And what this bill does, it gives a tool in the toolbox to our higher education institutions to improve the quality of the learning experience by being -- being able to fully embrace diversity. This is not going to be a -- a eradication of opportunity for students with -- within -- within the State. This

SENATOR LUECHTEFELD:

Thank you, Mr. President, Members of the Senate. You know, I -- I watched the debate in -- in committee and -- and listening to debate on the Floor. You know, I -- I think we're wrong if we want to simply -- you know, if you're -- if you're for this, as Senator Martinez, that doesn't make her bad. I saw those students, for instance, who were there that day, who were a lot of really good students, a lot of class kids, who -- who -- who, you know, have a, I think, a future. But -- but it's not wrong, I don't think, on either side -- that we vilify either side for a person who simply -- you know, I voted against the bill because I said to myself, "I got a choice. Should those scholarships go to citizens of the United States or should they go to the undocumented?" I'm not making -- I'm not criticizing you for wanting -- you're doing what you think is right. I think any person who looked at this, in that discussion, would say it's not necessarily -- it doesn't make a person bad or that he doesn't care if he wants to give them to citizens rather than to undocumented. So -- so, again, we -we -- we -- you -- you talk about division. All of this has been -- this discussion has been divisive, but both -- both have good reasons for what they did, I think, in this case. So, you know, again, you -- you vote your conscience, you vote the way you want

to do, but let's don't cut each other up be -- for what we're -- what we -- how we voted, okay? And -- and, again, whether I'm wrong or not, I think I care as much as you do and I know many people over here care as much as you do about it, but that was their decision. Thank you.

SENATOR BISS:

To the bill, Mr. President.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

To the bill.

SENATOR BISS:

Thank you. You know, as I'm listening to this debate, I — I find myself thinking about how often in our public discourse we hear people say, "Oh, the sky is falling in Illinois because our population is dropping or our population isn't growing fast enough". We hear that all the time. And there's a reason that people have that set of concerns and that reason is that when people come here our life improves. When people cross our State lines and choose to make their home here, life here gets better. And that's true if they come from Kenosha, it's true if they come from Davenport, if they come from St. Louis, if they come from Paducah, if they come from Gary, if they come from the east coast or the west coast or the south, if they come from Mexico, if they come from South America, or Poland, or elsewhere in Eastern Europe,

or in Asia, or in Africa. It makes our life better. It makes our life -- culturally richer and more enjoyable, but it also makes our economy more vibrant. In order for that second part of the bargain to hold true, the economic growth that comes from immigration, we have to make educational opportunity available to those who come through -- across our borders. And we're giving up on that opportunity if we don't pass this bill. We're saying, "Well, it's great, we're for it, if you come here under certain circumstances, if you come here from certain parts of the world; but under other circumstances, never mind, we don't want to benefit economically as a State". That's a bad economic bargain. It's unnecessary, it's unwise, in addition to obviously being unfair to the young people who are being locked out. So I think this bill is an important statement about who we are as a people and what kind of State we believe ourselves to be. I also think it's a very sensible economic step that will help our future financially. I strongly urge an Aye vote.

PRESIDING OFFICER: (SENATOR SILVERSTEIN)

...you. Senator Martinez, to close.

SENATOR MARTINEZ:

Thank you. I just want to thank all the Members for sharing their views on this bill. This is a very important bill, just not for the students, but for the entire State of Illinois. As you know, we have, right now, over a hundred and forty-four thousand students in four-year public universities. The undocumented students do not qualify for any kind of financial help whatsoever, based on the federal law. And I know that we have to fix our immigration system on -- in -- on the federal level. Right now these students, like I think one of the Senators from the other

side said, they were brought here by no fault of their own. They've done the right thing. They have gone to school. They've -- you know, they've passed secondary. You know, now they're in college. All we -- all this bill is doing is giving the opportunity to the universities to make the decision of any dollars that are there, that these young -- this one percent, fifteen hundred students that qualify - not that all will take advantage of it - but there's at least one percent of the overall university students are the ones that are trying to just at least be able to compete. We're not taking anything away from anyone. They just have the ability to compete in the process and it's up to the universities to decide, you know, if they want to be able to give a stipend, a waiver, some kind of financial help to the You know, we have some great students who are 4.0 averages. These are geniuses that we want to be able to keep here, graduate, and they can work here in our great State of Illinois. So all I'm asking, for Aye vote. Do it for the students out there that really need to be able to continue with school. As you know, all these students -- many of the students that came down are -are -- are American students, U.S. -- U.S. citizen students who, right now, are in favor of this. They want to be with their -with their fellow students and -- and fight this fight for them, because they know it's not -- it's not fair. So all I'm asking for is, let the university take control of that and be able to provide or help assist some of these students that really are brilliant students that need to stay in our universities and graduate so they can give back to us what we have given to them.
