Currently, these reports are filed by a guardian or appointed legal custodian. Furthermore, it requires the Department of Juvenile Justice to file reports to the court dealing with any incidents the minor might be involved in which appear to cause a serious threat to the minor's life or well-being. The DJJ must almost submit reports detailing all youth released by the Prisoner Review Board, but remain in the DJJ facilities due to not having an approved aftercare release host, along with reports on those who have been in the DJJ facility for more than one consecutive year. These reports must be made available to the minor's quardian ad litem, attorney, or parent, if known. We do not have any opponents that I know of at this time and the Department of Juvenile Justice is neutral. And this a -- work of the Cook County Public Defender; Cabrini Green Legal Aid; community mental health, substance abuse (and) prevention providers; Safer Foundation; the Juvenile Justice Commission; and the Cook -- Cook County -- Public Guardian. And I would ask for your Aye vote. PRESIDING OFFICER: (SENATOR LIGHTFORD)

This is pretty much identical to what was done in DuPage County a few years back. The amendments include — the first — there are two exclusions. So one thing that will be excluded under amendment, I believe 4, is the conservation district of McHenry, and under Amendment 3, we're excluding the mental health board. I know of no objections to the bill. I'd be happy to answer any questions and I would urge for an Aye vote. This is something that we've negotiated for quite a while and it's a good bipartisan bill.

So I thank you for all of your efforts and I look forward to, as we move this, as a statewide initiative for every county in the State.

We really felt that - you know, I agreed - that that should be excluded because of how it was created. But I appreciate your comments and, again, you know, many times in order to get something to a place where we can vote on it, there's bipartisan work that goes on here, and there was -- you know, certainly, that occurred in this Chamber, work across the aisle, and -- and I'm happy with the final results. But I understand your question. But I would still urge an Aye vote from you.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Further discussion? Senator McConchie, for what purpose do you rise?

SENATOR McCONCHIE:

To the bill, Madam President.

SENATOR CONNELLY:

We just did a -- IDOT did a project at Route 59 and 88 in Naperville/Aurora and it has been fabulously successful and it is -- not only has it made traffic easier, it's probably saved lives. Thank you. Okay, as amended, this bill just requires judges to explain consequences that may result from a conviction or a plea deal -- a guilty plea and requires that judges inform the defendants of the future consequences that may exist due to the conviction or the guilty plea. We'll let the record reflect, Senator. Senator Althoff, for what purpose do you rise?

SENATOR ALTHOFF:

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Koehler.

SENATOR KOEHLER:

Thank you, Madam President, Members of the Senate. This bill amends both the Labor (and) Storage Lien Act and the Labor Storage Lien Act {sic} Labor and Storage Lien (Small Amount) Act by inserting notice provisions for lienholders. In both Acts, the new language would provide that it is -- that an entity seeking to impose fees in connection with storing a vehicle in -- in its procession must provide a written notice to the lienholder of record prior to the accrual of such fees. Further, the notice would provide the rate at which the fees will be accrued {sic} (incurred) and give the lienholder an opportunity to inspect the vehicle. If the lienholder chooses to inspect a vehicle in the

procession of a repair shop and ultimately pay applicable fees, the bill provides that payment may be made by cashier's checks, certified check, wire transfer, which is at the option of the lienholder. I also want to read in for legislative intent -- a question was asked about will this bill apply to repossession companies regulated by the Consumer Financial Protection Bureau, and the answer is no, that this will not apply to that part -- that particular organization. So, happy to answer any questions. PRESIDING OFFICER: (SENATOR LIGHTFORD)

Is there any discussion? Senator Nybo, for what purpose do you rise?

SENATOR NYBO:

To the bill, Madam President.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

To the bill, Senator.

SENATOR NYBO:

I just wanted to rise in strong support of this bill, Senator Koehler. This is a tough issue. It's -- it's complex. But what's good about this bill is that it's beneficial to both financial lenders and to repair shops that store vehicles. I know you're carrying this bill on -- as -- at the request of the Credit Union League, the Community Bankers Association, and the Illinois Bankers Association. So, I -- I appreciate you carrying this bill. It is a good bill. It's a helpful bill and I would ask everybody to join him in supporting the bill.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Further discussion? Senator Syverson, for what purpose do you rise?

SENATOR SYVERSON:

Thank you. Question of the sponsor.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Sponsor indicates he will yield. Senator Syverson.

SENATOR SYVERSON:

Senator, I -- I -- I also support this legislation, but a question was -- was raised regarding in checking with the SOS system. If vehicles have been sold or vehicles that have not been processed right and in that system yet, how would -- how would a towing company know that information and be able to make that acknowledgement?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Koehler.

SENATOR KOEHLER:

That particular question, I'm not sure of, because generally a lienholder will -- will -- that information will be on the Secretary of State's website. I -- I can get back to you if that's -- if that's an issue that is of concern. But right now, and -- and I know that people have tried this, all you have to do is get the VIN number off the vehicle and get on to the Secretary of State's website and that automatically pops up. What you're talking about is if it hasn't been processed right. We'll -- we'll look into that.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Syverson.

SENATOR SYVERSON:

Thank you. Yeah, if we -- if -- I guess if we could look into that. I know, in the past, there's been issues where the Secretary of State's Office has gotten behind on -- in work and it could be a couple months before something gets processed, and in

those cases, you know, how would they -- how would they know? They could check the site and nothing would be on there. And so that's -- again, it's an issue that was raised, which seems like a legitimate question that we should probably make -- make sure we have an answer for, but otherwise I appreciate what you're doing on this bill. Thank you.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Further discussion? Senator Oberweis.

SENATOR OBERWEIS:

Question of the sponsor.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Sponsor indicates he will yield. Senator Oberweis.

SENATOR OBERWEIS:

Senator, I, too, had a couple of questions from towing companies and I just want to understand the mechanics here. A towing company tows a car, they then are able to go on to the Secretary of State's website to find out who the owner is? That -- that's -- and then -- and then what -- next question is, of course, then what happens, how do they notify the owner? And they cannot start charging storage fees until they're sure the owner has been notified. Am I understanding that correctly?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Koehler.

SENATOR KOEHLER:

Yes, thank you, Senator, for that question. What -- what this really relates to is where somebody has dropped a car off to a repair shop, as an example, and then decides that they -- they really don't want the car and they walk away from it and there's a lien on that vehicle. What -- what this legislation specifically

says is that the -- the tow truck company or the repair shop can send a certified letter, you know, once they find out who the -- by the VIN number, who the lienholder is - it's not the owner of the vehicle, it's the lienholder - and once they send that certified letter, the towing charges start on the day that that letter is sent. I mean, that's why it's a certified letter because there's a date on there. It's not when it's received, it's when that tow truck operator or that repair shop sends it, which guarantees them then that if that vehicle's recovered that they get paid for that -- that time. So it really is a -- a benefit, I think, to the repair shops and the -- and the tow vehicles. But they do have to find the hold -- the lienholder is by going to the Secretary of State's website.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Oberweis.

SENATOR OBERWEIS:

Thank you, Senator. That -- that seems to make sense. Just a -- a further question along the same line. In a case where a car is towed, how long might it take a towing company to learn who the lienholder is and to send them that request or letter or certified letter?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Koehler.

SENATOR KOEHLER:

Yeah, thank you again. I -- the -- the -- the time it takes to get on the Internet and -- and get into the Secretary of State's system. They may -- when they tow a car, you've got two parties involved here. One is the actual owner of the vehicle, the person that it's -- it's registered to. The second is the

lienholder that's made the -- the loan on it. So, if they want to protect themselves, they -- they might want to do that as soon as they bring the vehicle in, to know who the lienholder is. And again, if they -- if they're ever suspect that they're not going to have that -- that car redeemed by the owner, then they can charge the lienholder by sending that certified letter. So I think it -- it -- it means that they do have to send a letter, but it also means that they're guaranteed that -- that those charges start on that day.

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Oberweis.

SENATOR OBERWEIS:

Yes, I -- I believe this is my last question. It's related to the same thing. I -- my concern from some of the towing companies was I believe they were telling me that it might take them many days or several days to get a response from the Secretary of State's Office as to who the owner or lienholder is, and you're telling me it's virtually instant online. And -- and what if the address is wrong that's online or if a vehicle's changed hands, for example?

PRESIDING OFFICER: (SENATOR LIGHTFORD)

Senator Koehler.

SENATOR KOEHLER:

Again, we're not talking about the owner of the vehicle or the -- the person that the vehicle's registered to. We're talking about the lienholder. So it'd be XYZ credit union or community bank, those would be -- I mean, if -- if somebody saw a bank, for instance, in their community, they would know how to find them. But that information should all be on the Secretary of State's

website. You know, what Senator Syverson was asking is -- is kind of a question of what happens if -- if the information isn't there. But -- but -- but 99.9 percent of the time the information is going to be there and it's going to say who the lienholder is and what the address is.

SENATOR KOEHLER:

I just ask for an Aye vote. Thank you.

SENATOR BISS:

House Bill 2822 creates the Human Trafficking Task Force to address the issue in a comprehensive way. The bipartisan task force will be composed of Members from the House and Senate, a representative of the Chicago Regional Human Trafficking Task Force, who is appointed by the Governor, and the Director of the Department of State Police, or his designee. Administrative and other support will be provided by the Department of Human Services {sic} and the Department of Children and Family Services. The group has several objectives, including creating a data sharing network, a resource that will be vital to helping human trafficking organizations and law enforcement officers who work on the front lines. The task force will evaluate current procedures to create standards for more effective intervention, which will allow more lives to be saved and rehabilitated. The task force will be -- will create a muchneeded strategic and comprehensive action plan to combat human trafficking in Illinois. Human trafficking isn't a partisan issue, it's a human one. Please be part of the -- the solution. I ask you for a Yes vote on House Bill 2822.

Thank you, Madam President. I wanted to point out to the Body that it is no coincidence that today Dr. Maryam Mostoufi provided the Senate invocation. This week marks the fifteenth anniversary of the passage of Senate Bill 750, the Illinois Halal Food Act. It was the first time that more than five hundred thousand Muslims statewide became civically engaged with the Frankly, I'm very proud that they were my constituents at that time that provided the impetus for that movement. We worked together to become only the third state in the nation to require that food labeled as Halal does indeed conform to Halal standards. With broad bipartisan support, this legislation demonstrated that Muslim Americans were all -standing together with us today. Only a few of my cosponsors remain today, including Senate President Cullerton. But you might remember a couple of others, one being then Senate President James "Pate" Philip and also now President Barack Obama. together, Republicans and Democrats, to give Muslims in Illinois confidence that the Halal food products they buy are indeed prepared according to Islamic law. Finally, I can't mention Halal food without mentioning Senate Democrat staffer Nia Hassan and her

assistance in developing the Illinois Halal Food Act. Our work together also demonstrates - and I think we could use that demonstration right now - what bipartisanship can do for our constituents and the legislative process. Primarily, I inherited a large portion of Leader Radogno's old district and now I have the highest population of Muslim Americans in my district, so I would like to join with her in recognizing some of the progress that we've made as a State in reference to recognizing our Muslim American citizens. In 2005, we passed Senate Resolution 178. It was adopted and it urged development of a list by federal agencies of safe charitable organizations, including Muslim organizations, that are safe for all Americans to contribute to without fear of prosecution and with assurance that their contributions would be used for their intended purposes. We also adopted House Resolution 438, which was identical to Senate Resolution 178, as well as -also in 2005, we had the first Muslim in history of Illinois to do the Senate invocation in the Illinois General Assembly.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Cunningham.

SENATOR CUNNINGHAM:

Thank you, Mr. President. House Bill 4264, as amended, it is an initiative of a relatively new antidomestic violence group called Chicago Says No More. The bill will ensure that cosmetologists and other salon professionals will receive domestic violence awareness training as part of their licensing process and that will help them interact with customers who may have been the victims of domestic violence. The amendment was an agreement negotiated with the Cosmetologists Association, as well as the Department of -- Financial and Professional Review {sic} (Regulation). It removed all opposition. I'd be happy to answer any questions and I ask for the Chamber's support.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Is there any discussion? Is there any discussion? Seeing none, the question is, shall House Bill 4264 pass. All those in favor will vote Aye. Opposed, Nay. The voting is open.

Senator Forby. Ladies and Gentlemen, let's go to House Bill 4334. President Cullerton. Next up on the Calendar, Ladies and Gentlemen, the middle of page 16, the regular Calendar, House Bills 3rd Reading, we have House Bill 4336. Senator Tom Cullerton. We have next on the Calendar, Mr. Secretary, should be House Bill 4344. I'm told that bill has already passed, so let's go to the next bill, which is House Bill 4351. Senator Biss. Mr. Secretary, please read the bill.

ACTING SECRETARY KAISER:

House Bill 4351.

(Secretary reads title of bill)

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Biss.

SENATOR BISS:

Thank you, Mr. President, Members of the Senate. The purpose of House Bill 4351 is to save the Community Care Program as it currently exists. We've discussed components of this over the last year and a half. For instance, the component that retains the DON score requirement of twenty-nine. It also codifies current eligibility requirements for the Community Care Program, which is a program that literally tens of thousands of older adults rely on to stay in their homes and avoid more costly institutional care.

There's a push from the administration to dramatically change this via administrative rule and we believe that it's important for the legislation -- Legislature to have a clear hand on the mechanism by which this crucial, crucial set of services are delivered. Happy to take any questions and I'd be appreciative of your Aye votes.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Thank you. Is there any discussion? Is there any discussion? Senator Righter, for what -- Senator -- the two of you decide. Senator Righter, for what purpose do you seek recognition? SENATOR RIGHTER:

Will the sponsor yield, please, Mr. President?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Indicates he will yield for questions. Senator Righter. SENATOR RIGHTER:

Thank you. And my apologies for the confusion, Mr. President. Thank you for your indulgence. Senator Biss, this is an attempt to block an administrative rule change that would change the Community Care Program. Am -- am I fair -- fairly characterizing this? I mean, just kind of taking the varnish off and be honest

Senator Biss.

SENATOR BISS:

about it.

The administration has described a new program they want to create they call the Community Reinvestment Program. They want to establish it by administrative rule. This bill would stop that from happening.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Righter.

SENATOR RIGHTER:

And this would change how we do this with regards to taking the provisions of the program out of rule and placing them firmly in statute, which means that the administration, in order to make changes to the program, would have to come back and go through the General Assembly. Is that fair?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Biss.

SENATOR BISS:

Yes.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Righter.

SENATOR RIGHTER:

Outline for me, Senator, if you would, in whatever -- whatever detail you'd like, your objections to what the Governor's Office is trying to do and, trusting I know that you'll be -- you'll be objective, what the Governor's motivations are in changing the program as they've attempted to or are attempting to by rule.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Biss.

SENATOR BISS:

Thank you for the question and the compliment and the question that followed the compliment. My concerns primarily are these: vagueness; lack of clarity around what exactly this Community Reinvestment Program would look like; how precisely services would be delivered; what kind of transition plans would be in place; the question of do we or do we not want -- intend to retain a commitment that all individuals would be receiving the level of services

they're currently receiving. On the one hand, that was said in committee and has been said publicly by the administration, but on the other hand, there's a claim that half the cost can be saved without reducing services, which seems - to be honest - almost magical to me. And additionally, the rules that were -provisionally released specifically provided for the Department to create a waiting list, which seems to be exactly in contradiction to this concept of retaining services to populations already receiving them. So that's a set of concerns that I -- I feel very, very strongly. The second set of concerns that I feel is the -a lack of readiness and a lack of a clear stakeholder input in the creation of this very significantly new and different from the status quo program in a way that would be, I think, possibly disruptive of services to literally several tens of thousands of older adults who rely on these services. Now I believe that the administration has good intent. I take their word seriously that their intent is to save money and create a more person-centered mechanism for service delivery. I would say, great, I'm for that. You're for that. I'd be happy to work with the administration to do that, but their intent so far, it seems, has been to go full steam ahead, intending to implement fully a program that's at best poorly explained to date, and I think that should be something that causes tremendous alarm on the part of every single Member of this Chamber.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Righter.

SENATOR RIGHTER:

Senator, would this bill allow for a transition to the universal assessment tool?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Biss.

SENATOR BISS:

Yes.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Righter.

SENATOR RIGHTER:

Under the -- as you understand the Governor's proposal, would seniors lose -- I mean, seniors be left without services that are getting them now or would those services simply be changed in some instances depending upon their need?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Biss.

SENATOR BISS:

I think the core issue that brings us to this debate and this hopefully soon vote is a lack of clarity regarding what the Governor's plan is. Certainly it is hard -- it is impossible for me to say, based upon what I know, to this -- to -- to date that the -- that there's not an intention to take services away from people who are currently receiving them. For instance, as I said, the provisional rule explicitly calls for the creation of a waiting list.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Righter. Further discussion? Senator Syverson, for what purpose do you seek recognition?

SENATOR SYVERSON:

Thank you, Mr. President. Just to follow-up on a couple questions.

SENATOR SYVERSON:

Senator, you -- you -- you mentioned that -- briefly in your -- in your -- one of your responses about this new plan is supposed to be a -- a person-centered plan, where the Department would be able to have some creative solutions, as opposed to a one-size-fits-all for every senior - that this allows the Department to work with that individual on their particular needs, as opposed to saying you've got to have this service or this service. So, with that in mind and the fact that they said no one would be losing services, I guess I'm trying to figure out what is the problem with giving the Department that kind of creativity to work with these seniors.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Biss.

SENATOR BISS:

Like I said to the previous speaker, I trust the Department and the administration's motives here. I think those motives are good. I think this program, as it's been described to date, is, to put it mildly, not ready for prime time. And so to say, yeah, we intend to retain services; oh, and by the way, it's going to cost hundreds of millions of dollars less; oh, and we'll have a person-centered approach that allows us to find resources already existing, but not currently utilized in creative ways - that sounds awesome, but these are tens of thousands of people who, as far as I can see, do not have before them any kind of clear transition plan. And so I would say the vote before you now is, do you think there's a clear transition plan that you're comfortable with? If

so, you should vote No. But if you look at this and you say, hey, that sounds like a pretty good idea, but, whoa, I don't have any evidence that it's actually ready for prime time, then I believe you should vote Yes.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Syverson.

SENATOR SYVERSON:

Senator, I would submit that they are not going to turn the switch tomorrow and throw everybody into the -- into this new program, that it would be a transition as they work with the Department to implement these -- these new creative programs to give families more alternatives, that it would be something that would be phased in. And like many programs we pass here, there may be a time we come back in the future and have to address that or make changes in that. But going forward, I don't think -- the Department never said they were going to be jumping into this thing the next day and make that change. The concern we have with -- with this legislation, though, I -- I think the way it's drafted is even if a person no longer qualifies to be under this program, under your legislation they get to stay on the program for another twelve months, and what -- what's -- what would be the purpose for that part of the legislation?

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Biss.

SENATOR BISS:

Thank you. So first to your previous point, the fiscal year starts in a month and a few days, and so, to me, that's really, really soon and, frankly, alarmingly abrupt. I think what you're talking about is, what if there is the switch made from the DON

score to the universal assessment tool. I think there's broad agreement that we can do better in assessing need. I also think there's some pretty broad concern that the switch from the one assessment to the other would be kind of an excuse to throw a bunch of people off. And the purpose of this bill is to make sure that that's not what the switch is utilized for.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Senator Syverson.

SENATOR SYVERSON:

I guess a couple things. One, you would -- I'm sure you would admit that the DON score is a very -- is a failed system that has very limited opportunities, that you could have two different people that have the same DON score, but would have totally different needs that they would have, and that the universal assessment tool is something that the majority of other states do, which gives a lot more flexibilities for agencies to use. But you had mentioned that -- that -- that this somehow would be turned on on July 1 and everyone would be kicked off if this would -- I don't think anyone in the Department said that this would be a switch that would turn on July 1, that they would move forward in starting to implement this program, but it would be phased in. And again, the goal is to have more creativity and more flexibility for -for the Department and, yes, that could result in the savings of money as well, that if we can help an individual have more costeffective care at home versus a different type of treatment, that would make -- that would make sense. So, the end goal is, yes, to save money, but also to give flexibility to the Department. So, I guess, my concern is, this legislation keeps us locked in to a system that we know is not working, a system that we know is

failing some individuals that don't get the use of the flexibility that -- that the Department wants to do with this -- new program. And so whether or not we have to come back and address concerns a year from now, as this program gets implemented, we don't know and that's what -- that's our job to be here to look at that. But I think to tie the hands of the administration, trying to implement what is a creative idea, would be a big mistake and I would urge our Members to oppose this legislation. Thank you and thank you for your time answering questions.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Further discussion? Senator McCarter, for what purpose do you seek recognition?

SENATOR McCARTER:

To the bill.

PRESIDING OFFICER: (SENATOR SULLIVAN)

To the bill, Senator McCarter.

SENATOR McCARTER:

Specifically to the bill, this is -- there is a transition plan within this and it doesn't make any changes to anyone that's Medicaid eligible. In fact, you say, well, there -- there's -- there's cost-saving. There's a lot of cost-savings in this bill, about two hundred million dollars. You say, well, you're going to take that away from people? Well, look -- look -- let's put it into perspective as to what we do as a State first of all. We provide three times the national average in services to non-eligible Medicaid seniors - three times. And the proposal is to go to 2.2 times. We still lead in what we provide non-Medicaid eligible seniors. And so here's the thing. You -- you want to fix a budget? This is how you fix a budget. You make tough

decisions like this. You have a good plan, you make good -- you make tough decisions. Two hundred million dollars is within the Governor's budget. This is a reasonable plan. But if we're not willing to take on this small paradigm shift in the way we do things in this State, we're surely not going to save five billion. Is it uncomfortable? Yes, it's uncomfortable. Is some -- are there seniors...

PRESIDING OFFICER: (SENATOR SULLIVAN)

Shh. Please, Ladies and Gentlemen. Continue, Senator McCarter.

SENATOR McCARTER:

...that have the means to provide for some of these services? Are they going to get less from us? Yes, they would, but I don't think that's too much to ask. We're not kicking anybody on the street here with nowhere to go. We're just saying we can't do as much for you as we've done in the past, going from three times the national average to 2.2, not down to the national average. We're still 2. -- we would be 2.2 times what everyone else is doing. We're still compassionate. We're still -- kind and we would be honest that this is what we have to spend. This is the kind of thinking that we're going to have to change if we're going to fix this budget. This is a start.

PRESIDING OFFICER: (SENATOR SULLIVAN)

Seeing no further discussion, Senator Biss, to close.

SENATOR BISS:

Thank -- thank you, Mr. President. Thank you, Members, for the robust debate on what I believe to be a really important question. I think the -- the last two speakers really illustrated part of what makes this bill feel so important to me. The

immediately previous speaker talked about we've got a budget problem, we've got to make tough choices, and it's going to be uncomfortable and hard, but we got to give some people less, because we -- we're broke, and that's a point I understand. speaker before that said, hey, this isn't about giving people less, this is about doing things in a more innovative, flexible way and maybe we'll save money, but more importantly, we'll be doing things right and flexibly in an innovative, modern way - isn't that better? I understand that point, too, but they're in conflict with each other and they illustrate how little clarity we have from the administration about what this program would be and how it would work. What we do have clarity about is that it's in the Governor's fiscal year '17 budget plan and that starts in five weeks. There are tens of thousands of seniors who currently rely on this program. If you don't feel clarity, if you don't feel certainty that what's planned is ready to be rolled out and provide appropriate services that those tens of thousands of older adults have been relying on, starting in five weeks, then I would ask you to please vote Aye.

As introduced, House Bill 4536 increases the threshold amount at which competitive bidding is required for supplies, materials, and work to increase from twenty to twenty-five thousand dollars under the Park District Code. This has to do with mandating that Illinois provide coverage under its Medicaid program for a certain set of drugs, and my concern is, you're saying "upon federal approval" when, as you have agreed, the federal government already mandates this. I -- I'm just concerned -- I mean, I -- I don't know enough about all of the language in here to feel confident that we are going to simply cover what's already under federal law, 'cause this language clearly indicates that we are going to seek some kind of new coverages once the federal government approves them. I wonder -- Senator Link, I mean, I think that we're still here for a few days. I'm going to ask if you would kindly pull the bill out of the record, so we can all sit down and make sure that what you've described is your intent is actually what this language does.

Thank you, Mr. President and Members of the Senate. This is a -- a bill that is a little emotional just for me and my family. This was generated by Representative Gordon-Booth in the House.

The genesis of it was that two years ago, on May 24th, her son was murdered in the early morning hours. And I remember -- I remember the day that it happened because it was also the exact same day that I graduated from law school. She was going to surprise me at my graduation and texted me very early in the morning to say she would not be able to come because DJ had died. It was every parent's worst nightmare. This was her stepson, who she was very close to and the family was close to. This happened also a few weeks before she had that beautiful little girl that you guys see running around on the Floor all over because I'm her godmother. So, Representative Gordon-Booth is not my sister by birth, but we have become very close, and so this is a -- an issue that means something to a lot of people. Many times in a situation like that, you have to have an eyewitness that directly ties -- direct -gives you a direct nexus to the crime at hand. You know, we have a Crime Victims Compensation Act which allows for compensation for victims and their families, but this would expand to include a witness that was a personal witness to the thing when they testify on behalf of the State. Representative Gordon-Booth negotiated this with both the State's Attorneys and the Attorney General to make sure that we wouldn't be depleting the fund, but we would make it possible for -- in that particular circumstance, there was an eyewitness. There were a lot of people at the party. But this young woman was so afraid she picked up her four kids and moved them three or four states away, and it was difficult to get her to come back and testify. We were able to get a guilty verdict and life goes on, but for many families in this situation that's the impetus behind this bill. So I would ask for your support. know many of you have met her and know her. This is a Member

initiative. But I think it's going to do a lot of good in situations where it's very, very difficult for that person who was a personal eyewitness, who can be just as victimized as the victims of the crime themselves in a situation like that. So I would ask for your support and I'm happy to answer any questions.
